## **BOARD FINANCIAL REPORTS**

### Club Operating Financial Commentary for July 2015

#### **July Financial Statement Review**

For July, the first month of the new fiscal year, revenue was \$33,000 favorable to budget. Significant positive contributors on the revenue side were directory income +\$18,300 (due to timing of advertising income), food/bar sales +\$11,800, lessons/classes +\$8,000, interest income +\$3,300 (new late fee policy), guest room income +\$2,100, billable services +\$1,800 and Pro Shop merchandise sales +\$1,700, all of which were partially offset by green fees -\$8,600, resident activities income -\$5,300 and driving range income -\$2,100. Compared to last July, 18-hole golf play is down by only 22 rounds; however, there were 69 fewer outside tournament rounds and 100 fewer invitational/other guest rounds, which bring in a higher green fee. On a positive note, member play was up 116 rounds compared to last July. For the month, food/bar sales were \$4,800 higher than the prior year.

Total expenditures were \$112,000 favorable to budget for July. The largest favorable expense category was water at all the Club properties +\$61,300, although golf course water was unfavorable to budget -\$6,000. Other favorable expenditure categories were employee expense +\$25,400, landscape +\$15,300, supplies/maintenance +\$12,900, cost of sales +\$4,400 and other +\$2,500, all of which were partially offset by services -\$8,800 mostly due to the timing of expenses for the community survey. Food and bar costs were at 33.5 percent and 27.6 percent respectively, with food cost performing favorable to budget and bar cost unfavorable to budget. The net positive budget variance for the first month of the new fiscal year is \$145,000.

## The Villages Association Treasurer's Report for July 2015

#### **Association Operating Results:**

**July Revenues:** Revenue was \$6,300 below budget due to the timing of laundry income and credits given to owners who are now billed directly for individual trash collection.

**July Expenditure:** Expenses were below budget by \$304,000 primarily due to water (\$266,100). We are billed bi-monthly for water and this is the first full bill we have had since we began mandatory irrigation rationing. The above saving therefore represents the saving over the two month period relative to budget. Some Districts are showing a negative balance for July since their total water expenditure was below half the bi-monthly budget and therefore they are being credited for the over charge last month.

Other favorable to budget items were: Landscape expenses -\$31,100 (timing related); Maintenance -\$7,700; Trash -\$3,800 (due to certain properties being billed directly).

**YTD Revenue & Expenditure:** These are the same as the monthly expenditure since this is the first month of the year.

**Accounts Receivable:** As of August 18, there was \$48,434 in accounts receivable more than 60 days late (down \$533 from the prior month) for members' assessments and personal charges that are more than 60 days late.

#### **Association Replacement Reserve Plan:**

Year-to-date expenditure of the reserves total \$274,000, which is 4 percent of the budget. Principal expenditures YTD include: Cribari—Roofs \$13,000, Painting \$11,000; Building Components \$48,000; Deck Entry Coat \$85,000; Landscape \$11,000.

Other Districts, notably Montgomery, Heights, Highlands and Olivas \$100,000.

The year-end figures are being consolidated for FY 2015 and the Reserve Spreadsheet will be updated shortly with the rollover from FY '15 to the current year.

The Reserve Portfolio balance as of 31 July 2015 was \$10,748,000. The average interest rate on this investment is 0.94 percent. Our latest CD is earning a massive 2.00 percent.

A number of CDs mature over the next few months with low yields of between 0.55 and 0.65 percent and there is the prospect of being able to get a more attractive yield.

## Homeowners July Financial Statement Review

Homeowners' revenue was on budget for July. Expenditures were \$335 favorable to budget due to less than planned legal fees +\$413, offset by higher than budget pest control -\$50 (snake removal) and operating supplies -\$28. The net positive budget variance for the first month of the new fiscal year is \$336.

Estates revenue was unfavorable to budget for the month by \$2,441 due to trash credits given to owners with individual trash cart service. Beginning July 2015, Villages' owners who utilize individual cart service will pay for trash and recycling services through their Santa Clara County Secured Property Tax bill. Because the FY '16 operating budget included trash expenses, these owners are due credits every month. There is an offset in the trash expense since The Villages no longer pays the trash bills for Estates owners. This process will continue for the rest of the fiscal year. Expenditures are \$9,181 favorable to budget with less than planned water +\$7,073, trash +\$2,441, landscape +\$152 and legal fees +\$213 offset by higher than planned pest control expense -\$815 (annual ant spraying). The net positive budget variance for the first month of the new fiscal year is \$6,740.

## FROM THE CLUB BOARD

## Club Board Projects

There is not a single answer for describing how Club Board projects originate. Some come from long term planning, such as the golf course irrigation system upgrade, some come from club requests, such as the retrofit of the Montgomery Center for the Table Tennis Club. And some come from a requirement to upgrade an amenity, such as the Cribari Plaza, with the need for ADA ramp, better lighting, and crack free concrete. Also, the GM and Villager workshops are frequently involved with recommending projects to the Board.

All club projects must be voted on and approved by the Club Board of Directors. At least one or more Board members need to be involved with bringing the project to the Board's attention. The Board must give them permission to continue, to begin gathering data and planning the project, particularly in estimating potential costs.

As you probably know, the Club Board has limited resources for capital improvements, so care must be taken to limit unnecessary expenditures. In an effort to be frugal with spending, we have, in the past, asked for assistance from the Evergreen Villages Foundation (EVF). An excellent example was the EVF donation to the Cribari Plaza upgrade (\$100,000). Donations to the Club Board are voted on separately, only after the project has been officially approved to proceed by the Board.

The EVF does not recommend projects to the Club Board of Directors, in fact, just the opposite. An EVF form, (Request For Funding A Capital Improvement Project), must be submitted to the EVF Board in order to initiate the process for obtaining assistance. Recently, (on behalf of the Club Board), a formal request to EVF was made by Club Director Mike Poellot for the Fire Pit upgrade project. Since the existing Fire Pit on the Bistro patio had been deemed unsafe by our GM, the options seemed to be either upgrade or tear it down. Many on the Board decided an upgrade was preferred to tearing it down. To date, the EVF has obtained \$8,300 in contributions from Villagers for the Fire Pit upgrade. A first and second bid have been received by Tom Muniz with the first bid being the lowest at \$9,600. In consideration of the \$8,300 commitment from EVF, the Club Board funding limit will be set at \$1,400 if the Board votes to implement the Fire Pit upgrade.

## Coming September 10—Villages Age Certification Survey

Arriving with September's monthly statement will be the biennial age certification for all residents of The Villages.

To continue our community's status as a senior community, The Villages must comply with the state and federal laws that govern California senior housing developments. Federal law requires that at least 80 percent of the occupied units are occupied by at least one person who is 55 years of age or older. Furthermore, The Villages Association and Homeowners Corporation must conduct periodic surveys to verify and document that the community is in compliance with the federal 80 percent occupancy rule. Failure to satisfy the legal requirements may result in a determination that our community is not a lawful senior community and therefore mean that we must allow persons of all ages to live here.

In order to fulfill the requirements imposed upon the Corporation, one resident of your condominium or home must complete and sign the Age Certification (under penalty of perjury). Please note that if you are an offsite owner, you must have one of the tenant(s)/resident(s) complete and sign the Certification. Offsite owners are responsible for ensuring completion and return of the Certification by one of their tenant(s)/resident(s).

Please return the Age Certification on or before October 15, 2015. You may either mail the completed document back to us in the enclosed envelope or drop it in the box located at Building A. (For convenience, additional drop boxes are available at the Cribari Center just outside the Post Office and in the parking lot adjacent to Building A.)

We appreciate you taking the time to complete and return the Certification. Please be assured that the information that you provide is used strictly for the Corporation's records and to document our community's compliance with applicable laws. A summary of the survey results (not including names or addresses) will be made available following completion of the survey.

A message from your Community Standards Administrator

As your Community Standards Administrator it is my responsibility to routinely inspect the community for rules being broken. The Association's rules were developed and approved by your Board of Directors. They are revised when recommendations are made by members, the Rules Committee, or the General Manager. The rules are designed to provide uniformed protections for all Villagers.

I would like to inform Villagers of the most common Association rules being broken I've noticed while conducting inspections.

Rule 2.07 Common Area Alterations: Owners (or residents) may not alter, or install any improvement on common area, including common area landscape, without the prior approval of the Architectural Committee (AC).

Rule 2.21.12 Association Common Areas: Residents will not place items in common areas including utility closets except where specified in Rule 2.08 and/or AC approval. Prohibited items include but are not limited to yard art, statuary, figurines, potted plants and planter boxes.

Rule 2.08.3 Maintenance of Villas and Limited Common Areas: Each resident is responsible for keeping the garage, carport, patio, and other limited common areas that are open to view by others in a clean, orderly and sanitary condition.

Rule 2.08.4 Maintenance of Villas and Limited Common Areas: A 36-inch-wide, clear pathway must be maintained on all exterior stairs, stairway landings and villa entryways. Potted plants, or other decorative items, may be permitted within a minimum of five feet of the front entry door as long as they do not encroach into the 36-inch-wide pathway.

Rule 2.10.2.D Sound, Visual, and Odor Restrictions: Decks, patios, balconies and porches are not intended for storage. This restriction includes, but is not limited to, refrigerators, freezers, and household furniture. Storage cabinets over three feet in height must have AC approval.

Rule 2.23 Wood Preservation Requirements – Common and Limited Common Area: A. Wood Decks and Railings 1. Potted plants, figurines, or other decorative items are not permitted on wood railings; 2. Potted plants, including those in trays or pots that have holes in either the sides or bottoms, are not to permit water or moisture to reach the wood deck; 3. All items must be supported above the deck flooring in a manner that permits moisture under the item to evaporate; 6. Vine growing plants are not to cling to wood decks, railings or walls; 7. Trees planted in the limited common area shall have sufficient clearance from walls and fences. Trees shall not exceed seven feet in height without AC approval.

Please check around your home to see if any of these rules are being broken and try to correct them before I come by to inspect.

All the information there is publicly accessible by anyone, including the "search bots" that Google, Bing, and other search engines use to troll for new information.

Phone numbers and email addresses, and home addresses for folks like me who are unlisted, is private and can be used to verify credit card purchases among other things. It should always be treated as private.

Even though the Villages itself has a strong privacy policy, my understanding is that the Board feels it has no control over the private websites maintained by clubs. I would urge the Board to reconsider this approach and to require all Board-recognized clubs to follow the Villages communications policy, even on privately-maintained websites, in order to maintain their Board recognition.

### Notice of Proposed Changes to Villages Golf and Country Club Board of Directors' Policies:

At The Villages Golf and Country Club (Club) Board of Directors August 25, 2015, monthly meeting, the following proposed changes to Club Board Policies have been approved for 30-day notice publication in The Villager as required by Club Policy CPo 101, VGCC Policies.

The proposed changes will be considered, as well as oral and written comments from members and residents at the October 13, 2015, study session and considered for formal approval at the October 27, 2015, Board meeting.

Per Policy CPo 101, VGCC Policies, response to the proposed policy changes may be made by one or more of the following methods: 1) Participation in the discussion of the change at the Club Board of Directors study session (October 13, 2015), 2) via-email with comments sent to the Club Board at least seven (7) days prior (no later than October 6, 2015) to the Club Board of Directors study session, or 3) via written comments addressed to the Club Board and delivered to Building A at least seven (7) days prior (no later than October 6, 2015) to the Club Board of Directors study session (October 13, 2015).

As reported at the August study session and monthly meeting the proposed revisions have been compiled from recommendations from both the Ad-Hoc Policy Review Committee and the 2014/2015 Board Policy Committee.

Policy deletions are noted in strikethrough font, additions are underlined, and the purpose of the change is in italics.

## Title: BOARD-APPOINTED COMMITTEESS—Policy Number CPo 201:

Purpose of the proposed changes is to bring more consistency to committee charters and to conform policy to practice and to the Bylaws. There is clarifying language on committee meetings and minutes, how and where appointments are made, term length of associate members, and requirement that committee members be members in good standing.

**OBJECTIVE:** To define the procedures the Board will use in creating committees to advise it in the conduct of its business.

GOVERNING DOCUMENTS / LEGAL REQUIREMENTS: Club Bylaws and Corporation Code §7212

**POLICY:** The Board may establish from time to time committees, consisting of one or more persons, to advise, investigate, or take action on certain matters or subjects. Committees are generally one of three types –

- Standing Committees, which are established to perform assigned functions identified by the Board and which remain in place until dissolved by the Board
- Special (or Ad Hoc) Committees or task forces, which are appointed by the Board as the need arises, to carry out a specified task, at the completion of which the committee automatically ceases to exist.
- Executive Committees, consisting of two or three Directors, which can exercise some of the authority of the Board, subject to the limitations described in Corporation Code §7212 and Article 10 of the Club Bylaws.

**LIMITATIONS:** The limitations on each committee are unique to that committee and are defined in the Committee's Charter.

**IMPLEMENTATION PROCEDURES:** Committee Charters that define the nature, responsibilities, and limitations of each current Standing and Executive Committee are defined below.

In creating a committee, the Board shall approve a Committee Charter, which describes the committee's purpose, its composition, the term of membership, the selection of committee members and of a chairperson, the roles and responsibilities of its members, the frequency of meetings, and the limitation of the committee's authority. A standing or special committee does not have any of the authority of the Board to carry out actions; an executive committee can exercise the authority of the Board, subject to the limitations in Corporation Code §7212, Article 10 of the Club Bylaws, and the limitations defined in the committee's charter.

The charter of all committees shall be included in the Minutes of the Board meeting at which the committee is created. The charters of Standing and Executive Committees will be included in the Club's Policy and Procedures manual at its annual update. The charter of special committees need not appear in this manual upless it is expected that the committee will be in existence for more than one year.

Club Board Members and Committee Members are encouraged to solicit applicants through advertising in The Villager and through personal contact.

Each potential committee member shall fill out an application form that is obtained from the General Manager's Office or Board Members. The completed application is to be returned to the General Manager's Office. Applications shall be given to the appropriate committees for review prior to Board review and approval. The secretary or administration staff shall forward all applications to Club Board Directors for review at least two weeks prior to the Club Board's consideration for approval.

(CPo 201 continued)

The Board, at its discretion, may interview candidates for appointment to <u>new or existing</u> committee vacancies. The Board shall consider volunteer applications and <u>shall</u> make appointments at an Executive Session of the CBOD. <u>Members of committees</u>, whether voting or associate members, shall be members in good <u>standing</u>. Associate members of a committee will have the same term length as the voting member term of each committee.

Since all committees and committee members serve at the pleasure of the Board, the committee may be dissolved or any of its members removed by a majority vote of the Directors at a Board meeting in which a quorum is present.

Committee meetings (except for Nominating and Disciplinary Appeal) are open to members. Dates, times and locations of committee meetings will be made available in the VGCC media. Minutes will be taken and made available to members upon request.

## Title: RELATIONSHIP BETWEEN BOARD AND COMMITTEES—Policy Number CPo 202:

Purpose of the proposed changes: conformity to Bylaws and to conform policy to practice.

**OBJECTIVE:** To provide guidelines for the relationship between the Club Board and Committees

**GOVERNING DOCUMENTS / LEGAL REQUIREMENTS:** Corporation Code §7212.

**POLICY:** Board committees are appointed by the Board to act in an advisory capacity to the Board. As the elected representatives of the community, the Board cannot and does not empower any committee with a governing authority except as permitted by Corporation Code, Section 7212. Committees cannot give instructions directly to employees of the community or commit the VGCC to any expenditure, action, or contract. The Architectural Committee (AC) and Nominating Committees is are the only committees with authority as defined in the Club Bylaws.

The formal relationship is documented by a Committee Charter, which is included within each CPo 200 series Board Policy. The charter provides basic definition of the purpose and desired relationship of the committee, the Board, and Staff. Where applicable, the President, with the approval of the Board, shall appoint a Liaison to each Standing Committee and each Ad Hoc committee.

Unless specified in the Committee Charter, committees cannot request staff support without prior Board or General Manager approval.

**BOARD LIAISON:** The role of the Board Liaison is to act as a conduit between the assigned committee and the Club Board. The Liaison is not a member of the committee and does not participate in the determination of the Committee's agenda or work program, but rather is there to inform the Committee of the Board's Policies, when necessary, and to relay back to the Board any issues of concern.

**COMMUNICATIONS:** A) At least these formal methods shall be used by all committees:

- Copies of all minutes shall be given to the Board through the General Manager's office. The copies shall be distributed to the General Manager, the Liaison, and to the Board.
- A written annual or final report summarizing the accomplishments of the committee shall be submitted to the Board through the General Manager's office.
- Recommendations/requests should be submitted in writing by the chair or a member of the Committee to the Board through the General Manager's office. Such documents should clearly state what is proposed and include all arguments pro and con that were considered by the committee. Brevity is preferred but not at the expense of omitting essential information. Committees should not use notations within their minutes as their only means of communicating recommendations.
  - · Presentation to the Board by invitation.
  - Follow interface protocol with other committees if so indicated in the charter.
     B) Informal communication may include:
  - Discussion with and participation by the Liaison.
- Attendance of chairman or members of the committee at any study session.
   C) Any proposed projects under consideration by the Committee should be

submitted in writing to the Club Board for approval prior to embarking on a project. The written submittal shall be prepared by the Committee Chair or designee.

<u>Composition:</u> <u>Voting Members:</u> Five <u>to seven (5-7)</u> resident <u>owners members</u> <u>in good standing</u> appointed by the Board of Directors.

Non-Voting Members: The number of associate members shall be determined by the committee with approval of the Board. Associate members can actively participate in committee discussions but do not have a vote.

Board Liaison (non-voting)

Staff Support: General Manager or his designee (non-voting)

<u>Terms:</u> Each Appointee shall serve two-year staggered terms, from January 1 through December 31. There is no term limit for members. Reappointment is possible subject to a two term limit. There must be a one year break in service after two consecutive terms before reappointment. A replacement appointee will complete the term of the resident being replaced.

Chairman: Selected by committee.

#### Responsibilities:

- 1. To review annually all existing Villages Golf and Country Club (VGCC) rules.
- 2. To ensure that Club Rules are consistent with Club Policies and Bylaws.
- 3. To conduct public hearings as defined in The VGCC Rules.
- 4. To implement the procedures outlined in The VGCC Rules.

## Title: FINANCE AND RESERVE PORTFOLIO ADVISORY COMMITTEE—CPo 205:

Purpose of the proposed changes: to merge the objective and responsibilities of the Reserve Portfolio Review and Advisory Committee into the Finance Advisory Committee so that there will only be one combined committee to be called the Finance and Reserve Portfolio Advisory Committee. Additionally, to bring more consistency to committee charters in terms of number of voting members, associates, and number of terms.

**OBJECTIVE:** The purpose of the Finance <u>and Reserve Portfolio</u> Advisory Committee is to advise the Club Board (Board) of Directors on all matters of financial importance which the Board deems necessary <u>and to provide guidance for managing and investing the Club's Reserve Funds.</u>

GOVERNING DOCUMENTS / LEGAL REQUIREMENTS: None. Club Bylaws. POLICY: The Board shall appoint a standing Finance Advisory Committee having the Charter described in Club Procedure Number CPr 205.

LIMITATIONS: See Club Procedure Number CPr 205.

**IMPLEMENTATION PROCEDURES:** See Club Procedure Number CPr 205.

#### Finance and Reserve Portfolio Advisory Committee Charter

<u>Committee:</u> Finance <u>and Reserve Portfolio</u> Advisory Committee, a standing committee.

Responsible to: Club Board of Directors

**Composition:** <u>Voting Members:</u> <u>Up to five Five to seven</u>  $(5\underline{-7})$  <u>owner</u> resident <u>members owners in good standing</u> appointed by the Club Board of Directors (Board).

Non-Voting Members: The number of associate members shall be determined by the committee with the approval of the Board. Associate members can actively participate in committee discussions, but do not have a vote;

Treasurer and Assistant Treasurer, if applicable, shall serve as liaisons to the committee;

General Manager;

Controller.

Objective: To advise the Board regarding financial matters.

<u>Staff Support:</u> Director of Finance <u>VGCC Chief Financial Officer</u> and the Administration staff.

**Member Term:** Three-year terms with staggered appointments, January 1 through December 31. limited to three terms for a total of nine years. Reappointment is possible subject to a two term limit for a total of six years. There must be a one year break in service after two consecutive terms before reappointment. A replacement member shall complete the term of the member being replaced.

<u>Officers:</u> The committee shall elect from the owner resident members a chair and other officers as necessary.

<u>Subcommittees:</u> The committee may appoint subcommittees as necessary. <u>Meetings:</u> The committee shall meet at least monthly and whenever else it is necessary to fulfill its responsibilities.

#### Responsibilities:

- Collaborate with Management in the annual budget preparation process. Review and analyze the proposed annual operating budgets and replacement reserve plans noting areas requiring Board attention.

1) Gift <u>Certificates Cards</u> – Gift <u>Certificates Cards</u> awarded by recognized member golf clubs shall be <u>exclusively</u> purchased from <u>and for redemption at either</u> The Villages Golf Pro Shop <u>or The Villages Clubhouse and can be used at either location</u>.







**Saturday, September 5:** John Trudeau (949-887-6524) will lead a hike in the Sierra Azul Open Space Preserve near Lexington Reservoir and Los Gatos. We will take the Limekiln Trail from Alma Bridge Road to Priest Rock and return via the Priest Rock trail for a distance of 7.8 miles round trip and about 1100 feet elevation gain. Although the beginning of the trail is shaded, most of it is exposed. The Sierra Azul OSP has the beauty and ruggedness of an unspoiled wilderness. There are great views of serpentine grasslands, hard, rocky, and steep chaparral, dense stands of bay trees, or quiet, shaded oak woodland forests. Travel is 25 miles each way; there is a restroom at a park along Alma Bridge Road.

**Wednesday, September 9 (Rambler):** Amy Meier 408-799-4274 and Susan Brown 408-531-9750 will lead a hike from Forbes Mill Museum at Church Street in Los Gatos along the southern end of Los Gatos Creek Trail about 1.25 miles out and 1.25 miles back, with under 400 ft. elevation, then across Main Street to Andale Restaurant. After lunch each car can decide to hike further, go home or do some shopping in downtown Los Gatos. We will meet at Cribari at 8:45 a.m., leave at 9 a.m. This is about a 44-mile round trip. Then it's off to the Swedenborgian Church where we will have a private tour led by John Gaul. This remarkable church was designed by Bernard Maybeck in 1895. John dresses for the occasion in period costume of the 1890s.

At 12 p.m. we will go to the Presidio where we will enjoy lunch at the Presidio Café. ### Your DMV cheat sheet

Do you want to study DMV written exams before you take the test? Sample exams are available to you on the Internet at www.dmv.ca.gov. Under the driver license tab menu you will find "written test". There are five sample tests. As you complete the exams online, you are immediately corrected if you make a mistake. Or you may print the questions and answers. If you do not have a computer, ask a neighbor or friend or grandchild to print the questions and answers for you.

If you need the current Driver Handbook, you may download or print one from the Internet site or you may order one by phone at 1-800-777-0133. On the telephone tree you will select "Order Forms", followed by "Other Form", and then "Driver Handbook". The Handbook will arrive in the mail in about two weeks.

Want more test practice? We have heard favorable comments about the site www.dmv-written-test.com. There are 15 tests available. At this site under Frequently Asked Questions there is a California DMV Cheat Sheet. It is suggested you print the four-page cheat sheet to read while you are waiting for your test appointment.

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday and Friday from 10 a.m. to noon. The SRS office is located in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253. 

Note: Kaiser Members will be charged for shots administered at the clinic.



"A Full Life: Reflections at 90" by Jimmy Carter: At 90, Jimmy Carter writes about racism during his boyhood and the isolation of the Carters during the civil rights struggle and the profound influence his mother had on him. He tells us what made him proud and what he would have done differently, his regret about losing his reelection and how he and Rosalyn made a rewarding new life. Jimmy Carter has lived one of our great American lives and was arguably the most successful and popular ex-presidents to date. Nonfiction, biography, 920, 2015, large print.

"Under Fire" by Grant Blackwood: (under the banner of Tom Clancy). Tom Clancy died some time ago but his characters live on. Jack Ryan is on an intelligence gathering mission in Tehran. An old friend, Seth, an engineer with an oil company, slips him a key and a perplexing message, then disappears together with funds for a vital intelligence mission. (How did a petroleum engineer working for an oil company have access to these secret CIA funds?) Jack sets out to uncover the truth racing across Iran, through the war-torn Caucasus and deep into territory coveted by the Russians. Read the book and find out if this thriller equals some of the earlier novels written by Tom C. himself. Fiction 2015, large and regular print.

"Piranha" by Clive Cussler and Boyd Morrison: After many thrillers Clive may be tired of writing at least one book a year and has acquired a helper to continue the dastardly deeds described in the Oregon files. In 1902 the eruption of Mount Pelee on Martinique sinks the ship carrying a German scientist on the verge of an astonishing breakthrough. It's up to Juan Cabrillo and his crew of the Oregon to discover his secret, but an unknown adversary tracks and tries to assassinate them. Thus they fake the sinking of the Oregon and discover that a traitorous American weapons designer has completed the German's work and now wields great power. Does this sound fantastic? Not in the world of Clive Cussler and his co-writers. Fiction, 2014, large print.

"The Rocks" by Peter Nicholls: A double love story propelled by a 60-year-old secret that has shaped two families, four lovers and one seaside community. You can't go wrong with this novel, especially since it is set in Mallorca, the pearl of the Mediterranean sea. The characters are complicated and louche. They drink, eat, dance and misbehave beside the sea, yet their lives are bittersweet, intelligent and romantic. The characters are British and so is the author. This should be fun reading. Mystery 2015.

"Hot Pursuit" by Stuart Woods: Stone Barrington is back. It is not often that Stone finds a woman as accustomed to the jet set lifestyle as he is, so he is pleasantly surprised when he meets a gorgeous pilot, who is soon moving to New York, thus available for closer acquaintance. But there is an unstable, criminal ex-boyfriend pursuing them as well as several enemy operatives. Mystery 2015.

## John Podesta interviews George Soros

Can the war on terror be won? Who is the enemy? Is global cooperation in inevitable decline, or can it be rebuilt? In September 2006, international financier, Holocaust survivor, philanthropist, philosopher and author George Soros discussed these issues and his book, "The Age of Fallibility: The Consequences of the War on Terror" with John D. Podeseta, President and CEO of the Center for American Progress, former chief of staff to President Clinton and adviser to President Obama, and currently head of Hillary Clinton's presidential campaign.

George Soros was born in Hungary in 1930 to nonobservant Jewish parents. After the war he emigrated and began studying at the London School of Economics. He was a student of the philosopher Karl Popper and received BS and PhD degrees in philosophy and started his financial career at a merchant bank. He has become one of the 30 richest people in the world. He is a well-known supporter of progressive-liberal political causes, making him the target of right wing attacks. Between 1979 and 2011 Soros donated more than \$8 billion to various philanthropic causes. He created the Open Society Foundation to help former Soviet republics become democracies.

He is also the author of several books and although the interview about this book is nine years old, the topics discussed remain relevant today.





Slit-seeding has begun on the course to help repair the weak areas that developed while the pumps were down. We have been slit-seeding with Ryegrass and experimenting with some Bermuda grass in a few areas. The front nine has been worked on first and ropes and stakes were put out to direct traffic in different directions. Back nine will commence when filling of the current front nine locations are recovering well. Greens are getting rolled five to six days a week and will continue throughout the year. Some verticutting will be done mainly on the greens and the collars to achieved better playing conditions once weather permits.



## Polystyrene and Styrofoam

Cups, plates, egg cartons, foam packaging, meat and fruit trays, packing peanuts (tied securely in a plastic bag), take out and food containers, etc.

#### All Of The Above Are Not Recyclable.

These items are considered garbage and must be placed in the garbage bin.

## Plastic—Recycle container \*No plastic bags may be placed in the recycle container. Clear plastic bags may be used only to

hold shredded paper or textiles (for easier recycling purposes).

Plastic items labeled 1-7 inside chasing arrows, baby wipe containers, beverage bottles, bleach and detergent bottles, buckets (remove handle), flower pots, food containers (i.e. cottage cheese and margarine tubs, yogurt cups), household cleaner bottles, prescription bottles, shampoo bottles, plastic take out and food containers and compact disc cases. All items must be empty and rinsed.



Strategy: South needs to develop 3 more Diamond tricks and be very careful not to let West in the lead to run his Spades and defeat the contract.

West leads the 7 of Spades, South wins with the 9, follows with a low Diamond to the KIng on the board, finesses the Jack of Diamonds. East is expected to have the Queen since West is the preemptive bidder with the long Spade suit and most, if not all, of his points should be in Spades. Wow! it works. East has the Queen and ducks. South follows with another Diamond, East, the Queen, and South takes the trick with the Ace, plays the last Diamond, then a Club to the Ace on the board, switches to the Ace of Hearts and then leads a low Club to the King in his hand. He now leads the Jack of Hearts, East takes the trick with the King, plays a Spade, and West takes the rest of the tricks. South is still happy as he has made his contract.


\* This is a preemptive bid showing 7 cards in a suit with 6 -10 HCP. His points should mostly be in the long suit.

^ South has a stopper in the Spade suit and doesn't really have a good long suit and decides that 3 NoTrump would probably make the easiest game. By the way 3 Spades goes down 1 trick. Also if West initially leads the Ace and King of Spades, his partner can never get to his hand and it makes the contract, 3 NoTrump, easier to make.






