## FROM THE CLUB BOARD

### *The 25 mph speed limit and the “three strikes, you’re locked out” remedy*

Last month, the Club Board Disciplinary Appeals Committee heard two cases that have not come up in many years—residents who have accrued three tickets (usually speeding over 35 mph) against their residence number. One resident picked up three tickets in less than 6 months. The board finds this unacceptable behavior.

The Villages rules and by-laws regarding multiple infractions (Rule 1.02.1.J.3 and by-law 8.1.4) are quite clear and unyielding: “Third and subsequent violations—\$75 assessment and 30-day suspension of the right to use Club properties for the member and all occupants of the member’s residence.” These violations are not just limited to speeding, but any ticket such as failure to stop at a stop sign, use of a cell phone in a moving vehicle, etc. Tickets stay in your resident file forever but only the most recent two years are considered for the purpose of this rule.

The Club Board is strongly united in keeping our Villages streets safe for everyone. This especially involves speeding. Rather than put up more unsightly speed limit signs or add more speed bumps, we have chosen to step up enforcement by Public Safety. Remember, the maximum speed limit in the Villages is 25 mph, and lower in sections of Cribari and the Heights/Hermosa. If you go 26 mph, YOU ARE BREAKING THE RULE and are subject to being ticketed by Public Safety.

There is a rumor floating around—almost an urban myth at this point—that you can drive up to 34 mph in the Villages and get only a warning. DON’T BELIEVE THIS. The officer has some limited discretion in issuing you a warning rather than a \$30 ticket, but do not rely on this. Also, remember that our officer now wears a body camera so if you get pulled over, be civil.

Two other things to remember about citations: First, tickets are on file as a residence number. This means there could be more than one owner-driver. Second, Rule 1.71 (Enforcement) clearly states “A resident is responsible for the actions of his or her guests, employees, and any vendors performing services for the resident. In the event of a violation by any of the aforementioned parties, the sponsoring resident is held responsible. If the responsible resident is not a Member, the Owner (Member) of the Unit or Lot in which the resident resides is held responsible. Discipline imposed on a Member is applicable to all occupants of the Member’s Unit or Lot.”

So educate those that visit you here at the Villages on our traffic rules because you are financially responsible for them. Finally, if there is a silver lining in any of this, Villages traffic citations do not go to the California DMV and therefore into your driving record, affecting your insurance rates.

The temperatures will vary due to the sun and the time of day.


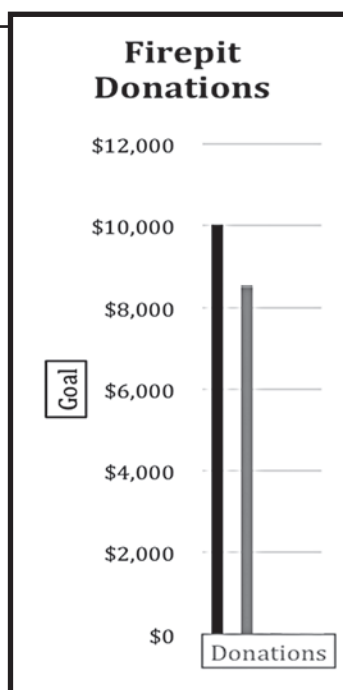

### “El Niño” and Turf Conversion

Hopefully, the current California drought will end soon and the current mandatory watering restrictions, which have turned portions of our lawns brown, will be lifted. The predicted (but not certain) “El Niño” weather pattern may be the beginning of the end of the drought. Once watering restrictions are lifted, we can go back to watering “as usual” and go back to having nice green lawns during the warm summer months.

But ... wait ... the drought may soon be over, and what will happen to our water bills if we go back to watering the same lawn areas again? Our lawns use more water than any other potable (personal use) water use in The Villages. Put quite simply: lawns are The Villages Association’s largest single water expense, costing us hundreds of thousands of dollars each year. If we don’t continue looking for opportunities to reduce the amount of lawn areas we have, water cost increases likely take their toll. Did you know that since 2012, our potable water rates for landscape have gone up by over 50%.

Do you think the City of San Jose will lower water rates when the drought is over? If one assumes that our water rates will not be significantly reduced when the drought is over, then we will see large increases in our water bills as we go back to watering our lawns in the pre-drought “no restrictions” manner.

The best way to lower our potable water use and to lower our long term water expense is to support Turf Conversion in your District. Turf Conversion replaces existing lawn areas with drought tolerant plants, thereby greatly reducing the water needed in those areas and the cost of watering them. The Santa Clara Valley Water District is offering significant rebates because of the drought. How likely is it that these rebates will still be available to us if our drought ends?

## TALKING TURF

### Talking Turf from ValleyCrest

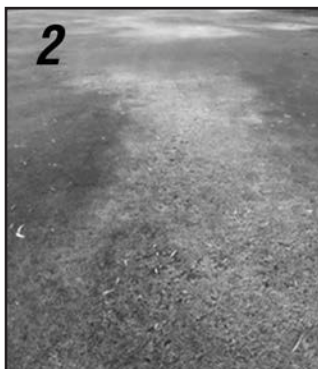
A quick reminder of the Aerification Schedule for the fall. The front 9 greens will be aerated on Monday, September 21, with the back nine open for play. On September 22 the entire course will be closed as we aerate the B9 and finish up any work on the front. Finally, on the 23rd, the short nine will be closed to complete the aerification process. Greens are healthy and have come out of the summer in great shape. Since the greens are healthy and strong we can expect a quick healing process after the aerification. Greens have been rolled an average of five days a week for the past month and this process will continue.

The month of October is when we begin the fairway aerification process. We will also seed the weak areas to make sure we have full turf coverage. Many of these areas have Bermuda grass beginning to grow and the extra fertilizing and hand watering will allow the Bermuda to fill in. If you look closely at the weak spots in the fairways you will see the healthy turf is growing in a circle. Irrigation pressure is the reason we see these circles. (See picture 1) The areas outside the circle would have had a high population of Poa Anna (a cool season grass) growing in them. When the heat of summer arrives the Poa will die and Bermuda will start to fill in. (See picture 2) This usually is a slow process over the summer and many times goes unnoticed. The pump station issues we experienced at the end of July sped up the turf decline. Over the past month we have increased our use of wetting agents to help hold water in these areas, and have been spot-fertilizing to help these areas fill in. Tom and Beto have also been working hard on making sure sprinklers that are out in the field matches what is in the irrigation computer program. We have also been replacing the sprinkler internals so that all the sprinklers of a station are the same. (See picture 3) Many of the areas we are seeing did not match in the computer and had different sprinklers models. Making these changes will improve our pressure issues.

We are still waiting for Pump #3 to be replaced, but Pump #1 and #2 are working properly. Pump #3 should be installed some time this month.

I hope everyone enjoyed the Mixed Couples event on Labor Day weekend. For that event we brought in some staff to give the fairways an extra mowing. We have also started to sweep the clippings on the driving range after we mow to improve the first impression many of you and your guests have of the course each day.

## PUBLIC SAFETY

### May outsiders come to The Villages’ Clubhouse, Restaurant or Bistro?

Recently I was asked if “can anyone come into The Villages to eat at the Clubhouse, restaurant or bistro?” The answer is no, they cannot.

Any of the local Country Clubs who have a reciprocity agreement with The Villages may enter after showing ID. But simply pulling up to the gate and saying “I’d like to eat at the Clubhouse, restaurant or bistro,” won’t get you in. Of course, there are outside banquets that take place from time to time at the Clubhouse; however, those guests will need to be listed and approved.

Your Public Safety Officers know how important safety is to Villagers, and as such, only authorized people are allowed access to our community. If someone who is not authorized wants to patronize one of our eating establishments, they must be either 1) a guest of a resident, 2) attending a sponsored event at the Clubhouse, or 3) a member of one of the outside country clubs with which we maintain a reciprocal agreement.

#### **Title: OWNER APPEAL HEARINGS—Policy Number APo 104**

**OBJECTIVE:** Define a procedure and protocol for the orderly conduct of appeal hearings when such a request is made by an owner.

**GOVERNING DOCUMENTS / LEGAL REQUIREMENTS:** Association Governing Documents (Articles 10, 11 of the CC&Rs) and California Corporation Code Sections 4920, 4935, 5000.

**POLICY:** Appeal hearings are classified into two types:

Disciplinary Appeals - appeals to governing document violation decisions such as the CC&Rs and Rules that result in disciplinary action, and

Non-disciplinary Appeals – appeals from ~~to~~ owners requesting for special consideration relating exceptions to the following: 1) Architectural Committee AC application denials/cisions, 2) and management decisions-/enforcement, 3) rental restrictions, or 4) matters. requests or appeals the owners deem sensitive in nature.

The Board shall conduct appeal hearings when requested by owners on the above types of appeals per Association Procedures APr 104-01 and APr 104-02.

**LIMITATIONS:** None.

**IMPLEMENTATION PROCEDURES:** See Association Procedure Numbers APr 104-01 and APr 104-02; and Apo 109 for the Internal Dispute Resolution Process Policy.

#### **Title: APPEAL HEARINGS—Appeal Hearings—Procedure Number APr 104-01**

##### **Disciplinary Appeals**

1. Owner requests for a meeting before the Board shall be submitted in writing to the Board or General Manager, and shall include a brief statement of the matter to be considered and the justification(s) for Board review.

- If a request is made by a group of individuals, the group shall designate a spokesperson to submit the request and represent the group. The Board will address its reply and any following correspondence to the designated spokesperson only.

- The Board shall suspend the levy of discipline until the hearing meeting. The individual may bring up to three witnesses and/or representatives to the meeting to support the individual's position.

2. The Board reserves the right to determine, at its sole discretion, when a meeting before the Board will be scheduled following receipt of a written request for meeting.

- The Board may, at its sole discretion, reject a request for a meeting if it determines that the request does not meet existing Association policies and rules.

- The requesting individual shall be notified in writing of the Board's decision to either schedule or reject a meeting by either personal delivery or first-class mail, no later than ten (10) working days following receipt of the individual's request. The reason for the rejection shall be stated in the response.

- If the Board decides to schedule a meeting, the notice shall include the date, time and location of the meeting.

- An owner notified of a board meeting shall be granted one postponement request to accommodate his/her schedule.

3. Disciplinary hearings shall be in executive session if the owner so requests

- Only the requesting owner and/or those persons designated by the owner to provide evidence will be permitted to address the Board.

- An owner must advise the Board no later than 10 days prior to the hearing date of his/her intent to be represented by legal counsel. At its discretion, the Board may choose to not conduct the hearing if legal counsel for the owner is

present and counsel for the Board is not present.

- The Board, at its sole discretion, may allow other interested parties (i.e., an advisory committee or AC representative, the General Manager, or other management staff, etc.) to attend and present information pertinent to the matter under consideration.

4. When applicable, all written materials, drawings, photographs, evidence, etc. to be presented at the meeting by the requesting individual(s) shall be provided to the General Manager no later than ten (10) working days prior to the scheduled meeting date. The General Manager shall provide copies of the materials to the Board and any invited interested parties.

- Only materials provided to the parties in advance of the meeting as required above will be considered at the hearing.

5. The Appeal Hearing Meeting Procedure is as follows: (The Chair may extend the indicated time limits upon approval of the Board.)

- Open the Hearing

- The Chair opens the hearing and explains the procedure that will be used.

- Association Presents its Case - 5 minutes

- Explanation of the evidence on which the Association relied in alleging that a violation took place including the history of the dispute, factors influencing the decision, applicable governing documents, findings that must be made as part of the decision, factual and legal issues, written documentation supporting or opposing the appealed subject.

- Alleged Violator's Defense - 5 minutes

- Explanation of the evidence supporting the alleged violator's position including anyone who can speak in support of the alleged violator's position.

- Board Questions - no time limit

- The Chair entertains questions from Board members.

- Association's Rebuttal - 2 minutes

- Respond to points made by the alleged violator.

- Alleged Violator's rebuttal-2 minutes

- Respond to points made by Association.

- Close the Hearing

- The Chair formally closes the hearing.

- Board Deliberations and Decision

- Deliberation may be conducted in the presence of the alleged violator. The Board's decision is final.

- Confirming Letter and Hearing Minutes

- The decision must be communicated to the alleged individual(s) in writing within ten (10) working days following the hearing. The decision must be documented in the Hearing Meeting minutes.

##### **Sample Board Checklist for Disciplinary Hearings**

- Determine whether there has been a violation or infraction of the governing documents (i.e., CC&Rs, Bylaws or Rules).

- Determine whether there is sufficient evidence (i.e. witnesses and/or documents) to sustain an enforcement proceeding.

- Determine the status of the alleged violator (i.e. member, qualified resident, invited guest/visitor of a member or qualified resident, employee, contractor, etc.) and whether there is a responsible owner to be noticed.

- Determine whether there is authority in the governing documents to make and enforce the rule. (*This should have been done at the time of enactment.*)

- Determine whether the rule is reasonably related to the purposes it is intended to achieve. (*This should have been done at the time of enactment.*)

- Determine whether the violator and responsible member have received proper notice of the rule and related penalties in advance of the violation.

- Determine whether the violator and responsible member have received prior enforcement notices.

- Determine whether there are any defenses to enforcement, such as lack of notice, waiver, selective enforcement, illegality, etc.

- Give adequate notice of a hearing pursuant to Appeal Hearing Meeting Procedure.

- Conduct the hearing in accordance with the Appeal Hearing Meeting Procedure. Give limited weight to hearsay, particularly uncorroborated or inherently untrustworthy third party statements.

- Give the alleged violator a full and fair opportunity to be heard and present evidence in his/her behalf, upholding the dignity of the alleged violator.

- Render a prompt decision based upon the evidence. The decision should be a simple, concise statement of ultimate decision.

- When applicable, commence and carry out enforcement without delay.

### Non-disciplinary Appeals

1. Owner requests for a meeting before the Board shall be submitted in writing to the Board or the General Manager, and shall include a brief statement of the matter to be considered and the justification(s) for Board review.

- If a request is made by a group of individuals, the group shall designate a spokesperson to submit the request and represent the group. The Board will address its reply and any following correspondence to the designated spokesperson only.

- Requests to appeal a decision by the AC will not be considered unless the AC has first heard and denied the owner's appeal. Individuals must submit a request for appeal to the Board within 60 days of the date the AC renders its appeal decision.

2. The Board reserves the right to determine, at its sole discretion, when a meeting before the Board will be scheduled following receipt of a written request for a meeting.

The Board may, at its sole discretion, reject a request for a meeting if it determines that the request is without merit or does not adhere to or comply with existing Association policies and rules.

- The requesting individual shall be notified in writing of the Board's decision to either schedule or reject a meeting by either personal delivery or first-class mail, no later than ten (10) working days following receipt of the individual's request. The reason for the rejection shall be stated in the response.

- If the Board decides to schedule a meeting, the notice shall include the date, time, and location of the meeting.

- An owner notified of a Board meeting shall be granted one postponement request to accommodate his/her schedule.

3. Non-disciplinary matters, requests or appeals to the Board hearings shall be conducted in executive open session. If the owner does not want to appeal to the Board in open session, the owner may request a meeting with an Executive Committee of the Board in a closed session to present their matter, request or appeal. If the owner so requests or if the Board so determines on its own initiative, The Executive Committee will then make a recommendation to the Board of Directors.

- Appellant's Presentation - 5 minutes
- Explanation of the evidence supporting the appellant's appeal including anyone who can speak in support of the appellant's position.

- Board Questions - no time limit
- The Chair entertains questions from Board members.

- Committee/Management Rebuttal – two minutes
- Respond to points made by the alleged violator.

- Appellant's Rebuttal - two minutes
- Respond to points made by Committee/Management.

- Close the Hearing
- The Chair formally closes the hearing.

- Board Deliberations and Decision
- Deliberation may be conducted in the presence of the appellant. The Board's decision is final.

#### **1.14 GOLF FACILITIES**

##### **1. General Rules**

H. Competitive prizes: Gift Certificates Cards and Sweeps

1) Gift Certificates Cards – Gift Certificates Cards awarded by recognized member golf clubs shall be ~~exclusively purchased from and for redemption at either The Villages Golf Pro Shop or The Villages Clubhouse and can be used at either location.~~

2) ~~Sweep Credits Sweeps Awards~~ – ~~Sweep Credits Sweeps Awards~~ awarded by recognized member golf clubs shall be exclusively purchased from and for redemption at The Villages Golf Pro Shop and may also be used for range balls, cart rental and lessons. However, Sweeps Awards expire at the end of the year in which they are awarded. Unexpired Sweeps Awards may, at any time, be converted in The Villages Golf Pro Shop to Gift Cards. These Gift Cards can then be used at either The Villages Golf Pro Shop or The Villages Clubhouse. The conversion of unexpired Sweeps Awards to Gift Cards prevents the expiration of their value.

Note: The remainder of 1.14.1.H. "Exceptions to the rule..." is unchanged.

**Rule 1.18 Table Tennis, 1.** – *the purpose of the change is to reflect the fact that the table tennis equipment has been moved to the Montgomery Center multi-purpose room.*

**How does the VMA use your money?**

Many of the VMA services are provided by volunteers who give their time to assist Villagers by staffing the VMA office, delivering and picking up medical equipment, taking those in need to medical appointments, the pharmacy and grocery store and delivering an occasional meal from the Bistro or Clubhouse restaurants. VMA volunteers also organize and staff health-based events, i.e., the June "We Care" Health Festival.

However, as we age, our needs go beyond the services volunteers are able to provide. Professional assistance is needed from simple information and referral, to long-term comprehensive care planning and coordination. This is where having a full-time professional services coordinator comes in. The coordinator is an advocate, counselor, educator and support person. Through one-on-one interactions with residents and your family members, the coordinator assesses needs for service, develops a care plan, coordinates services and provides ongoing monitoring.

The VMA maintains an office open Monday through Friday 9 a.m. to 3 p.m. where you'll find a medical library and other informational materials. Medical equipment is purchased and loaned free to Villagers. Working with the services coordinator, educational programs and support groups are offered free to all Villagers.

The VMA does not receive funding from Villager assessments, therefore, fundraising events and the donations from events of clubs and organizations are a major part of the VMA's income. The other includes donations from Villagers and your families, through memorials, contributions at the annual fund drive and continuous giving through homeowners' bills. The VMA budget to provide the services currently offered free to all Villagers is \$100,000 a year.

It's a struggle to make our budget each year, but the VMA is working to keep the programs we have in place and we appreciate the efforts of our volunteers and financial contributors enabling us to provide our current services.

Whether it's a fundraising or pledge-seeking campaign, projects are chosen by EVF based on our internal priorities of health, safety, education and conservation. All projects need to be strongly supported financially and emotionally by the key promoters and based on sincere efforts to improve our community. Once any campaign has been completed, the Foundation may add an additional donation from our general funds, but there is no guarantee that we'll do so.

When the campaign is complete, the sponsoring group—not the Foundation—will present their project for approval to the VGCC Board and assist during the many phases of the political process.

Here is some additional and significant Foundation information for our residents to keep in mind:

1. Our first and foremost responsibility is to our residents and the community as a whole.
2. As an IRS-approved 501(c) (3) Non-Profit we are a totally independent organization and do not report to any of the Villages Boards or to management.
3. We will not show any favoritism to any club or other organization.

**Oh Congress, not again!**

It is that time of year again. If you are age 70 ½ you need to plan to take all of your traditional IRA Required Minimum Distribution (RMD) by the end of the year. And yet again, no one is sure about the tax law for RMD distributions to charity in 2015.

Since 2006 there has been an on-again-off-again tax law that permits taxpayers to transfer part or all of their RMD directly from their IRA account to the charity of their choice. Doing this avoids income tax on the amount that goes to charity. Many Villagers have used this law for their charitable gifts.

Last year SRS warned Villagers the charity law was no longer in effect for 2014. We suggested you might delay taking your 2014 RMD until you knew the law was reinstated. An alternative suggestion was to go ahead and have your IRA custodian transfer money or other assets directly to a charity. Then, if the gifting rule was revived retroactive to January, your distribution would qualify. If the law was not extended, you would have a taxable IRA withdrawal and a tax-deductible charitable gift as an itemized deduction.

What happened in 2014? On December 19, 2014, Congress reinstated the RMD to charity law retroactive to January 1, for the 2014 tax year. However, in December last year did Congress think about 2015? No, of course not. So here we are again wondering if the law for IRA RMD charity contributions will be extended for 2015. We again recommend you go ahead and make your transfer to charity and hope this favorable law will be extended.

Your IRA statement(s) should show your RMD for 2015. Note that if you have more than one IRA account, you can take your distribution from any account—as long as the total distributions equal your total RMD.

If you wish to check your RMD calculation, SRS has a brochure to help guide you through your RMD calculation. Please stop by the office for your free copy.

## Senior Academy: Apollo moon landing lecture

The accompanying picture is one that is familiar to all of us when 69 years ago when astronauts Neil Armstrong and Buzz Aldrin landed their Lunar Module and walked for the first time on the surface of the moon.



The Senior Academy's new lecture, "The Apollo Mission to the Moon," on September 28 from 2 to 4 p.m. at Foothill Center, will help you relive the entire spaceflight program. Carried out by the National Aeronautics and Space Administration (NASA), Apollo was dedicated to President John F. Kennedy's national goal of "landing a man on the Moon and returning him safely to the Earth" by the end of the 1960s, which he proposed in a May 25, 1961 address to the U.S. Congress.

Our speaker, Ed Ferner, has firsthand knowledge of the entire mission. As a Field Service Department training instructor for Gruman Aircraft Engineering Corporation assigned to the Lunar Excursion Module Program, his specialty was the Environmental Control System in the spacecraft. His slideshow will include photos from all the major events of the flight, including the action of the boosters, command and service modules, as well as the lunar module and the return flight back to Earth.

My apologies, serious book readers, nothing but mysteries, thrillers and romances this week.

**“Solitude Creek” by Jeffery Deaver:** Panic ensues when somebody shouts “Fire” during a concert on the Monterey peninsula. Several people get trampled to death when several exits are blocked. There was no fire. Kathryn Dance, a brilliant California bureau of investigation agent and body language expert, discovers the stampede was caused intentionally and that the perpetrator, intent on using people’s fear as a weapon may plan more similar attacks. ## Senior Academy: Latin American History, ‘The Colonial Period’

The Senior Academy will offer an Osher course on Latin American History, “The Colonial Period, 1500-1800.”

Bob Senkewicz, a dynamic and popular history professor at Santa Clara University, will teach about the progress of Central and South American colonial society, after the Spanish arrived. 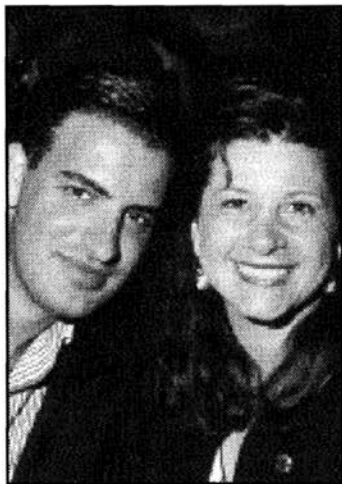

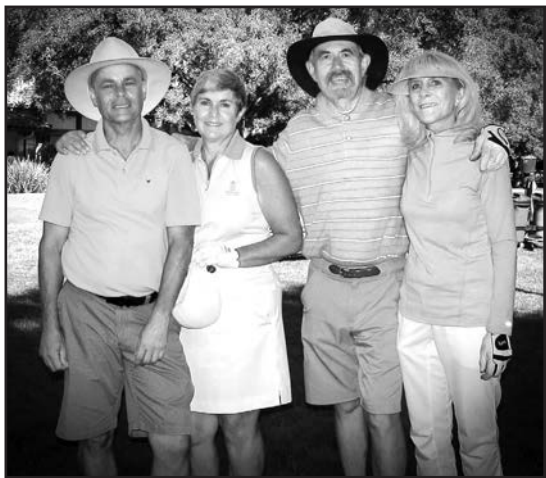

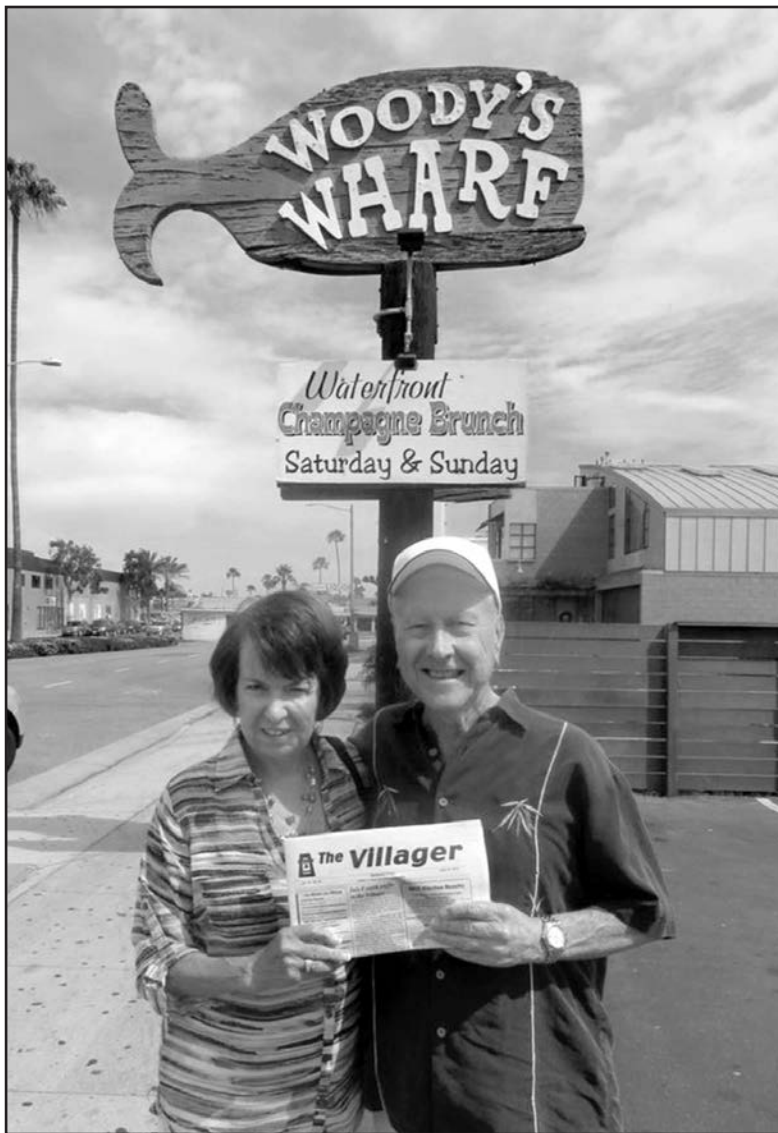
Strategy: Try to set up Diamonds and cross ruff the other suits.

West leads the 10 of Clubs, South, the Queen on the board, continues with the King, sluffs a Spade from his hand, and West takes the trick with a trump. He switches to the Ace of Diamonds, then a Spade, South wins with the Ace, leads a low Diamond and trumps it on the board. He then plays a Heart, covers with the King, and West, the Queen. Next South leads the Queen of Diamonds, East trumps, switches to a Club, South plays the Ace, then leads a Spade, trumps it in his hand, and continues with the 10 of Hearts. East takes the trick with the Jack, then plays the Ace of Hearts, next leads a good Club, and South uses his last Heart. He has one card left, the Jack of Diamonds, and has now succeeded in making his contract. North is aware that South will probably have 5 Hearts and will be playing the contract with 6 trumps in the opponents' hands. It is too dangerous to mention another suit at the 3 level. It turns out that 2 NT could also be made but it is difficult to find this bid.

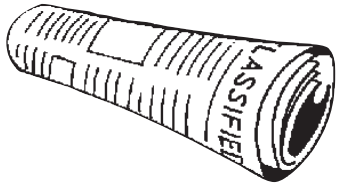

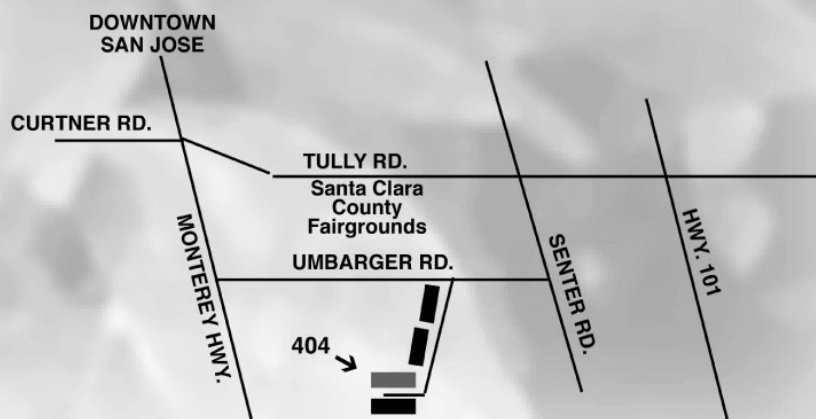
