

Chianakas is currently an Associate Professor of Voice and the nationally-awarded Director of Opera Theater at San Jose State University. She most recently made her Carnegie Hall Debut and performed the mezzo-soprano solos in the Hayden's Lord Nelson Mass with the Limerick Sings Festival in Limerick, Ireland. She has sung such leading opera roles as Santuzza in Cavalleria Rusticana, Amneris in Aida, Cherubino in Le Nozze



di Figaro and over 80 performances of Carmen throughout the United States and Europe. She recently directed the Barber of Seville for Opera San Jose and is the Director of Opera San Jose's Summer Program for Singers and Pianists. She is the Stage Director for the Vivace Youth Chorus Summer Opera Workshop.

Her accompanist, Dr. Snitkovsky, received her Bachelor, Masters and Doctorate of Musical Arts in Piano Performance and Accompanying from the St. Petersburg Conservatory in Russia. She was the main vocal coach and accompanist at the Conservatory and the Mariinsky Theater for 10 years. She moved to California in 2001 where she is the leading coach for Lyric Opera of San Francisco and Opera San Jose.

The proceeds from the recital will go towards the newly created Villages Opera Lovers' Scholarship Competition to be presented next year.

We look forward to a strong relationship with the School of Music and Dance of San Jose State University and look forward to having some of their students performing for us in the future.

2017 Annual Meetings of the Membership and Votes

The three Villages Corporations (Club, Association, and Homeowners Corporation) are preparing for this year's annual membership meetings and votes. Votes will be conducted in May and June, and this year's annual meetings will be held on Wednesday, June 14 at 4 p.m. in the Villages Clubhouse.

The Villager newspaper is now publishing candidate statements and candidate questions and answers. This year, for all three corporations, directors will be elected by acclamation. However, per the governing documents, notices for the membership meetings will be sent to all members and included will be the ballots for the ballot resolution Excess Membership Income Over Membership Expenses Refunded to Members. An approval vote of these resolutions will enable the corporations to avoid income tax on operating surpluses by refunding these surpluses to the membership in the form of assessment reduction in accordance with IRS Revenue Ruling 70-604.

In addition, The Villages Homeowners' Corporation, will be conducting a separate vote on updating its governing documents.

Club: There will be two director vacancies on the Club Board. Those who will continue to serve during the ensuing year are Howie Blumstein, Rick Casey, Debbie Champion, Mike Poellot, and Wayne Weiler. The Club Nominating Committee has announced Jim Neill and Robert "Bob" Wilk as its candidate nominations, and both will be elected by acclamation with terms to begin June 14 and expire in June 2020.

Association: On the Association Board, there will also be two director vacancies. Those who will continue to serve during the ensuing year are Garry Ashby, Sherry Benz, John Campbell, Brooks Fuller and Peter Nicholls. The Association Nominating Committee announced Matthew Giordono and Frank Veloz as its candidate nominations, and both will be elected by acclamation with terms to begin June 14 and expire in June 2020.

The Association Board has set May 1, 2017 as the Record Date (Bylaws Section 3.6) for the 2017 Director Election. Only those members in the records of the Association on May 1, 2017, shall be entitled to notice and only members in good standing as of the record date shall be entitled to vote.

Homeowners: As with the Club and Association, the Homeowners' Corporation Board will have two director vacancies. Those who will continue to serve during the ensuing year are Mike Kane, Julian Rodriguez, and Greg Stewart. Teddy Morse and Jeannie Omel have declared their candidacies, and will be elected by acclamation with terms to begin June 14 and expire in June 2020.

All ballot packages have been distributed, with the deadline of Monday, June 12, at 8 a.m. for the return of ballots. Ballot counting will take place in an open meeting on Tuesday, June 13 at 9:30 a.m. in Vineyard Center, and the results are to be announced the following day, Wednesday, June 14 at the annual meetings.

Along with voting, your Boards encourage you to attend the Annual Meetings of the Members on Wednesday, June 14 at 4 p.m. in the Clubhouse. After the conclusion of the meetings, members will be treated to a community celebration with refreshments.

Important Notice for Single-Family Homeowners

Sunday, May 7 you received an 11 $\frac{1}{2}$ x 14 inch white envelope delivered to your front porch. It contained the Homeowners' Corporation updated governing documents, a ballot and double envelope for returning the ballot. Three and a half years ago Villagers requested that these documents be brought up to date with current corporate law. After months and months of document review by our attorney, your board of directors and interested Villagers at a cost of \$7,500, the documents are complete and ready for your approval. We need a minimum of 114 votes in favor of the updates. To date we only have 75 ballots returned and one ballot is invalid because the double envelope system was not used. Don't let your money and the time spent on this project go to waste, please VOTE.

If you can't find your documents and ballot, contact Interim General Manager Julia Meadows in Building A, telephone 408-223-4634, email jmeadows@the-villages.com. A ballot box is located in the parking lot just outside Building A and the deadline for receipt of the ballots is June 12 at 8 a.m.

The Homeowners' Corporation Board of Directors held two informational meetings regarding the documents, the last one, just last week, May 18. However, if you were unable to attend and have questions please contact one of your board directors or Interim General Manager Julia Meadows.

Update from the GM Search Committee

A lot has happened since we last reported to you May 4. The committee completed its assessment of the questionnaires sent to 14 of 37 candidates. Two additional candidates applied after the questionnaires were returned for a total of 39 candidates.

After the resume and questionnaire assessment process, seven candidates were invited for a telephone interview. One candidate accepted a position elsewhere leaving six candidates scheduled for telephone interviews this week.

The committee is turning its assessment documentation and recommendations over to the Club Board June 1 for the Club Board to begin its candidate evaluation process.

Frequently Asked Comcast Questions:

1. Why wasn't my district listed in the paper?

A: Due to the size of the Villages, we are deploying a phased approach. This way we can ensure that your experience goes as smoothly as possible. Rest assured that we will get to you should you need assistance with this process. Comcast is committed to ensuring this is a great experience for the Villa-gers. Please keep an eye out on the paper as your district will be announced when the schedule is updated monthly. You can also check the office and Cribari Center bulletin boards for the event calendar dates.

2. What will I need to bring?

A: Nothing is needed for these events. You will simply provide Comcast with your address and phone number and we will schedule a tech appointment for you to swap out your equipment.

- 3. What if I am unable to make the event that is designated for my district? A: After Comcast has completed all the district's events, they will be back on site and will host a list of events at varying times to catch anvone they missed.
- 4. Do I have to wait for the events or can I swap my equipment out now? A: For your convenience, Comcast will be on site to schedule the appointments for you. However, you are more than welcome to schedule your own appointments and upgrade your equipment by calling our designated Bulk Services Call Center at 1-855-307-4896. (Additional fees may apply if you do not wait for your scheduled village swap-out event.)
 - 5. Should I bring my old equipment?
 - A: No. Please leave all old equipment at home.
 - 6. What is the purpose of this event?
- A: This event is strictly to set appointments for technicians to come out to your unit and swap out your equipment with the updated equipment.
- 7. What if I don't want to schedule an appointment and I want to install it myself?
- A: We will have Self-Install Kits available, too, for you during our events, or you can visit your local Xfinity Store and swap out your old equipment there. Please note you will only be able to do a Self-Install Kit for your Internet services. All X1 boxes will be installed by a tech.

Can you settle the argument?

Mother has died and the two brothers are arguing over the settling of Mom's estate. When Mom died, she had a tiny house in the desert and a small checking account. After selling the house there is a total estate of \$160,000 cash. A couple of years ago she desperately needed some major plumbing and roof repairs. The total cost was \$40,000 - money she did not have. So Older Brother suggested to Younger Brother that they both give Mom \$20,000 to pay for repairs. Younger Brother asked Older to pay the entire \$40,000 and he would make it up when the estate was settled.

The time has come. Younger brother believes that the estate of \$160,000 should split 90,000 to the Older and 70,000 to the Younger to make up the 20,000.

Older brother believes both he and Younger brother should receive equal shares of \$80,000 from Mom's estate. Then out of the \$80,000 received by Younger brother, he should reimburse Older Brother the \$20,000 he did not pay earlier. Thus, Older Brother would receive a total of \$100,000 rather than \$90,000.

Who do you think is correct?

SRS sides with Older Brother. The loan was from him, not from Mom. In effect, a couple of years ago Older Brother loaned the Younger \$20,000 who then gave it to Mom. If Mom had loaned Younger Brother \$20,000, then the loan or note receivable

would be included in Mom's estate of \$160,000. Older Brother would receive

\$80,000 cash; Younger Brother would receive his equal share of \$80,000 - comprised of \$60,000 cash and \$20,000 in the form of his paid and satisfied note payable to Mom.

Paratransit service

VTA Outreach has a new name: ACCESS. Under this program, VTA provides paratransit service for eligible individuals with disabilities who cannot use conventional public transit due to their physical, visual or cognitive disabilities. There has been some confusion because of the recent name change as some web sites and phone numbers reflect the original information.

The way to access on the internet is to go to VTA.org and follow the path accessibility and paratransit. Here you will find eligibility information and application. 





Personally, my experience in industry and other boards have exposed me to complex situations. I trust this background will help guide me through the complexities ahead.







At the request of our homeowners, your Board has been working for several years to update our CC&Rs and Bylaws to comply with current law. We are pleased to tell you that your Board completed its work with the Corporation's legal counsel to update the existing CC&Rs (Declaration of Covenants, Conditions and Restrictions) and Bylaws to comply with current law. We now need your "Yes" vote to complete the project.

Ín November 2016, a Homeowners' Informational Forum was held to give all singlefamily homeowners an opportunity to hear a presentation by the attorney concerning the proposed amended documents, ask questions and provide comments. The forum was well-attended, those in attendance were engaged, and some members suggested changes to the documents. The Board considered all comments made and decided it was appropriate to make additional changes to the docu-

On May 7 the vote packages were distributed for the updated Second Amended and Restated CC&Rs and Bylaws. This package will include the most recent draft of the updated governing documents.

Again, the Board's primary goal in amending the existing documents is to update the documents to comply with current law and industry practice.

Bylaws: Changes in the updated Bylaws include revisions to Article 4, entitled "Membership Voting." Article 4 was rewritten to require that all membership votes be conducted by secret written ballot using a double envelope system. This is a change from the current Bylaws mandate that membership votes be conducted at either a membership meeting or via "written ballot." One reason the Board made this change is because the Homeowners' Corporation has been using the secret written ballot and double envelope system for all membership votes for many years, and believes it is best to continue that practice. In addition, the Association and Club conduct their votes using a double envelope system, and the Board believes it appropriate that its voting procedures conform to the way the Association and Club conduct their votes.



CC&Rs: Section 3.20 was revised to provide that "only lots greater than one-half (1/2) acre may be subdivided, subject to approval of the city, the Architectural Control Committee, the Board, and a majority of the Total Voting Power of the Corporation." The lot that contains "the Mansion" is the only one that is bigger than one-half (1/2) acre and the Board wants to make sure that the membership has a vote on whether that lot can be subdivided in the future.

Changes were made to Sections 7.3.3 ("Front Setback Requirements") and Section 7.3.4 ("Side Setback Requirements") to update the front setback and side setback measurements and insert the names of the affected "Village" (e.g., "Village Hermosa") after the tract number.

The governing document amendment vote ballot deadline will be the same deadline as the annual meeting ballot deadline, Monday, June 12, 2017, at 8 a.m.

The Board believes that the proposed governing documents are in the best interest of all Corporation Members. If you have questions, you are encouraged to contact your Homeowners' Board (President Burt Lancaster, Vice President Teddy Morse, Secretary Julian Rodriguez, **CFO Greg Stewart or Assistant** CFO Mike Kane) or Interim General Manager Julia Meadows. The Board has also scheduled an informational open house on Thursday, May 18 from 5 to 6:30 p.m. in the Fairway Room at the Clubhouse where members are encouraged to attend and ask questions. (There will be refreshments.)

Long distance loves Mike and Grace are reunited at the United Nations. They marry and acquire a large exotic white cat with attitude. They become a dynamic Intelligence Team recruiting a Russian hacker who opens a back door into OPEC's secrets, catch a spy, solve a murder, foil a kidnapping and uncover secret information on China's leadership. Their heroics break all the espionage rules and are called back to Washington to explain the intel they received in their exploits. Where will the next book take them? Fiction. 2017.

"The Steel Kiss" by Jeffrey Deaver: Amelia Sachs is hot on the trail of a killer. She's chasing him through a department store in Brooklyn when an escalator malfunctions. *Note: The above times may be altered during tournament play.


Who is Clyne Soley and why should I care?


As The Villages celebrates its 50th Anniversary, it's useful to look back on a key contributor to golf play at the Villages and around the world. Dr. Russell "Clyne" Soley and his wife Bertha, were the 29th and 30th residents of the Villages in 1967. Clyne Soley had a long involvement in golf in The Villages and was a key developer of the USGA golf handicapping system that is now used worldwide.

Clyne Soley was the Club Champion for The Villages in 1968 when the course consisted only of the front nine holes. He played hundreds of rounds on the Villages courses, but his favorite was the Par 3 course. He had a total of 86 holes-in-one on our short (Par 3) course, two on the regular 18-hole course, and three holes-in-one on other courses.

Dr. Soley was also a key member of the USGA Handicap Research Team that developed the handicapping system now used over most of the world.

Turf Rejuvenation Program continues

In October, the Association Board approved a community wide turf rejuvenation program at a cost of \$198,383. The work entails slit-seeding (a planting process) roughly 30 acres of common area with Tall Fescue grass. This work is the second part of a two-part project intended to fill in community turf areas that have either died, or have become infested with noxious grasses or weeds, over time due to the most recent drought period.

The first step of the preparation process for a slit-seeding program like this is to kill all the weeds and noxious grasses (in all 30 acres). Round Up will be used to achieve the objective (signs and notices will be posted). This means that many turf areas in the community will brown out, and they will stay that way for a couple of weeks before the seeding process can take place. Even then, please remember that it will take time for the grass to grow in, so areas will look sparse for a couple of months. (Mowing and day watering schedules will be adjusted accordingly.)



During my 1950's "growin' up" years on Long Island, we kids heard a lot about the Cold War, the Arms Race and the wisdom or folly of building underground fallout shelters in our backyards. A six to twelve-month store of food and supplies was recommended. What we kids mostly overheard was the folly side —that the odds were against a nuclear attack ever happening and, if it did, a fallout shelter probably wouldn't save us, anyway.

As Dad put it: Eventually you would have to emerge from the shelter, and either you would die from the remaining radioactivity, or you would be captured or killed by the conquerors. As kids, we of course had no awareness of the costs involved, or the fact that none of the families around us could afford one. But most of us were fairly traumatized, as our childish imaginations ran wild.

One of our young friends had us convinced that he could identify enemy aircraft. He had us all watching the skies when we were with

him, and alerting him if we saw an airplane. He would then stare at it and we would all heave a sigh of relief when he announced that it was not an enemy plane: It was "one of ours." He must have come from a family where a close relative had served in World War II and talked about the planes the enemy used-the insignias and colors to watch for, maybe the sounds to listen for, etc. This was childishness, of course, but the Cold War and the threat of attack was very real and scary for us kids during the 1950s.

Fast forward to 1967, married and living on the Peninsula: I'm awakened in the middle of the night by a sonic boom—a sound I was only vaguely familiar with. My first thought was that maybe we just had an atomic bomb dropped on us. As I lie there listening for sirens or other indications that we might be under attack, I relived that fear from my childhood. Most of my fellow Villages can probably relate. Hopefully, most of our grandchildren never will.

Strategy: Obviously the strength is in West's hand; therefore, it would be a good idea to take finesses through West.

West leads the Ace of Clubs, East plays the 10, he continues with a low club, East trumps, plays a heart hoping West has the Ace. He is rewarded as West has the Ace, continues to play another club which East trumps, switches to a low heart, South covers with the Queen on the board, follows with the Ace of Diamonds, then a diamond to the King in his hand. He then leads the Queen of Spades, West, the King, South takes the trick with the Ace, plays a club, South, the 9 and claims since the rest of his cards are diamonds. Well done, the contract is made exactly. If West had initially led the Queen of Diamonds instead of the Ace of Clubs, then South would be very happy since he now can make an extra trick by being able to pull trumps before playing the clubs.

- North had a problem. He couldn't double since he had 2 hearts and more than 2 clubs, also a spade bid would promise 5 cards in the suit. Fortunately he had stoppers in Clubs and had enough points to bid 1 NoTrump.
- ^ South's artificial bid of 2 Spades is a Jacoby transfer asking his partner to bid 3 clubs. Since that was not his suit, South corrects to 3 Diamonds and his partner will pass.



Werner B. Plagge passed away in his home in the Villages on April 23, 2017 after a long illness. His amazing compassion, thoughtfulness, intelligence, playful spirit, and wit will be deeply missed by all who knew him. Werner left behind his own obituary:

"I was born in San Francisco on May 16, 1926 to Hajo P. Plagge, M.D. and Elisabeth Martha Plagge (nee Werner). They arrived in this country from Germany in 1922. I had two brothers and a sister. My sister Dorothea Hoffman died in 1957, my brother Mike passed away in 2005, and Ralph died in 2001.

I was married to Jane Evelyn Axell in 1949. She was my love, a jewel, a saint, irreplaceable. From her first marriage she had two children, whom I adored: Vinita Azarow (Jay) and Bruce Bellandi (Karen). We had two exceptional, loving children Werner Eugene Plagge (Sally) and Amy Elisabeth Plagge Hansen (Todd). Jane died in 2004. I had marvelous grandchildren Mark Plagge (Naomi), Christopher Plagge, Hank Hansen (fiancée Shasta), Carrie Weatherbie (Mike), Sarah Ritter (Matt), Colton Bellandi, and great-grandchildren May and Abel, and Cade and Kalee. I was most fortunate in finding and loving Rayna Kelley in my later years. She is a loving, wonderful and selfless person.

I graduated from Polytechnic High School in San Francisco. In 1944, I was drafted into the Army and honorably discharged in 1946. I served with the 38th Military Government in Korea. I graduated from San Francisco State University (B.A.) and received an M.A. from Stanford University. Most of my teaching and administrative career was at Log Cabin Ranch School, a court school of the San Francisco Unified School District."

Family members also remember his service for decades as a volunteer at Kaiser Hospital in San Jose and as an election-day worker, as chair of the Criminal Justice Committee of the Sonoma County Grand Jury, as a cub scout leader, and with Jane as a community mentor to troubled youths in San Jose. And they recall with joy his unceasing readiness for an indoor or outdoor game, a trivia quiz, or hand of cards, and his most excellent homemade jams.

Planning a Moving or Estate sale?

Residents, or those working on the behalf of residents, are advised to call the Public Safety Administration office at 239-5246 before planning or opening a sale at the Villages. All sales on Villages property are subject to Association Rule 2.02 Residence Use and Occupancy Restrictions.

Homeowner Rule 3.2.10, Estate and Garage Sales states:

3.2.10 Estate and garage sales are permitted subject to the following:

A. A permit for the sale shall be obtained from the Public Safety Office prior to holding the sale and placement of advertising.

Also, effective July 1, 2012, all estate and garage sales in the Association will require a permit. The owner of the property must request the permit from Public Safety Administration in Building C.

The Villages Association Rule 2.02. 5., Residence Use and Occupancy Restrictions applies:

- 5. Estate and garage sales are permitted subject to the following:
- A. Public Safety will not allow entry to anyone who is not authorized by name in advance (Club Rule 1.01, Access to the Villages).
- B. All sales activity and sale items must be contained with the residence or garage.
 - C. Sales maybe held only between 9 a.m. and 4 p.m.
 - D. Sales period may not exceed two days.
- E. Only one sale per resident household per year will be permitted. In the event of the death of a resident of the unit, a subsequent estate sale will be permitted. A permit is required and can be obtained from Public Safety.

Note: When placing classified ads for estate or garage sales in The Villager, you will need to attach proof of the permit to your Classified Advertising form.
