If there is, it must be jazz—sweet, hot, spicy, and ecstatic—and jazz is what you'll get this Sunday, June 10, at 2:30 p.m. in Cribari Auditorium. You can purchase open seating tickets for \$15 in the Cribari lobby this Saturday, June 9.

In the concert's first half, our Villages band and The Daddios (a jazz band we've previously heard and enjoyed) will combine for seven musical numbers. But after intermission, The Daddios will perform solo, surprising us with their own musical selections.

Our combined bands will play all of the following numbers: "Under the Double Eagle," a march by J. F. Wagner, a huge favorite of American bands and audiences for over a century; Edward J. Madden's "Flutes, Flutes, Flutes" starring our band's flute section; a popular jazz standard called "Invitation," featuring our own soprano sax player, Dawan Muhammad; Highlights from "Sophisticated Ladies," a medley of familiar Duke Ellington favorites; "Yesterday," the beautiful ballad by Paul McCartney and John Lennon; with "It Had Better Be Tonight," composed by Henry Mancini for the 1963 film "The Pink Panther" and another jazz standard, "How High the Moon," from the 1940 Broadway revue "Two for the Show."

And you will, indeed, experience your very own Two for the Show—two great bands providing a fantastic afternoon of music to jump-start your summer and get you flyin' high and rarin' to applaud. If you miss this, you may find that your P. F. Flyers don't run as fast, and your lemonade is never quite sweet enough. So as the saying goes: Be there, or be square!

After reading Mike Swiontek's Pulse letter about health problems from geese excrement, I am also very concerned. I run on the course on Mondays, and counted 64 geese on the 6th hole alone. Using information from Wildlife Management sources Mike noted, this equates to more than 50 lbs. of feces per day!

What used to be a relaxing run is now a minefield of droppings. I dodge them, but usually step in a few and have even slipped and fallen. It's worse for golfers. Though golf maintenance picks up droppings on tees and greens, the rest are mowed over and left on fairways. This means golfer's shoes, clubs, balls and anything that touches them are all potentially contaminated with these gastrointestinal diseases. Which means that this contamination is spread to the Patio, Bistro, Clubhouse and into all our homes.

Other courses have many methods (dogs) to control geese. We should urgently take action before we have a crisis that impacts the health of residents, the Villages reputation and property values. My husband plays golf 2-3 times/week and has survived cancer, heart attack, respiratory arrest and a stroke. I'd hate to see him done in by a goose!

2018 Director Elections

The three Villages Corporations (Club, Association and Homeowners Corporation) are preparing for this year's annual membership meetings and elections.

Elections will be conducted in May and June and this year's annual meetings will be held on Wednesday, June 13 at 4 p.m. in The Villages Clubhouse. See Candidates' Night on Channel 27 or on The Villages web site: theVillagesgcc.com (Also see pages 16 through 19 for specific information on the candidates.)

Board of Directors Elections

Club. There will be three director vacancies on the Club Board. The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. The three directors for which terms expire are Howie Blumstein, Debbie Champion, and Mike Poellot. Per the Bylaws, all are eligible to run for re-election. Those who will continue to serve during the ensuing year are Rick Casey, Jim Neill, Wayne Weiler and Bob Wilk. There are five candidates for which nominations have been qualified for the ballot: Janet Atkins, Howie Blumstein, Frank Langben, Mike Falarski and Jan Champion. The Club Board has set May 1, 2018 as the Record Date (Bylaws Section 3.6) for the 2018 Director Election and IRS Resolution vote. Only those Members in the records of the Club on May 1, 2018, shall be entitled to notice, and only Members in Good Standing as of the Record Date shall be entitled to vote.

Association. On the Association's Board, there will also be three director vacancies. As with the Club, the Amended and Restated Bylaws of the Association Corporation provide that there shall be seven directors. The three directors for which terms expire are Sherry Benz, John Campbell, and Peter Nicholls. Per the Bylaws, Sherry Benz and Peter Nicholls are eligible to run for re-election. Those who will continue to serve during the ensuing year are Garry Ashby, Brooks Fuller, Matthew Giordano, and Frank Veloz. There are four candidates for which nominations have been qualified for the ballot: Diana Omo Hallock, Rajeev R. Singh, David

L. Cook, and Julie Wash. The Association Board has set May 1, 2018 as the Record Date (Bylaws Section 3.6) for the 2018 Director Election. Only those Members in the records of the Association on May 1, 2018, shall be entitled to notice and only members in Good Standing as of the Record Date shall be entitled to vote.

Homeowners. The Homeowners' Corporation Board will have two director vacancies. The Second Amended and Restated Bylaws of the Homeowners' Corporation provide that there will be five directors. The two directors for which terms expire are Julian Rodriguez and Greg Stewart. Both are eligible to run for re-election. Those who will continue to serve during the ensuing year are Mike Kane, Teddy Morse, and Jeannie Omel. Greg Stewart and Ron Steckel have declared their candidacies.

IRS Resolutions. For all three corporations, vote packages will also include a ballot resolution, Excess Membership Income Over Membership Expenses Refunded to Members. An approval vote of these resolutions will enable the corporations to avoid income tax on operating surpluses by refunding these surpluses to the membership in the form of assessment reduction in accordance with IRS Revenue Ruling 70-604.

Inspectors of Election. In addition, all three Villages' corporate Boards have appointed Vera Buescher, Claudia Nicolai and Jeanne Filice as Inspectors of Election to perform any acts as may be proper to conduct the election with fairness to all members and also to perform their duties impartially, including, but not limited to, assigning persons to assist in counting and tabulating votes as the inspectors deem appropriate.

All ballot packages were distributed May 11 with the deadline of Monday, June 11, at 8 a.m. for the return of ballots. Ballot counting will take place in an open meeting on Tuesday, June 12 at 9:30 a.m. in Vineyard Center and the results are to be announced the following day, Wednesday, June 13 at the annual meetings.

Along with voting, your Boards encourage you to attend the Annual Meetings of the Members on Wednesday, June 13 at 4 p.m. in the Clubhouse. After the conclusion of the meetings, members will be treated to a community celebration with refreshments.

PUBLIC SAFETY

Emergency evacuation routes out of The Villages

If there were to be a major incident which would require evacuation from some or all of The Villages, there are three entry/exit routes.

1. The main entrance, which is the Plaza Gate. This is the primary ingress/egress and will always be the first choice.
2. The second choice is the Sonata Gate, which is located on Gutadel Drive in Sonata. When driving towards the entry Plaza from San Felipe Road, it is on your right.
3. The third choice is the Villa Vista gate, which is located in Cribari Hills. The road is a one-lane road, which exits on to Yerba Buena near Evergreen Valley College.

If there is to be an evacuation out of The Villages, this order would be given by Cal-Fire or a representative from the city and/or county government.

Do not proceed to the exit closest to you as it may not be staffed. The Sonata and Villa Vista Gates, when ordered to do so, will be opened by Public Safety.

Roth for a student for a future home

Is your grandchild a student? Will he or she have a summer job? Maybe also a part-time job during the school year? Consider giving them a gift of starting a Roth IRA for them.

Your student can annually fund a Roth IRA up to \$5,500 or their earned income compensation, whichever amount is smaller. There is no tax deduction for funding a Roth, but after retirement, withdrawals will be tax-free. Grandma or Grandpa might consider a contribution of \$1 for every \$1 your Grand earns. Or consider a contribution amount of \$2,000 or \$3,000 if your budget is smaller than the maximum.

This is a way to encourage your Grand to start long-term savings. In a Wall Street Journal article, the reporter commented that while her teenage son thought she was crazy when the Roth IRA was started, at age 27 the son is impressed with the appreciation of compounding investment gains over time. And there are more possibilities than retirement; read on.

The contributions can be withdrawn tax-free any time. But more exciting, if a Roth IRA account has existed for a minimum of five tax years, a withdrawal of its earnings up to \$10,000 to acquire a first-time home is tax free and penalty free.

Example: From age 18 through 22 a student deposits \$5,500 in a Roth IRA for a total of \$27,500. She leaves the investment in a growth stock fund earning 5 percent per year until age 28 when the balance is about \$42,800. She then buys a condo in downtown San Jose. The original contributions of \$27,500 can be withdrawn tax-free. Earnings of \$10,000 can also be withdrawn tax free to help with the home purchase giving a total of \$37,500. The remaining earnings of \$5,300 will be subject to income tax and the 10 percent penalty if withdrawn at this time.

Warning: Like any gift, you have no say in the disposition of your contribution. You cannot control, you only recommend, how your gift is used. The young adult may withdraw everything to finance a trip to Europe, buy a sports car, or something else believed more important than purchasing a home or financing retirement income.

As with all financial decisions, check with your professional advisor before starting a gifting program.

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

SRS Reminder:

Estimated tax due June 15

April 15 was only two months ago, but if you file forms 1040ES and 540ES, your second payment of estimated tax for 2018 is due Friday, June 15. You owe 25 percent of your annual tax estimate to the IRS. California demands more: you owe 40 percent of your annual tax estimate to the Franchise Tax Board. There is no fee to use the online Web Pay service to pay either tax or you may mail a check.

Unless otherwise indicated, all hikes meet at Cribari Center at 8:30 a.m. and depart at 8:45 a.m. Bring water, snacks and lunch, and always wear layered clothing appropriate to the current weather; hats and sunscreen are also recommended.

Saturday, June 9: Wate and Johanna Bakker (408-223-2190) will lead long and rambler hikes on the Long Ridge trail, along skyline boulevard (rt 35). The long hikers will start at the hw 9/hw 35 intersection for a 9-mile hike. The rambler

hikers will start at the Grizzly flat parking lot, a few miles north. Lunch will be at the Wallace Stegner bench and, with luck, both groups will meet there. Elevation differences are low, less than 1000 feet. Bring water and lunch and dress seasonably. A libation stop in Saratoga is planned, but optional. Round trip car mileage about 70.

Wednesday, June 13 (Rambler/Long Hiker): Wate and Johanna Bakker (408-223-2190) will lead hikes on the trails around Mt. Umunhum. Both Long Hikers and Ramblers will start at the top parking lot, visit the nearby exhibits, and enjoy the panoramic views before descending on the trail toward Mt. Baldy. Ramblers will hike to the first observation deck (or further if desired) before returning to the parking lot, a distance of approximately 3.5 miles. Long Hikers will hike to end of the trail and return, a distance of approximately 7.5 miles. Trails were engineered to maintain a consistent 10 percent grade. Total elevation for the long hikers is approximately 1150 feet, less for Ramblers, depending on how far down the trail they go before returning. People should bring an extra jacket as it can be cooler on top than in the Valley. Water and a light lunch are recommended. We can stop at Pete's on Almaden Expressway near Whole Foods afterward. Round trip car mileage is approximately 60 miles. We will meet at the Cribari Center at 9 a.m. for a 9:15 a.m. departure.

Saturday, June 16: Rich and Wendy will lead a hike in our Hills from Foothill Center to the Mail Box.

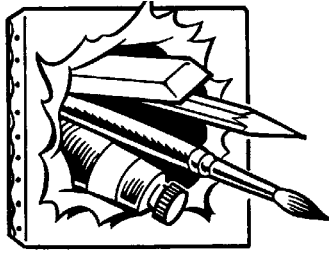

After lunch, we will take a short walk to the Pier and visit the Maritime History Museum (free admission). There is a \$5 fee for a pass to see the ships. If you are member of the National Parks, bring your senior cards (each card gets four persons in free). See Balclutha 1886, Eureka Ferry Boat, C.A. Thayer 1895, Alma 1891, Hercules (steam tug) 1907, Epplenon Hall 1914. This is the largest Maritime Park in the United States.

The Association for the preservation of the Presidential Yacht Potomac is offering, for the first time, a special "World War II Sightseeing and History Cruise." We are offering this experience to our residents on Saturday, August 11. Departure time from the Villages is 8 a.m. and the estimated return is 5 p.m. The cost for this outing, which includes transportation, 3-hour cruise on the USS Potomac, lunch and history tour, is \$102 per person. 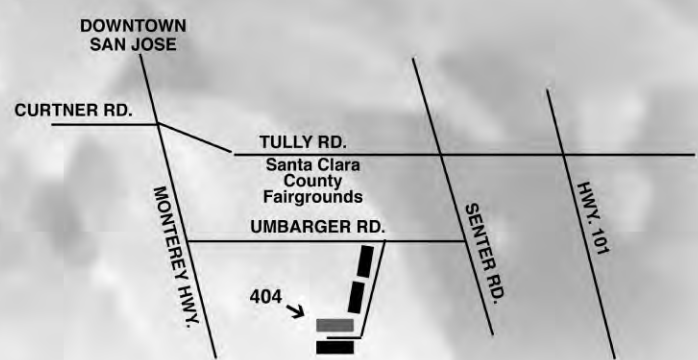

Notice of Proposed Changes to Club Policy CPo 222 Technology Advisory Committee

At the May 29, 2018 Club Board meeting, the Club Board approved to publish for 30-day notice proposed change to CPo 222 Technology Advisory Committee prior to formal approval consideration at the July 31, 2018, monthly board meeting. The Board will consider oral and written comments regarding the proposed change at the July 17, 2018, study session (1:30 p.m. at Foothill Center). Response to the proposed policy change may be made by one or more of the following methods: 1) Participation in the discussion of the change at the Club Board of Directors study session at which the proposed policy change will be considered, 2) via e-mail with comments sent to the General Manager's office at least seven (7) days prior to the Club Board of Directors study session (jmeadows@the-villages.com), and 3) via written comments to the General Manager's offices delivered at least seven (7) days prior to the Club Board of Directors study session.

The purpose of the change is to modify the committee's charter changing the required meeting schedule from monthly to quarterly.

Note: Deleted items are in ~~strike-through font~~, inserted items are in underlined font, and the purposes of the proposed changes are in *italics*.

OBJECTIVE:

The purpose of the Technology Advisory Committee (TAC) is to advise the Club Board on technology matters relating to the Villages. The mission of the TAC is to introduce technologies into The Villages that will benefit the residents of The Villages.

GOVERNING DOCUMENTS / LEGAL REQUIREMENTS:

None.

Committee: TECHNOLOGY ADVISORY COMMITTEE

Responsible to: Club Board of Directors

Composition:

Voting Members: Five to seven (5-7) resident owners in good standing appointed by the Board of Directors.

Non-Voting Members: The number of associate members shall be determined by the committee with the approval of the Board. Associate members can actively participate in committee discussions but do not have a vote.

Board Liaison (non-voting)

Staff Support: As designated by the General Manager

Member Term: Two-year staggered terms by Board appointment, from January 1 through December 31. Reappointment is possible subject to a two-term limit. There must be a one year break in service after two consecutive terms before reappointment. A vacancy prior to completion of a term will be filled by appointment by the Board for the remainder of the vacant term. If the vacancy is less than one year, the appointee shall be eligible to be reappointed for two full consecutive terms.

Officers: The committee shall elect a Chair and other officers, as it deems necessary. Officers shall be elected to one year terms.

Subcommittees: The committee may appoint subcommittees, as it deems necessary to perform its appointed tasks.

Meetings: The committee shall meet at least monthly quarterly or as required to fulfill its responsibilities.

Responsibilities:

1. The primary responsibility of this Committee is to create a technology plan for The Villages, to review and update the plan, and to advise the Board on technology matters relating to The Villages. This committee will review, investigate and make recommendations in various IT areas. The committee will also make recommendations to the CBOD on emerging technologies that would benefit the residents of the Villages.

2. The TAC will focus on five areas, each of which will have a subcommittee: Technology Strategy, Residential, Management, Cable & Wireless and Utilities Cost Containment (UCC). The UCC will review, analyze, and present to the Board of Directors reasonable and affordable opportunities for any potential utility cost reductions and operational efficiencies.

3. The committee shall provide the Club Board written minutes for all committee meetings.

Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the change at the Club Board of Directors study session at which the proposed rule change will be considered, 2) via e-mail with comments sent to the General Manager's office at least seven (7) days prior to the Club Board of Directors study session (jmeadows@the-villages.com), and 3) via written comments to the General Manager's offices delivered at least seven (7) days prior to the Club Board of Directors study session.

Note: Deleted items are in ~~strike-through font~~, inserted items are in underlined font, and the purposes of the proposed changes are in *italics*.

The purpose of this revision is to clarify and define the Clubhouse Dress Code in the restaurant.

C. Clubhouse Dress Code

- 1) All venues – no swimwear attire, no metal spiked golf shoes. Shirts and footwear are required.
- 2) Bistro Patio: No further requirements.
- 3) Bistro: Dress is casual but clean and neat – no torn or soiled clothing.
- 4) Clubhouse Restaurant:

~~No hats allowed, except for medical or religious reasons.~~

~~Lunch and weekend brunch attire is casual but clean and neat – no torn or soiled clothing – no exercise attire.~~

At all times – no clothing that is torn, ripped, soiled, or has holes.

~~Dinner attire required after 5 p.m. – no casual or torn denim or jeans, no flip-flops.~~

After 5 p.m. in the restaurant –

No shorts, casual denim, jeans, flip-flops, sweatshirts, sweatpants, or t-shirts.

No hats, caps, or visors, except for medical or religious reasons.

Dress denim is allowed. Shirts do not need to be tucked in.

Senate candidate Kevin de León visits Villages

Three days in the Vatican left little time for a visit to The Villages. But last Friday, June 1, the Democratic Club had a chance to listen to one of the 32 contenders for nomination for the California Senate seat.

Kevin de León—have you heard of him?—is challenging Diane Feinstein for a seat in the U.S. Senate.

Kevin was raised by a single mother who immigrated to California illegally from Guatemala. He never knew his father, who was half-Guatemalan and half-Chinese. He has acknowledged growing up with “a chip on my shoulder,” thinking “I wasn't good enough, maybe.”

Against these odds he is currently President Pro Tem of the California Senate and has pushed through a range of socially focused bills that have helped California remain a caring and people sensitive State. Polls indicate he doesn't have much chance against Feinstein. For starters, he doesn't have much campaign money. Last week, a survey by the Public Policy Institute of California showed Feinstein leading De León by 42 to 16 percent, with 39 percent undecided.

De León responded, “Whoever thought that the youngest child of a single immigrant mother with a third-grade education would become the leader of the Senate? The odds have always been against me. It's the story of my life.”

Art Film for June: Mary Cassatt

The Art Film for Tuesday, June 12 at 7 p.m. is “Mary Cassatt: Great Women Artists” produced by Kultur. Mary Cassatt's pastel and portrait paintings primarily show the leisure world of wealthy women, mothers and homemakers of her time (1844-1926). She was influenced by her family's social position, her training at the Pennsylvania Academy of Fine Arts, her travels throughout Europe, Impressionism, and the Japonisme, such as Kitagawa Utamoro (1750-1806), a major artist of the Okiyo-e school. Although she had spent most of her life in France, upon her death, she was called America's greatest woman artist.

This video is packed with her paintings. But there is more to tell. Germaine Greer said, “Mary Cassatt may have turned out some schmaltzy paintings but the best of her work is feminist at heart” (theguardian.com). Is this too harsh? Cassatt lived her life on her own terms, never marrying, defying her father by becoming an artist, moving to Paris, supporting herself, turning her back on the Paris Salon and accepting Edgar Degas' invitation to the Anonymous Society. Degas and Cassatt worked together for 40 years. One of Art History's unsolved mysteries is her “lost” mural, which was hung at the entrance of the 1893 Chicago World's Fair Women's Building,

Help Us Keep Your Vote a Secret

Do you wonder if your vote is really a secret? If so, you're not alone. Some Villagers do not fully understand our two-envelope secret ballot system, so here are some answers.

The Villages' elections are governed by California Civil Code requiring our voting system to safeguard the privacy of our residents' votes.

Three Election Inspectors, Vera Buescher, Jeanne Filice and Claudia Nicolai, have been appointed by The Villages Association, Homeowners and Club Boards of Directors.

Once your ballot is placed in a locked ballot box, it is kept under lock-and-key at all times. Only the Election Inspectors have access to the ballot boxes.

The Inspectors remove and sort the ballot envelopes according to color (blue for Association, green for Homeowners, and buff for Club).

The bar codes are scanned, which registers and validates that the envelope was received from a member in good standing who is eligible to vote. The bar code must remain intact for the ballot to be valid.

Following registration, the barcoded envelope is opened and the secret envelope is removed. Barcoded envelopes are sent to storage while secret envelopes are bundled for counting.

On counting day, only the secret envelopes are given to the Tellers for counting. These envelopes contain no names, bar codes or other identifying marks. They remain sealed and under lock-and-key until the Inspectors and Tellers meet at an open Board of Directors meeting to begin the counting process.

This entire process is in accordance with California Civil Code.

TENNIS TALK

Three weeks ago I was watching a league match in the critical moments of a 10 point super tie break game. It was an intense mood, because the winner of this game would win the match for their entire team, the other two matches having split one win and one loss. At the score of 9-8 match point, the server of one team complained that he was being distracted during his service toss by the movement of the receiver, who was approaching to be closer in. The delay caused by the prolonged discussion of whether or not this was permissible was unfortunate, because I think it disturbed the concentration of both teams.

I had to bite my tongue and remain silent during the dispute, because there is a rule that says, "No spectator has a part in the match." After the match had finished, I brought out a copy of "The Code" from my tennis bag, and let the players know about the rule that states "Body movement: A player may feint with the body while a ball is in play. A player may change position at any time, including while the server is tossing a ball. Any other movement or any sound that is made solely to distract an opponent, including, but not limited to, waving arms or racket or stamping feet, is not allowed."

Because these situations can come up occasionally, I recommend that players who are playing in competition keep in their tennis bags a copy of "The Code, the Players' Guide to Fair Play and the Unwritten Rules of Tennis." It is available here:

https://www.usta.com/content/dam/usta/sections/northern-california/norcal/pdfs/leagues/resources/rules/2015_Code.pdf

No system of rules will cover every specific problem or situation. If players of goodwill follow the principles of "The Code," they should be able to reach an agreement, while making the game more fun and harmonious.

This was the first round where it was required to putt everything out, and being mindful of ESC, raw scores are adjusted only at posting time, which Alan does for us.

Take Note...The ladies will have the whole course to themselves **two weeks from now** (June 12). No Pinseekers that day, so do a little practicing on that off day.

Now, since I can't give advice but can ask questions, follow me here. I have filled out a spreadsheet with all of the gross scores from January 1, looking for any trends. I found none except some of the contenders made sure they played those last few weeks. What I did notice was, in many cases, the scores in the first hole played turned out to be the worst score of the 9-hole round, triple bogies, quadruple bogies and in one case 5 over par.

My question to all of us, when you get your card and see which hole is your starting hole, how many of us practice/warm up the clubs that will be used on that hole?

In my case I go directly to the putting green and "calibrate" my putting stroke with a long series of straight putts. This tells me if I'm pulling or pushing the putter head. Once I'm satisfied the stroke is good, I practice breaking putts and then *long* putts. My depth perception provides a challenge on the long ones, 8' short or 8' long many times (still working on it).

Tips from the Pro—Small muscles can supply power too...As we age, we all lose strength and flexibility. So our ability to turn and extend diminishes. Here are some tips to help you turn more... Narrow your stance, flare your toes out a minimum of 45 degrees, stand a bit taller at the waist. If you cannot swing with your left arm straight (few of us can), then go ahead and let it bend, just limit the bend...you never want your right hand too close to your right shoulder on the backswing...push it away as far as you can, given your degree of flexibility. Another tip is to use your hands and wrists more. When big muscles and joints become less elastic, a good thought is to try to hinge your wrists more on the backswing and to make sure that your swing arc is narrower on the downswing than on the backswing (ala Sergio Garcia). Let us know if these tips help! See you at the course!

It even appeared that the man never intended to finish the work and abandoned his responsibility in mid-project.

Before engaging in the services of any contractor, residents should be aware that California state law mandates any contractor bidding for a job more than \$500 in parts and labor must be licensed.

Call the Contractors State License Board at 1-800-321-2752 to ask any questions or express your concerns about a contractor.

Checking the references of contractors and getting more than one competitive bid are also ways for customers to protect themselves from fraudulent operators.

It is a good idea to get estimates from at least three companies, so you can get an idea of the price of the work or equipment. Shop around online or by making some informational calls before you set out to get a quote.

A good company will give you a written bid (or proposal) outlining the work to be done and the equipment to be installed, and the price—including all labor costs.

Reliable contractors are professional. They are generally prompt, courteous and respectful. Their behavior in dealing with you will probably reflect how they will act when a problem arises or when service is required.

Most reputable business have a permanent office with a specific address. Be careful of post office boxes or businesses in other states. An office location indicates the company has been in business and intends to continue selling goods or offering services.

The Landscape & Maintenance Department would also like to remind Villagers having construction or repair work done to inform the contractors or repair persons doing the work that district dumpsters are not available for the disposal of construction and repair-related debris. Contractors must dispose of construction waste properly, per Association Rule 2.13.

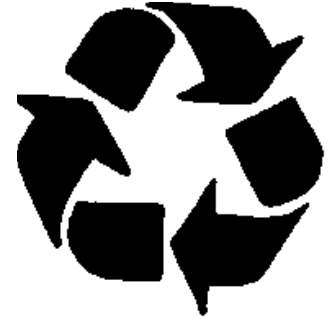

West leads the 10 of Hearts, Ace from the board, switches to the Queen of Spades, then a Spade to the Ace in his hand, continues with the King to pull the last trump. He next plays a Diamond, finesses the King, leads a Heart, trumps it in his hand, follows with another Diamond West ducks again, South covers with the Queen, continues with a Diamond, East, the Jack, and West, the Ace. He plays a Heart, South trumps, leads a Club, finesses the Queen, then plays the last Diamond from the board, and sluffing a Club from his hand. He next leads the Ace of Clubs, then plays the last card, a Club from the board, and wins with the last card in his hand, a trump. Great. The contract is made with 2 overtricks. This is not a biddable slam, because the Ace of Diamonds and the King of Clubs have to be in West's hand to make the 2 overtricks.

* This is a weak preemptive bid showing 6 cards with 6 to 10 HCP. North is very happy to bid game with his 19 HCP and 2 cards in the preemptive suit.

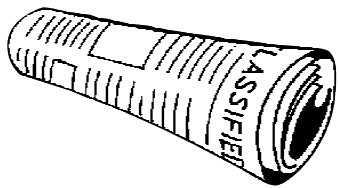
