We have been having termite problems in one of walls of our master bedroom for the past four years. It is not going away. There is a window in our bedroom in our Cribari Bend lower condo where there are termite droppings on the inside window sill, which have been referred to the Maintenance Department many times. After that some contractor comes and does a superficial job of sealing, etc. But the problem recurs and is not resolved. Actually, the wall of above condo is affected, too. Now Maintenance is telling us to replace the window. We may have to do it.

My point, however, is that there are no clear-cut responsibilities of resolving termite problems. We would like to know the procedure to resolve such issues. There should be a higher officer designated where we can take such problems and get them resolved.

# **Change of Insurance Requirements**

The Association Board of Directors unanimously voted to buy down the proposed \$25,000 master policy deductible to \$10,000 which is the lowest deductible now offered to The Villages. It is important that you contact your HO6 policy insurance company or broker to adjust your HO6 policy to the new \$10,000 deductible amount effective March 1, 2019.

As you know, per The Villages Association CC&Rs Section 7.5 Insurance to be Maintained by Owners, Owners must maintain property and liability coverage (commonly referred to as HO6).

For Owners (HO6), the following requirements apply:

1. General Liability coverage must be maintained in an amount of not less than \$300,000;

2. Property damage insurance covering contents and personal property within the condominium in an amount deemed appropriate by the owner, and;

Loss assessment coverage must be maintained in an amount equal to or greater than the amount of the deductible under the hazard insurance policy carried by the Association (\$10,000).

Again, please contact your insurance broker to adjust your HO6 policy to the new \$10,000 deductible (previously \$5,000) amount effective March 1, 2019.

It is important to note that this requirement is not an elective, it is mandatory per the Association's governing documents.

# Club and Association Boards met for regularly scheduled February meetings

The Villages Association and Club Boards of Directors met Tuesday, February 26, for their regularly scheduled meetings at Foothill Center. Numerous items of business were discussed and voted upon.

## Association Operating Financial Commentary

For the month of January 2019

**January Operating Statement Review:** Revenue was \$700 unfavorable to the budget of \$719,800 for the month due to less than planned laundry concession fees.

Expenditures for the month were \$19,400 (3.3 percent) favorable to the budget of \$587,100. The most significant favorable to budget expense category was repair and maintenance with a \$10,400 positive budget variance for the month (\$14,800 spent vs. budget of \$25,200). Other significant favorable to budget expense categories were planting expense coming in \$3,200 lower than the budget of \$10,800 (due to timing), as well as pest control expense at \$2,300 less than the budget of \$8,300. The most notable expense line unfavorable to budget was legal fees with a negative budget variance for the month of \$2,100 (budget of \$400). All other expense lines tracked fairly close to budget. The net positive operating budget variance for the month of January was \$18,700.

Year-to-date (seven months of operations), total revenue is \$500 favorable to the budget of \$5,034,600 due to higher than planned third-party assessments and golf cart electricity fees, offset by less than planned laundry concession fees. Year-to-date, total operating expenditures are \$4,896,700, coming in 1.4 percent less (\$69,400) than the budget of \$4,966,100. Most of the positive budget variance is in water expense that is \$32,700 or 2.5 percent less than the year-to-date water budget of \$1,302,600. Additionally, planting expense is favorable to budget by \$35,700 (YTD budget of \$142,100) due to timing. Repair and maintenance is also favorable to budget by \$24,000 or 13.6 percent (YTD budget of \$176,500). The most significant unfavorable year-to-date expenditure category is irrigation maintenance at \$35,300 more than the budget of \$83,900 spread throughout most of the districts. **The year-to-date net positive operating budget variance is \$69,900**.

## **Club Operating Financial Commentary**

#### For the month of January 2019

January Operating Statement Review: Total revenue was \$9,400 favorable to budget, 0.9 percent more than the budget of \$1,030,300. Food and bar sales surpassed the combined budget of \$184,700 by \$9,100 with strong sales in the Bistro. Advertising income was also significantly higher than budget (actual \$21,100 vs. budget of \$12,000) due to timing. The rainy weather in January hurt golf play with green fees posting a negative budget variance of \$13,800 (budget of \$75,500). There were 16 days of rain and red flag status (golf carts on paths only) on the golf course. Resident activities income was \$5,700 higher than the budget

Total expenditures were \$15,600 favorable to budget, 1.4 percent less than the budget of \$1,085,800. The most significant favorable to budget expense category was employee expense with a \$28,400 positive budget variance for the month, partially offset by higher professional fees (HR consultant). Other expenditure categories significantly favorable to budget were tree trimming (\$2,300 actual vs. budget of \$10,800) due to the timing of golf course tree trimming. Repair and maintenance was \$6,000 favorable to budget (\$19,900 actual vs. budget of \$25,900) as well. The most notable unfavorable to budget expenditure category was professional fees (\$27,700 actual vs. budget of \$14,000), however this was partially offset in lower employee expense as mentioned above. Also unfavorable to budget was Pro Shop cost of sales (\$15,100 actual vs. budget of \$4,200) without higher merchandise sales volume. These results showed a clear decline in inventory and managerial control for December and January. Systems are now being put into place to reverse this trend and improved results will be realized for the remainder of this fiscal year and beyond. The net positive operating budget variance for the month of January was \$25,000. See table below.

Year-to-date revenue is \$51,000 favorable to budget, 0.6 percent higher than the budget of \$7,962,000. Year-to-date expenditures are \$153,000 (1.9 percent) favorable to the budget of \$7,899,000. The year-to-date net positive budget variance is \$204,000. See the table in the next column for detail by department.

The bottom of the table shows the financial impact of the monthly solar lease payments and contribution to the balloon payment fund (to be paid in 2023) captured on the Club's balance sheet. **The YTD total for these two items is \$133,000**.

The above table shows the Clubhouse/Restaurant has a \$66,000 net positive variance due to favorable to budget food/beverage sales, partially offset by higher than planned cost of sales and employee expense. The community centers have a \$46,000 net positive variance from favorable electricity expense (due to solar) and intra-co cost transfers. G&A has a \$37,000 net positive variance due to less than planned employee expense, legal fees and board of directors' expense, offset by less than planned income from resale administration fees, HOA document sales and rental unit setup fees. Community Activities has produced a \$32,000 net positive variance from less than planned employee expense and higher than planned resident activities income. All Other has a net positive variance of \$22,000 primarily from less than planned supplies/maintenance expenses and total landscape expenses.

## See Monet exhibit at de Young Museum

See the Monet exhibit at the de Young outing is planned for Thursday, May 2. The exhibition will feature nearly 50 paintings by Claude Monet dating mainly from 1913 to 1926, the final phase of the artist's long career. During his late years, the well-traveled Monet stayed close to home, inspired by the variety of elements making up his own garden at Giverny, a village located about 45 miles from Paris. With its evolving scenery of flower beds, footpaths, willows, wisteria, and nymphaea, the garden became a personal laboratory for the artist's concentrated study of natural phenomena. The exhibition will focus on the series that Monet invented, and just as important, reinvented, in this setting. In the process, it will reconsider the conventional notion that many of the late works painted on a large scale were preparatory for the Grand Decorations, rather than finished paintings in their own right. Boldly balancing representation and abstraction, Monet's radical late works redefined the master of Impressionism as a forebear of modernism.

## District Attorney Jeff Rosen to visit Villages

Please mark your calendars for a wine and cheese reception to meet District Attorney Jeff Rosen this Monday, March 4 at 6 p.m. and to hear his presentation at 6:15 p.m. at Vineyard Center. This event is sponsored by the Villages Democratic Club and is open to all.

Jeff Rosen's passion for justice began before he was born. Jeff's father, grandmother and other family members were interned in three Nazi slave labor and concentration camps during World War II. In 1945, they were liberated from the infamous Bergen-Belsen concentration camp, spending another five years in refugee camps before finally reaching the United States as penniless immigrants.

Raised in the San Fernando Valley, Jeff graduated from UCLA as "the most Outstanding Senior." He moved to UC Berkeley's Boalt Law School, where he served

on the Moot Court Board but still found time to teach English to new immigrants. After a short stint at private law firms, Jeff realized public service was his calling. In 1995, he joined the Santa Clara County District Attorney's Office as a junior prosecutor and distinguished himself as "Misdemeanor Trial Attorney of the Year" in his first year on the job. Jeff earned a reputation for prosecuting tough and high profile criminal cases. A San Jose Mercury News columnist called Jeff "the most respected career prosecutor in the (DA's) office." With an outstanding conviction record, Jeff prosecuted some of Santa Clara County's most notorious criminals including the head of the Hell's Angels for manufacturing methamphetamine.


A new DA was elected in 2006, but the Office soon became mired in several ethical scandals that were getting in the way of justice. Jeff decided to challenge the incumbent and after a hard fought campaign was elected the new District Attorney of Santa Clara County and has been reelected several times to continue in that office today. During his tenure he has worked successfully to reform the DA's Office and restore its integrity.

"My family faced one of history's most evil regimes. I learned from an early age that when tyranny rises, justice disintegrates. We must fight to protect and promote justice no matter the challenges," Jeff said.

We are fortunate indeed that DA Jeff Rosen has found time to share with us his thoughts and experiences in his role as our District Attorney.

**"Dark Sacred Night" by Michael Connelly:** Detective Renée Ballard works the graveyard shift and returns to Hollywood Station in the early hours to find a stranger rifling through old files. The intruder is none other than legendary LAPD detective Harry Bosch, hunting for leads in an unsolved case that has gotten under his skin. Ballard escorts him out but becomes curious to know what he was searching for, soon becoming obsessed by the murder of Daisy Clayton. Was she the first victim of a serial killer who still stalks the streets? For Bosch, the case is more than personal; it may be all he has left. But in a city where crime never sleeps, even detectives have a dark side. Mystery 2018. Large Print.

"Virgil Wander" by Leif Enger: Midwestern movie house owner Virgil Wander luckily survives crashing into icy Lake Superior, but his language and memory are altered and he emerges into a world no longer familiar to him. Slowly, Virgil begins to piece together his personal history and the lore of his broken town with the help of a cast of affable and curious locals: Rune, whose son disappeared; Nadine, the wife of the vanished man; Tom, a journalist and Virgil's oldest friend; and others who must confront tragedies of their own. Into this community returns a shimmering prodigal son who may hold the key to reviving their town. Fiction 2018.

"Kingdom of the Blind" by Louise Penny: When a peculiar letter arrives inviting Armand Gamache to an abandoned farmhouse, the former head of the Sûreté du Québec discovers that a complete stranger has named him an executor of her will. Frankly curious, Gamache accepts and soon learns that the other two executors are Myrna Landers, the bookseller from Three Pines, and a young builder. None of them had ever met the elderly woman. The will is so odd and includes bequests that are so wildly unlikely that Gamache and the others suspect the woman must have been delusional. But what if, Gamache begins to ask himself, she was perfectly sane? But it isn't the only menace Gamache is facing. The investigation into the events that led to his suspension six months ago has dragged on into the dead of winter. And while most of the opioids he allowed to slip through his hands in order to bring down the cartels have been retrieved, there is one devastating exception. With the deadly drug about to hit the streets, Gamache races for answers, begins to see his own blind spots, and the terrible things hiding there. Mystery 2018.

"There There" by Tommy Orange: Here is a story of several people, each of whom has private reasons for traveling to the Big Oakland Powwow. Jacquie Red Feather is newly sober and trying to make it back to the family she left behind in shame. Dene Oxendene is pulling his life together after his uncle's death and has come to work at the powwow to honor his uncle's memory. Opal Viola Victoria Bear Shield has come to watch her nephew dance in public for the first time. There will be glorious communion and a spectacle of sacred tradition and pageantry. And there will be sacrifice, heroism, and unspeakable loss. Fierce, angry, funny, heartbreaking, this is a relentlessly paced multi-generational story about violence and recovery, memory and identity, and the beauty and despair woven into the history of a nation and its people. Mr. White has given over 170 presentations to over 10,000 people to date.



Currently retired, Mr. White spent nearly 30 years as a Human Resources Executive in the Silicon Valley with Apple, Intuit, and Palm. In addition to HR, Mr. White took on responsibility for Corporate Social Responsibility (CSR) at his workplaces over the past 15 years.

He holds a B.A. in Sociology from Stony Brook University, an M.S.W. from UC Berkeley, and an Executive Education Certificate in CSR from the Harvard Business School. Mr. White lives in Belmont, CA with his wife of 18 years and is an active member of the Rotary Club of San Mateo. He swims and reads when he is not advocating solutions to climate change.



## March Art Film: Paul Cézanne

On Tuesday, March 12 at 7 p.m. in the Vineyard Center, the Villages Arts and Crafts Association will present "**Cézanne, Portraits of a Life,**" from the Seventh Art Productions series Exhibitions on Screen. This very special video gives us several different perspectives on the art, life, impact of Cézanne and the world of museum exhibitions themselves through the eyes of leading art historians and the curators who created this major exhibition based primarily on the artist's portraits including his self-portraits. This exhibition traveled to three of the world's major museums, the Musée D'Orsay in Paris, the National Portrait Gallery in London and the National Gallery of Art in Washington, D.C.

These exhibitions are not just a fascinating inside look into the individual museum cultural decision-making processes but also an intimate look into the artist himself as seen through his portrait subjects combined with Cézanne's lifetime of correspondences. From these sources, we get a real sense of the human side of the artist and legacy claimed by so many iconic artists. Both Matisse and Picasso called Cézanne "the father of us all." He is the bridge between Impressionism and Cubism. Lead Curator John Elderfield's commentaries, among other historians of similar caliber, make this viewing beyond compare.

Before Picasso, there was Cézanne in dialogue with his childhood friend and fellow painter Camille Pissarro, and joined latter by writer Émile Zola, who together changed the direction of art.



### Tips from the Pro - Scott Steele.

Simulate Game Time Conditions...Golf is unique in many ways...one of which is that it's the only sport in which you do not practice and play on the same "field." That is why it is imperative to attempt to simulate real golf when practicing as best you can...meaning one try, under pressure.

## Here are two practice putting tips along those lines:

1. To simulate pressure putting try using the "Par 5" Drill. Choose a hole on the practice green and set balls down at 5 feet, 10 feet, and 25 feet away. The goal is to make all three balls into the hole in 5 strokes or less. The 5 and 10 footers are both very makeable, and the 25-footer will allow you to work on your "lag" or distance control. With each stroke you will feel the pressure build just like it does on the golf course.

2. Take one ball to the practice green and putt 10 putts to 10 different holes starting from your average distance from the hole on a 100 yard approach. Whether it's 20 feet, 25 feet, 30 feet or whatever; putt 10 balls from that distance to 10 different holes. The goal is to get down in two on average or 20 putts total. Using 1 ball and totaling the strokes will simulate only getting one try and also feeling pressure as you approach 20 total strokes. Quick Tip: When you get nervous and your heart beat quickens, remember these four things: Stick to your routine / Focus on the target / Breathe evenly / Relax your grip pressure. See you at the course.

The purpose of the proposed changes is to clarify and standardize the formatting of all new and revised policies.

## Association Policy POLICY NUMBER: APo 101

#### **PURPOSE OF REVISION:**

To simplify the documentation for changes to existing policies and procedures and for new policies and procedures.

**OBJECTIVE:** Provide guidelines for developing Association polices and procedures. GOVERNING DOCUMENTS / LEGAL REQUIREMENTS: None.

POLICY: The Association Board establishes policies and procedures that will be used to manage and govern the Association's operations. A policy is a predetermined course of action established as a guide toward carrying out the Mission of The Villages Association Board of Directors, which is "to PROTECT, MAINTAIN, and ENHANCE the common property of its members." A policy lays out what the Board wants done; the procedure, which is a subset of and integral to the policy, describes how it should be done in much more detail. Policies deal with the "what" and "why"; procedures deal with the "how." Policies and procedures are required by the Board in order to provide clear communication among Association members, non-members living in or visiting the Villages, and individuals contracted / hired / employed by residents, or the Association's Managing Agent. New policies and procedures or proposed changes to existing policies or

## More COMMUNITY NOTICES SRS SENIOR RESOURCE SERVICES

Fiduciary and Enrolled Agent

Several Villagers have asked about the terms "Fiduciaries" and "Enrolled Agents." We will try to explain their duties in this article.

A dictionary definition of a Fiduciary is "a person to whom property or power is entrusted for the benefit of another." A fiduciary is legally required to take actions that are in the best interests of the other party as opposed to his or her own. Many individuals can have a fiduciary role. Two examples are Villages Board Directors for the benefit of Villagers or an Executor for your estate.

As the term fiduciary is a level of responsibility as opposed to a job title, it may be hard to define in the investment field. Representatives can be called stock brokers, investment advisers, or financial planners and they may or may not be fiduciaries. Generally, if a person is fee based, he or she is a fiduciary and must make recommendations that are in the best interest of the client, not the best interest of the adviser.

On the other hand, if the person is commission based, he or she generally is not a fiduciary. These individuals however do have to consider suitability when making transactions. The federal government is working toward making all financial representatives fiduciaries. Ways to try to determine an individual's status are to identify method of compensation, check with the individual's firm, and ask him or her.

The SRS list of paid tax preparers includes both EAs (Enrolled Agents) and CPAs (Certified Public Accountants). After passing exams administered by the IRS, Enrolled Agents are authorized by the IRS to do tax preparation and related work. There are no college education requirements.

CPAs are licensed by individual states after passing national exams administered by the American Institute of CPAs. CPAs can do a wide range of accounting work. Usually five years of college units are required to be able to take the examinations.

An Enrolled Agent is qualified to prepare tax returns and represent you before the IRS, while a CPA has additional areas of expertise such as auditing financial statements and financial and management consulting. Choosing one or the other depends on your personal situation.

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

Proposed changes to The Villages Association Policy APo 101 Policies were procedures shall only be considered for formal approval at an open meeting of the Association Board where a quorum is present. A majority vote of the Directors present and voting at the meeting is required to approve the proposed revisions or new policy/procedure language. A motion will be recorded in the minutes of the board meeting that establishes the basis for the new policy or for the change in an existing policy/procedure that was felt to be necessary. Such a record will assist future boards in understanding the reason for the action.

The Association Board shall provide written notice to the members/residents of any proposed change to a policy or procedure at least 30 calendar days after it was approved for such purpose at a board study session. The notice shall include the text of the change, by underlining new language and striking through deleted language. The notice will request member/resident comment(s) on the proposed change(s). Included in the notice will be the date and time of the open board meeting at which the Association Board will formally consider the proposed change(s), only after considering oral and/or written comments from members/residents.

Delivery of the above notice may be made to the members/residents by one or more of the following methods: Personal delivery, mail, The Villager newspaper, or as provided for in the Association's governing documents or California Civil Code.

Responses to the proposed change(s) may be made by one or more of the following methods:

1. Participation in the discussion at the Association Board's open board meeting at which the proposed change will be considered.

2. Via e-mail with comments sent to the Association Board at least seven (7) days prior to the Association Board's open board meeting.

3. Via written comments addressed to the Association Board and delivered to Building A at least seven (7) days prior to the Association's Board's open meeting.

A new policy statement will have the header "Association Policy" and will generally contain the following elements:

**TITLE** – the title of the policy.

• POLICY NUMBER – a number identifying the policy. The format is APo nnn, where APo signifies an Association Policy and nnn is a three-digit number.

OBJECTIVE – what is to be accomplished by the policy

 GOVERNING DOCUMENTS / LEGAL REQUIREMENTS – references to any governing or legal documents which require or pertain to the policy. POLICY – the policy statement itself.

LIMITATIONS – any specific limitations in or pertaining to the policy.

Dealer has 1 or more possible losers in Spades, at least 1 in Hearts, maybe 1 in Diamonds, and 1 or 2 in Clubs. Strategy: Before pulling trumps, need to trump a Club loser in dummy.

West leads the 2 of Clubs, Queen; East covers with the King, switches to a Diamond, South low, West, the Queen, and South wins with the King on the board. He plays a Heart, finesses the King, follows with a Club, and trumps it on the board. He shifts to a Spade, finesses the Queen, West takes the trick with the King, leads the Jack of Hearts, Queen, and East, the Ace. He plays a Diamond, South, the Ace, follows with the Ace of Spades, then leads the 6 of Diamonds, covers with the Jack on the board. He then plays a Heart, trumps it in his hand, leads a Diamond, West trumps, follows with a Club, and South claims because his last two cards are Spades. Well done! The contract is made exactly. East/ West took four tricks, the two Aces and two tricks in Spades. Another scenario is if East had led a Spade after winning the first trick with the Ace of Clubs, then South would still finesse the Queen of Spades. West wins with the King and still plays a Heart. South will be able to get in with a red suit while dummy still has a Spade and trump his losing Club. It is often a good idea when dummy has a singleton in a suit to lead a trump after getting the lead. This will prevent the dealer from using trumps to get rid of his losers in the suit. In this contract, however, it doesn't make a difference. By the way, East and South are aware they are not vulnerable and take the chance to bid higher with fewer points.



## Homeowners' Operating Financial Commentary

### For the month of January 2019

January Operating Statement Review: Revenue tracked budget at \$3,263 (non-Estates single family homes). Expenditures for the month were \$112 favorable to budget due to less than planned legal fees of \$112. The year-to-date net positive operating budget variance is \$773 (legal fee expense).

Estates revenue for the month was on budget at \$12,319. Expenditures were \$340 favorable to budget, 3.7 percent less than the budget of \$9,088. All expenditure categories were close to budget for the month of January. The year-to-date net positive operating budget variance is \$1,651 due to favorable planting and pest control expense, offset by unfavorable water expense.

## Association/Homeowners documents available via e-mail

#### **By Julia Meadows**

Per an amendment to California Civil Code, homeowner associations are permitted, with owner's written consent, to distribute annual disclosures, (like the pro forma budget summary) and other specified association documents to owners via electronic mail, facsimile, or other electronic means (such as posting on the association's website) instead of sending those documents out by regular mail or personal delivery. This has the potential to provide cost savings to The Villages. Delivery and postage costs for the Villages' annual distribution of the pro forma budget summary alone are close to \$1,000, not to mention the paper and printing costs that run about \$8,000.

In order to transmit association documents via e-mail or by posting on the homeowners association's website, 1) the homeowners association must first receive the owner's written consent, and 2) the homeowners association sends a separate notice to the owner that the documents have been posted and are available for viewing.

·IMPLEMENTATION PROCEDURES - procedures by which the policy is to be implemented. Not all policies will require Implementation Procedures. If the Implementation Procedure is reasonably short, it can be included on the page with the other policy elements. If it is not, it should be included on one or more pages with the header "Association Procedure" and given a PROCEDURE NUMBER of the form APr nnn, where APr signifies an Association Procedure and nnn is the same three-digit number as the associated policy.

Formatting Requirements: New or revised policies should conform to the following document formatting rules.

1. This APo101 will serve as the reference document for formatting standards for APo and APr documents. When not otherwise specified, the layout, fonts, and font size, and character style (e.g. bold, italic, normal) should match the composition of this document.

2. Standard font type, size, and style:

- a. Headers: Font "Arial", size 12pts, normal
- b. Footers: Font "Arial", size 10pts, normal
- "TITLE:": Font "Arial", size 14pts, bold
- d. TITLE text: Font "Arial", size 14pts, normal
- e. "POLICY NUMBER:": Font "Arial", size 14pts, bold
- f. POLICY NUMBER text: Font "Arial", size 14pts, normal
- g. "CATEGORY:": Font "Arial", size 12pts, bold
- h. CATEGORY text: Font "Arial", size 12pts, normal i. "DATE OF ADOPTION" and "DATE OF REVISION":
- Font "Arial", size 12pts, BOLD j. Dates of Adoption or Revision: : Font "Arial", size 12pts, normal
- k. Section Titles (e.g. "OBJECTIVE:", "GOVERNING DOCUMENTS/LEGAL REQUIREMENTS:", "POLICY:", "PURPOSE:": : Font "Arial", size 12pts, bold
- I. Section body text: Font "Arial", size 12pts, normal (may also use bold or underlining for emphasis). m. Lists: Lists should use the format "number" "period" with second level entries "lower case letter" "period", and third level entries as "number" ")" (e.g.1. a. 1)), paragraphs are separated by 5pts.
- n. Alignment: text should generally be "justified", but "left alignment" may be used if needed for better appearance.
- o. Page numbering: All pages should be numbered in the right side of the Footer as "Page x of y", where "x" is the current page number and "y" is the total number of pages in the document.

3. When new or revised Policies are submitted for consideration all proposed changes should be tracked and highlighted. Deletions are tracked by strikethrough and text color set to red, and additions tracked by underling and text color set to blue. When a revised policy is accepted then the revisions are "accepted" and the markings and highlighting is removed leaving just the new content, and the adoption or revision date is set to the date on which the policy was approved by the Association Board of Directors.




