
Forgetting to follow the Pulse guidelines may result in your letter being delayed.

## *The Villages Golf and Country Club Notice of Emergency Rule Change to Rule 1.53 Disorderly Conduct*

Under the authority of Attachment D to the Club Rules, "If the Board determines that an immediate rule change is required to address an imminent threat to public health or safety or an imminent risk of substantial financial loss to the Club, it may make an emergency rule change. No previous notice is required."

At the May 14, 2019, Club Board of Directors study session, the Board approved an emergency rule change, effective immediately, to Rule 1.53 Disorderly Conduct. The purpose of this change is to safeguard employee and resident safety, and provide a safe work and living environment when a resident has threatened or intimidated employees or residents, or committed an act constituting a crime, pending a Board hearing.

This emergency rule change will expire on December 10, 2019, unless modified through the regular rule changes provisions.

Note: Deleted items are in ~~strike through~~ font, inserted items are in underlined font.

### **RULE 1.53 Disorderly Conduct**

Any individual or group, including all non-residents, while on The Villages Club property will abide by normally accepted standards of behavior; e.g. abusive, unruly, intimidating, or disruptive behavior, is or any threatening statement or action, are not permitted. Violations of the Rule, at the discretion of the General Manager or his or her designees, may be dealt with immediately and could include removal from any Club facility or, in the case of non-residents, removal from The Villages premises. Any violation of this Rule should be immediately reported to Public Safety unless there is a compelling reason to call 911.

If the Board, or the General Manager or his or her designees, reasonably believes that a person's alleged rule violation may recur, and presents a risk of intimidation, abuse, threat, or property loss or damage, to residents and/or employees, the Board, or the General Manager or his or her designees, may immediately suspend any or all of the person's rights to use or enter the Club's recreational and other facilities, including Club business offices, pending a hearing by the Club Board. The General Manager shall immediately notify the Club Board of his or her actions.

## *Emergency Preparedness Committee—Neighbors Helping Neighbors*

**A tip for all homeowners who have a water heater (not a tankless one).**

The installation of all water heaters must comply with the local San Jose permit process and the Federal minimum Energy Factor standards. Those that meet the exact minimum shall be externally wrapped with insulation. The first 5 feet of hot and cold water pipes from the water heater must be insulated. In addition, a properly installed water heater must be raised at least 12 inches off the ground and have two earthquake straps (located on the top and bottom thirds of the tank). Finally, all interior water heaters must be properly vented. The size of the vent corresponds to the size of the water heater. These are some of the requirements associated with the proper installation of a water heater. If you have any questions concerning your own water heater, please consult with a licensed plumber.

## Club and Association Boards met for regularly scheduled May meetings

The Villages Association and Club Boards of Directors met Tuesday, May 28 for their regularly scheduled meetings in Foothill Center. Numerous items of business were discussed and voted upon.

### Association Operating Financial Commentary

For the month of April 2019

**April Operating Statement Review:** Revenue was \$1,100 favorable to the budget of \$718,500 for the month due to higher than planned laundry concession fees and third-party assessments.

Expenditures for the month were \$128,600 (19.7 percent) unfavorable to the budget of \$651,400. The most significant unfavorable-to-budget expense category was insurance with a \$76,800 negative budget variance (\$183,000 spent vs. budget of \$106,200) due to the property insurance premium renewal that became effective on March 1 at much higher rates. Other notable unfavorable to budget expense categories were water expense (\$28,900 higher than budget of \$111,300) and repair and maintenance (\$13,000 higher than budget of \$25,200). Additionally, irrigation maintenance and planting expense combined for a \$9,000 negative budget variance due to timing. All other expense lines tracked fairly close to budget. **The net negative operating budget variance for the month of April was \$127,500.**

Year-to-date (ten months of operations), total revenue is \$1,300 favorable to the budget of \$7,191,400 due to higher than planned third-party assessments and golf cart electricity fees, offset by less than planned laundry concession fees. Year-to-date, total operating expenditures are \$6,969,200, coming in 1.7 percent higher (\$119,300) than the budget of \$6,849,900. The negative budget variance can be attributed to insurance expense at \$164,100 more than the budget of \$1,010,000, as discussed above. **The year-to-date net negative operating budget variance is \$118,000.**

### Club Operating Financial Commentary

For the month of April 2019

**April Operating Statement Review:** Total revenue was \$1,200 unfavorable to budget, 0.1 percent less than the budget of \$1,187,700. Food sales had a banner month performing \$22,600 higher than the budget of \$198,400. Nearly 500 Villagers and family members enjoyed Easter Brunch at the Clubhouse this year. Bar sales were short of budget by \$8,600 (15.5 percent). Green fees were \$7,200 below the budget of \$124,200 (down 5.8 percent) with decent weather but enough rainy days to hinder golf play. Resident activities showed a negative budget variance of \$11,200 due to timing (offset with lower expense). All other revenue lines tracked fairly close to budget.

Total expenditures were \$15,600 unfavorable to budget or 1.4 percent more than the budget of \$1,136,800. The most significant unfavorable to budget expense category was water expense (\$67,200 actual vs. budget of \$47,700). Other notable unfavorable expense categories were professional fees (\$28,300 actual vs. budget of \$14,000) due to the timing of 401(k) plan administration fees and HR consultant (offset in lower employee expense). The most significant favorable to budget expense category was employee expense with a \$21,200 positive budget variance (\$678,900 actual vs. budget of \$700,100). Food cost got back on track at 30.7 percent due to the high volume of banquet sales. The Spring Bash event, sponsored by the Community Activities Department, was not only a joyous celebration, but also contributed nearly \$4,000 net profit in April. **The net negative operating budget variance for the month of April was \$16,800. See table below.**

Year-to-date revenue is \$21,000 unfavorable to budget, 1.8 percent less than the budget of \$11,304,000. Year-to-date expenditures are \$182,000 (1.6 percent) favorable to the budget of \$11,148,000. **The year-to-date net positive budget variance is \$161,000.** See table on the next page for detail by department.

Significant favorable to budget expenditure categories for April were water, planting expense and pest control expense. **The year-to-date net positive operating budget variance is \$10,439 mostly due to favorable planting expense, pest control expense, water and legal fees, offset by unfavorable electricity expense.**

**Saturday, June 15:** Rich Bainbridge will lead a hike up our hill starting from Foothill center, route and distance to be determined by weather and hikers.

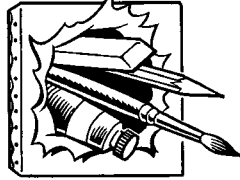

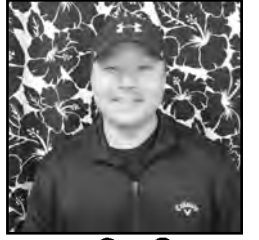

Your donation is for a very good cause as it goes toward education and maintaining this historical vessel for events such as ours. Once aboard the USS Potomac we will enjoy a three-hour cruise on the Bay and an air show. We will enjoy sandwiches, fruit, chips, dessert, soft drinks, coffee, tea or bottled water, and there is a hosted wine bar aboard the Potomac.

We will arrive by 12:15 p.m. at Jack London Square where the Potomac is docked. Enjoy the Farmer's Market, shops, bookstore, antiques, novelty stores and much more. Any purchases made may be left at the Potomac's Visitor Center during our cruise and picked up prior to leaving that day (bring a pen to mark your bag.) We board the Potomac by 1:15 p.m. for the sail time of 1:30 p.m. for a three-hour cruise. The Potomac will be positioned underneath the Blue Angels' flight pattern for this awesome show.

The USS Potomac was originally built in 1934 as the Coast Guard cutter Electra, and converted to the presidential yacht in 1936 by President Franklin D. Roosevelt, who had her re-commissioned as a U.S. Navy vessel. After the President's death in April 1945, the USS Potomac began a long and ignominious decline from her former role in world affairs. Falling into private hands and later seized in San Francisco Bay as a front for a drug-smuggling operation in 1980, the proud vessel's hull was pierced and she sank at Treasure Island. She was re-floated by the Navy two weeks later and sold by the U.S. Customs to the only bidder, the Port of Oakland, for just \$15,000. The Port of Oakland then spearheaded a cooperative effort with organized labor, maritime corporations and dedicated volunteers to complete a \$5 million restoration. The Association for the Preservation of the Presidential Yacht Potomac now operates this National Historic Landmark as an active memorial to Franklin Delano Roosevelt.

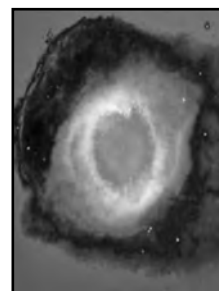

## FROM THE BOOKSHELF

**“The Chef” by James Patterson and Max DiLallo:** In the Carnival days leading up to Mardi Gras, Detective Caleb Rooney comes under investigation for a murder in the line of duty as a Major Crimes investigator for the New Orleans Police Department. Has his sideline at the Killer Chef food truck given him a taste for murder? While fighting the charges against him, Rooney makes a pair of unthinkable discoveries. His beloved city is under threat of attack and the would-be terrorists may be local. As crowds of revelers gather, Rooney follows a trail of clues, racing from outlying districts into the city center. He has no idea what or who he will face in defense of his beloved hometown, only that innocent lives are at stake. Mystery 2019.

**“The Border” by Don Winslow:** For over 40 years, Art Keller has been on the front lines of America’s longest conflict—the War on Drugs. His obsession to defeat the world’s most powerful, wealthy, and lethal kingpin—the godfather of the Sinaloa Cartel, Adán Barrera—has left him bloody and scarred. Now Keller is elevated to the highest ranks of the DEA, only to find that in destroying one monster he has created 30 more who are wreaking chaos and suffering. Barrera’s final legacy is the heroin epidemic scourging America. Keller finds himself surrounded by enemies—men who want to kill him, politicians who want to destroy him, and an incoming administration in bed with the drug traffickers Keller is trying to bring down. He is at war with not only the cartels, but with his own government. Fiction 2019.

**“True Places” by Sonja Yoerg:** A girl emerges from the woods, starved, ill, and alone—and collapses. Suzanne Blakemore hurtles along the Blue Ridge Parkway, away from her overscheduled and completely normal life, and encounters the girl. Suzanne has the perfect house, a successful husband, and a thriving family. But beneath the veneer of an ideal life, her daughter is rebelling, her son is withdrawing, her husband is oblivious to it all, and Suzanne is increasingly unsure of her place in the world. Suzanne invites the girl, Iris, into her family’s life and all its apparent privileges. But Iris has an independence, a love of solitude, and a discomfort with materialism that contrasts with everything the Blakemores stand for—qualities that awaken in Suzanne first a fascination, then a longing. Now Suzanne can’t help but wonder if she is destined to save Iris, or if Iris is the one who will save her. Fiction 2019.

**“The Banker’s Wife” by Cristina Alger:** A couple boards a private plane bound for Geneva, flying into a storm, and its wreckage is later uncovered in the Alps. Among the lost is Matthew Werner, a banking insider at Swiss United, a powerful offshore bank. His widow, Annabel, is left grappling with the secrets he left behind, including an encrypted laptop and a shady client list. As she begins a search for answers, she discovers Matthew’s death was no accident, and that she is now in the crosshairs of his powerful enemies. Meanwhile, ambitious society journalist Marina Tourneau is now engaged to Grant Ellis; she can stop writing about powerful families and finally be a part of one. But after the death of her mentor, she agrees to dig into one more story. While looking into Swiss United, Marina uncovers information that implicates some of the most powerful men in the financial world, including a few who are too close to home. Fiction 2018.

**“The Last Woman in the Forest” by Diane Les Becquets:** Marian Engström has found her true calling, working with rescue dogs to help protect endangered wildlife. Her first assignment takes her to northern Alberta, where she falls in love with her mentor, the daring and brilliant Tate. After they are separated from each other on another assignment, Marian is shattered to learn of Tate’s tragic death. Worse still is the aftermath in which Marian discovers disturbing inconsistencies about Tate’s life, and begins to wonder if the man she loved could have been responsible for the unsolved murders of at least four women. Hoping to clear Tate’s name, Marian reaches out to a retired forensic profiler who is haunted by the open cases. But as Marian relives her relationship with Tate and circles ever closer to the truth, evil stalks her every move. Fiction 2019.

## June Art Film: ‘Robert Motherwell & The New York School’

On Tuesday, June 11 at 7 p.m. in the Vineyard Center, the Villages Arts and Crafts Association will present Catherine Tatge’s “Robert Motherwell & the New York School: Storming the Citadel.” This film covers a period of art history that is within our own lifetimes. Most of us can recognize the names Duchamp, Pollock, de Kooning and Rothko but how many know of Robert Motherwell? His story begins on the Pacific coast, reaches its greatest moments in New York City (NYC) and ends in Provincetown, Massachusetts. One critic said his color palette was based on the color of California summers, ochre for the hills and the blue of a San Francisco sky. But this story is also about the New York School, a group of American artists and artists fleeing WWII Europe who created a community between 14th Street and Washington Square in NYC. The American Abstract Expressionist movement’s primary spokesperson was Motherwell. He pulled together artists around the defining philosophy and the Guggenheim support. This put NYC at the center of Western art after Paris fell, and Motherwell at NYC’s art center.

His story runs through the halls of Stanford and Harvard, and Columbia University where his academic career redirected into painting. Along the way, his interests were influenced by Southwestern Native American artists, Duchamp, Kerouac, Jungian analysis, and much more.

The best part of this film is that Robert Motherwell, a true public intellectual, narrates his own story.

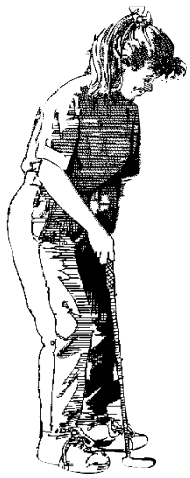

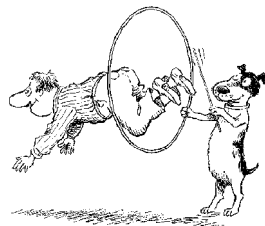

## Help Us Keep Your Vote a Secret

By Claudia Evans Nicolai

Do you wonder if your vote is really a secret? If so, you're not alone. Some Villagers do not fully understand our two-envelope secret ballot system, so here are some answers.

The Villages' elections are governed by California Civil Code requiring our voting system to safeguard the privacy of our residents' votes.

Three Election Inspectors, Vera Buescher, Jeanne Filice and Claudia Nicolai, have been appointed by The Villages Association, Homeowners and Club Boards of Directors.

Once your ballot is placed in a locked ballot box, it is kept under lock-and-key at all times. Only the Election Inspectors have access to the ballot boxes.

The Inspectors remove and sort the ballot envelopes according to color (blue for Association, green for Homeowners, and buff for Club).

The bar codes are scanned, which registers and validates that the envelope was received from a member in good standing who is eligible to vote. The bar code must remain intact for the ballot to be valid.

Following registration, the barcoded envelope is opened and the secret envelope is removed. Barcoded envelopes are sent to storage while secret envelopes are bundled for counting.

On counting day, only the secret envelopes are given to the Tellers for counting. These envelopes contain no names, bar codes or other identifying marks. They remain sealed and under lock-and-key until the Inspectors and Tellers meet at an open Board of Directors meeting to begin the counting process.

This entire process is in accordance with California Civil Code.

The counting process is closely directed and monitored by the Election Inspectors. All ballots are counted by two different Teller teams to ensure accuracy.

The Inspectors present the election results to the Boards of Directors at the annual membership meeting on June 12. Mark your calendar now and plan to attend!

Villagers can rest assured that the Election Inspectors follow the Civil Code for every election so your vote remains a secret. You can help us keep your vote valid and a secret by carefully following the instructions included with your ballot package.

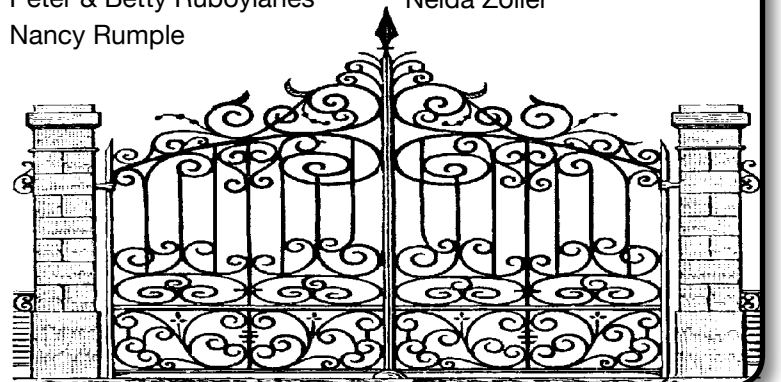

*Are your assets in your Trust?*

Recently, a Villager sold his vacation home and received a hefty check from the title company. He took it down to his primary bank and the bank refused to accept the check for deposit to his account. In a huff, he took it to a credit union where he has another account. Again, the deposit was refused.

Why would financial institutions refuse a deposit? It was refused because the check was made out to the Villager's Living Trust and both bank accounts are in his name alone – not the name of his Living Trust.

The Villager took the check back to the Title Company and demanded a new check made out to him personally. The Title Company refused because the deed to the vacation home had been in the name of the Trust – i.e. the Trust had been the owner of the property and was the seller.

SRS inquired what property the Villager had put into the Trust and got a blank stare. His Living Trust provisions apply only to property which is actually owned by his Trust. His attorney had changed the deed for his condo and his vacation home making the Living Trust the owner. Along with the Trust document, we discovered the attorney had included written instructions to the Villager about changing the title to his brokerage and other financial accounts. He meant to follow the instructions, but never got around to doing it.

If you have paid to create a Living Trust, have you followed through and made sure your financial assets are in your Trust? If you can answer "Yes," great job.

If you haven't gotten around to doing it, what does all this mean for you?

Under current California Probate law, if the total of real and personal property (not including motor vehicles, motor homes, and certain other items) owned by an individual is more than \$150,000, then a Probate proceeding is required in order to pass one's estate to heirs after death. We were told his savings accounts and stock accounts amounted to more than \$1,000,000. Unless ownership of these assets is transferred to the Trust while he is still alive, part of his estate will have to go through Probate.

Remember, one of the purposes of creating a Living Trust is to simplify and avoid the cost and difficulties of probate for your heirs. In our Villager's case, if he does not move his assets into the trust, upon his death there will be two tax entities created: a Trust for the real estate and a probate Estate for the brokerage and bank accounts. This will require two tax identification numbers and two 1041 income tax returns.

Remember the old Doublemint Gun jingle? Double your pleasure, double your fun. The tax and legal people will go around singing "Double the clients, double the fees." You don't want that to happen to your estate.

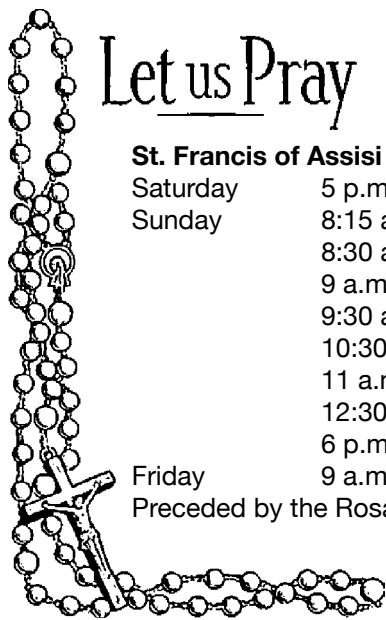

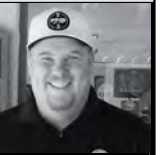

**Ropes Removed**—You might have noticed that we have removed the ropes from in front of the green complexes. You're welcome, ha ha. *But*, this does not give golfers the liberty to drive their carts to the green edge or fringe. The ropes were an indicator of where we want cart traffic to stop around the greens, so we ask that you still keep your carts away from the perimeter of the greens. Think of the greenside bunkers as the stopping point, and please keep your cart on the outside perimeter of the greenside bunkers. We all want the best playing conditions possible on the golf course, and keeping cart traffic away from the greens goes a long way toward great playing conditions. If golfers break this rule continually, the turf around our greens will suffer, and so will course conditions. Let's all maintain that private club mentality and do our part to keep our golf course pristine, which is what we all want anyway. Thank you!

We will continue trimming tree canopies on the golf course to allow more sunlight on the course fairways and rough and to eliminate potential and dangerous limbs or trees falling.

The golf course landscaping areas are all being upgraded over the next four weeks. We will remove all the wooden dowels and add new fresh bark and landscaping plants and rocks to these areas. Some areas will also have nice borders installed around the landscaping. This will create a consistent and clean look to all of our landscaping on the golf course.

### Tips from the Pro – Scott Steele

#### 3 Yardages to know...

We carry 14 clubs, which can make club selection confusing at times. Knowing these three yardages and clubs will help a lot!

**Your 150 Yard Club.** In addition to being one of the most common approach shot yardages on par 4's this can also be an extremely common yardage on many par 3 tee shots. Most golfers will find their 150 yard club in their mid-irons (6, 7, or 8) but with many of today's new combo sets you may also find your 150 yard club to be a hybrid.

**Your 100 Yard Club.** This is where some serious shot making happens, and if you aren't comfortable with a wedge or short iron that travels 100 yards your scorecard is going to suffer. If you aren't able to find a good 100-yard club in your current set talk to your Pro Shop staff and find out if you can demo some wedges in different lofts. You're looking for a club that will travel 100 yards on the fly with a nice easy, controlled swing.

**Your 200 Yard Club.** Whether it's your driver, your 3-wood, or a trusty hybrid getting familiar with a club in your bag that can constantly travel over 200 yards is a must if you want to take your game to the next level. Just think—3 shots with this club and you'll be on the green in regulation on a 600 yard par 5!

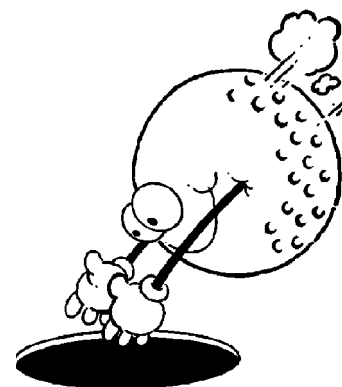

Given the growing threat of extreme weather, we want all of our customers to be prepared for power outages. If extreme fire danger conditions threaten a portion of the electric system serving your community, it will be necessary for us to turn off electricity in the interest of public safety. This is called a Public Safety Power Shutoff.

### What you need to know about Public Safety Power Shutoff:

- Before any Public Safety Power Shutoff, we carefully review a combination of criteria such as predictions of strong winds and very low humidity levels, along with critically dry vegetation and on-the-ground observations from field crews.

- When we need to turn off your power, we will attempt to contact you in advance by phone, text and email, and provide updates through social media, local news, radio and the pge.com website.

- Because the energy system relies on power lines working together to provide electricity across cities, counties and regions, **your power may be shut off, even if you do not live or work in an area experiencing high winds or other extreme weather conditions.** This is done for the safety of all communities and customers.

- We expect to be able to visually inspect the system for damage and restore power to most of our customers within 24 to 48 hours after extreme weather has passed. Because extreme weather can last several hours or days, for planning purposes, **we suggest customers prepare for outages that could last longer than 48 hours.**

### How to better prepare

We know how much our customers rely on electric service and want to work together to help you prepare for power outages related to extreme weather and wildfire threats. Here are some important steps you can take today:

### Update your contact information

Visit [pge.com/mywildfirealerts](http://pge.com/mywildfirealerts) or call 1-866-743-6589 during normal business hours. We will use this information to alert you through automated calls, texts and emails, when and where possible, prior to a Public Safety Power Shutoff.

### More helpful tips:

- Plan for medical needs like medications that require refrigeration or devices that need power.
- Identify backup charging methods for phones and keep hard copies of emergency numbers.
- Build or restock your emergency kit with flashlights, fresh batteries, first aid supplies and cash.
- Know how to manually open your garage door.

- Remove all plastic and packaging from cardboard containers and dispose of properly (garbage).
- Flatten cardboard (release all seams so cardboard lays flat)
- Place inside white recycle dumpster or blue recycle carts (as applicable)

### Medium to large sized cardboard (in smaller quantities) – Flatten and place beside the green garbage dumpster or blue recycle carts (as applicable) inside the trash enclosure

Items such as small appliance and furniture boxes, small moving boxes, etc.

- Remove all plastic from cardboard containers and dispose of properly (garbage).
- Flatten cardboard (release all seams so cardboard lays flat)
- Place neatly beside the green garbage dumpster or blue recycle carts (as applicable)

\*Curb side garbage and recycling pick up: Cardboard must be flattened and bundled and placed next to the recycle cart.

Dealer has at least 2 heart losers and dummy's doubleton makes it possible to trump the last heart in his hand. Strategy: Since the hands are distributional, immediately take out trumps.

West leads the Ace of Hearts, East plays the 6 showing, hopefully, an honor in the suit. West continues with a low heart, East wins with the King, and switches to a spade. South wins with the King, plays the Queen of Clubs, then leads a diamond to the Ace on the board, continues with a diamond, and trumps it in his hand. He then plays his last heart, trumps it on the board and claims since all his remaining cards in his hand are trumps. Great, the contract is made exactly. The challenge in this deal is not the play so much as to bid game in clubs. Since West had originally bid hearts, a game in NoTrump would present difficulties since North/South have no stoppers in hearts. It turns out that 2 NoTrump can be made because the opponents can only take 5 tricks in hearts. If West does not lead a heart for some reason, then South has a possibility of making 6 due to the King of Diamonds being in West's hand.

\* This is a preemptive bid, normally showing 7 cards in a suit at the 3 level unless it is clubs. Then it could be as few as 6 cards. The preemptive bid at the 2 level or at the 3 level shows 6 - 10 HCP.

^ North has a great hand 18 HCP plus having 4 clubs with the top 2 honors, and these factors make game in clubs a good possibility.
