#### Notice of Proposed Changes to Association Policy APr 103-01Board and Member Meetings

The following proposed changes to The Villages Association <u>Policy APr 103-01 Board and Member Meetings</u> were conditionally approved by the Association Board of Directors at a Special Open meeting held October 15, 2019. The purpose of the policy change is to schedule study sessions as needed.

Before formal approval consideration, the proposed changes must be noticed and published 30 days as required by California Civil Code 4360 and Association Policy APo 101. To that end, the proposed changes will be considered for formal approval at the December 10, 2019, board meeting. The Board will consider oral and written comments regarding the proposed changes at the November 12 and December 10 board meetings. Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the proposed changes at the Association Board of Directors board meetings, or 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at mehernandez@the-villages.com.

Deletions are noted in strikethrough font, additions are <u>underlined</u>, and the purpose of the change is in *italics*.

#### Study Sessions

Regular monthly study sessions will be scheduled immediately preceding the monthly Board meeting. Additional study sessions may be called as needed. Study sessions will be called as needed.

Study sessions will be called as needed. A study session may be called as needed. A study session may be called by the President of the Association Board (Board) to discuss items of interest to the Board, Management or Members. In addition, two Board Members or the General Manager may request that the President call a study session. Upon that request, the President must call a study session within 14 days.

Except in the case of an emergency meeting or Executive Session meeting, notice of the time and place of a Board meeting including agenda items shall be posted at Cribari Center and via Fast Lane at least four (4) days in advance of the meeting and may also be posted on community television, and published in *The Villager*.

The purpose of the study session is to allow a topic to be studied by the Board in open session, prior to a formal decision being made at the monthly board meeting. Formal Board decisions will not normally be made at the study session, unless timing is such that a decision must be made. Rather, agenda items the Board deems appropriate will be brought back to the formal board meeting for consideration.

The President of the Board at his/her discretion shall conduct the meeting, dispensing with the normal formalities of the board meeting following the order of the agenda, which was published four days in advance of the study session. The President at his/her discretion may limit resident participation during the discussion of agenda items. An opportunity will be provided for audience members to address the Board

An opportunity will be provided for audience members to address the Board on any Association-related matter. The time allotted to each speaker will be determined by the Chair. The Chair has sole discretion to permit response to questions and opinions.

#### Notice of Rule Change to Villages Homeowners' Corporation Architectural Control <u>Rule 3.7.6 Property Maintenance</u>

At the October 9, 2019, quarterly meeting, the Board approved the following change to <u>Rule 3.7.6 Property Maintenance</u>. The purpose of the change is to include fire fuel reduction maintenance.

New rules document to be distributed to single-family homeowners in November.

Additions are underlined

#### 3.7.6 PROPERTY MAINTENANCE:

Homeowners must maintain their home and landscaping in a manner that presents a neat and attractive appearance. <u>Owner is required to maintain the</u> fire fuel reduction program (defensible space) as developed by the State Board of Forestry, and California Department of Forestry. General guidelines for fuel control are identified in pages four through eight in the Guidelines document. The ACC may cite a homeowner for failing to meet this standard. If the situation is not corrected within a reasonable time the ACC will refer the matter to the HOC Board for their action.

Maintenance involving repair or replacement of home exteriors and landscaping that are of the same material, dimension and color as the original do require an Alteration Request. The ACC may revoke the administrative fee if no alteration is completed.

## Club and Association Boards met for regularly scheduled October meetings

The Villages Association and Club Boards of Directors met Tuesday, October 29 for their regularly scheduled meetings in Foothill Center. Numerous items of business were discussed and voted upon.

#### Association Operating Financial Commentary For the month of September 2019

September Operating Statement Review: Revenue was \$400 unfavorable to the budget of \$855,500 for the month, mostly due to less than planned third party assessments.

Expenditures for the month were \$27,000 (3.1 percent) favorable to the budget of \$875,500. The most significant favorable to budget expense category was planting with a \$22,700 positive budget variance (\$2,600 actual vs. budget of \$25,300) due to timing. Also favorable to budget was repair and maintenance (\$19,100 actual vs. budget of \$22,400) and electricity expense (\$11,800 actual vs. budget of \$13,300). The only significant unfavorable to budget expense category was pest control (\$11,900 actual vs. budget of \$8,500). Professional fees totaling \$750 were incurred for services needed for the bi-annual FHA recertification process for the Association. The net <u>positive</u> operating budget variance for the month of September was \$26,600.

Year-to-date (three months of operations), total revenue is \$1,900 unfavorable to the budget of \$2,567,300 due to less than planned laundry concession fees, third party assessments and golf cart electricity and storage fees. Year-to-date, total operating expenditures are \$2,814,600 or 0.8 percent higher than the budget of \$2,792,900. The negative budget variance can be attributed to water expense that is \$33,500 or 3.9 percent higher than the budget of \$864,900, as well as irrigation maintenance expense that is \$29,500 or 57 percent higher than the YTD budget of \$1,800. Planting expense is favorable to budget by \$24,200 (due to timing) and helps offset the negative budget variance.

The year-to-date net negative operating budget variance is \$23,700.

Association Board Voting Record for October 2019

#### Club Operating Financial Commentary For the month of September 2019

September Operating Statement Review: Total revenue was \$13,600 favorable to budget, or 1.1 percent higher than the budget of \$1,185,100. The most significant favorable to budget revenue category was directory income coming in \$14,900 (78 percent) higher than the budget of \$19,000, partially due to timning. Also favorable to budget was food sales, 5.6 percent higher than the budget of \$175,500. Guest room rentals surpassed the budget by \$5,000 (actual \$12,000 vs. budget of \$7,000). Green fees were higher than the budget (by \$2,100 or 1.9 percent) due to strong guest play, although member 18-hole rounds were down compared to last September. The most notable unfavorable to budget or \$21,500) due to timing.

Total expenditures were \$58,900 favorable to budget or 5.1 percent lower than the budget of \$1,159,300. The most significant favorable to budget expense category was electricity with a \$27,400 positive budget variance (actual -\$9,000 vs. budget of \$18,400). We received a refund from PG&E in the amount of \$25,800 due to a retroactive favorable rate change correction (from December 2016 to September 2018) at Cribari Center, Vineyard Center and the Pro Shop. Employee expense was also favorable to budget by \$17,400 (actual \$678,900 vs. budget of \$696,300). Other notable expense categories favorable to budget (both due to timing) were tree trimming (actual \$3,800 vs. budget of \$9,700) and resident activities expense (\$15,000 actual vs. budget of \$25,700). The most significant unfavorable to budget expense category was legal fees (\$12,700 actual vs. budget of \$1,800). The net <u>positive</u> operating budget variance for the month of **September was \$72,500. See table below.**

The bottom of the table below shows the financial impact of the monthly solar lease payments and contribution to the balloon payment fund (to be paid in 2023) captured on the Club's balance sheet. The YTD total for these two items is \$57,000.

### PG&E's Energy Savings Assistance Program

Improving the energy efficiency of your home can significantly reduce your energy bills. However, PG&E realizes you might not be able to afford energy improvements to your home. If you qualify as a low-income customer, you may be able to receive some free improvements.

Energy-saving measures through the Energy Savings Assistance Program can include installing insulation, caulking and even repairing or replacing your refrigerator. Qualification is based on two things: 1) the number of persons living in your home and 2) the

total annual household income. The total gross annual income (based on the number of household members) must be at or below the amount shown below:

Household Size Income \$33,820 \$42,660 1 or 2 3

PG&E defines income as money from all household members and from any source including non-taxable as well as taxable income sources. Social security benefits, pensions, disability pay ments and unemployment benefits are some examples of income.

The application starts with your PG&E Account Number as shown on your PG&E bill. You must indicate your total annual household income, but you do not submit proof at the time of application. The other information is simply your name, address and other straightforward information. An SRS office volunteer can complete the online application for you at your direction. Remember, bring your PG&E bill with you to show your Account Number.

After your application has been reviewed, an energy specialist will contact you to schedule an assessment of your home. During the visit you will then need to provide proof of your household income such as social security statements, bank statements or your last tax return. Please note the energy specialist will likely be a contractor hired by PG&E rather than a PG&E employee.

Caution: Some scammers pose as subcontractors for PG&E. Do not start this process by re-sponding to a cold call from a contractor firm. Start by applying to PG&E for the program. Energy Savings Assistance Program subcontractor employees wear a royal blue shirt with ESA logo on right breast and subcontractor company logo on left breast with words, "Participating Contractor for Pacific Gas and Electric Company." Central Inspection Program inspectors wear dark blue shirts with a PG&E logo and carry a PG&E ID. PG&E Gas Service Representatives wear PG&E uniforms and carry a PG&E ID. If in doubt of a subcontractor's identity, please call 1-800-933-9555. If in doubt of a PG&E employee's identity, please call PG&E at 1-800-PGE-5000 (1-800-743-5000).

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave age at 408-239-5253. The purpose of SRS is to provide education and general business and financial informa tion. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

## FROM THE BOOKSHELF

"The Last Guest House" by Megan Miranda: Littleport, Maine has always felt like two separate towns: an ideal vacation enclave for the wealthy and a simple harbor community for yearround residents. Friendships almost never develop between the two, but that's just what happens with visitor Sadie Loman and Littleport resident Avery Greer. Each summer for almost a decade, the girls are inseparable until Sadie is found dead. While the police rule the death a suicide, Avery feels that some in the community, including a local detective and Sadie's brother. Parker, blame her, Someone knows more than they're saving. and Avery is intent on clearing her name before the facts get twisted against her. Mystery, 2019.

"Inland" by Tea Obreht: In the lawless, drought-ridden lands of the Arizona Territory in 1893, two extraordinary lives collide. Nora is an unflinching frontierswoman waiting for the return of the men in her life-her husband, who has gone in search of water for the parched household, and her elder sons, who have vanished after an explosive argument. Nora is biding her time with her youngest son, who is convinced that a mysterious beast is stalking the land around their home. Lurie is a former outlaw and a man haunted by ghosts. He sees lost souls who want something from him, and he finds reprieve from their longing in an unexpected relationship that inspires a momentous expedition across the West. The way in which Nora's and Lurie's stories intertwine is both surprising and suspenseful. Fiction, 2019.

"The Warning" by James Patterson and Robison Wells: Two roads lead to Mount Hope. None leads out. There's no place to run in a community that's been taken off the grid. A small southern town was evacuated after a freak power plant accident. As the first anniversary of the mishap approaches. some residents are allowed to return past the national guard roadblocks. Mount Hope natives Maggie and Jordan quickly discover their hometown has changed. Downed cellular networks fail to resume service. Animals savagely attack humans. And the damaged power plant, where Jordan's father is an engineer, is under military lockdown. As friends and family morph into terrifying strangers. Maggie and Jordan increasingly turn to each other. Their determination to discover who or what has taken control of Mount Hope soon has them in the cross-hairs of a sinister presence. Mystery, 2019.

"Old Bones" by Douglas Preston and Lincoln Child: Nora Kelly, a curator at the Santa Fe Institute of Archaeology, is approached by historian Clive Benton to lead a team in search of the Lost Camp of the Donner Party. These pioneers earned a place in history when they became snow-bound in the California mountains in 1847, their fate unknown until the first survivors stumbled out of the wilderness, raving about starvation, murder, and cannibalism. Benton has found a victim's diary and Nora agrees to lead an expedition to locate and excavate the camp and reveal its secrets. As they uncover old bones, they expose the real truth of what happened, one that is far more shocking and bizarre than mere cannibalism. When those ancient horrors lead to present-day violence, FBI agent Corrie Swanson is assigned the case, discovering her first investigation could be her last. Mystery and Large Print, 2019.

What Rowan doesn't know is that she's stepping into a nightmare that will end with a child dead and Rowan in prison awaiting trial for murder. Writing to her lawyer, Rowan struggles to explain the unravelling events that have brought her here. Rowan knows she's made mistakes. She admits she lied to obtain the post and that her behavior toward the children wasn't always ideal. She's not innocent, by any means, but she's not guilty of murder. Which means someone else is. Mystery, 2019.

## Senior Academy: 'The Mystery of Infinity'

On Tuesday, November 12 at 7 p.m. in the Vineyard Center, the Villages Arts and Crafts Association will present "Arcimboldo: Nature & Fantasy" (2010), produced by the National Gallery of Art. This will be followed by "Grandma Moses" (1950) from The Museum of Modern Art Library. Both of these artists have a hint of the festive in their work. High Renaissance painter Giuseppe Arcimboldo was a favorite of Hapsburg and Holy Roman Empire rulers Maximillian II and Rudolph III. Arcimboldo poked fun at these high court subjects in his allegorical portraits. Each showed scientifically accurate foods, botanicals, animals, tools and insignia assembled into each person's likeness. He was wildly popular for 35 years until his death and then forgotten. In the 1920s he was rediscovered. Picasso and Salvador Dali were influenced by Arcimboldo's work. In 2011, the Louvre reported his exhibit received the most visitors.

American Primitive painter Grandma Mose speaks for herself, in this one of a kind recorded interview. Anna May Robertson Moses began painting at the age of 78 because her arthritis prevented her from doing farm chores. She painted 1,500 canvasses showing loving scenes of rural farm life.

At the start of your holiday season, we hope Arcimboldo will give you a chuckle and Grandma Moses a smile.

## Ann Ravel to speak on 'The American Experiment'

In 1863, Abraham Lincoln set up the foundation of our great Democracy: Government of the people, by the people, for the people. This was, and still is a lofty goal that has been sorely tested over the intervening years. In particular the coming of age of the Internet has provided tools for the ease of propagation of information.

Digital Deception is now all too easy and "Fake News" has become a divisive rallying cry in attacking Lincoln's goal. But there are many fighting to achieve a government that (actually) works for the people.

Ann Ravel, Director of Maplight's Digital Deception project is a leading light in the development and promotion of policies that tackle online disinformation in politics. She brings a wealth of experience to this project and will be sharing her insights with us on November 15 at 6 p.m. in the Vineyard Center. This event

is sponsored by The Villages Democratic Club and is open to all Villagers and guests.

Ann was appointed by California Governor Jerry Brown in February 2011 to serve as the Chair of the California Fair Political Practices Commission (FPPC) where she sought to leverage technology to "enhance efficiency, improve governance and repair the relationship between the public and their government."

As Chair she pursued a year-long investigation into the methods used by anonymous donors to influence political campaign.

Ravel was appointed by President Obama to the Federal Election Commission (FEC) in 2013, and became Vice Chair in 2014 and Chair in 2015. In May 2015, Ravel told the New York Times that it is "unlikely that the FEC will be able to regulate the coming 2016 presidential election."

We are fortunate indeed that Ann is a local native and will be in The Villages sharing her views on how we, as citizens, can fight to take back the control of our government-to minimize the impact of money in our system.





Back-Nine Start—Here's an idea that you may enjoy. Due to our demographic, we have many golfers who enjoy playing nine holes only on the long course. Our course is set up perfectly for that option, as both Hole #9 and Hole #18 return to the Clubhouse. But most of the time, nine hole golfers are relegated to playing the front-nine only, as that is where we typically start play. In hopes of creating a more diverse golfing experience for our nine hole golfers, we are going to start rotating the nines on Wednesdays and Fridays twice per month starting on Friday, November 1. So play will start on Hole #10 two Wednesdays and two Fridays per month starting in November. This way, those of you who enjoy nine holes only can experience our wonderful back nine more often. You will enjoy Holes #10-#18, and a different golf experience!

#### Tips from the Pro Your basic Chip & Run...

The art of the classic chip & run (or bump & run) shot has been somewhat lost with the advent of high spinning golf balls and wedges with grooves like razors that create suction-like backspin. Also, the best players in the world usually miss a green on the side that the flagstick is located, therefore "short-siding" themselves, which requires a different type of shot, but not a chip & run. A chip and run is played when you have a bit of green to work with, and when you do not need to carry your ball over any obstacle or rough. Here at The Villages where we have large subtle and sloping greens, and a wide greenside fringe cut; the chip & run is a perfect stroke saver to learn and have in your short game repertoire.

#### Here are some simple starting points for good chipping...

A chip is played when your ball is near the putting surface but not on it (5-15 feet from the green) A chip is a *Low* shot with just enough loft to carry your ball over the fringe or rough and onto the edge of the green.

A chip has more Ground time than air time...so you want to see it roll.

Use a less lofted club...a pitching wedge or a 9, 8 or 7-iron can be used to chip depending on the length of the shot.

Position the ball Back in your stance closer to your right toe (left toe for lefties).

Keep your hands ahead of the ball with the club-shaft leaning toward the target.

Narrow your stance and pre-set your weight slightly into your left leg...keep you lower body still. Stroke the chip like a putt...meaning use a 1-lever motion void of wrist hinge (like a putting stroke) Brush the grass at the ball.

Keep the club moving and accelerating through impact.

Practice these chip & run techniques and let us know how you fare. I guarantee your scores will improve here at The Villages if you master the chip & run! Let us know if these tips help.





### Notice of Proposed Changes to Club <u>Rule 1.40</u> Villages Board Recognized Clubs and Organizations

At the October 29, 2019, Club board meeting, the Board approved to publish for 30-day notice proposed changes to Club Rule 1.40 Villages Board Recognized Clubs and Organizations prior to formal approval consideration at the December 10, 2019, board meeting.

The purpose of the proposed changes is to provide clarity and direction to clubs, and potential clubs, by listing reasonable requirements for clubs to meet to gain Board Recognized status and listing the benefits of Board Recognition.

The Board will consider oral and written comments regarding the proposed changes at the November 12, and December 10, 2019, monthly meetings. Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the changes at the November 12 and December 10 board meetings, 2) via e-mail with comments sent to the General Manager's office at least seven (7) days prior to the meetings (jmeadows@ the-villages.com), and 3) via written comments to the General Manager's office delivered at least seven (7) days prior to the meetings.

Note: Because the proposed rule changes required rewriting and reformatting of the current rule, and highlighting specific additions and deletions would make the rule difficult to read, proposed Rule 1.40 as rewritten, is presented for review. You can find current Rule 1.40 in your Club rules document, on The Villages website, or in Building A.

#### 1.40 Villages Board Recognized Clubs

The Club Board (Board) encourages residents to form resident clubs (club) among themselves to share their interests. The following benefits (1) are available to those clubs which meet the listed required minimum standards (2)

#### 1. Benefits of Board Recognition for a club:

A. Master Calendar access for reservation of facilities, subject to appropriate availability B. Fast Lane for announcements

- C. Channel 26 for announcements
- D. Resource Guide listing
- E. Telephone Directory listing
- F. The Villages website listing
- G. New Resident Orientation

#### 2. The Board requires these minimum standards be met by each club:

- A. The club must not engage in any illegal activity, or violate any rule of the VGCC, Association, or Homeowners Corporation.
- B. The club must be open to all residents who meet membership requirements
- C. Only residents can be members of clubs. Non-residents may be invited guests of a resident club member at all club activities, subject to any club restrictions on guests. Non-residents cannot vote, be directors, or hold office.
- D. A club must have written operating rules (or Bylaws) which must include these provisions and be approved by a majority of the membership:
  - 1) If the club requires election of directors, the election must be open to all members, and each member must be given an equal opportunity to run for such position. Directors can only be removed by vote of all members.
  - 2) The club must notify all members of all meetings.

3) All meetings must be open to all members unless an executive session is required for reasonable purposes as specified in the operating rules.

- E. The club must have at least 20 active members attending a minimum of 80 percent of the clubs functions because of the high demand on our limited facilities.
- F. The club must register annually with VGCC Community Services in Building B with a written list of their current officers and directors (if any), and the names and addresses of every current active member.
- G. No club, nor any club member, shall by any means whatsoever invite the general public to any club activity.
- H. Clubs may not obtain bids or estimates from contractors for suggested changes to Club facilities.

3. The club must be fair and reasonable in all matters. Clubs are prohibited from political opinions or endorsements with the exception of the partisan political clubs' political activity within their own club. If the Board determines the club has not acted fairly or reasonably in any particular matter or has not complied with any section of this Rule, the Board may revoke its Board recognition status and cancel all benefits.

4. To receive Board recognition as a club, submit an application to the Community Activities Office with a list of members and addresses, proposed operating rules or Bylaws and expected facility use. A set of model Bylaws is available in the Community Activities Office.
