He checked on the computer and confirmed it was still February 2. So next morning, I made the reservation and informed my three guests about playing on February 2 with the Guest Day rate. However, on reading the January 28 FastLane, I found Guest Day has been moved! I explained my situation to the Director of Golf by email the same day. He responded "I am sorry Rajeev but guest day is now February 9...if you would like to play on February 9 your friends will receive the guest day rate. If you play on February 2 it will be the standard guest rate."

### Notice of Proposed Changes to Association <u>Rule 2.25The Villages Association Election Rules</u>

**ARTICLE 2** 

Proposed changes to The Villages Association Rule 2.25 Voting and Election Rules were conditionally approved by the Association Board of Directors at its January 28, 2020, meeting for the required member notice period prior to formal approval consideration at an open special meeting to be held on Thursday, February 27, at 9:30 a.m. at Foothill Center. The purpose of the proposed revisions is to comply with the new election law codified in Civil Code Section 4100-5145 that became effective on January 1, 2020. Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the proposed changes at the Association Board of Directors special board meeting (February 27, 2020), or 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at mehernandez@ the-villages.com.

Note: Because the proposed rule changes required the reformatting of the current rule and highlighting specific additions and deletions would make the rule difficult to read, proposed Rule 2.25 as modified, is presented for review. You can find current Rule 2.25 in your Association rules document, on The Villages website, or in Building A.

### The Villages Association Election Rules

These Election Rules apply to all Member votes undertaken by THE VILLAGES ASSOCIATION ("Association"). These Election Rules shall be effective on the date of adoption, shall supersede any other rules of the Association affecting voting or elections, and shall remain in effect until modified by the Board of Directors (the "Board").

#### **MEMBER VOTING RIGHTS ARTICLE 1**

1.1 Member Voting Rights. Notwithstanding anything to the contrary in the Association's governing documents, including Section 3.3 of the Bylaws and Section 11.8 of the CC&Rs, all Members shall be entitled to vote, and no Member shall be denied a ballot for any reason other than not being a Member. "Member" means a person who holds legal title to the separate interest (i.e., is named in the recorded deed for the separate interest property). The "separate interest" property means the condominium unit owned by a Member.

1.1.1 Entity Owners. In the case of a Member that is not a natural person (such as a trust, corporation or other entity), the vote of such Member may be cast by any authorized representative of the Member designated by written notice to the Association.

1.1.2 General Power of Attorney. A person with general power of attorney for a Member, who has provided satisfactory evidence thereof, shall not be denied a ballot and said ballot shall be counted if returned by the deadline for voting.

Voter List. The Association shall maintain a "Voter List" which shall include 1.2 for each separate interest: the Member's name; voting power; and, unless the Member has "opted out" of the public distribution of their address, the physical address of the Member's separate interest, or the parcel number, or both, and the mailing address of the Member if it is different than the physical address of the separate interest (or if the parcel number is used). Upon request, the Association shall permit Members to verify the accuracy of their individual information on the Voter List at least 30 days before the ballots are mailed. The Member shall report any errors to the Inspector of Elections who shall make the correction within two business days. The Association may, at its discretion, report any known errors to the Inspector of Elections. The Voter List shall be retained as "association election materials" as required by law.

1.3 Voting Power of Each Membership. On each matter before the Members, only one (1) vote shall be cast for each separate interest. Once a ballot is received by the Inspector of Elections, it may not be rescinded. Votes on behalf of a separate interest owned by more than one person or entity shall be treated as a single member for voting purposes. The vote for such separate interest shall be exercised as the owners among themselves shall determine, but in no event shall more than one (1) vote be cast with respect to any separate interest. If the joint owners of a separate interest are unable to agree among themselves as to how their vote is to be cast, they shall lose their right to vote on the matter in question. If any joint owner of a separate interest casts a vote representing the separate interest, it will thereafter be conclusively presumed for all purposes that such owner was acting with the authority and consent of the other owners of that separate interest.

1.4 <u>Cumulative Voting</u>. Cumulative voting is not permitted in the election of

### **VOTING PROCEDURE**

2.1 Notice of Election Information. At least thirty (30) days before the ballots are distributed, the Association shall provide general notice of all of the following: (i) the date and time by which, and the physical address where, ballots are to be returned by mail or handed to the Inspector of Elections; (ii) the date, time, and location of the meeting at which ballots will be counted; and (iii) the "Candidate Registration List," as defined in Section 3.3 below.

2.2 Distribution of Ballots. All voting by the Members shall be conducted by secret ballot using a "double envelope system" as described in Civil Code section 5115(a). Ballots and two envelopes with instructions on how to return ballots shall be mailed by first-class mail or delivered to all Members in such vote or election. For a vote on any of the matters specified in Civil Code section 5100(a), ballots shall be distributed a minimum of thirty (30) days prior to the deadline for voting. These matters are: (i) elections regarding assessments legally requiring a Member vote, (ii) election and removal of directors, (iii) amendments to the governing documents, and (iv) grants of exclusive use of common area property pursuant to Civil Code section 4600. For votes on any other matter, ballots may be distributed a reasonable time (which may be less than thirty (30) days) prior to the deadline for voting.

2.3 Election by Acclamation. If, as of the published deadline for receiving nominations, the number of qualified candidates for election to the Board is not more than the number of directors to be elected, then the qualified candidates shall be declared elected and shall take office at the first Board meeting following the deadline for nominations or, if later and an annual meeting is held, then at the first Board meeting after the annual meeting. Written notice of the election shall be given to the Members.

2.4 Frequency of Director Elections. The Association shall hold an election for a seat on the Board at the expiration of the corresponding director's term and at least once every four years, or sooner if required by the Bylaws.

2.5 Extension of Voting. The Board shall be entitled to extend the deadline for the return of ballots one or more times due to the lack of a quorum or for such other reason(s) as the Board deems reasonable and prudent.

2.6 Tabulation and Observation. The Inspector of Elections shall open all ballots and tabulate the votes at a properly noticed open meeting of the Board or Members in a manner that allows the Members to view the opening and tabulation. The Inspector of Elections may appoint additional persons to assist in the opening of ballots and tabulation of votes. Observers must remain at least five (5) feet from the area of opening and tabulation and not communicate, harass, or otherwise interfere with the Inspector of Elections and/or those assisting the Inspector of Elections in any manner whatsoever. The Inspector of Elections or the Board shall have the power and authority to cause the removal of any person who interferes with or disrupts the voting, opening or tabulating process. The Inspector of Elections may suspend the opening and tabulation process if anyone causes interference with or disrupts the process.

2.7 Reporting Election Results. The tabulated results of the election shall be promptly reported to the Board and shall be recorded in the minutes if reported at a meeting of the Board or recorded in the minutes of the next meeting of the Board if reported at a Member meeting. Within fifteen (15) days of the election, the Board shall give the Members general notice of the tabulated results of the election.

2.8 Retention of Association Election Materials. "Association election materials" shall mean the returned ballots, signed voter envelopes, the Voter List, proxies, and the Candidate Registration List. The association election materials shall at all times be in the custody of the Inspector of Elections or at a location designated by the Inspector of Elections for a period of one (1) year after the Inspector of Elections notifies the Board and Members of the election results, at which time custody shall be transferred to the Association. The Association shall retain the association election materials for the current fiscal year and prior two (2) fiscal years. At the expiration of the retention period all association election materials may be destroyed.

#### ARTICLE 3 CANDIDATES FOR THE BOARD AND NOMINATION PROCEDURES

3.1 Qualification of Candidates. Candidates for the Board must be Members at the time of their nomination and (i) must meet any other qualifications or restrictions set forth in these Election Rules and (ii) must meet any other qualifications or restrictions set forth in the Bylaws so long as they do not conflict with these Election Rules. In the case of a Member that is not a natural person (such as a corporation or other entity), the entity Member shall have the power to appoint a natural person as the "Member" for purposes of director elections. The Association shall disqualify a nominee for the Board for any of the following reasons

1.5 Proxies. Use of proxies in connection with membership votes or membership meetings is expressly prohibited. "Proxy" shall mean a written authorization signed by a Member or a Member's attorney-in-fact giving another person or persons power to vote for such Member, as defined in Corporations Code section 5069.

1.6 General Power of Attorney. A Member may delegate their voting rights to a third party by use of a general power of attorney that conforms to the laws of the state in which the power is conveyed. The power of attorney must be returned to the Association at or before the casting of the ballot for which voting rights have been delegated.

3.1.1 The nominee is not a Member.

3.1.2 The nominee does not reside within The Villages condominium project. 3.1.3 If the nominee, if elected, would be serving on the Board at the same time as serving on the Board of The Villages Golf and Country Club. 3.1.4 If the nominee, if elected, would be serving on the Board at the same time as another owner of the same separate interest and the other person is either properly nominated for the current election or is an incumbent director.

3.1.5 If the nominee, at the time of nomination, is delinquent in the (Continued on page 16)

# **PUBLIC SAFETY** Don't feed the 'critters'

One of the many attractions of The Villages is the variety of wildlife that can be encountered on a daily basis. Many Villagers feel that being a good host necessitates feeding our four-legged or winged guests on a routine basis, which can be quite detrimental to our wild friends. Most wild animals naturally fear humans and keep their distance. Problems arise when animals have access to food and garbage left out by residents. They develop an appetite for easy pickings and keep coming back for more. When this happens, they often lose their natural fear of humans and can become aggressive. To prevent that, residents should not leave out any type of food, including canned food, in a manner that may become accessible to our fury or feathered friends.

Please comply with Villages Golf & County Club Rule 1.51.4, which states: "Feeding of waterfowl and other wild animals on a routine basis is prohibited for the protection of both residents and the animals."





"To the Land of Long Lost Friends" by Alexander McCall Smith: Latest in The No. 1 Ladies' Detective Agency series. Mma Ramotswe learns that her friend Hope has fallen on hard times. This initially comes as a shock to her, as the woman came from wealth. But when she learns that Hope has recently separated from her husband, a local politician with a less than a stellar reputation, she becomes determined to find out the truth. Elsewhere, Charlie and Fanwell are also involved in tricky matters of the heart, as Queenie-Queenie, Charlie's girlfriend, seems to have transferred her affections to Fanwell. It's up to Mma Makutsi to set things right. As these mysteries are unraveled, Mma Ramotswe and the entire No. 1 Ladies' Detective Agency will be reminded of the value of tried and true wisdom. Mystery, 2019.

"On Earth We're Briefly Gorgeous" by Ocean Vuong: This is a letter from a son to a mother who cannot read. Written when the speaker, Little Dog, is in his late 20s, the letter unearths a family's history that began in Vietnam before he was born and serves as a doorway into parts of his life his mother has never known, all of it leading to an unforgettable revelation. At once a witness to the fraught yet undeniable love between a single mother and her son, it is also a brutally honest exploration of race, class, and masculinity. With stunning urgency and grace, the story tells of people caught between disparate worlds, and asks how we heal and rescue one another without forsaking who we are. Fiction, 2019.

"A Minute to Midnight" by David Baldacci: Atlee Pine has spent most of her life trying to find out what happened on the night her 6-year-old twin sister, Mercy, was kidnapped and Atlee was left for dead while their parents were partying downstairs. The family moved away. The parents divorced. Atlee chose a career with the FBI dedicating her life to catching those who hurt others. One person she suspects is notorious serial killer, Daniel James Tor, confined to a maximum-security prison. When she oversteps during an arrest, she's given a leave of absence, which offers her the opportunity to return and find some answers. But the trip turns into a roller-coaster ride of murder, long-buried secrets, and lies. Mystery, 2019.


### Join Democratic Club's Super Tuesday party!

payment of regular and/or special assessments. A nominee shall not be considered "delinquent" if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the nominee: (a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) the nominee has requested and has not been provided an opportunity to engage in internal dispute resolution.

3.1.6 If the nominee has been a member of the Association for less than one vear.

3.1.7 If the nominee discloses, or if the Association is aware or becomes aware of, a past criminal conviction that would, if the Member was elected, either prevent the Association from purchasing the fidelity bond coverage required by Civil Code section 5806 or terminate the Association's existing fidelity bond coverage.

3.2 Nominations.

3.2.1 <u>Solicitation of Candidates.</u> At least thirty (30) days before the deadline for submitting a nomination, the Association shall provide general notice of the procedure and deadline for submitting a nomination for the Board. Any Member who satisfies the qualifications and is not otherwise prohibited from running for the Board may place their name in nomination for the Board by submitting the nomination before the published deadline for receiving nominations. In addition, the Board may recruit qualified candidates and/or may appoint a nominating committee to nominate qualified candidates. 3.2.2 <u>No Write-Ins.</u> No "write-in" candidates shall be permitted on

the ballots in the election of directors.

3.3 Candidate Registration List. The "Candidate Registration List" shall mean the list of candidates who will appear on the ballot. Upon request, the Association shall permit Members to verify the accuracy of their individual information on the Candidate Registration List at least thirty (30) days before the ballots are mailed. The Member shall report any errors to the Inspector of Elections who shall make the correction within two business days. The Association may, at its discretion, report any known errors to the Inspector of Elections. The Candidate Registration List shall be retained as "association election materials" as required by law.

3.4 Notice of Known Candidates. The names of all persons on the Candi-

date Registration

List shall be set forth on the ballot.

3.5 <u>Candidacy Statements.</u> Any candidate who wishes to submit a candidacy statement may only do so using the Association's authorized form. The content of any candidate statement shall be limited to a statement of the candidate's qualifications to serve as a director.

3.6 Declaration of Vacancy for Delinquency. Any Member serving on the Board shall be current in the payment of regular and special assessments or the delinquent director's seat may be declared vacant by the Board following notice to the director and an opportunity to meet with the Board in executive session to explain why the director should not be disqualified. A director shall not be considered "delinquent" in the payment of assessments if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the director: (a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) has requested and has not been provided an opportunity to engage in internal dispute resolution.

#### **ARTICLE 4** USE OF ASSOCIATION MEDIA AND CAMPAIGNING

4.1 <u>Access to Association Media – Candidates for the Board</u>. The Board may, but is not required to, make Association media (e.g., newsletter, notice board, website, or other notices provided to the Members) available to qualified candidates running for election to the Board for purposes that are reasonably related to the election in which that candidate is running. If the Board allows any candidate access to Association media, then all qualified candidates shall be allowed equal access to the same media.

4.2 <u>Access to Association Media – Other Matters</u>. If the Board utilizes Association media to advocate a point of view on any matter (other than election of directors) that requires Member approval or allows any Member access to Association media for that purpose, then all Members advocating a different point of view shall be allowed equal access to the same media. The Board shall not be required to allow access to more than one Member advocating the same point of view.

4.3 "Equal Access." "Equal access" shall mean publication of written statements not to exceed a predetermined length as determined by the Board. The Board shall not edit or redact any statement but shall not be required to publish any statement that exceeds the predetermined length restrictions. Modifications to formatting may be made so as to allow for space and/or media restrictions. If any formatting modifications should become necessary, they shall be applied equally to all submissions and at no time shall any formatting be applied that may signify a preference or partiality.

Please stop by to look at them and take note of the locations, as you may be called upon to bring the defibrillator to the emergency scene or assist in other ways.

Sudden Cardiac Arrest (SCA) is a condition in which the heart guivers instead of effectively pumping blood throughout the body and strikes 325,000 people of all ages every year. AEDs are the definitive treatment for this condition, but for each minute that passes before defibrillation therapy reaches a victim, the chances for survival decrease by 10 percent. The American Heart Association estimates that 40,000 lives can be saved each year with AEDs that reach victims within 3-5 minutes of collapse, which is why we are pleased to have an AED program on our campus. Once turned on, the AED will talk the responder through the steps of using the AED and applying chest compressions.

# **Public Safety Tips to Avoid Scams**

Many scams are aimed at senior citizens, and the reasons are obvious. Senior citizens are, in general, more trusting than younger persons; often live alone; and often have cash on hand, or other assets that can easily be converted into cash. While senior citizens make up approximately 12 percent of the population, they account for approximately 33 percent of all fraud victims. There are a few key things that you can do to avoid being a victim of a scam:

1. Let common sense be your guide. Do not let greed influence your decision-making process. Sleep on it. There is no need to rush into a decision. A reputable offer will wait (fraudulent offers won't).

2. Remember, there are very few things in this world that are free. So beware of any offer that says it is free.

3. Look out for "You Have Won" solicitations. These are common practices to lure you in. You cannot win a contest that you did not enter.


4. Seek the opinion of others. Have someone review the offer with you. Reputable offers will withstand the scrutiny of others.

5. Keep your vital information to yourself. Be very wary of anyone asking for your date of birth, Social Security number, credit card numbers, or PIN (personal identification number).

6. Some scams target your emotions, supposedly coming from a friend or family member in trouble. Think rationally before you make a snap decision based on emotion.

Also, be very wary of products or services that have a delayed delivery. The dishonest con artist could be in another state by the time the promised delivery date arrives.





## TENNIS TALK

The Tennis Club occasionally puts the spotlight on its members, this week we wish former Tennis Club president Gordon Knapp a happy birthday.

On Gordon's 80th birthday, it was only fitting to celebrate at the tennis courts. In his own words, "Tennis has been an important part of my life since high school. When I was young, I was not the best athlete though I loved sports so I tried tennis and joined the high school team with a few friends. Tennis was a fit and three years later I was the number one player on the team. Still I was not very good, and I only won four of 13 matches but I enjoyed it. College was a busy time and I did not play much until graduate school when I played a few times a month. After I got my Ph.D. in 1967, I had more time for tennis while I worked as a post doc.

Tennis really became a passion when we moved to Naperville, Illinois in 1969. They had an indoor club (as you need those in Illinois), and also a nice outdoor facility near the high school. I soon found out that I was one of the best players in town. I had never been one of the best at any sport before and I loved it. Janet took up tennis and was quite good and we were a great mixed doubles team. Both of us won some local tournaments. A few years later our kids took up tennis. They both became outstanding players playing tournaments and having a lot of success in their high school tennis. My son also played in college. It was a family affair and my daughter and I won every mixed tournament we entered until we were finally defeated and then we retired as a team. As things go and I got older, I was no longer the best but I still played on some 4.0 and 4.5 teams.

In 1998, I took early retirement to move back to California where my kids had settled. On my first day at The Villages, I was in the golf pro shop—we won't talk about my golf game—and a guy came up to me and said he was Bob Wendell and he played tennis. He looked familiar so I asked him if he had played on Cal's national championship team in 1959. He was pleased to be recognized and we hit it off since I also went to Cal. He invited me to play tennis with his group the next day. I played with some good players and I did all right. When I got home I got a phone call from Andy Nishimura who I had just played with and he asked me to play with him in the upcoming Club Championship and lo and behold we won it. Andy and I played USTA 3.5 and 4.0 for a number of years with a strong winning record. When Andy had to stop playing I teamed with Mohan Aiyargari and we were also guite successful. Unfortunately, injuries and getting older means that the strong winning records are now a thing of the past. But at age 80, I am still playing with the better Village players and even coach a few whether they want it or not. I sure win a lot less than I used to but I love the game and am always up to play. I am hoping that at 90, I will still be working on my serve."

As of February 1, anyone not on the new Registered Guest list will not be able to book a tee time and play unaccompanied golf at The Villages until the signup form is completed by the sponsoring resident.

As of February 1, any Registered Guest that is not on the Chelsea Tee Sheet by name will not be granted access at the Front Gates.

If you would like to add anyone to the Registered Guest Program, simply stop by the Pro Shop and we will walk you through the process.

Golf Course #2 Tees Project—The remaining #2 Tees will be elevated and reconstructed starting on Monday, February 3rd. The #2 Tees Project entails ten of the #2 tees. Observations from the Pro-As I play both the 18-hole and the Par-3 course weekly, here are the three As I play both the 18-hole and the Par-3 course weekly, here are the three most prominent things I notice that we all need to work on as a team when we go play...

1. Ball Marks left on the green – this is the #1 issue I see on the golf course, when I play golf after 3 p.m., there are accrued many unrepaired ball marks on each and every green - please fix your mark on the green regardless of where it is.

2. Bunker Rakes not replaced properly - we ask that the rakes be replaced at a 90 degree angle to the bunker edge with the teeth in the sand, and the handle on the edge of the bunker.

3. Un-filled Divots – I see this a lot on the Par-3 Course tees and on a number of approaches on the 18-hole course. And by the way, there are no high schools playing the Par-3 Course right now, so it is not our guests making these divots. It's simple, be prepared and take a bottle or two of your sand mix with you every time you play; and if you make a divot in the turf, simply fill it with the sand mix.

If all of us did these 3 simple things each and every time we play, the golfing experience will improve for everyone involved!

Tips from the Pro-Want to drive it further? Lean the shaft back with your driver for a better angle of attack!

Forward lean in the shaft (toward the target) promotes more downward movement in the clubhead through impact, which is ideal for an iron, but bad news for the driver. With the advent of trackman radar and video technology, we now know that the optimal shaft angle for a driver is a backward shaft lean at impact creating a low spin, high launch ball flight.

### Here are some tips to get that shaft leaning back at impact with the driver...

Try to set up more neutral with your driver. Set up with the shaft more straight up and down (i.e., neutral) to leaning slightly back, so that your hands are in line with the clubhead, and not pressed ahead. Tilt your left shoulder up just a bit to help with an ascending blow. Set up with ball position more forward, opposite the tip of your left shoulder or left foot out-step, this will help you make contact at the ascending point of the swing. The goal is that the clubhead should be fairly level to the ground or slightly ascending through impact. Relax your left hand so the tendency to pull the shaft into a forward lean position is negated. If you do all this successfully, you will be surprised how much higher and further it goes. See you at the course!

Dealer has maybe a winner in Spades, 3 in Hearts, 1 sure winner in Diamonds and 2 or more in Clubs. Strategy: It is good to be aware that the opponents have the Ace and King of Spades, the King and Jack of Diamonds, plus the Queen of Clubs. Obviously, you can't do anything about the 2 Spade honors and only hope that either the Queen of Clubs or the King of Diamonds is able to be finessed.

West leads the Jack of Hearts, King from the board, then South switches to the Ace of Clubs, continues with a low Club, and finesses the Jack. West covers with the Queen, plays a low Heart, Queen from the board, and now South leads the 2 of Spades, East, the 10, South, the Queen, and West covers with the Ace. He then plays another Heart, South sluffs a Diamond from the board and takes the trick with the Ace in his hand. He leads the 10 of Diamonds, West, ducks, low from the board, and East covers with the Jack. He plays the 9 of Clubs, South, the King, then leads a low Diamond, West, the King, and South wins with the Ace on the board. He plays a low Spade, East the King, switchers to the 8 of Diamonds, South covers with the Queen, plays the good Club and then leads his last card, a Spade and takes it on the board with the Jack. Great. The contract is made exactly. This hand can easily go down if South is not careful about taking out the top honors in the suits while still having controls. He doesn't want West to get in after he sets up his Heart suit.

\* South has 12 HCP and that is enough to bid 2 NT showing no 4-card major, and North bids game having a flat hand, 14HCP, and an honor in each suit.

### Ten tips for choosing contractors

### Brace for another round of IRS scams. Be ready!

Once again it's tax time and large numbers of people across the nation are being targeted by fake Internal Revenue Service (IRS) telephone scams. Criminals pretending to be IRS agents are calling random telephone numbers throughout the United States trying to harass people into send-ing pre-paid debit cards to pay fake fines and owed taxes. Scammers generally ask for payment by wire transfer or pre-paid debit cards—or even gift cards.

Real IRS agents are once again responding to this rash of criminal activity. According to US Department of Treasury investigators these impersonation scams are the most pervasive.

If you receive such a call, please remember that the IRS does not call individual taxpayers on the telephone to collect fines or funds owed. The agency sends notices through the mail.

And according to the IRS web site (www.irs.gov): "Remember: The IRS doesn't initiate contact with taxpayers by email to request personal or financial information. This includes any type of electronic communication, such as text messages and social media channels."

If one of the impersonators calls you, he or she will probably begin with the threat of jail and demands of immediate payment to avoid prison time. The scammers' primary goals are to frighten victims into sending payment to them via means of transfer that are not easily traced (prepaid debit or wire transfer). Do not allow yourself to be tricked by these unsavory criminals.

To fight back, do not be intimidated. Either try to get as much information about the caller or hang up the phone on the fake IRS agent. After you get off the phone with the criminal, call the IRS at 1-800-366-4484 to report the illegal activity. Do not give these callers any of your information to prevent them from filing false tax returns in your name or hijacking your refund.

You can go to the IRS website, irs.gov, to report phishing, identity theft or other suspicious messages you receive.

If you are contacted by fake IRS scammers, the IRS web site offers the following advice:

• If you receive an email claiming to be from the IRS that contains a request for personal information, taxes associated with a large investment, inheritance or lottery. 1. Don't reply. 2. Don't open any attachments. They can contain malicious code that may infect your computer or mobile phone. 3. Don't click on any links. Visit the identity protection page on the IRS web site if you clicked on links in a suspicious email or website and entered confidential information. 4. Forward the email as-is to the IRS at phishing@irs.gov. Don't forward scanned images because this removes valuable information. 5. Delete the original email.

• If you receive a phone call from someone claiming to be from the IRS but you suspect they are not an IRS employee. 1. Record the employee's name, badge number, call back number and caller ID if available. 2. Call 1-800-366-4484 to determine if the caller is an IRS employee with a legitimate need to contact you. If the person calling you is an IRS employee, call them back. If not, report the incident to the Treasury Inspector General for Tax Administration (TIGTA—www. treasury.gov/tigta/) and to the IRS at phishing@irs.gov (Subject: 'IRS Phone Scam')

# Do you need to file a tax return?

During tax season the SRS volunteers are frequently asked this question: I don't have much income; do I need to file a tax return?

For most people, the need to file a return depends on their gross income. Based on your tax filing status and age, you must file a tax return if your gross income equals or exceeds the amount in the chart below. If your income falls in this range, a return is required even if you are sure you will have no tax due after deductions such as medical expenses, charitable contributions or home mortgage interest.

For example, if you are single and under age 65, you must file a return if your gross income is \$12,200 or more.

Single and under 65	\$12,200
Single and 65 or older	13,850
Married filing jointly, both spouses under 65	24,400
Married filing jointly, one spouse 65 or older	25,700
Married filing jointly, both spouses 65 or older	27,000

For example, if you are married and both of you are at least age 65 and your gross income is \$27,000 or more, you must file a tax return.

Gross income means all income you received in the form of money, goods, property, and services that is not specifically exempt from tax, including any income from sources outside the United States. Do not include social security benefits unless one-half of your social security benefits plus your other gross income and any tax-exempt interest is more than \$25,000 (\$32,000 if married filing jointly).

As with all tax law, there are some exceptions to this general rule. For example, if you have \$400 or more in self-employment income such as commission income, you must file a return to pay the self-employed social security tax. Another example is if you received advance payments of the health premium tax credit, you must file a return.

Even if you are not required to file it may be to your advantage to file to get a tax refund. For example, if you have had withholding from your pension, you should file a return to request a refund of the withheld tax. The same is true if you paid estimated tax and you do not owe any tax.

If you are unsure of your need to file a return, SRS suggests you make an appointment for the free preparation of tax returns available at the Evergreen Community Center on San Felipe Road. A trained volunteer (a Villages resident) will determine whether a return is necessary. The phone number to call for an appointment at the Evergreen Community Center is 408-270-2220. Your appointment will be for a Thursday or Friday afternoon.

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday and Friday from 10 a.m. to noon. The SRS office is located in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

### <u>SRS Announcement:</u> Introducing a new 1040-SR return

Many taxpayers complained about the half-page 1040 return with small print last year. The IRS has issued a new tax return - form 1040-SR. SR stands for senior. The font is larger than last year's returns and the shading in boxes has been removed to improve the contrast and increase legibility.

Using the new form won't be mandatory, but the IRS believes it will be user-friendly for many seniors. The standard deduction chart is on the bottom of page 1 of the return to ensure you claim the larger amount if you and/or your spouse are age 65 or older.

The 1040-SR form is basically for people who are doing a paper filing of their return. If you use one of the computer programs to file, you probably won't see the new SR form.

Normally you report these distributions along with other taxable income on your annual income tax return. However charitable IRA gifts can be all or part of your required distribution up to a maximum of \$100,000 per taxpayer per year.

### **Proposed Association Rule Change...**

### (Continued from page 12)

4.4 <u>Responsibility for Content</u>. All statements published in Association media pursuant to the "equal access" rules must identify the author or proponent. No anonymous statements will be permitted. The author and/or proponent of any statement or point of view shall be solely responsible and liable for the content of their statements. The Association shall not be responsible or liable for the content of any statement published pursuant to the "equal access" rules.

4.5 <u>Campaigning</u>. No Association funds shall be expended for the purposes of campaigning in connection with any vote or election other than those funds specifically required to distribute required correspondence, notices, or forms that may contain the names of candidates or necessary information on the issues being voted upon, or as is otherwise deemed by the Board to be necessary or appropriate for the fair and reasonable conduct of a vote or election, or to the extent necessary to comply with duties of the Association imposed by law. Specifically excluded is the expenditure of Association funds for the purposes of expressly advocating approval, election, or defeat of any candidate.

#### **ARTICLE 5 USE OF COMMON AREA MEETING SPACE**

5.1 Access to Common Area Meeting Space - Campaigning by Candidates for the Board. The Board shall ensure that during a campaign all qualified candidates for election to the Board are given access to common area meeting space (if any) upon request, at no cost, for purposes reasonably related to their campaigns.

5.2 Access to Common Area Meeting Space - Other Matters. Whenever the Board places a matter before the Members which requires Member approval, the Board shall ensure that Members advocating a point of view on the matter are given access to common area meeting space (if any) upon request, at no cost, for purposes reasonably related to advocating their point of view, whether or not they agree with the point of view advocated by the Board on the matter at issue.

5.3 <u>All Access</u>. Any use of the common area facilities for the purposes described above shall be regulated by any existing rules and regulations for such use. The Board, in its sole discretion, may reasonably limit a candidate's or Member's access to common area facilities in order to facilitate equal access for other candidates and Members, and so as not to unreasonably interfere with other Members' rights to use such facilities.

#### **INSPECTOR OF ELECTIONS ARTICLE 6**

6.1 Appointment of Inspector of Elections. Whenever there is a membership vote or election, the Board shall appoint one (1) or three (3) Inspectors of Elections, hereinafter individually or collectively referred to as the "Inspector of Elections," whose powers and duties shall be as set forth in Civil Code section 5100 et seq. The Board shall have the power to remove an Inspector of Elections who ceases to meet the required qualifications, is unable or unwilling to perform their duties, or for other good reason, and to appoint a new Inspector of Elections in their place.

6.2 Qualification of Inspector of Elections. The Inspector of Elections may be any persons the Board reasonably believes to be independent with respect to the matter or matters being voted on and may include Members of the Association, but may not be (i) a member of the Board or a candidate for election to the Board or be related to a current member of the Board or a candidate for election to the Board or (ii) the Association's manager, accountant, legal counsel, or any other person, business entity, or subdivision of a business entity that is employed by or under contract with the Association to provide compensable services to it at and/or after commencement of the election process other than serving as Inspector of Elections.

6.3 Payment to Inspector of Elections. The Board may authorize payment of Association funds to any third party appointed to serve as Inspector of Elections; however, no payment may be authorized for any Member appointed to serve as the Inspector of Elections.

6.4 Duties of the Inspector of Elections. The Inspector of Elections shall be responsible to perform their duties as follows:

6.4.1 Perform those tasks enumerated in Civil Code section 5110(c); and 6.4.2 Perform all duties impartially, in good faith, to the best of the Inspector of Election's ability, as expeditiously as is practical, and in a manner that protects the interest of all Members of the Association; and 6.4.3 Make any necessary corrections to the Candidate Registration List or the Voter List within two business days of being informed of an error by a Member or by the Association; and

6.4.4 Deliver (or cause to be delivered) the following documents to the members at least thirty (30) days before an election: (a) the ballot(s) by first-class mail and (b) a copy of these Election Rules by (i) individual delivery or (ii) by posting the internet website address where these Election Rules may be accessed on the ballot together with the phrase in at least 12-point font, "The rules governing this election may be found here: [insert internet website address]"; and

6.4.5 Retain the association election materials as provided herein.

6.5 Indemnification of Inspector of Elections; Liability Insurance. The Association may, at the Board's sole discretion, indemnify the Inspector of Elections to the fullest extent provided by law. The Association shall have the power to purchase and maintain insurance to protect it and/or the Inspector of Elections against any liability asserted against the Association and/or against the Inspector of Elections arising out of the Inspector of Elections' acts and/or omissions relating to any Association vote or election.

#### **ARTICLE 7 AMENDMENTS**

The Board may amend these Election Rules from time to time except that these Election Rules may not be amended less than ninety (90) days prior to an election unless that amendment is merely to conform to non-discretionary changes in the law.






### Christopher Logan Edwards March 16, 1947 – January 23, 2020

# Planning an estate, moving or garage sale?



Residents, or those working on the behalf of residents, are advised to call the Public Safety Administration office at 239-5246 before planning or opening a sale at the Villages. Sales on Villages property are subject to Association Rule 2.02 Residence Use and Occupancy Restrictions (for condominiums) or Homeowners' Rule 3.2.10 Estate and Garage Sales (for singlefamily homes).

Homeowners' Rule 3.2.10, Estate and Garage Sales states:

3.2.10 Estate and garage sales are permitted subject to the following: A. A permit for the sale shall be obtained from the Public Safety Office prior to holding the sale and placement of advertising.

Also, all estate and garage sales in the Association require a permit. The owner of the property must request the permit from Public Safety Administration in Building C. The Villages Association Rule 2.02. 5., Residence Use and Occupancy Restrictions applies:

5. Estate and garage sales are permitted subject to the following:

A. Public Safety will not allow entry to anyone who is not authorized by

name in advance (Club Rule 1.01, Access to the Villages). B. All sales activity and sale items must be contained within the residence or garage

C. Sales maybe held only between 9 a.m. and 4 p.m.

D. Sales period may not exceed two days.

E. Only one sale per resident household per year will be permitted. In the event of the death of a resident of the unit, a subsequent estate sale will be permitted. A permit is required and can be obtained from Public Safety.

F. Residents may not use public media to invite members of the general public to attend estate or garage sales at The Villages.

In this context, "public media" includes the internet, social media such as Facebook and Twitter which will be seen by non-residents, and publications which circulate outside The Villages such as the Evergreen Times and Spotlight. Residents may post activities and notices on Next Door but must use the "Choose Neighbors: The Villages [only]" option.

Note: When placing classified ads for estate or garage sales in The Villager, you will need to attach proof of the permit to your Classified Advertising form.


