## Association Members – Annual Form Coming Your Way

As you know, The Villages Association is a common interest development (CID) subject to California Civil Code Sections 4000-6150 (also known as the Davis-Stirling Act). Passed in 2016 and effective in 2017, Civil Code Section 4041(a) requires all CID owners (owners of condominiums), to annually and in writing provide the HOA (The Villages Association), their contact information for sending HOA notices, and to inform the association whether the residence is owner-occupied or rented.

Associations are required to solicit these notices at least 30 days prior to the annual association disclosures. For The Villages Association, that is the Annual Budget Report and Annual Policy Statement that are distributed in May. If an owner does not annually provide this notification, the association must deem the last address provided in writing by the owner, or if none, the property address, shall be deemed to be the address to which notices are delivered. Completing this form will not discontinue electronic distribution of association documents if you have signed up for that program.

So coming in early March will be a form, "Request for Annual Notice of Address, Representative and Rental Status," (the form is yellow in color) for owners to complete and return that complies with this law. Owners may return completed forms to Business Administration Building A. (For convenience, additional drop boxes are available; 1) Cribari Center, just outside the Post Office and 2) in the drop box located in the parking lot adjacent to Building A) or send by mail to:

Again, if an owner does not provide this notification/information, the Association must deem the last address provided in writing by the owner, or if none, the property address, shall be deemed to be the address to which notices are delivered. #### From The Villages Association

The deadline for nominations for The Villages Association Board of Director candidates for this year's election is March 31, 2020, at 5:00 p.m.

Pursuant to California Civil Code §5105(a)(3), The Villages Association Bylaws Section 6.1.2, and The Villages Association Election Rules Section 3.2.1, any Member who satisfies the qualifications and is not otherwise prohibited from running for the Board may place their name in nomination by completing the "Solicitation of Candidates Form" and submitting the form to the President (Garry Ashby) or Secretary (David Cook) of the Board before the above posted deadline.

## The Villages Association Election Rules

### ARTICLE 3: Candidates for the Board and Nomination Procedures

#### 3.1 Qualification of Candidates.

Candidates for the Board must be Members at the time of their nomination and (i) must meet any other qualifications or restrictions set forth in these Election Rules and (ii) must meet any other qualifications or restrictions set forth in the Bylaws so long as they do not conflict with these Election Rules. In the case of a Member that is not a natural person (such as a corporation or other entity), the entity Member shall have the power to appoint a natural person as the "Member" for purposes of director elections. The Association shall disqualify a nominee for the Board for any of the following reasons:

- 3.1.1 The nominee is not a Member.
- 3.1.2 The nominee does not reside within The Villages condominium project.
- 3.1.3 If the nominee, if elected, would be serving on the Board at the same time as serving on the Board of The Villages Golf and Country Club.

3.1.4 If the nominee, if elected, would be serving on the Board at the same time as another owner of the same separate interest and the other person is either properly nominated for the current election or is an incumbent director.

3.1.5 If the nominee, at the time of nomination, is delinquent in the payment of regular and/or special assessments. A nominee shall not be considered "delinquent" if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the nominee: (a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) the nominee has requested and has not been provided an opportunity to engage in internal dispute resolution.

3.1.6 If the nominee has been a member of the Association for less than one year.

3.1.7 If the nominee discloses, or if the Association is aware or becomes aware of, a past criminal conviction that would, if the Member was elected, either prevent the Association from purchasing the fidelity bond coverage required by Civil Code section 5806 or terminate the Association's existing fidelity bond coverage.

#### 3.2 Nominations.

3.2.1 Solicitation of Candidates. At least thirty (30) days before the deadline for submitting a nomination, the Association shall provide general notice of the procedure and deadline for submitting a nomination for the Board. Any Member who satisfies the qualifications and is not otherwise prohibited from running for the Board may place their name in nomination for the Board by submitting the nomination before the published deadline for receiving nominations. In addition, the Board may recruit qualified candidates and/or may appoint a nominating committee to nominate qualified candidates.

3.2.2 No Write-Ins. No "write-in" candidates shall be permitted on the ballots in the election of directors.

## **(SRS) SENIOR RESOURCE SERVICES**

### Itemized deductions for California?

**Question:** With last year's changes to income taxes, I will claim the standard deduction on my Federal return. Must I also take the standard deduction on my California return? Am I allowed to itemize on my California return?

**Answer:** Yes, you may itemize. And many taxpayers are doing this. If you file single, the standard deduction for your Federal return is \$12,200 or \$13,850 if you are age 65 or older. If you file a joint return, the Federal standard deduction is \$24,400. It is \$25,700 if one of you is age 65 or \$27,000 if both of you are age 65.

However, when you claim the California standard deduction you discover it is only \$4,537 if you file single and \$9,074 if you file jointly. It may reduce your taxes if you itemize on the California return. Here's how you do it:

If you took the standard deduction on your Federal income tax return but will itemize deductions for your Form 540, first complete Federal Schedule A (Form 1040), Itemized Deductions. Then check the box on Side 2, Part II of the Schedule CA (540) and complete Part II. Attach both the federal Schedule A (Form 1040) and California Schedule CA (540) to the back of your tax return.

If you are using a computerized tax program to do your return (TurboTax, Tax Slayer, H&R Block) it will automatically do the calculations and prepare the correct forms. You will need to complete the above process if you are doing the manual (paper forms) process.

Yes, it is weird to complete Federal Schedule A, even though you will not attach it to your Federal return but must attach it to your California return. But weird is okay if it reduces your taxes.

*Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.*

## March 13 Evergreen tax exemption filing

If you do not have an exemption from the annual \$125 Evergreen School District parcel tax, you may file for the exemption on March 13 in the Foothill Center from 1:30 to 4:00 p.m. Complete information about the exemption was in the SRS article in the March 27 Villager. The Villager is available online if you can't find your copy.

Don't forget to bring your property tax bill and your driver's license or other identification proving your age and address.

If you are not sure if you have the exemption, the School District representatives will have a list to check your exemption status.

Bring a light snack and water. To avoid heavy traffic, we'll gather at Cribari at 9:15 for a 9:30 departure.

**Rambler Lite hike** will meet at 9:15 a.m. and decide if they wish to join the Ramblers to Fremont Older Open Space with many hills (30-miles round trip) or have a local hike of about 2 - 3 miles. Call Bonnie Preston (408-531-1513).

**Saturday March 14:** Wate and Johanna Bakker (408-223-2190) will lead long and rambler hikes in Castle Rock State Park. We will admire spectacular sandstone rock formations and a waterfall, especially if it rains again in the near future. The new visitor center and parking lot are now open. Atop the plateau, a pastoral landscape predominates, and a variety of other animals make their home in the open grasslands, ponds, and steep wooded canyons. Bring water, poles and a snack. Optional lunch stop TBD! Meet at Cribari at 9 a.m. for a 9:15 am departure. Round trip 50 miles.

**Rambler Lite hike** will meet at 9 a.m. and decide if they wish to join the Ramblers to Vargas Plateau Regional Park (50 miles round trip) or have a local hike of about 2-3 miles. Call Bonnie Preston (408-531-1513).

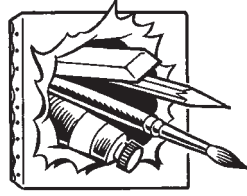

## Association Board Approves Association Rule 2.25 Voting and Election Rules

Proposed changes to The Villages Association Rule 2.25 Voting and Election Rules were approved by the Association Board of Directors at its February 27, 2020, Special Open Meeting. The purpose of the proposed revisions is to comply with the new election law codified in Civil Code Section 4100-5145 that became effective on January 1, 2020.

Changes in the law and the subsequent changes in the Association's election rules have modified (extended) the traditional timeline for the Association annual director election schedule, as well as for other Association votes that may occur. This is to accommodate other requirements of the law and new election rules, such as, the Association shall now maintain a Voter List which Members are permitted to verify the accuracy of their individual information at least 30 days before the ballots are mailed.

Another addition to the election rules (relating to the annual director election) is the Candidate Registration List. This is the list of candidates who will appear on the ballot and now Members (candidates), as with the Voter List, are permitted to verify the accuracy of their individual information on the Candidate Registration List at least 30 days before the ballots are mailed.

Also, the following additional candidate qualifications not currently in the Bylaws have been added to the election rules:

**Section 3.1.6:** This provision prevents an owner from running for the Board if they have been an owner less than one year.

**Section 3.1.7:** This provision requires a nominee to be disqualified if the nominee has a past criminal conviction that would either prevent the Association from purchasing the fidelity bond coverage required by Civil Code Section 5806 or terminate the Association's existing fidelity bond coverage. This does not require the Association or Management to undertake any background checks of nominees and only imposes the disqualification requirement if the Board becomes aware of the conviction.

### Rule 2.25 Voting and Election Rules

These Election Rules apply to all Member votes undertaken by THE VILLAGES ASSOCIATION ("Association"). These Election Rules shall be effective on the date of adoption, shall supersede any other rules of the Association affecting voting or elections, and shall remain in effect until modified by the Board of Directors (the "Board").

### ARTICLE 1 MEMBER VOTING RIGHTS

1.1 **Member Voting Rights.** Notwithstanding anything to the contrary in the Association's governing documents, including Section 3.3 of the Bylaws and Section 11.8 of the CC&Rs, all Members shall be entitled to vote, and no Member shall be denied a ballot for any reason other than not being a Member. "Member" means a person who holds legal title to the separate interest (i.e., is named in the recorded deed for the separate interest property). The "separate interest" property means the condominium unit owned by a Member.

1.1.1 **Entity Owners.** In the case of a Member that is not a natural person (such as a trust, corporation or other entity), the vote of such Member may be cast by any authorized representative of the Member designated by written notice to the Association.

1.1.2 **General Power of Attorney.** A person with general power of attorney for a Member, who has provided satisfactory evidence thereof, shall not be denied a ballot and said ballot shall be counted if returned by the deadline for voting.

1.2 **Voter List.** The Association shall maintain a "Voter List" which shall include for each separate interest: the Member's name; voting power; and, unless the Member has "opted out" of the public distribution of their address, the physical address of the Member's separate interest, or the parcel number, or both, and the mailing address of the Member if it is different than the physical address of the separate interest (or if the parcel number is used). Upon request, the Association shall permit Members to verify the accuracy of their individual information on the Voter List at least 30 days before the ballots are mailed. The Member shall report any errors to the Inspector of Elections who shall make the correction within two business days. The Association may, at its discretion, report any known errors to the Inspector of Elections. The Voter List shall be retained as "association election materials" as required by law.

1.3 **Voting Power of Each Membership.** On each matter before the Members, only one (1) vote shall be cast for each separate interest. Once a ballot is received by the Inspector of Elections, it may not be rescinded. Votes on behalf of a separate interest owned by more than one person or entity shall be treated as a single member for voting purposes. The vote for such separate interest shall be exercised as the owners among themselves shall determine, but in no event shall more than one (1) vote be cast with respect to any separate interest. If the joint owners of a separate interest are unable to agree among themselves as to how their vote is to be cast, they shall lose their right to vote on the matter in

## Association Board Seeks New Directors

There will be two Director vacancies on the Association Board beginning in June. We encourage all condo owners to consider running for the Board.

The mission of the Association Board is to protect, maintain, and enhance the common property of its members:

- Being on the Board is interesting.
- Board Directors are informed and involved in making decisions which affect assessments and quality of life in The Villages.
- It would be helpful if a candidate has some business or administrative or DAC experience, but what really counts is being willing to listen to other owners, work with staff, and make good, common sense decisions for the best long-term interests of The Association.

question. If any joint owner of a separate interest casts a vote representing the separate interest, it will thereafter be conclusively presumed for all purposes that such owner was acting with the authority and consent of the other owners of that separate interest.

1.4 **Cumulative Voting.** Cumulative voting is not permitted in the election of directors.

1.5 **Proxies.** Use of proxies in connection with membership votes or membership meetings is expressly prohibited. "Proxy" shall mean a written authorization signed by a Member or a Member's attorney-in-fact giving another person or persons power to vote for such Member, as defined in Corporations Code section 5069.

1.6 **General Power of Attorney.** A Member may delegate their voting rights to a third party by use of a general power of attorney that conforms to the laws of the state in which the power is conveyed. The power of attorney must be returned to the Association at or before the casting of the ballot for which voting rights have been delegated.

### ARTICLE 2 VOTING PROCEDURE

2.1 **Notice of Election Information.** At least thirty (30) days before the ballots are distributed, the Association shall provide general notice of all of the following: (i) the date and time by which, and the physical address where, ballots are to be returned by mail or handed to the Inspector of Elections; (ii) the date, time, and location of the meeting at which ballots will be counted; and (iii) the "Candidate Registration List," as defined in Section 3.3 below.

2.2 **Distribution of Ballots.** All voting by the Members shall be conducted by secret ballot using a "double envelope system" as described in Civil Code section 5115(a). Ballots and two envelopes with instructions on how to return ballots shall be mailed by first-class mail or delivered to all Members in such vote or election. For a vote on any of the matters specified in Civil Code section 5100(a), ballots shall be distributed a minimum of thirty (30) days prior to the deadline for voting. These matters are: (i) elections regarding assessments legally requiring a Member vote, (ii) election and removal of directors, (iii) amendments to the governing documents, and (iv) grants of exclusive use of common area property pursuant to Civil Code section 4600. For votes on any other matter, ballots may be distributed a reasonable time (which may be less than thirty (30) days) prior to the deadline for voting.

2.3 **Election by Acclamation.** If, as of the published deadline for receiving nominations, the number of qualified candidates for election to the Board is not more than the number of directors to be elected, then the qualified candidates shall be declared elected and shall take office at the first Board meeting following the deadline for nominations or, if later and an annual meeting is held, then at the first Board meeting after the annual meeting. Written notice of the election shall be given to the Members.

2.4 **Frequency of Director Elections.** The Association shall hold an election for a seat on the Board at the expiration of the corresponding director's term and at least once every four years, or sooner if required by the Bylaws.

2.5 **Extension of Voting.** The Board shall be entitled to extend the deadline for the return of ballots one or more times due to the lack of a quorum or for such other reason(s) as the Board deems reasonable and prudent.

2.6 **Tabulation and Observation.** The Inspector of Elections shall open all ballots and tabulate the votes at a properly noticed open meeting of the Board or Members in a manner that allows the Members to view the opening and tabulation. The Inspector of Elections may appoint additional persons to assist in the opening of ballots and tabulation of votes. Observers must remain at least five (5) feet from the area of opening and tabulation and not communicate, harass, or otherwise interfere with the Inspector of Elections and/or those

On Tuesday, March 10 at 7 p.m. in the Vineyard Center, the Villages Arts and Crafts Association will present "Chihuly Short Cuts II" produced by Mark McDonnell. 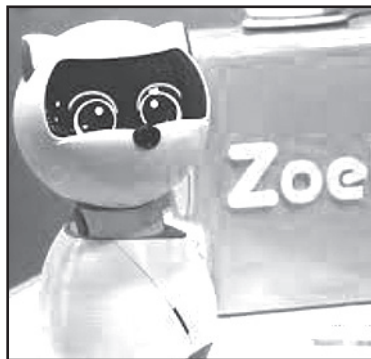
## Opera Lovers: See Verdi's 'Attila the Hun'

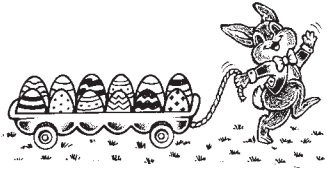

## Free preliminary bone density screening

On Wednesday, March 18, 2020 from 11 a.m. to 1:30 p.m. in the Cribari Conference Room the VMA is sponsoring a preliminary bone density screening. Jerry notes, especially, that the four-night passage aboard VIA Rail Canada, the premier trans-Canada railroad, showcases the country's changing landscape of tranquil lakes, dense forests, expanses of grasslands, verdant river valleys and the majestic Canadian Rockies.

Jerry has recently presented travel slide shows covering Moscow and St. Petersburg last fall and "The Ancient Kingdom" of Thailand, Laos, Cambodia and Vietnam this past January. Both were very well attended, and the


feedback was enthusiastic and encouraging. Future travel slide presentations may include Jerry's trips to England and Norway, Central Europe, Yosemite, and a Colorado River Rafting adventure, among others.

The Episcopal Book of Common Prayer invites us to live our lives in imitation of Jesus' self-giving love. This is nowhere more clear than in our baptismal rites, which are structured around the 4th century Apostles Creed. A priest blesses and bathes (OK, sprinkles...) the person being baptized, but that person (or their parents) makes a corresponding commitment to live a new life of faith. The Prayer Book explicitly mentions prayer and study, fellowship and repentance, proclaiming Good News, serving one another and practicing justice. Many of us have made those commitments (or had them made for us) in church, but how do we actually live them out?

Because Lent was historically a time of preparation for Holy Baptism, why not take this opportunity to consider anew how you live out the Christian faith given to you in Baptism? Do you long for more prayer, fellowship, or teaching (the first Baptismal commitment)? Or are you carrying a spiritual burden you'd like to let go of? God always welcomes us to repent and return (the second of our Baptismal commitments). 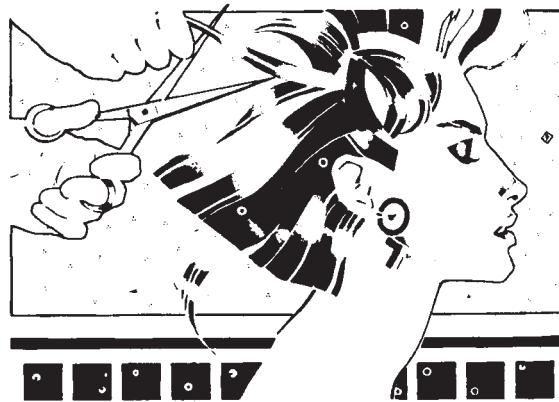

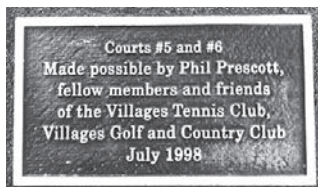

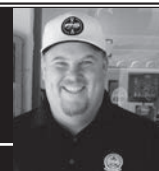

### Pedestrian Safety on Villages streets

Walking in the Villages is great exercise and an excellent way to see our beautiful community. Walking can also be dangerous, however; one in six traffic fatalities is a pedestrian. To avoid being a statistic, take note of a few tips for walkers and drivers alike.

California Vehicle Code requires you to yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk of an intersection. This does not relieve pedestrians, however, from the duty of being cautious and watching out for their own safety.

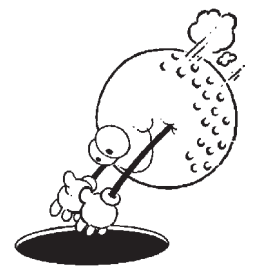

assisting the Inspector of Elections in any manner whatsoever. The Inspector of Elections or the Board shall have the power and authority to cause the removal of any person who interferes with or disrupts the voting, opening or tabulating process. The Inspector of Elections may suspend the opening and tabulation process if anyone causes interference with or disrupts the process.

2.7 Reporting Election Results. The tabulated results of the election shall be promptly reported to the Board and shall be recorded in the minutes if reported at a meeting of the Board or recorded in the minutes of the next meeting of the Board if reported at a Member meeting. Within fifteen (15) days of the election, the Board shall give the Members general notice of the tabulated results of the election.

2.8 Retention of Association Election Materials. "Association election materials" shall mean the returned ballots, signed voter envelopes, the Voter List, proxies, and the Candidate Registration List. The association election materials shall at all times be in the custody of the Inspector of Elections or at a location designated by the Inspector of Elections for a period of one (1) year after the Inspector of Elections notifies the Board and Members of the election results, at which time custody shall be transferred to the Association. The Association shall retain the association election materials for the current fiscal year and prior two (2) fiscal years. At the expiration of the retention period all association election materials may be destroyed.

**ARTICLE 3 CANDIDATES FOR THE BOARD AND NOMINATION PROCEDURES**

3.1 Qualification of Candidates. Candidates for the Board must be Members at the time of their nomination and (i) must meet any other qualifications or restrictions set forth in these Election Rules and (ii) must meet any other qualifications or restrictions set forth in the Bylaws so long as they do not conflict with these Election Rules. In the case of a Member that is not a natural person (such as a corporation or other entity), the entity Member shall have the power to appoint a natural person as the "Member" for purposes of director elections. The Association shall disqualify a nominee for the Board for any of the following reasons:

- 3.1.1 The nominee is not a Member.
- 3.1.2 The nominee does not reside within The Villages condominium project.
- 3.1.3 If the nominee, if elected, would be serving on the Board at the same time as serving on the Board of The Villages Golf and Country Club.
- 3.1.4 If the nominee, if elected, would be serving on the Board at the same time as another owner of the same separate interest and the other person is either properly nominated for the current election or is an incumbent director.
- 3.1.5 If the nominee, at the time of nomination, is delinquent in the payment of regular and/or special assessments. A nominee shall not be considered "delinquent" if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the nominee: (a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) the nominee has requested and has not been provided an opportunity to engage in internal dispute resolution.
- 3.1.6 If the nominee has been a member of the Association for less than one year.
- 3.1.7 If the nominee discloses, or if the Association is aware or becomes aware of, a past criminal conviction that would, if the Member was elected, either prevent the Association from purchasing the fidelity bond coverage required by Civil Code section 5806 or terminate the Association's existing fidelity bond coverage.

3.2 Nominations.

3.2.1 Solicitation of Candidates. At least thirty (30) days before the deadline for submitting a nomination, the Association shall provide general notice of the procedure and deadline for submitting a nomination for the Board. Any Member who satisfies the qualifications and is not otherwise prohibited from running for the Board may place their name in nomination for the Board by submitting the nomination before the published deadline for receiving nominations. In addition, the Board may recruit qualified candidates and/or may appoint a nominating committee to nominate qualified candidates.

3.2.2 No Write-Ins. No "write-in" candidates shall be permitted on the ballots in the election of directors.

3.3 Candidate Registration List. The "Candidate Registration List" shall mean the list of candidates who will appear on the ballot. Upon request, the Association shall permit Members to verify the accuracy of their individual information on the Candidate Registration List at least thirty (30) days before the ballots are mailed. The Member shall report any errors to the Inspector of Elections who shall make the correction within two business days. The Association may, at its discretion, report any known errors to the Inspector of Elections. The Candidate Registration List shall be retained as "association election materials" as required by law.

3.4 Notice of Known Candidates. The names of all persons on the Candidate Registration List shall be set forth on the ballot.

3.5 Candidacy Statements. Any candidate who wishes to submit a candidacy statement may only do so using the Association's authorized form. The content of any candidate statement shall be limited to a statement of the candidate's qualifications to serve as a director.

3.6 Declaration of Vacancy for Delinquency. Any Member serving on the Board shall be current in the payment of regular and special assessments or the delinquent director's seat may be declared vacant by the Board following notice to the director and an opportunity to meet with the Board in executive session to explain why the director should not be disqualified. A director shall not be considered "delinquent" in the payment of assessments if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the director: (a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) has requested and has not been provided an opportunity to engage in internal dispute resolution.

Strategy: There are 7 winning tricks and need to find two more. Obviously, a minor suit has to provide the tricks. His choice is to try a Diamond finesse or play the Ace and King of Clubs hoping that the Queen will fall. If South plays the Diamond finesse first, and it doesn't work, then the opponents will get in, run the Spades, and set the contract. Therefore, it would be a good idea to try the Club suit first and if it doesn't work then play the Diamond finesse.

West leads the 4 of Spades, 9 from the board, East, the 10, South, the King, switches to the Ace of Clubs, continues with the King and is happy to see that the Queen falls. South plays a Club to the Jack on the board, and then leads the last Club. He plays the King of Hearts, next a Heart to the Queen in his hand, follows with the Ace of Hearts. He then leads a Diamond to the Ace on the board, continues with Queen, East wins with the King, and plays a Spade. West wins with the Ace, follows with the good Jack of Spades, and leads his last card, the thirteenth Spade. Great. The contract is made exactly.

\* North doesn't have a 4-card major, but has more than enough points to bid game and not enough for slam.

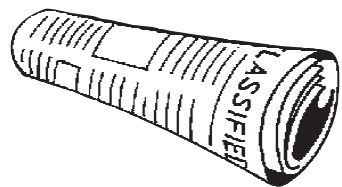

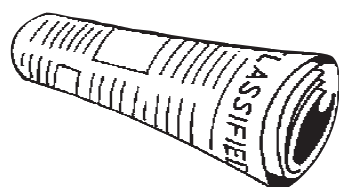

*(Continued from page 23)***ARTICLE 4 USE OF ASSOCIATION MEDIA AND CAMPAIGNING**

4.1 Access to Association Media – Candidates for the Board. The Board may, but is not required to, make Association media (e.g., newsletter, notice board, website, or other notices provided to the Members) available to qualified candidates running for election to the Board for purposes that are reasonably related to the election in which that candidate is running. If the Board allows any candidate access to Association media, then all qualified candidates shall be allowed equal access to the same media.

4.2 Access to Association Media – Other Matters. If the Board utilizes Association media to advocate a point of view on any matter (other than election of directors) that requires Member approval or allows any Member access to Association media for that purpose, then all Members advocating a different point of view shall be allowed equal access to the same media. The Board shall not be required to allow access to more than one Member advocating the same point of view.

4.3 “Equal Access.” “Equal access” shall mean publication of written statements not to exceed a predetermined length as determined by the Board. The Board shall not edit or redact any statement but shall not be required to publish any statement that exceeds the predetermined length restrictions. Modifications to formatting may be made so as to allow for space and/or media restrictions. If any formatting modifications should become necessary, they shall be applied equally to all submissions and at no time shall any formatting be applied that may signify a preference or partiality.

4.4 Responsibility for Content. All statements published in Association media pursuant to the “equal access” rules must identify the author or proponent. No anonymous statements will be permitted. The author and/or proponent of any statement or point of view shall be solely responsible and liable for the content of their statements. The Association shall not be responsible or liable for the content of any statement published pursuant to the “equal access” rules.

4.5 Campaigning. No Association funds shall be expended for the purposes of campaigning in connection with any vote or election other than those funds specifically required to distribute required correspondence, notices, or forms that may contain the names of candidates or necessary information on the issues being voted upon, or as is otherwise deemed by the Board to be necessary or appropriate for the fair and reasonable conduct of a vote or election, or to the extent necessary to comply with duties of the Association imposed by law. Specifically excluded is the expenditure of Association funds for the purposes of expressly advocating approval, election, or defeat of any candidate.

**ARTICLE 5 USE OF COMMON AREA MEETING SPACE**

5.1 Access to Common Area Meeting Space – Campaigning by Candidates for the Board. The Board shall ensure that during a campaign all qualified candidates for election to the Board are given access to common area meeting space (if any) upon request, at no cost, for purposes reasonably related to their campaigns.

5.2 Access to Common Area Meeting Space – Other Matters. Whenever the Board places a matter before the Members which requires Member approval, the Board shall ensure that Members advocating a point of view on the matter are given access to common area meeting space (if any) upon request, at no cost, for purposes reasonably related to advocating their point of view, whether or not they agree with the point of view advocated by the Board on the matter at issue.

5.3 All Access. Any use of the common area facilities for the purposes described above shall be regulated by any existing rules and regulations for such use. The Board, in its sole discretion, may reasonably limit a candidate’s or Member’s access to common area facilities in order to facilitate equal access for other candidates and Members, and so as not to unreasonably interfere with other Members’ rights to use such facilities.

**ARTICLE 6 INSPECTOR OF ELECTIONS**

6.1 Appointment of Inspector of Elections. Whenever there is a membership vote or election, the Board shall appoint one (1) or three (3) Inspectors of Elections, hereinafter individually or collectively referred to as the “Inspector of Elections,” whose powers and duties shall be as set forth in Civil Code section 5100 et seq. The Board shall have the power to remove an Inspector of Elections who ceases to meet the required qualifications, is unable or unwilling to perform their duties, or for other good reason, and to appoint a new Inspector of Elections in their place.

6.2 Qualification of Inspector of Elections. The Inspector of Elections may be any persons the Board reasonably believes to be independent with respect to the matter or matters being voted on and may include Members of the Association, but may not be (i) a member of the Board or a candidate for election to the Board or be related to a current member of the Board or a candidate for election to the Board or (ii) the Association’s manager, accountant, legal counsel, or any other person, business entity, or subdivision of a business entity that is employed by or under contract with the Association to provide compensable services to it at and/or after commencement of the election process other than serving as Inspector of Elections.

6.3 Payment to Inspector of Elections. The Board may authorize payment of Association funds to any third party appointed to serve as Inspector of Elections; however, no payment may be authorized for any Member appointed to serve as the Inspector of Elections.

6.4 Duties of the Inspector of Elections. The Inspector of Elections shall be responsible to perform their duties as follows:

6.4.1 Perform those tasks enumerated in Civil Code section 5110(c); and

6.4.2 Perform all duties impartially, in good faith, to the best of the Inspector of Election’s ability, as expeditiously as is practical, and in a manner that protects the interest of all Members of the Association; and

6.4.3 Make any necessary corrections to the Candidate Registration List or the Voter List within two business days of being informed of an error by a Member or by the Association; and

6.4.4 Deliver (or cause to be delivered) the following documents to the members at least thirty (30) days before an election: (a) the ballot(s) by first-class mail and (b) a copy of these Election Rules by (i) individual delivery or (ii) by posting the internet website address where these Election Rules may be accessed on the ballot together with the phrase in at least 12-point font, “The rules governing this election may be found here: [insert internet website address]”; and

6.4.5 Retain the association election materials as provided herein.

6.5 Indemnification of Inspector of Elections; Liability Insurance. The Association may, at the Board’s sole discretion, indemnify the Inspector of Elections to the fullest extent provided by law. The Association shall have the power to purchase and maintain insurance to protect it and/or the Inspector of Elections against any liability asserted against the Association and/or against the Inspector of Elections arising out of the Inspector of Elections’ acts and/or omissions relating to any Association vote or election.

**ARTICLE 7 AMENDMENTS**

The Board may amend these Election Rules from time to time except that these Election Rules may not be amended less than ninety (90) days prior to an election unless that amendment is merely to conform to non-discretionary changes in the law.

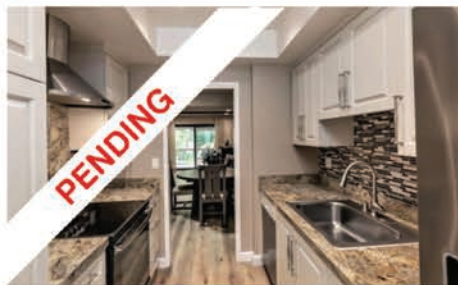
