

Message from the General Manager's Office

Shelter-at-home order extended to May 3



Dear Villagers, here are a few quick updates:



The golf course and associated practice facilities cannot be opened for play or practice as it is not considered an essential business under the county health order.

Public Safety cannot restrict persons that are providing essential services that residents have properly cleared.

Residents that believe they need Coronavirus testing should contact their medical providers for more information.

The Department of Public Health does not provide a neighborhood or household listing of those who have tested positive for the Coronavirus, and The Villages does not have that information as well.

The "Pink Palace" restroom near the 8th tee, or near Bocce Courts, is still open although folks are stealing supplies (which includes toilet paper) as fast as we can stock and restock. Many residents have worked through the outdoor bathroom limitations by walking in their beautiful neighborhoods. This "emergency" bathroom will remain open as long as the staff is available to keep it usable, clean and stocked.

The Clubhouse Restaurant and Bistro are closed for dine-in service, but are offering limited, to-go breakfast, lunch and dinner menus, available through our drive-through service, and a meal delivery service to villas, condos and single-family homes.

Residents are not permitted to have social gatherings within private residences during the shelter-in-place order, and are requested to keep their dogs on leashes when walking them.

Please stay at home, be safe and be well.

Essential services allowed during shelter-in-place; What's operating in The Villages?

While the shelter-in-place order has locked down California through April 7, the Villages Golf and Country Club ("VGCC") is continuing to provide essential services to residents at The Villages.

The Santa Clara County shelter-in-place order, that started March 17, and was revised March 31, has provisions that allow the Villages Golf and Country Club ("VGCC") to operate certain essential services.

According to the order, residential facilities that serve seniors are allowed to operate as an essential business provided that certain protocols are followed, including strict adherence to the social distancing requirement of 6 feet.

We recognize that the current health crisis and shelter-at-home order are unsettling, uncomfortable and certainly not business as usual for all involved. This health pandemic is uncharted waters for all of us that live, work and love The Villages.

Here is a detailed look at services at The Villages that are still permitted under the county and state order:

Business Offices: The business office is closed to walk in traffic, but for all general business inquires please call 408-223-4634 or email jmeadows@the-villages.com. If you have general accounting and payment questions, please call 408-223-4639 or email stlaloza@the-villages.com

Facilities Maintenance Operations: This is considered an essential business according to the county order, which allows plumbers, electricians, exterminators and other service providers to offer "services that are necessary to maintaining the safety, sanitation and essential operation of residences, essential activities and essential businesses."

Therefore, Facilities Maintenance Services will continue to provide maintenance services as outlined in the management agreement for the safety and wellness of the Association and District properties.

Facilities Maintenance Offices are closed to walk-in traffic but are answering phone calls and emails. Please call 408-223-4670 or email workorder@the-villages.com

Landscaping: Limited landscape safety maintenance may occur to keep plants, trees and grasses from getting overgrown. Fixing hazards in or near buildings or in landscaped areas; fire abatement activities; and broken irrigation system repairs are all permitted. New plantings and irrigation installations must be suspended.

The Villager, Website, Fastlane and Channels 26 and 27: As media vehicles and platforms classified as essential, these communication vehicles will continue broadcasting and *The Villager* will continue Friday delivery of the paper.

Club and Association Boards met for regularly scheduled March meetings

The Villages Association and Club Boards of Directors held their virtual online meetings Tuesday, March 31, with directors on their home computers.

Numerous items of business were discussed and voted upon.

Association Operating Financial Commentary

For the month of February 2020

February Operating Statement Review: Revenue was \$300 unfavorable to the budget of \$855,900 for the month, mostly due to less than planned laundry concession fees.

Expenditures for the month were \$34,200 (4.6 percent) unfavorable to the budget of \$734,400. The two most significant unfavorable to budget expense categories were water expense (actual \$124,300 vs. budget of \$101,600) and planting expense (actual \$32,500 vs. budget of \$18,200). Water expense was higher than budget due to the lack of rain in February and the need to turn the irrigation system back on. The only notable favorable to budget expense category was irrigation maintenance (actual \$4,800 vs. budget of \$8,300). The net negative operating budget variance for the month of February was \$34,500.

Year-to-date (eight months of operations), total revenue is \$3,300 unfavorable to the budget of \$6,845,500 due to less than planned laundry concession fees, third party assessments and golf cart electricity/storage fees. Year-to-date, total operating expenditures are \$6,642,500 or 0.7 percent (\$48,300) less than the budget of \$6,690,900. The positive budget variance is mostly attributed to the timing of planting expense (\$102,600 actual vs. budget of \$159,300). The most significant unfavorable to budget expense category is irrigation maintenance which is \$26,900 (or 23.4 percent) unfavorable to the YTD budget of \$114,700.

The year-to-date net <u>positive</u> operating budget variance is \$45,000.

Club Operating Financial Commentary

For the month of February 2020

February Operating Statement Review: Total revenue was \$86,300 favorable to budget, or 7.9 percent higher than the budget of \$1,096,800. With the absence of rain during the month, both the golf course and food and beverage operations had strong performances. Food sales were \$41,600 (25.5 percent) higher than the budget of \$163,000. Green fees were \$28,000 (32.9 percent) favorable to the budget of \$85,100. The only notable unfavorable revenue category was resident activities (due to timing), offset with lower resident activities expense.

Total expenditures were \$26,200 unfavorable to budget or 2.5 percent higher than the budget of \$1,056,300. The negative variance was due to three notable expenses lines: 1) Water - \$13,800 more than planned due to lack of rain, 2) Repair and maintenance - \$12,100 more than planned (work at pools and timing of video monitoring systems maintenance expense) and 3) Legal fees - \$9,400 more than planned. The net positive operating budget variance for the month of February was \$60,100. (See the table on the next page.)

Year-to-date revenue is \$85,000, or 0.9 percent, favorable to the budget of \$9,381,000. Year-to-date expenditures are \$94,000 favorable to budget, 1 percent lower than the budget of \$9,438,000. **The year-to-date net positive operating budget variance is \$179,000.** See table below for detail by department.

The bottom of the table on the next page shows the financial impact of the monthly solar lease payments and contribution to the balloon payment fund (to be paid in 2023) captured on the Club's balance sheet. The YTD total for these two items is \$156,000.

The above table shows Golf Course/Pro Shop with a \$72,000 positive variance due to more than planned revenue for green fees, Pro Shop merchandise sales, golf lessons and cart rentals, as well as less than planned professional fees, water expense and electricity expense. The community centers have a \$51,000 net positive variance from favorable utilities expense, intra-company cost transfers and rental income. All Other has a \$48,000 net positive variance due to less than planned Comcast fees, repair and maintenance, and planting expense.

Community Activities has posted a \$41,000 net positive variance from less than planned resident activities expense, as well as favorable advertising income and employee expense. Public Safety shows a \$31,000 net positive variance mostly from less than planned employee expense and favorable other income. G&A shows a \$23,000 positive variance from favorable employee expense, offset by unfavorable professional fees and legal fees. Clubhouse/Restaurant shows an \$85,000 net negative variance due to less than planned bar sales, higher than planned employee expense and legal fees.

Homeowners' Operating Financial Commentary

For the month of February 2020

February Operating Statement Review:

Revenue tracked budget at \$3,309 (non-Estates single family homes). Expenditures for the month were \$56 favorable to budget due to less than planned legal fees. The year-to-date net positive operating budget variance is \$448 (legal fees).

Estates revenue for the month was on budget at \$13,112. Expenditures were \$695 favorable to budget, 6.5 percent less than the budget of \$10,633 due to lower than planned planting expense (timing), offset by higher than planned water expense of \$870. All other expenditure categories were close to budget for the month. The year-to-date net positive operating budget variance is \$7,545 (planting expense and irrigation maintenance expense).

Coronavirus Q & A

Daily Activities

Q: Can I leave home to visit friends or family members in another household or living unit if there is no urgent need or I am not performing an essential activity?

A: No. For your safety as well as their safety, you are not allowed to visit friends or family members outside your own household. We need to help each other fight the spread of COVID-19 by staying at home.

Q: Can I still get my mail and deliveries?

A: Yes. Mail and delivery services may continue to operate under the Order.

Q: Can I still order the things I need online from businesses and have them delivered to my home?

A: Yes. The Order allows you to go online, purchase items, and have them delivered to your home.

Q: Can I go out to do laundry or to have my laundry done?

A: Yes

Q: Should I stock up on food, necessities like toilet paper, and on medicines? **A:** No. You will continue to be able to purchase these items. Stores selling necessary items like grocery stores, pharmacies, and hardware stores will stay open. Please continue to buy normal quantities of these items on the same schedule you normally follow. This will ensure that there is enough for everyone.

Q: What if I can't get out of the home? How can I get supplies and food?

A: Please contact friends, family, or others you know who can provide support. They are allowed to pick up the items you need. You can also order food and other supplies and have them delivered to your home. If you think you might be eligible for meals on wheels, call 408-350-3246 to start the eligibility intake process.

Q: Can I leave home to go to my church, synagogue, or mosque?

A: No. For your safety as well as the safety of your fellow worshippers, we need to help each other fight the spread of COVID-19 by staying at home. Places of worship may offer remote access to services, such as by emails, video streaming, or teleconference.

Q: How can I buy non-essential products if stores are closed?

A: Most items can be ordered online and delivered to your home, and many other non-essential items may be available from retailers who primarily sell essential items.

Q: Can I go to a bar, nightclub, or theater?

A: No. Entertainment venues are not allowed to operate.

Q: Can I go to a restaurant, café, coffee or tea shop, ice cream shop, or other foodservice location?

A: Yes, but only to pick up food. You cannot dine, eat, or drink in or around the facility. These facilities can also deliver.

Q: Can I walk my dog?

A: Yes, but you cannot use dog parks. Be sure that you distance yourself at least six feet from others who are not part of your household

Q: Can I take my dog to the dog park?

A: No. Dog parks are areas that encourage people to gather together, and are required to close.

Q: Can I go to a vet or pet hospital if my pet is sick?

A: Yes. Please call first to determine if the vet has any restrictions in place.

Q: I don't cook—how can I purchase meals?

A: Restaurants, cafes, food trucks, and similar establishments are encouraged to remain open to supply meals to the public via delivery and carryout. You can also purchase prepared foods at grocery stores, supermarkets, certified farmers' markets, convenience stores, and other such food retailers.

Q: How can I access free or reduced-price meals for myself or my family?

A: Schools, soup kitchens, food banks, and other entities that provide free or reduced price food or meals to the public are encouraged to continue providing these services. You must pick up and take away the food or have it brought to you. Do not eat on the premises.

Q: Can I carry out a court-ordered visit with my kids?

A: Yes. The Order exempts travel by court order or law enforcement.

Q: Can I still access necessary items in my self-storage unit?

A: Self-storage facilities are not essential businesses but that they can maintain minimum business operations and allow people to access their units to the extent they are accessing them for medical or other essential needs.

REAL ID deadline extended

Good news for many people. The Department of Homeland Security has delayed the deadline for needing a REAL ID to board a domestic plane for one year. You are not required to have a REAL ID until October 1, 2021 rather than October 1, 2020.

All California DMV field offices were temporarily closed to the public statewide beginning March 27. All appointments at this time have been canceled and no appointments are currently available. Please continue to check the DMV website for updates.

The DMV will launch a Virtual Field Office allowing customers to be able to complete vehicle title transfers and complex vehicle registration renewals online. This is in addition to the existing DMV online services and the kiosks in stores.

The customer service centers will continue to operate during regular business hours at 800-777-0133 or through live chat on the DMV website.

The Governor has asked California law enforcement to exercise discretion in their enforcement of driver license and vehicle registration expiration dates (including Smog Certification requirements) beginning March 16 and running until further notice.

Transactions that fall within the Governor's action include driver license renewals for those 70 years of age and older who are required to take a knowledge test and individuals who are required to renew in the office for some other reason.

Note: The Senior Resource Services (SRS) office is currently closed for drop-in assistance. You may still leave messages at 408-239-5253 as we monitor phone messages every day and can still answer questions by phone. We can also e-mail handouts. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

SRS Reminder:

Property tax due April 10

Don't forget that Friday, April 10 is the last date for paying your second installment of your Santa Clara County real estate tax for the fiscal year ending June 30, 2020.

You may pay online at www.scctax.org. There is no fee for paying electronically. Just have your check book in front of you so you can record the routing and account number. This way you don't have to worry about your check getting lost in the mail and you immediately receive a receipt by e-mail if you give them your e-address.

However, there is still a 2.38 percent fee for paying with a credit card and a 1 percent fee for paying with a debit card.

If you pay with a paper check, your payment envelope needs to be postmarked by April 10. At the time of submitting this article, there is no expectation that the California Legislature will give an extension of time for your property tax payment.

FROM THE BOOKSHELF

"A Long Petal of the Sea" by Isabel Allende: In the late 1930s, civil war grips Spain. When General Franco and his Fascists succeed in over throwing the government, hundreds of thousands are forced to flee in a treacherous journey over the mountains to the French border. Among them is Roser, a pregnant young widow, who finds her life intertwined with that of Victor Dalmau, an army doctor and the brother of her deceased love. In order to survive, they must unite in a marriage neither of them desires. Together with 2,000 other refugees, they embark on the SS Winnipeg, a ship chartered by the poet Pablo Neruda to Chile: "the long petal of sea and wine and snow." As unlikely partners, they embrace their exile as the rest of Europe erupts in world war. Starting over on a new continent, Roser and Victor face trial after trial. But they will also find joy as they await the day when they might go home. Through it all, their hope of returning to Spain keeps them going. Destined to witness the battle between freedom and repression as it plays out across the world, Roser and Victor will find that home might have been closer than they thought all along. A masterful work of historical fiction about hope, exile, and belonging, "A Long Petal of the Sun" shows Isabel Allende at the height of her powers. Fiction 2020

"The Testaments" by Margaret Atwood: Fifteen years after the events of "The Handmaid's Tale," the theocratic regime of the Republic of Gilead maintains its grip on power, but there are signs that it is beginning to rot from within. At this crucial moment, the lives of three radically different women converge, with potentially explosive results. Two have grown up on opposite sides of the border: one in Gilead as the privileged daughter of an important Commander, and one in Canada, where she marches in anti-Gilead protests and watches news of its horrors on TV. The testimonies of these two young women, part of the first generation to come of age in the new order, are braided with a third voice: that of one of the regime's enforcers, a woman who wields power through the ruthless accumulation and deployment of secrets. Long buried secrets are what finally bring these three together, forcing each of them to come to terms with who she is and how far she will go for what she believes. As Atwood unfolds the stories of the women of The Testaments, she opens up our view to the innermost workings of Gilead in a triumphant blend of riveting suspense, blazing wit, and virtuosic world-building. Fiction 2019

"Three Women" by Lisa Taddeo: Desire as we've never seen it before: a riveting true story about the sex lives of three real American women, based on nearly a decade of reporting. It thrills us and torments us. It controls our thoughts, destroys our lives, and it is all we live for. Yet we almost never speak of it. And as a buried force in our lives, desire remains largely unexplored—until now. Over the past eight years, journalist Lisa Taddeo has driven across the country six times to embed herself with ordinary women from different regions and backgrounds. In suburban Indiana we meet Lina, a homemaker and mother of two whose marriage, after a decade, lost its passion. She passes her days cooking and cleaning for a man who refused to kiss her on the mouth. To Lina's horror, even her marriage counselor says her husband's position is valid. Starved for affection, Lina battles daily panic attacks. When she reconnects with an old flame through social media, she embarks on an affair that becomes all-consuming. In North Dakota we meet Maggie, a 17-year-old high school student who finds a confidant in her handsome married English teacher. By Maggie's account, supportive nightly texts and phone calls evolve into a clandestine physical relationship with plans to skip school on her 18th birthday and make love all day: instead he breaks up with her on the day he turns 30. A few years later Maggie has no degree and no job. When she learns that this man has been named North Dakota's Teacher of the Year, she steps forward with her story.

Interesting golf terms from royalandawesome.com to contemplate during "the hiatus":

Afraid of the Dark: A putted ball which refuses to fall in the hole. Army Golf: The term "Army Golf" originates from the famous army marching cadence ("left-right-left"), which can be used when a player hits the ball left, then right, and so on.

Big Dog: Another term for the driver ("time to let the big dog eat"). Stiffing It: To "stiff it" is to hit a ball to "gimme" range from off of the green.

Fried Egg: When a golf ball has plugged, or buried, in a bunker, it hits the soft sand and settles down, creating a circular splash around the ball—the top half of the ball is visible, giving it the appearance of a yolk in the middle of a fried egg.

Frog Hair: Another name for the fringe—the closely mowed grass that surrounds a putting green.

Hosel Rocket: Another name for a "shank"—when the point of contact between the ball and club is the club's hosel (the part of the club head into which the shaft is fitted).

Nuked: You have "nuked" the ball when you achieve maximum distance with a particular club.

Pin-seeker: Hitting a ball straight for the flagstick, like a heat-seeking missile.

Snowman: A score of "8" on a hole. The connotation is for the figure's likeness to a snowman. A card covered in snowmen is inevitably one to forget.

Wormburner: A poorly hit shot that shoots along the ground. Yips: A term most often applied to a putting problem that afflicts most golfers at some point during their playing career. It describes a nervous tick which prevents the golfer from making short putts.

18 Hole Women

Since the golf course is "quiet," Judy Owens has written a reminder of some of the "new" golf rules. It is always helpful to have a review. Thanks, Judy.

When is a hazard not a hazard?

With the implementation of changes to Rules of Golf in 2019 the term "Hazard" was removed from the rules of golf. Now there are Red and Yellow Penalty areas. There were additional changes on what was OK to do in a penalty area. You can ground your club in a penalty area and remove loose impediments provided the ball does not move in the process. It is OK to take a practice swing touching the ground in a penalty area. You can take relief from Red and Yellow penalty areas with a one stroke penalty. Yellow penalty relief: stroke and distance relief and back on the line relief. Red penalty area relief includes a third option: lateral relief.

Bunkers are not penalty areas. That means that the things you can do in a penalty area do not all apply in a bunker. You cannot rest club on sand immediately in front of or behind the ball. You cannot take a practice swing touching the sand in the bunker. You cannot touch sand on backswing. Before the rule changes there were many things you could not do in a bunker. Now you can remove loose impediments provided the ball does not move in the process; can touch the sand with your club or hand; rest a club on the sand. If the player decides the ball in the bunker is unplayable they have two choices: take one of three types of relief in the bunker with a one stroke penalty; or move the ball out of the bunker using back on the line relief with a two-stroke penalty.


Ladies of the Court



Tips From The Pro

This is a great visual image of the proper set up technique for a full shot. We call this "building your stance around the clubface". This is referring to the proper sequence of a golf set up routine. This would be a great sequence of actions to move from the "think box" into the "go box". First stand behind your ball and pick your target. Second, set the clubface behind the ball aimed at your target...tilt your head and do a target check. Third, build your grip and stance. Lastly, once comfortable after a couple of club waggles...let it go! The key here is to always start from behind your ball, always have a target in mind, and always align the clubface first and your body second. Remember the clubface dictates where the ball goes! See you at the Course!

Our very own 'Brigadoon'

Sandy and I counted ourselves fortunate back in 2014 when we stumbled our way into The Villages. We had lived in Almaden Valley for 40 years and had never heard of this place. In fact, we had virtually never ventured into East San Jose, except maybe to take the kids to Raging Waters when they were little. But Sandy had been dimly aware that an old high school friend had moved to some place in the East Foothills of San Jose called The Villages. So had the mother of one of our daughter's friends. Thanks to the Internet, I was able to Google The Villages of San Jose (not Florida) and learn more. The website I found showed only one real estate company. I figured they were the only ones that dealt with Villages buyers and sellers. After all, there couldn't be that much turnover there.

I contacted them and our journey began. During the process I got my hands on The Villages Resource Guide. The 2014 issue and a few subsequent issues noted that by some accounts The Villages was the best kept secret in San Jose. We certainly had to agree! As an aside, the first VAT show we attended, March 2015, was "Brigadoon," the story involving two American tourists who stumble upon this mysterious Scottish village that appears for only one day every 100 years. In a similarly mysterious way, it seemed to us, we had stumbled upon The Villages of San Jose.

During visits to the real estate agent's office over the weeks I would read the latest issues of The Villager to get a feel for life here. I remember asking the agent about used golf carts. I told him I imagined that there would be a small network of buyers and sellers that residents could tap

into. He said that he just tells new people to listen for the sirens, follow the ambulance, and ask the resident whether they have a golf cart they no longer needed. I found that really comical and obviously never forgot it.

We have been residents since near the end of 2014. By my analysis, about two-thirds of our HOA dues represented expenses we were already bearing, such as the gardener, the water and garbage, gym memberships, pest control

and the like. We would also have reduced homeowner's insurance premiums and Internet connection fees. The remaining third of our dues represented to us the beauty of the golf course, even though neither of us played golf at the time. What we initially overlooked, but place great value on now, though, is the safety and security we enjoy here. As we hear about porch pirates and break-ins "out there," we are so glad to live here in The Villages. We also didn't know about the VMA and how it enables us to "age in place."

We all came from someplace else, of course, and we all had jobs and careers that we retired folks don't have anymore. It all seems so strange and surreal. I dare say that most of us didn't know what retirement would be like, and probably none of us expected to live out our retirement years in a place like The Villages. This is not a commercial for The Villages. You already live here. If anything, maybe it is a reminder and an attempt at mutual rejoicing. I am writing this during the coronavirus "shelter in place" time. I have no idea when you will be reading it. Maybe I am only cheering up myself.

I have come to realize and verbalize recently how much I enjoy the critters around us. We have a pond just down the hill and off to the left from our del Lago townhouse. Sleeping upstairs with the windows open from early spring to early winter, I fall asleep listening to the ruckus that the crickets make, and wake up to the quacks and squawks of the ducks and geese. Sound travels nicely up from the pond area to the second story window. As best I can estimate, it's around 6 a.m. that the crickets go to sleep and the ducks and geese wake up and take over; although I have woken up in the middle of the night to the sound of bullfrogs, too. I presume the fowl start looking for food in the morning. What the crickets were accomplishing all night, other than making a racket, I have no idea.

It starts at nightfall with one cricket, then a few others join in, and pretty soon it sounds like there are thousands of them. Then a mysterious thing happens: They all fall silent at once. I can't imagine how they coordinate. It is as if they have a choir director they are all watching in the dark: When the signal is given they all shut up like a well-disciplined, well-rehearsed choir. After a minute or two of silence, the cycle starts again: One cricket becomes two, becomes 10, then seemingly a thousand. Then after a few minutes of this, another abrupt silence.

Strangely but fortunately, I love falling asleep to the sounds of the crickets and waking up to the sounds of the ducks and geese. I mentioned to Sandy the other day that, though we have many fond memories of our lives together, I don't think I have ever been happier than I am today. Each spring when we begin again to sleep with the windows open I renew my acquaintance with the cheerful-sounding little critters and the hungry birds. A new day; a new season; a new life.

Don't Feed the 'Critters'

One of the many attractions of The Villages is the variety of wildlife that can be encountered on a daily basis. Many Villagers feel that being a good host necessitates feeding our four-legged or winged guests on a routine basis, which can be quite detrimental to our wild friends. Most wild animals naturally fear humans and keep their distance. Problems arise when animals have access to food and garbage left out by residents. They develop an appetite for easy pickings and keep coming back for more. When this happens, they often lose their natural fear of humans and can become aggressive. To prevent that, residents should not leave out any type of food, including canned food, in a manner that may become accessible to our furry friends.

Please comply with Villages Golf & County Club Rule 1.51.4, which states: "Feeding of waterfowl and other wild animals on a routine basis is prohibited for the protection of both residents and the animals."

Who is responsible for your pet's waste?

The Villages Rules and CC&Rs states it is the owner's/handler's responsibility for immediately cleaning and disposing of pet excrement in a sealed container. We are finding and hearing that some owners are not immediately cleaning up after their pets and assume that it is the responsibility of the landscaping crew, which it is not.

The pet poop should be picked up immediately and placed into the dumpsters in the trash enclosure near your home or in the designated pet poop stations in the center parking lots. Please do not place any pet poop in any restrooms or other containers at any of the various centers.

Please help us keep our beautiful community clean.



Landscape & Maintenance

BrightView Activities at The Villages

To follow is a list of landscaping activities that will continue due to time sensitivity, activities we will postpone until after the shelter-in-place restriction is lifted (as they are non-essential) and activities that BrightView will take a modified approach on to keep the site clean and safe, in alignment with the new county health order.

Modified Activities:

- Mowing is typically done weekly this time of year due to warm weather, rains and fast growth. However, we will mow every two weeks instead, to minimize creating pest and rodent habitats. This will result in slightly unkempt looking lawns in the off-weeks.
- Edging of lawns will be done approximately one time per month just to keep overgrowth off sidewalk edges.
- Blowing will be done as needed, to blow grass clippings from mowing, larger debris from trimming, and significant leaf drop or other debris. All sidewalks and walkways will not be blown on a regular rotation (as they currently are).

Postponed Activities:

- Annual color installation will be pushed to May, to be installed after the restriction is lifted.
- Fertilization will be done towards the end of the month so that when we get a flush of growth, it will be in May, when mowing can be done weekly.


Continuing Activities:

• Tree pruning will continue on a daily basis due to the size of the site, to reduce fire-fuel, limb drop hazards, etc.

Time-Sensitive Activities:

- Aerating will commence today and continue for a couple of weeks until completed. This is the ideal weather for this service as it allows for water penetration into the turf rather than run off, and if we conduct this work in warmer weather, we are likely to damage/dry out the lawn.
- Pruning will be done selectively. We will focus on plant material overgrowing walkways, fast-growing shrubs like Abelia that can grow out of control in a matter of weeks and shrubs in areas between homes and nature areas, to reduce possible future fire fuel.
- Weed control will continue as it has. A month of no weed control will result in one-inch-tall weeds, a deferred maintenance clean up and possible fire fuel.
- Irrigation repairs will need to be kept on schedule to ensure the irrigation system is functioning properly in the hot summer months to reduce dry plant material/potential fire fuel.
- Planting work that has been approved and which cannot be done in summer months, will continue as usual.

With the reduction in mowing activities, the postponement of the annual color and some of the modified edging and blowing, we will reallocate that labor to the fire fuel areas in preparation for this summer's fire season.

Dial 211 for Essential Community Services

In many states, dialing "211" provides individuals and families in need with a shortcut through what can be a bewildering maze of health and human service agency phone numbers. By simply dialing 211, those in need of assistance can be referred, and sometimes connected, to appropriate agencies and community organizations.

Dialing 211 helps direct callers to services for, among others, the elderly, the disabled, those who do not speak English, those with a personal crisis, those with limited reading skills, and those who are new to their communities.

Several Ways to Contact

Types of Referrals Offered by 211

Basic Human Needs Resources - including food and clothing banks, shelters, rent assistance, and utility assistance.

Physical and Mental Health Resources – including health insurance programs, Medicaid and Medicare, maternal health resources, health insurance programs for children, medical information lines, crisis intervention services, support groups, counseling, and drug and alcohol intervention and rehabilitation.





City of San Jose closures and cancellations

These cancellations and closures from the City of San Jose blog.

Parks, playgrounds and attractions: Practice Social Distancing

Effective Friday, March 27, the City of San Jose has temporarily closed Alum Rock Park and the Communication Hill Trail and staircase. This is due to overcrowding and disregard of the County and State Orders to shelter in place and keep a social distance of at least 6 feet from others. Other parks (or areas within parks) experiencing high visitation or disregard for legal orders may be subject to closure to keep people safe and reduce stress on emergency services and first responders, police, and park rangers.

The following parks are temporarily closed: Please note, this list is fluid and will be updated regularly on the City of San Jose website.

Alum Rock Park

Communications Hill Trail and Staircase

Playgrounds are closed to prevent cross contamination of COVID-19 in children and youth. Park and trail users must refrain from using parks or trails if they are sick or exhibiting symptoms; maintain a physical distance of at least 6 feet from others; and follow Centers for Disease Control and Prevention guidance on personal hygiene prior to, during, and after use.

The City of San José will be closing all city-operated attractions effective immediately, including Happy Hollow Park & Zoo and Lake Cunningham Action Sports Park.

For Emma Prusch Farm Park, the following have been closed: Hatchery Preschool—All classes and activities through the end of March; school tours through end of March; small animal area; and the Animal Barn

Community centers: Closed with exception to senior nutrition

The City of San José will be closing all community centers effective immediately, with exception to the Senior Nutrition Program. The Senior Nutrition Program has transitioned to a boxed pick-up lunch format until further notice.

The Neighborhood Center Partner Program "Reuse" Request for Qualifications has been postponed as well.

This closure will take effect immediately for the following centers:



All City events have been postponed effective immediately, including: All PRNS Commission meetings, Neighborhood Commission, Parks & Recreation Commission, Senior Commission, Youth Commission, All City volunteer events, Alum Rock Trail Crew on Saturdays, Sunday in the Park series, The Japanese Friendship Garden Scout Cleanup on 3/21, Aging Mastery Program for Caregivers, Arcadia Ballpark Grand Opening on 3/28, Black and White Ball, Caregivers Conference, Clean Slate Tattoo Removal Program, Citywide Teen Ski Trip, Fish Camp, Gen2Gen AARP/SJSU/PRNS, Latino Caregiver Conference, Neighborhood Night event series, Movies and Meals Film Festival and the Volunteer Appreciation Event.

Program and rental refunds: Currently processing

All PRNS rentals and program fees will be refunded, beginning March 17. This includes prorated refunds for all cancelled classes. Due to the high volume of requests and response to the COVID-19 pandemic, it is important to note that all refunds issued by the city may take longer than the usual 2 to 6 week window. Automatic payments are currently on hold as community centers are closed to the public, and all programming is suspended until further notice.
