## Golf Re-Opening Safety Guidelines for The Villages Golf and Country Club

In Compliance With the Existing Health Orders by the County and State

May 6, 2020; updated May 9, 2020

#### **GOLF GUIDELINES**

- Any player with a fever or recent contact with anyone known to have COVID-19 is not allowed at the facility
  - · Golfers are encouraged to wear facial coverings
  - Members only—No guests until further notice
- · All 6-Clubs scheduled golf days and golf events are postponed until further notice. The golf course will be open for recreational golf only on Mondays at 1 p.m., and Tuesday-Sunday at 7 a.m.
- · Modified hours No Twilight Golf Last tee time is 3 p.m. Golf Course is CLOSED at 7 p.m. and all golf play must cease and golfers must leave the course
- · All golfers must have a reservation—no walk-in play—even for Par-3 Course
- · Must use your own cart or walk single cart riders only unless family members from the same residence
- No carts on Par-3 Course
- Cart parking at Clubhouse every other spot will be blocked
   Expectation is that each golfer will show up only 10-15 minutes prior to their tee time, keep things streamlined and simply go play golf. No gathering or socializing for extended periods of time before golf. And social distancing must always be maintained. No "hanging out"
- Pro Shop is closed to foot traffic
- · Individuals can purchase necessities only. Pro Shop staff will deliver necessities or scorecard packets outside to resident
- · All transactions billed to the house number no cash or credit cards
- Singles play only, no group play and no tournaments. Tee Time reservations are required for both the long course and the Par 3 course. Tee Times may be booked through Chelsea or by calling the Pro Shop. Players phone the Pro Shop to check in or can stop by the Pro Shop window to wave and check in. Singles may play the same hole at the same time with up to three (3) other singles and up to one (1) other single on the Par-3 Course
- · All play starts from the #1 tee—No shotguns
- 10-minute minute tee time increments
- · Recreational golf ONLY No tournaments, no sweeps
- No pre or post-golf gathering for any reason—golf and go home
- · Only golfers scheduled for the next tee time shall be on/near teeing ground at any given time
- · One rider per golf cart, unless family from the same household
- Driving range CLOSED until further notice
- All Practice Greens CLOSED until further notice

#### **ON THE GOLF COURSE**

A Golf Staff Member will be on the golf course all day to answer any questions and to ensure that all

- safety protocols are being followed by all golfers
- Golfers must maintain social distancing—6 feet apart Face masks are encouraged but not mandatory
- · Raised Cups Flags in
  - Do NOT touch flags hit the raised cup and ball is holed then pick it up
- At tees and greens, carts must be parked 6-10 feet apart, minimum. Please spread out!
- · 1-in-1-out restroom policy / must wash hands / no touch towel dispensers
- · No ball-washers
- · No benches
- No sand-seed scoops / No Sand-seed bottles
- · No Bunker Rakes Play bunkers as GUR, pick up ball and drop at nearest spot outside bunker, no penalty

#### **PLEASE DO NOT**

- · Ride together in a cart
- Touch Flagsticks for any reason Touch another Ball only yours
- · Touch another Tee, only yours
- Stand closer than 6 feet apart
- · High-five, fist/elbow bump, or shake hands
- Play from sand bunkers
- Pick up trash

Right now we are not allowed to use any of the amenities that we moved here for and for which we pay high HOA prices. I will not go into the politics of the situation at all here because it is irrelevant.

I am not a golfer but golfers come here to golf. I use the gym, the pools and hot tubs, the clubs and other amenities, all of which are denied to me now. Nonetheless I write a check each month for over \$1,100 to the HOA.

Now, since this amounts to a broken contract between Villagers and the HOA, and since no one can give us a date when we will be allowed to use what we are paying for, how about a break in our HOAs while we are not allowed to use the vast majority of we are paying so much money for?

I look forward to a response from the HOA in this regard.

Stop Sign Conversation:

It appears many residents are having difficulty with the "rolling stop sign" rule.

First, we all understand: it is never okay to not stop at a stop sign or to exceed the speed limit. It is almost impossible to argue for breaking traffic signs. So then what is the problem? If some questions were answered we may know. For example, why have the violations increased from 1 to 300+ in one year? Who is asking security to severely increase violations? And why? Is this severe change in policy money motivated? I am sure the change did not happen because of a rash of accidents or because the professional, respectful and well-meaning residents of this community drastically changed. Respect and transparency are paramount, which has been lacking. I would offer a suggestion: continue to stop people for violating traffic signs, BUT issue a warning for the first offence, which is being sensitive and respectful to the community and situation. As an example: is it really necessary to fine a motorist for going 2 or 4 miles over the speed limit? The yield signs suggested previously is well worth discussion.

### 2020 Director Elections Updates, Ballot Information, Candidates' Night and More

As you may have read in previous editions, for all three Villages Corporations (Club, Homeowners' and Association), elections will be conducted in May and June and this year's annual meetings will be held on Wednesday, June 10 via teleconference.

All ballot packages are scheduled to be distributed beginning May 6 (you may have already received yours) with the deadline of Monday, June 8, at 8 a.m. for the return of ballots. Ballot counting will take place in an open teleconference meeting on Tuesday, June 9 at 9:30 a.m. Results are to be announced the following day, Wednesday, June 10 at the annual meetings-all via teleconference meetings, with the Association's to be held at 4 p.m., the Homeowners' Corporation at 4:30 p.m. and the Club's at 5 p.m. Specific meeting information to be published in future Villager editions and is included in annual meeting notices distributed to all members in their ballot package.

#### **Board of Directors Elections**

Candidate Information, Candidates' Night and Villager Questions. As detailed in the information that follows below, the candidates for the Association and Homeowners' Boards have been elected by acclamation per their corporation's governing documents. Only Člub candidates participated in this year's Villager Candidate Questions and Candidate's Night (a virtual program) sponsored by the Club's Communications Advisory Committee. Candidate's Night can be seen on Channel 27 at noon, 6 p.m., midnight and 6 a.m., as well an on the Villages Resident Portal. (See pages 10 and 11 for all candidate information.)

Association: On the Association's Board, there will be two director vacancies. As with the Club, the Amended and Restated Bylaws of the Association Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are Garry Ashby, David Cook, Diana Hallock, Noel Lanctot, and Julie Wash. The two directors for which terms expire are Matthew Giordono and Frank Veloz.

Pursuant to The Villages Association Rule 2.25 Voting and Election Rules, Richard Holmboe is a candidate for the annual election of Directors. In addition, pursuant to Article 2.3 of Rule 2.25, because the number of people nominated is not more than the number of Directors to be elected as of the published and duly noticed deadline for nominations (March 31, 2020), Richard Holmboe is declared elected by acclamation and shall take office at the first Board meeting following the annual meeting.

Homeowners: The Bylaws of the Homeowners' Corporation provide that there shall be five Directors. The Directors previously elected by the owners who will continue to serve are: Mary McBride, Ron Steckel, and Greg Stewart. As of the deadline of May 1 at 5 p.m. there have been two candidates nominated and qualified, Rob Kirschbaum and Richard Zahner, and per Section 7.3 of the Second Amended and Restated Bylaws of The Villages Homeowners' Corporation they are declared elected by acclamation and will begin their terms as Directors on June 10, 2020, upon adjournment of the Annual Meeting of the Members.

**Club:** The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Those who

will continue to serve during the ensuing year are Rick Casey, Jan Champion, Mike Falarski and Teddy Morse. The two director terms that expire are that of Bob Wilk and the late Jim Neill, and with the resignation of Frank Langben, there will be three director vacancies, two directors to fill a three-year term and one director to fill the one-year term that completes the remainder of Frank Langben's term.

There are three candidates for whom nominations have been qualified for the ballot, Bob Wilk, Jeannie Omel, and Howie Blumstein. Pursuant to the Bylaws Section 6.2, the persons receiving the largest number of votes shall be elected and, of those persons

elected, the two receiving the largest number of votes shall be elected to three-year terms and the one receiving the lowest number of votes shall be elected to the shortest position term, a term of one year.

IRS Resolution Vote: For all three corporations, vote packages will include a ballot resolution, Excess Membership Income Over Membership Expenses Refunded to Members. An approval vote of these resolutions will enable the corporations to avoid income tax on operating surpluses by refunding these surpluses to the membership in the form of assessment reduction in accordance with IRS Revenue Ruling 70-604.

Please take the time to vote and return your ballot.

## A Message from your Association Operations Manager

It is my responsibility to routinely inspect the community for rules being broken. As you may know, the Association's rules were developed and approved by your Board of Directors. They are revised from time to time when recommendations are made by members, the Rules Committee, or the General Manager. The rules are designed to provide uniformed protections for all Villagers.

I would like to inform Villagers of the most common Association rules being broken that I've noticed when conducting my inspections.

Rule 2.07 Common Area Alterations: Owners (or residents) may not alter, or install any improvement on common area, including common area landscape, without the prior approval of the Architectural Committee (AC).

Rule 2.21.12 Association Common Areas: Residents will not place items in common areas including utility closets except where specified in Rule 2.08 and/or AC approval. Prohibited items include but are not limited to yard art, statuary, figurines, potted plants and planter boxes.

Rule 2.08.3 Maintenance of Villas and Limited Common Areas: Each resident is responsible for keeping the garage, carport, patio, and other limited common areas that are open to view by others in a clean, orderly and sanitary condition.

Rule 2.08.4 Maintenance of Villas and Limited Common Areas: A 36-inch-wide, clear pathway must be maintained on all exterior stairs, stairway landings and villa entryways. Potted plants, or other decorative items, may be permitted within a minimum of five feet of the front entry door as long as they do not encroach into the 36-inch-wide pathway.

<u>Rule 2.10.2.D Sound, Visual, and Odor Restrictions:</u> Decks, patios, balconies and porches are not intended for storage. This restriction includes, but is not limited to, refrigerators, freezers, and household furniture. Storage cabinets over three feet in height must have AC approval.

Rule 2.23 Wood Preservation Requirements – Common and Limited Common Area: A. Wood Decks and Railings 1. Potted plants, figurines, or other decorative items are not permitted on wood railings; 2 Potted plants, including those in trays or pots that have holes in either the sides or bottoms, are not to permit water or moisture to reach the wood deck; 3. All items must be supported above the deck flooring in a manner that permits moisture under the item to evaporate; 6. Vine growing plants are not to cling to wood decks, railings or walls; 7. Trees planted in the limited common area shall have sufficient clearance from walls and fences. Trees shall not exceed seven feet in height without AC approval.

Please take some time to check around your home to see if any of these rules are being broken and try to correct them before I come by to inspect.

## Explore The Villages' beautiful hill lands

Since the institution of the Shelter in Place Order, The Villages Hiking Club, like all other Clubs, has ceased having meetings and sanctioned group hikes as required by the Order. However, not only Hiking Club members, but also all Villagers are still allowed access to our beautiful hill lands for individual hiking so long as social distancing is practiced.

Our hill land property consists of 450 acres with an elevation gain from 800 to 2300 feet. There are multiple well-marked trails, some relatively easy and others more difficult. Given enough time, most of our active seniors can make it to the top and be treated to a magnificent view of San Jose and even Mount Hamilton. Getting there usually takes less than two hours and it is about a 4-mile round trip.

One of the Hiking Club's important purposes is to promote the preservation of the Hill Lands, the natural springs and trails in their present pristine condition. The Club's annual Trail Maintenance Day does part of this when volunteers spend a Saturday touching up the trails for a better and safer hiking experience. This is usually done in the early spring when the soil is more easily workable. This could not be done this year due to the necessity of social distancing, but a few hikers occasionally grabbed a tool or brought their own and did what they could in addition to a having wonderful hike.

However, not only this year, but also always, The Villages Club Board regularly provides workers with power equipment to do most of the necessary

work of maintaining the trails. If something is more of a major undertaking like making a new trail or widening an old one, the Board has authorized an outside contractor with the necessary expertise to perform that task.

As for staff work, it is not uncommon for a hiker to report a fallen tree across a path and the trail is opened up on the next day. Recently, hikers were encountering ticks, especially where the long grass has encroached onto the trail. This was reported to Maintenance and on Saturday, May 3, 2020 at least four men with two mules (not the hay eating type—only gasoline) were observed on the trails making our trails safer and more enjoyable. From the two photos taken by Hiking Club members, you can see the workers weed whacking the high grass so that picking up hitchhiking ticks will be less likely; and the other, with three hikers practicing social distancing and enjoying the newly mowed Switchback foot trail. The other trails that were observed as being weed whacked were upper Meadow, upper Rawhide, and upper Oak.

The Villages Hiking Club appreciates all of the assistance given in preserving the Hill Lands in their pristine condition.

So if the high grass in the hill lands has discouraged you from leaving the short golf course grass, feel free to experience this gem that is within walking distance of your home. Of course, many will drive their vehicles and park near one of the two trailheads; but out of respect to the gardeners of Garden Clubs and the horse owners at the stables, all who need adjacent parking, please park at the Foothill Center for the Stables entry or at the cul de sac at the Upper Gardens entry. It's only an extra 100 yards added to your hike.

So, even if you are not yet tired of being in semi isolation, experiencing The Villages Hill Lands should be on your "To Do" list.






## VMA Office closed for now

#### Permitting Meetings, Sports Activities



## 'Forty... but not Forever!'

In the Hebrew imagination, any multiple of 40 is a really long time. Perhaps it rained for 40 days and nights while Noah and his menagerie were quarantined together, perhaps it was 40 years that the people of God wandered in the Sinai desert, perhaps Jesus spent 40 days fasting. Or perhaps a little less or a lot more; what we know for sure is that it felt like a long time to the characters involved. We know this because the biblical writers used the symbolically significant 40-something to describe the time period... and at the end of their long time of trial, the faithful emerged with greater commitment to God and to each other.



It's been more than 40 days now that we've been sheltering in place. You get where I'm going with this, right? It feels like we've been waiting a long time and we'll be waiting even longer still. Waiting to visit friends and family, waiting to travel, waiting to come back to church. And this wait, like every Biblical interval of 40-something, will change us. God did not give us a virus as a trial, but God does have the capacity to transform every trial for good. We already see it happening as we're sheltered, in the care and generosity of neighbors. Who knows what kind of community we'll be when we gather again, but I'm going to trust the Scriptural record and assume that we're being made more faithful during this quarantine (a word whose Latin etymological root is "40").

Being the people of God's transformative 40 doesn't mean we can't be bored, cranky, or anxious during this long pause. Go ahead—feel all the feels—as our millennial grandchildren would say. And know that all your feelings are holy to God, who accompanies us and renews us. But also give yourselves a few minutes every day to imagine a future in which God transforms our sorrow. A future in which the earth is healed (Genesis 6-9), in which people are more free (Exodus 13-40), and in which we have the capacity to choose the better way God calls us to (Matthew 4:1-11). That kind of future is merely 40-somethings away!

#### What is a Foot Fault?

**The Rule:** A foot fault occurs when one player steps over or on the baseline during a serve before making contact with the ball. Similarly, if your foot touches the imaginary extension of the center mark you will also be called for a foot fault. That is the short answer, but for a more in-depth look read on.

The Foot Fault in Every Day Play: Most people aren't playing in the U.S. Open. Most are just at their local court with a buddy trying to get away from their household responsibilities for an hour or two.

So, where does the foot fault come into play for these matches? As straightforward as this rule usually is, it's actually one that isn't invoked very often. Why? Most footfalls aren't glaringly obvious. They might be small, and only observable to the person committing them, or to an outside party that is purposely watching out for them.

If a foot fault is called in a casual match the person doing it will probably need to volunteer the verdict. It's not necessarily a big deal, but it can muddy up the game. If you are playing with someone and you constantly foot fault, they might get irritated over time. It slows things down, it's easily avoidable, and, frankly, it's an amateurish move to make over and again.

Why Foot Faults Will Hurt your Game: If you do experience a foot fault call, it can impact your game in two ways. For one thing, the penalty itself. Foot faults are weighed the same way as any other missed serve. If it your first serve, you get a redo. If it's your second, you lose the point. In the former case, it might seem like a low stakes matter. And indeed, it can be. But a foot fault call can disrupt your concentration, and the overall flow of your game. Tennis works best when everything is smooth and streamlined. To keep your game as tight as possible, you will want to avoid any type of fault.

Notes from Betty Olsen, Tennis Club President: "I'm writing this on May 8 to let you know that by May 15 when you actually read it, the situation could be very different as rules are shifting and changing daily. Last week I appointed six to a committee to research rules and directives to form guidelines for tennis to reopen on a limited basis. Phyllis Seeger and Jim Murphy chaired the committee, as well as Roy Pennington, Ken Kline, Sherry Benz and Akiko Giordono. On Wednesday, May 6 I presented their guidelines to Tim Sutherland, Julia Meadows and Jan Champion. On May 7, I received an email from Tim Sutherland that too few people would be eligible to play open tennis now, but that they would carefully review the Tennis Club guidelines we sent."

## **SHONIS**

News of the opening of the golf course was greeted by the Shonis with plenty of electronic "hurrahs!" At this writing we understand that the Par-3 Course is open to non-club play, for groups of no more than two, and for walkers only-no golf carts on the Par-3 Course. Captain Bonnie Evans, in her regular Monday Morning email of May 4 had said that the protocols were pending. The next day she sent out the protocols and procedures, and by Wednesday we were hearing of Shonis having tee times. We are also aware, of course, of the rules and guidelines published via Fast Lane and included in The Villager. Bonnie suggested, in addition, that each golfer putt out, rather than taking turns on the greens.

West leads the 5 of Hearts, East, the Queen, South, the King, switches to the Jack of Clubsl; overtakes it with the King on the board, plays the Queen of Diamonds, and West takes the trick with the King. He leads a low Spade, East, the 10, South, the Jack; then plays a low Diamond to the Jack on the board, continues with the 10 of Diamonds, next plays the 7 and wins with the Ace in his hand. He leads the Ace and then the Queen of Clubs. He now plays the 9 of Hearts; West covers with the 10 and takes the last trick with the Ace of Hearts. Great! The contract is made with an overtrick.

\* South has 20 HCP with a flat hand and opens 2 NoTrump. North knows that his partner has a flat hand with 20 or 21 HCP and bids game since he has no 4-card major and enough points to bid game and not enough points to suggest something more than game.

## Even non-profits must file IRS returns

Does your social club, activity club or special interest group have a bank account? If it does, this means it has an Employer Identification Number (EIN) from the IRS. Are you an officer or leader of the group? If you have answered yes to these questions, SRS has another question for you. Are you the person responsible for filing the required annual report with the IRS?

Of course, the next puzzlement is which IRS form to file? You have a choice of form 990, 990-N, 990-EZ and 990-PF. The primary test for the form number is the club's gross receipts.

Are the gross receipts of the organization \$50,000 or less? If so, all the organization needs to file is Form 990-N also known as the e-Postcard. Form 990-N must be filed online at the IRS web site. It is easy. You do not have to be an accountant to do this form. It requires eight items of information:

- Employer identification number (EIN)
- Tax year (most likely calendar)
- Legal name and mailing address
- Any other names the organization uses
- · Name and address of a principal officer
- Web site address if the organization has one
- · Confirmation that the organization's annual gross receipts are \$50,000 or less
- If applicable, a statement that the organization has terminated or is terminating (going out of existence)

  If the group's gross receipts are more than \$50,000 but less than \$200,000, the organization

If the group's gross receipts are more than \$50,000 but less than \$200,000, the organization will likely file Form 990-EZ. Gross receipts of more than \$200,000 will require the long Form 990. Private Foundations will file Form 990-PF. Most likely as an officer of a group with large receipts, you already have legal and accounting services and advice. By the way, churches are not required to file these reports.

Most likely the group reports on a calendar basis which means the return is normally due May 15 (the 15th day of the fifth month after the close of the group's year). However, as we all know, this year is different in many ways. Tax returns due from April 1 until July 14 are not due until July 15, 2020.

The IRS web site is highly informative for non-profit organizations. It has access to the filing site for Form 990-N and also includes the Forms 990-EZ and 990. Go to www.irs.gov. In the top right corner is a drop-down menu labeled Information for...with a choice for Charities and Non-profits.

Of course, the State of California would also like to hear from the non-profit. The State forms are similar to the IRS forms starting with the e-postcard form 199-N. Go to www.ftb.ca.gov. Enter "charities nonprofits" in the search box; then click on "Annual Filing Requirements" and you will see 199-N.

Note: The Senior Resource Services (SRS) office is currently closed for drop-in assistance. You may still leave messages at 408-239-5253 as we monitor phone messages every day and can still answer questions by phone. We can also e-mail handouts. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

## Contractor problem with PG&E Energy Program

As activity opens up in The Villages, be alert to contractors making false claims about the PG&E Energy Program. There are some contractors claiming any Villager on Social Security qualifies for free insulation and other work through the PG&E Energy Savings Assistance Program.

To qualify for the PG&E program, you must have income in the lower range or be on a qualifying public assistance program such as Medi-Cal or SSI. Social Security is not a public assistance welfare program. The PG&E web site details the income limits (\$33,820 for two people) and the qualifying welfare programs. As always, remember that income for assistance programs includes nontaxable income such as Social Security.

The Energy Savings Assistance Program is an excellent program and we encourage Villagers who qualify to utilize the program. However, if the work is performed without your being prequalified by PG&E, you are at risk. If you are later audited by PG&E and it's determined that you don't qualify for the program because your income is too high, you could be charged for your home improvements.

Consequently, it is imperative that you start the process by contacting PG&E. They will explain the requirements, review that you qualify and have a contractor call you. Your application can be started either online or by calling 800-933-9555.



This commitment meant that when he officially retired from SJSU in 2016, he never retired from the WP.

In 2016 he became a member of the Democratic Club and, following his newest passion, joined the Pickleball Club, in the Villages Community where he resided. In these clubs he, as ever, took on new responsibilities and readily made new friends. Most recently, Jonathan was looking forward to pursuing new avenues of learning and had joined the Brandeis Study community.

Almost every day, rain or shine he ran with his dear dog, Mindy, enjoying the people they met and the beauty of their surroundings. Jonathan was never one to sit still for long. He sailed his treasured boat whenever possible taking with him friends, family and, of course, Mindy. He especially loved taking his grandchildren, nieces, and nephews for a sailing lesson or to battle with the pirates on the lake. For Jonathan, the roughest weather was the best for a sail and the most treacherous hill the obvious choice to ski.

### Madeline "Maddy" Stusnick

October 27, 1943 - April 30, 2020



Madeline "Maddy" Stusnick passed away peacefully at home on Thursday, April 30. She died from complications resulting from a rare inherited genetic defect. Her death was not related to the current coronavirus pandemic.

Maddy was born on October 27, 1943, in Brooklyn, New York. She was the only child of Benjamin and Irma Seidelle. She grew up in the town of Wantagh on Long Island, New York. In 1965 she received a B.A. in Psychology from Hofstra University and in 1970 she received a Ph.D. in Clinical Psychology from the State University of New York at Buffalo.

Eventually, the couple discovered The Villages and purchased their home in Hermosa. Maddy was not yet ready for retirement and she returned to her original roots as a School Psychologist. From 2002 to 2009, she worked at the Mount Pleasant

Elementary School District, assessing students for placement in Special Education Programs.

As was to be expected from such a high-energy person, Maddy was very active in Villages life. For many years she was Chairperson of the Emotional Support Group in the Emergency Preparedness Committee (EPC) and, eventually, she became one of EPC's Co-chairs. She has been on the Senior Academy for Education Board, the Property Improvement Advisory Committee, the Bocce Club Board, and the Association Nominating Committee. From 2009 to 2012, she served on the Board of Directors of The Villages Golf & Country Club and was its Vice President from 2010 to 2012. While on the Club Board she was instrumental in getting the Bocce Courts built and working to win approval for the construction of the Bistro. She was a member of the Village Voices and the Villages' Jewish Group. And, then, there were the twice weekly Mah Jongg games.

Maddy is survived by her husband Eric, her son Harold, her daughter-in-law Jenny, and her two grandchildren, Matilda and Hugo. Donations in Maddy's honor should be sent to Second Harvest of Silicon Valley.


