## Updated Order of the Santa Clara County Health Officer

The Health Officer of the County of Santa Clara, Sara H. Cody, M.D., issued an updated Order on May 18 that supersedes the April 29 Order. The following is an excerpt from the Executive Summary of that document:

Executive Summary: Because of the substantial progress our community has achieved in slowing the spread of COVID-19, this updated Shelter-in-Place Order allows certain additional businesses and activities to resume, subject to restrictions to reduce transmission risk. The Order also makes important changes to the Social Distancing Protocol requirements for all operating businesses.

This new Order will go into effect at 12:01 am on Friday, May 22, 2020, and will remain in effect until the Health Order amends or rescinds it. This new Order replaces the prior order, which went into effect on May 4, 2020. We refer to the May 4 order as the "Prior Order" and this new Order as the "May 22nd Order" or "Order."

What changes does this new Order make? The May 22 Order allows several new categories of businesses and activities to reopen, subject to specific conditions and limitations. It also keeps key restrictions in place, requiring people to stay in their homes except when engaging in certain essential or allowed activities. The activities and businesses allowed to reopen under the new order are referred to as "Additional Activities" and "Additional Businesses" and are explained in Appendices C-1 and C-2 to the Order. These and other significant changes are highlighted below.

#### Additional Businesses:

· Retail stores may reopen for sales, but only for curbside/outside pickup or by delivery. Customers are not allowed to enter these retail stores. These retail stores must also comply with several additional operating conditions, including: They cannot move goods outside the store to display and sell.

They must limit the number of workers inside the facility as described in the Order.

They must have direct access to a sidewalk, street, outdoor walkway, parking lot, or alley for pickup. · The Order also allows businesses that support these retail businesses to resume operating, including those

that manufacture goods sold at these stores and businesses that provide warehousing and distribution services. · Outdoor museums, historical sites, and publicly accessible gardens are allowed to reopen, but visitors are

restricted to outdoor areas.

#### Additional Activities:

· The May 22nd Order allows people to participate in car parades, so long as they ride in cars only with members of their households and do not leave the cars during the parade or stop to gather at a fixed location. Bicycles and motorcycles are not allowed to join car parades.

#### Social Distancing Protocol:

· The May 22nd Order updates the Social Distancing Protocol (Appendix A to the Order) to incorporate new State of California requirements for training personnel and other measures.

To operate, all businesses must complete a Social Distancing Protocol using the new template or update their Protocols to incorporate the new requirements. A copy of the Protocol must be distributed to all employees.

· To show that they are implementing the Social Distancing Protocol to keep their staff and customers safe from COVID-19, all businesses must print and post in a prominent place near the entrance to the businesses (1) a COVID-19 PREPARED Sign and (2) a Social Distancing Protocol Visitor Information Sheet. Both the Sign and Visitor Information Sheet can be found in Appendix A to the Order.

· All businesses must post signage required in the Social Distancing Protocol to educate customers about health and safety requirements. Sign templates are available on the County's website.

In the time of this horrendous pandemic, it makes a lot of sense to close all the facilities where social distancing is not possible. The golf course is the one area where walkers can meet and still keep to the safety health guidelines (6 feet apart). The open use of the golf course has been the one bright spot for many of us during this stressful time. While exercise is essential, social contact is also important for our overall health. The golf course provided the space to have both exercise and social contact. Starting tee times at 7 a.m. seems excessively early. While having the golfers use the golf course is obviously a no-brainer, sharing the one venue that everyone can make use of in a more equitable way, would satisfy the needs of many, many more Villagers. It seems reasonable to me, and my many walker friends, to ask the golfers to wait until 9:30 a.m. to begin their games. In that way morning walkers would be able to adjust their schedules to an earlier time slot and still be able to make use of the one resource that can be used in a safe and healthful way. —Judy Rogers

I have read several letters from people who have complained about getting a ticket for not coming to a full stop at a stop sign even though they are sure that they had. What I have been doing is watching my digital speedometer. When I stop, I wait for the speedometer to show a "0" before proceeding. So far, no tickets and it only takes a couple of seconds.

California's Insurance Commissioner issued a bulletin on April 13—Bulletin 2020-3—that ordered insurance companies to refund automobile premiums as a result of the shelter-in-place orders currently in effect. Insurers were ordered to "...make an initial premium refund for the months of March and April to all adversely impacted California policyholders ...." As a result of this order, insurance companies are refunding monthly premiums 15% - 20% for these two months. The insurance commissioner's bulletin also states "If the COVID-19 pandemic continues beyond May, Commissioner Lara will send out a subsequent Bulletin to insurers and provide appropriate instructions."

In addition to the refund referred to above, a reduction in the premium can be obtained by revising the estimated annual mileage for each vehicle. Automobile insurance premiums are determined by the vehicle's estimated annual mileage, which are overstated as a result of the current restrictions in place. I notified our insurance carrier of the lower annual mileage estimates for our vehicles which resulted in a premium reduction of approximately \$275. Added to March and April refund we saved about \$350. Hope you find this Pulse Letter helpful.

## 2020 Director Elections Updates, Ballot Information, Candidates' Night and More

As you may have read in previous editions, for all three Villages Corporations (Club, Homeowners' and Association), elections will be conducted in May and June and this year's annual meetings will be held on Wednesday, June 10 via teleconference.

All ballot packages are scheduled to be distributed beginning May 6 (you may have already received yours) with the deadline of Monday, June 8, at 8 a.m. for the return of ballots. Ballot counting will take place in an open teleconference meeting on Tuesday. June 9 at 9:30 a.m. Results are to be announced the following day, Wednesday, June 10 at the annual meetings-all via teleconference meetings, with the Association's to be held at 4 p.m., the Homeowners' Corporation at 4:30 p.m. and the Club's at 5 p.m. Specific meeting information to be published in future Villager editions and is included in annual meeting notices distributed to all members in their ballot package.

#### **Board of Directors Elections**

Candidate Information, Candidates' Night and Villager Questions. As detailed in the information that follows below, the candidates for the Association and Homeowners' Boards have been elected by acclamation per their corporation's governing documents. Only Club candidates participated in this year's Villager Candidate Questions and Candidate's Night (a virtual program) sponsored by the Club's Communications Advisory Committee. Candidate's Night can be seen on Channel 27 at noon, 6 p.m., midnight and 6 a.m., as well an on the Villages Resident Portal. (See pages 10 and 11 for all candidate information.)

Association: On the Association's Board, there will be two director vacancies. As with the Club, the Amended and Restated Bylaws of the Association Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are Garry Ashby, David Cook, Diana Hallock, Noel Lanctot, and Julie Wash. The two directors for which terms expire are Matthew Giordono and Frank Veloz.

Pursuant to The Villages Association Rule 2.25 Voting and Election Rules, Richard Holmboe is a candidate for the annual election of Directors. In addition, pursuant to Article 2.3 of Rule 2.25, because the number of people nominated is not more than the number of Directors to be elected as of the published and duly noticed deadline for nominations (March 31, 2020), Richard Holmboe is declared elected by acclamation and shall take office at the first Board meeting following the annual meeting.

Homeowners: The Bylaws of the Homeowners' Corporation provide that there shall be five Directors. The Directors previously elected by the owners who will continue to serve are: Mary McBride, Ron Steckel, and Greg Stewart. As of the deadline of May 1 at 5 p.m. there have been two candidates nominated and qualified, Rob Kirschbaum and Richard Zahner, and per Section 7.3 of the Second Amended and Restated Bylaws of The Villages Homeowners' Corporation they are declared elected by acclamation and will begin their terms as Directors on

June 10, 2020, upon adjournment of the Annual Meeting of the Members.

Club: The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are Rick Casey, Jan Champion, Mike Falarski and Teddy Morse. The two director terms that expire are that of Bob Wilk and the late Jim Neill, and with the resignation of Frank Langben, there will be three director vacancies, two directors to fill a three-year term and one director to fill the one-year term that completes the remainder of Frank Langben's term.

There are three candidates for whom nominations have been qualified for the ballot, Bob Wilk, Jeannie Omel, and Howie Blumstein. Pursuant to the Bylaws Section 6.2, the and return your ballot.

persons receiving the largest number of votes shall be elected and, of those persons elected, the two receiving the largest number of votes shall be elected to three-year terms and the one receiving the lowest number of votes shall be elected to the shortest position term, a term of one year.

IRS Resolution Vote: For all three corporations, vote packages will include a ballot resolution, Excess Membership Income Over Membership Expenses Refunded to Members. An approval vote of these resolutions will enable the corporations to avoid income tax on operating surpluses by refunding these surpluses to the membership in the form of assessment reduction in accordance with IRS Revenue Ruling 70-604.

## A Message from your Association Operations Manager

It is my responsibility to routinely inspect the community for rules being broken. As you may know, the Association's rules were developed and approved by your Board of Directors. They are revised from time to time when recommendations are made by members, the Rules Committee, or the General Manager. The rules are designed to provide uniformed protections for all Villagers.

I would like to inform Villagers of the most common Association rules being broken that I've noticed when conducting my inspections.

Rule 2.07 Common Area Alterations: Owners (or residents) may not alter, or install any improvement on common area, including common area landscape, without the prior approval of the Architectural Committee (AC).

Rule 2.21.12 Association Common Areas: Residents will not place items in common areas including utility closets except where specified in Rule 2.08 and/or AC approval. Prohibited items include but are not limited to yard art, statuary, figurines, potted plants and planter boxes.

Rule 2.08.3 Maintenance of Villas and Limited Common Areas: Each resident is responsible for keeping the garage, carport, patio, and other limited common areas that are open to view by others in a clean, orderly and sanitary condition.

Rule 2.08.4 Maintenance of Villas and Limited Common Areas: A 36-inch-wide, clear pathway must be maintained on all exterior stairs, stairway landings and villa entryways. Potted plants, or other decorative items, may be permitted within a minimum of five feet of the front entry door as long as they do not encroach into the 36-inch-wide pathway.

Rule 2.10.2.D Sound, Visual, and Odor Restrictions: Decks, patios, balconies and porches are not intended for storage. This restriction includes, but is not limited to, refrigerators, freezers, and household furniture. Storage cabinets over three feet in height must have AC approval.

Rule 2.23 Wood Preservation Requirements - Common and Limited Common Area: A. Wood Decks and Railings 1. Potted plants, figurines, or other decorative items are not permitted on wood railings; 2 Potted plants, including those in trays or pots that have holes in either the sides or bottoms, are not to permit water or moisture to reach the wood deck; 3. All items must be supported above the deck flooring in a manner that permits moisture under the item to evaporate; 6. Vine growing plants are not to cling to wood decks, railings or walls; 7. Trees planted in the limited common area shall have sufficient clearance from walls and fences. Trees shall not exceed seven feet in height without AC approval.

Please take some time to check around your home to see if any of these rules are being broken and try to correct them before I come by to inspect.

## IRS wants dead people to return stimulus payments

We have heard from several Villagers who have received a stimulus payment for their deceased spouse or for a deceased parent. The IRS has issued that the payment should be returned to the IRS. If the payment was made to joint filers, you only need to return the portion of the payment made on account of the decedent. The IRS has issued guidance on how to return the payment.

If the payment was a paper check:

Write "Void" in the endorsement section on the back of the check.

Mail the voided Treasury check immediately to the appropriate IRS location listed below.

Don't staple, bend, or paper clip the check.

Include a note stating the reason for returning the check.

If the payment was a paper check and you have cashed it, or if the payment was a direct

Submit a personal check, money order, etc.

Make the check/money order payable to "U.S. Treasury" and write 2020EIP, and the social security number of the recipient on the check.

Include a brief explanation of the reason for returning the Economic Impact Payment (stimulus payment).

Note: The Senior Resource Services (SRS) office is currently closed for drop-in assistance. You may still leave messages at 408-239-5253 as we monitor phone messages every day and can still answer questions by phone. We can also e-mail handouts. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

## **SRS Reminder**:

## Water tax exemption application

June 30 is the deadline to request an exemption from the water district parcel tax. This tax is labeled SCVWD SAFE CLEAN WATER on your property tax bill. To qualify for the exemption, you must be at least 65 years old as of June 30, 2021 (the end of the next County fiscal year) and your 2019 household income, including social security, must be below \$56,458. The income limit is inflation indexed so some Villagers who once did not qualify, may now be able to file for the exemption. Applications are available online at www.valleywater.org. Enter "Senior Exemption" in the search box.


## Attention hikers using the hill lands: A special request

Committee Charter "to develop and present to the Board a plan to familiarize residents with the Pickleball facility project prior to a Villages vote."

City Approval: The City of San Jose approved the project design for the proposed four pickleball courts project (see renderings at left) last November. This design complies with city requirements for sound, storm water runoff and soil.

Bid Process: Subsequently, the Club Board approved funds to have project consultant Robert Mowat Associates prepare construction drawings and bid specifications. Three qualified bids have been received and are being evaluated.

VGCC Capital Improvement Fund: At the May 26 Zoom Board meeting, the Villages Golf and Country Club (VGCC) Board of Directors will determine the maximum contribution the board will allocate for the proposed pickleball courts project, from the approximately \$515,000 balance in the Capital Improvement Fund (Capital Fund).

VGCC Bylaws Article - Capital Improvement Fund: It should be noted The Villages Bylaws (Article 8.2.5) has a provision stating that money in the Capital Fund can only be utilized for a Capital Improvement. Funds in this account cannot be used for any other purpose such as offsetting operating/reserve expenses.

VGCC Bylaws Article - Required Vote: The Bylaws (Article 8.3.3) also requires "...vote shall be conducted by 'written ballot' ..." of Villages (voting) Members for a Capital Improvement Project that exceeds \$240,000. The ballots for the proposed pickleball courts project are expected to be mailed by June 1, due back by June 28 and counted by June 29.

Donations Raised to Date: In addition to any funds from the Capital Fund, to date the Pickleball Club has secured over \$475,000. Fundraising is ongoing with the expectation to raise additional funds.

Maintenance Costs: One concern some members have expressed is about the maintenance costs for the pickleball courts and adjacent golf cart parking lot. For fiscal year 2020/2021 (FY21), the operating and reserve assessments for our six tennis courts is less than \$1.45 per month for Villages Members. Four pickleball courts are equivalent in area to two tennis courts. Including the golf cart parking area, the monthly operating and reserve costs are expected to be less than budgeted for the six tennis courts. Furthermore, funds will be saved for landscaping and water expenditures that will not be required for the area replaced by the pickleball courts and golf cart parking lot.

You might like Oil Pastels because they have no dust, unlike soft chalk pastels.


The materials for this class are inexpensive: one set of Craypas oil pastels and a 11" by 14" Bristol pad.

## Let's practice mindful drawing

Drawing is the best way for me to calm my mind and relax. This drawing lesson is designed to help your mind stay focused and bring peacefulness during the process. You would need few simple dry media such as graphite or/and colored pencils, ball point pens, crayons or pastels and a sketch pad or some paper of any kind. Of course, your favorite beverages within reach. This lesson can be repeated by applying different shapes and colors.

Turn on some music you love, tell anyone in the house you'd like to be left alone. Lay out all art materials next to the paper. Stay present and as detached as possible from the result. Your attention is totally on every single stroke you put on the paper.

- 1) Start with any **shape** that comes to your mind, then continue to repeat it with varied size and colors, one next to another, let it grow as large as you hold your attention. Then start another one by switching to another shape.
- 2) Ready to move on? Go to the next project: **lines.** Draw lines that curve and flow. Think only of variation of lines flowing together, side by side.
- 3) Draw a **tree** with one **continuous** line (start with one side of tree trunk and end it on the other side).
- 4) Start a random **colored background** with colored pencil or/and soft pastels, then apply combo of shapes and lines over the background color.

## These 50 Great Days

As you read these words, our church will be approaching the end of the Easter Season, these 50 days of celebrating Christ's resurrection. Although 40 is a Biblically long time—as I've written here before—nevertheless 50 is hardly long enough to get our minds and hearts around the mystery of God's imperishable love. The Gospel stories we hear in this season—questioning Thomas, bewildered Emmaus-bound pilgrims, Jesus the Good Shepherd, Jesus the way and truth and life, and finally the promise of the Holy Spirit—reveal the many manifestations of the Risen Christ. And yet there are more to come, most importantly the manifestations of Christ in your own life.

We might think of the upcoming feasts of the Ascension, Pentecost, and Trinity Sunday as a kind of hinge, turning our attention towards the long, patient season after Pentecost (also known as Ordinary time). In these three sacred observances, the whole range of human emotion is expressed. Sorrow, surprise, and trust in the mysterious completeness of one God in three persons. All of them function to show us the kind of community we're called to be: trusting in each other, filled with the Spirit, and mutually self-giving. Note that they do not mean we have to be happy about the circumstances in which we find ourselves; indeed Christians have found strength and comfort in these histories and doctrines in times every bit as risky and confusing as our own. They remind us that God is with us for all time, even when our questions have no immediate answer.

Our bishop, The Right Reverend Lucinda Ashby will be visiting (virtually) for our feast of name on June 7. Even though we may feel (and indeed be) geographically far from loved ones, she is a symbol of our unity in Christ and with each other. Myself, I'm so grateful for a connective church that allows us to see and hear from each other during Shelter in Place, and during whatever form of "re-entry" will follow. The multiple Trinity symbols in our sanctuary are reminders of our unity as well (see if you can spot some in our videos). What reminds you of our connectedness? What would help you to feel more connected to your church community? Please do take a moment to let me know; being connected to you and your hopes is what enables me to be your priest.



**Men's Club Announcements:** Considering the required Safety Guidelines approved by the CBOD, the Men's Golf Club Executive Committee made the following decisions:

- 1. Hole in One Insurance and Eagle recognition are suspended until further notice.
- 2. The June 13th Senior Net Tournament is postponed. We are considering moving it to August 8 in place of/combined with the Annual Picnic.
- 3. Player of the Year and Ryder Cup points tracking will be reviewed for modification/cancellation.
- 4. NCGA has stated that even with modified course conditions (sand traps, cups, etc.), the scores are postable and should be posted. **Post all your rounds**, if playing by the Rules of Golf. (When playing as a single you may not post. "Practice rounds" using two balls, mulligans throughout the round, etc. are not postable.) If you have a question about posting scores, contact any member of the Handicap Support group listed in your Green Book.

Please familiarize yourselves and comply with the Safety Guidelines. Consequences for noncompliance include removal from the course and/or suspension of privileges.

#### Message from the Golf Course Committee:

If you had a chance to play in the past week, I think you'll agree that our golf course is in pristine shape. Our challenge now is to maintain these conditions. The pause in play allowed out maintenance staff to complete many projects that enhanced the playability and beauty of our course.

You will notice the re-contouring of fairway and green complexes, the clean-up of the gulley between the 13th and 14th green, the reduction of moguls on aprons, the beautiful new #2 teeing grounds, and the addition of new sand in many of our bunkers.

The downtime also allowed many of the hard pan areas to heal, particularly at the mouths of many of our fairways (1, 5, 12, 14, 15 and 18). We can protect these areas and allow them to completely heal if we just follow our stated golf cart etiquette rules. Specifically, all carts must remain on paths on all teeing grounds—all #3 and #4 tees are less than 20 steps from the cart paths. Stay on the path after teeing off until you are at least 10 yards beyond the #2 tees, or better yet, adhere to the 90-degree rule. Following these guidelines is particularly important since we now have the individual cart rule that almost doubles the wear and tear on our turf.

Stay safe and enjoy our course.

Golf Champion: Francis Ouimet (1893-1967)

U.S. Open Champion 1913, U.S. Amateur Champion 1914; 1931, World Golf Hall of Fame 1974, Bob Jones Award 1955

Francis Ouimet is often called the father of American golf. His victory in the 1913 U.S. Open is considered by many to be one of the greatest upsets in golf history. At the time, Ouimet was just 20 years old and an amateur. His caddy was his 10-year-old-friend, Eddie Lowery. He was up against two of the best professional golfers in the world, Great Britain's Harry Vardon and Ted Ray. The three were tied after 72 holes of regulation play. Ouimet beat both in an 18-hole playoff the next day.

Tips from the Pro-Set up for success...Putting: Your set up when putting is just as important as your set up on your full swing. Setting up to succeed means setting up with your angles square to the target line, especially your putter face; and also setting up with your eyes in line and over the ball. To help you set up properly when putting, a carpenter's chalk line, a yardstick, and a CD disc are great putting aids to have in your repertoire. The chalk line is useful to help you with your alignment and stroke. Find a straight 6 to 10-foot putt on a practice green. Snap a chalk line from the hole back to desired distance. Put a ball on line and make sure your putter and body are lined up properly. Try to roll the putt right up the chalk line. You can also use a yardstick placed just above your putter-head; chose a straight 5-foot putt, make sure your putter is perpendicular to the yardstick, then use the lines on the yardstick to make your stroke equal distance on either side of the ball. Use the CD as a mirror. Lay the disc on the green and place a ball in the hole. Take you stance until your eyes are either directly over the ball or just inside. Let us know if these practice tips help your putting.

## Don't feed the 'critters'

Strategy: Need to set up the Diamonds in order to make the contract while still having controls of the other suits

West leads the 4 of Spades, East, the Queen and now South must make a decision. Does he hold up untill the third round of Spades or play the Ace immediately? South decides to play the Ace and I will give the reason later. He then switches to the Queen of Diamonds, East wins with the King, returns a Spade, West covers with the good Jack, continues with the King and next leads the last Spade, and East sluffs the 9 of Hearts signaling he likes that suit. West then plays a Heart, East, the Queen, and South takes the trick with the Ace. He plays the Jack and 10 of Diamonds. He gets back to the board with a low Club to the King. He next leads the Ace of Diamonds, then the Queen and Jack of Clubs, and plays his last Club on the board to the Ace in his hand. Great! The contract is made exactly. If South had ducked the first Spade lead, then East might switch to a Heart and that would be bad news for South. Under those circumstances South would have to use his Ace of Hearts and when he loses to the Ace of Diamonds, East takes 3 tricks in Hearts, plus the Spade and Diamond tricks, which means South is down one trick. Also when West leads the 4 of Spades, South has to hope he only has four of them. In addition, being able to see where the 3 and 2 of Spades are located aids South.

\* North has no 4 card major and enough points to bid game and not enough points to suggest something more than




