Updates to the May 22 Order of the Health Officer of the County of Santa Clara go into effect Friday, June 5. This revision to the existing order permits additional outdoor activities provided the proper social distancing and other requirements are met.

The Villages staff is reviewing the order as it relates to reopening tennis, pickleball, bocce and swimming pools and will report in a future Fast Lane our plans to re-open these outdoor amenities mid to late next week.

The Villages Clubhouse will be resuming outdoor dining on Saturday, June 6 at 7 a.m.subject to the following limitations in addition to those required elsewhere in the Order:

- Outdoor seating arrangements shall limit the number of patrons at a single table to no more than six individuals, all of whom must be

This seems in clear non-compliance with the transparency policies of the board meetings. Also, it is not apparent that this supposed "Management Agreement" is readily available to residents on the Residents Portal. Before this agreement is allowed to expire I believe the residents are entitled to the complete ramifications to the residents.

Something very wrong has happened in the Villages. The decision to NOT renew the Management Agreement has been made without any VOTE by either the Club Board or the Association Board. How can a decision of such importance be made in total secrecy? Something is very wrong in the Villages.

The Management Agreement should be renewed for another year, and any discussion to end it should take place in public. This is not a contract with an outside party, it is an agreement between two sets of elected boards who supposedly represent substantially the same constituency. Any petty bickering between these boards is not in the best interest of the members, and represents a failure of the boards to look after the best interest of the members.

The ABOD has made the decision to hire an outside company to take over management for the Association, without any public discussion on alternative courses of action. The Association could choose an alternate course and hire a Manager and management team. However that is another decision that has been made in secrecy, and sprung on us at the last minute.

Ad Hoc Pickleball Committee Proposed Pickleball Courts Project

The voting package for the Pickleball Courts Project has been distributed to all Villages Golf and Country Club Members. The deadline to vote and submit ballots is 8 a.m. Monday, June 29, 2020. Ballots will be counted later that day (in open via teleconference; time to be determined and noticed)

Project Costs: The Club Board of Directors (CBOD) announced, at its May 26 Board Meeting, that three bids were received from qualified contractors and Saviano's bid was the lowest and was the winning bid. Their bid to construct the four pickleball courts, surrounding landscaping, and golf cart parking area was \$760,996.

A portion of the total project cost has already been spent on soft costs necessary to obtain the City of San Jose's planning permit. These costs totaled \$142,900, which included noise, soil, and drainage studies, the permit fees from the city, design, construction drawings and bid specifications. In addition to these initial soft costs there is a) a 10-percent contingency of \$76,100 (spent only if needed) and, b) additional soft costs to complete the project are estimated to be \$74,050 for the building permit and project management. The total project cost is \$1,029,046.

After permits from the city are obtained, construction will commence. Completion timeframe is expected to be around three months.

Project Funding: At the May CBOD meeting, the Villages Golf and Country Club (VGCC) Board of Directors approved \$436,146 (not to exceed \$450,000) from the Capital Improvement Fund towards the completion of the project. When the project is completed approximately \$160,000 will be in the Capital Improvement Fund. The remaining funding required will be provided by \$400,000 raised to date by the Pickleball Club, and \$75,000 from the Evergreen Villages Foundation (EVF) and the total Capital Improvement Fund contribution of \$554,046. Consequently, no additional assessment from Members will be required to build the Pickleball Courts Project.

2020 Director Elections Ballot Deadline is Monday, June 8, 8 a.m.

As you may have read in previous editions, for all three Villages Corporations (Club, Homeowners' and Association), elections will be conducted in May and June and this year's annual meetings will be held on Wednesday, June 10 via teleconference.

All ballot packages were distributed beginning May 6 with the deadline of Monday, June 8, at 8 a.m. for the return of ballots. You may deposit your sealed ballot envelope in the locked box located in the parking lot of Building A. Ballot counting will take place in an open teleconference meeting on Tuesday, June 9 at 9:30 a.m. Results are to be announced the following day, Wednesday, June 10 at the annual meetings—all via teleconference meetings, with the Association's to be held at 4 p.m., the Homeowners' Corporation at 4:30 p.m. and the Club's at 5 p.m. Specific meeting information is on page 1 of this edition of *The Villager* and is included in annual meeting notices distributed to all members in their ballot package.

Board of Directors Elections

Candidate Information, Candidates' Night and *Villager* Questions. As detailed in the information that follows below, the candidates for the Association and Homeowners' Boards have been elected by acclamation per their corporation's governing documents. Only Club candidates participated in this year's Villager Candidate Questions and Candidate's Night (a virtual program) sponsored by the Club's Communications Advisory Committee. Candidate's Night can be seen on Channel 27 at noon, 6 p.m., midnight and 6 a.m., as well an on the Villages Resident Portal. (See pages 10 and 11 for all candidate information.)

Association: On the Association's Board, there will be two director vacancies. As with the Club, the Amended and Restated Bylaws of the Association Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are Garry Ashby, David Cook, Diana Hallock, Noel Lanctot, and Julie Wash. The two directors for which terms expire are Matthew Giordono and Frank Veloz.

Pursuant to The Villages Association Rule 2.25 Voting and Election Rules, Richard Holmboe is a candidate for the annual election of Directors. In addition, pursuant to Article 2.3 of Rule 2.25, because the number of people nominated is not more than the number of Directors to be elected as of the published and duly noticed deadline for nominations (March 31, 2020), Richard Holmboe is declared elected by acclamation and shall take office at the first Board meeting following the annual meeting.

Homeowners: The Bylaws of the Homeowners' Corporation provide that there shall be five Directors. The Directors previously elected by the owners who will continue to serve are: Mary McBride, Ron Steckel, and Greg Stewart. As of the deadline of May 1 at 5 p.m. there have been two candidates nominated and qualified, Rob Kirschbaum and Richard Zahner, and per Section 7.3 of the Second Amended and Restated Bylaws of The Villages Homeowners' Corporation they are declared elected by acclamation and will begin their terms as Directors on June 10, 2020, upon adjournment of the Annual Meeting of the Members.

Club: The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are Rick Casey, Jan Champion, Mike Falarski and Teddy Morse. The two director terms that expire are that of Bob Wilk and the late Jim Neill, and with the resignation of Frank Langben, there will be three director vacancies, two directors to fill three-year terms and one director to fill the one-year term that completes the remainder of Frank Langben's term.

There are three candidates for whom nominations have been qualified for the ballot, Bob Wilk, Jeannie Omel, and Howie Blumstein. Pursuant to the Bylaws Section 6.2, the persons receiving the largest number of votes shall be elected and, of those persons elected, the two receiving the largest number of votes shall be elected to three-year terms and the candidate receiving the lowest number of votes shall be elected to the shortest position term, a term of one year.

Message from the EPC Food Committee

The leaders of the Emergency Preparedness Committee (EPC) and its Food Service Committee have been giving serious thought to the best way to be of value in the inevitable earthquake or other catastrophe that might visit us in The Villages. We understand that any outside first responders will be fully equipped to take care of residents' needs without our help. The question of how we, as Villagers, should be planning is where we are going to be focused in the coming months. So, what should we do? It is our recommendation that Villagers prepare themselves as follows:

- 1. Have enough long-life food supplies for a minimum of three days.
- 2. Have enough water to last for at least a week. This means at least six pints of all kinds of liquid per day per person.
- 3. Develop a plan with your immediate neighbors to support each other's state of health, need for any help, sharing of any needed supplies, including food.

EPC encourages all Villagers to review the comprehensive article "Surviving the Next Earthquake" in the back section of the Villages Telephone Directory. It is a valuable source of helpful and sensible information on planning for the next earthquake—or other emergency. Finally, more detailed information on disaster preparedness can be found in the Red Folder that is given by EPC to all new residents. If your folder is lost, or more than a few years out of date, a new copy may be obtained by calling the Public Safety Administration office in Building C at 408-239-5246, option 2. You are only protecting the self-serving interest of your Board and not the Villages as a whole. You pledged, and we elected you to "work together" to control the cost/expenses within The Villages. Both Boards have failed at that!

I don't understand California's rules and regulations on condos. But I challenge you to take a deep and thorough look at combining the two boards into one. You'll decide what portion of the HOA is fixed and what is prorated to our AFA. Eliminating this petty infighting. WE ARE IN THIS TOGETHER! Don't disappoint us!

The very least you "should" do is a 6-12 months cooling period; make compromises and come to a solution that will not increase our HOA. Please discontinue the path of legal consuls and consultants. It is not acceptable to us!

I was surprised to read the notice from the Association Board regarding the decision to not renew the contract between the Club Board and the Association Board and to go with the hiring of a for-profit outside Management Agent. I was surprised that money has already been spent on the hiring of attorneys by both boards to reach an unsuccessful conclusion. The issues noted in the notice were vague. The notice stated that "The pathway to this decision has been arduous, but well studied and unanimous.", yet there have been little prior communication and discussion among homeowners regarding the issues and alternatives.

A decision such as this should only be made with full awareness to the community. This decision will definitely affect every homeowner as a new Management Agent added to the existing management will substantially increase costs. I suggest that any/all decisions be deferred and a short extension of the existing contract be made so that steps towards better communication of these issues be given to all the members (our village community) and hopefully a more cost-effective solution can be achieved. Such a decision should not be made by the board alone, but with the support of all homeowners.

I was dismayed to see that the Association Board is considering bringing in an outside management company. Alternatively, the Association Board needs to negotiate a fair and equitable management agreement with the Club Board, based on today's reality.

As a former Club Board Director (2014-2016), I chaired the committee, with Association Board representation, that looked at outside management companies after the resignation of former GM Darren Shaw. I am familiar with their cost structures. It is my strong opinion that bringing in an outside firm will inevitably lead to a significant increase in the Association operating assessment at a time when many of us condominium owners are already seeing massive increases.

At one time The Villages had just one board. Given the fact that this year they could not find enough residents to run for the Association Board, I think The Villages needs to seriously consider returning to this model. The Club Board should be this one board since they are already the managing agent for all three corporations and are familiar with the processes and personnel.

June 30 is final date to pay property tax

Question: I couldn't pay all of my property tax due April 10, 2020. My neighbor told me if I couldn't pay it all, I might as well not pay any of it because I would be charged penalties on the entire amount. Now a friend just told me there are no penalties at all this year. Those are two vastly different statements. What is correct?

Answer: First, your neighbor's comment was once true, but the law has changed. The County used to return any amount that was less than the full amount stated on the first and/or second installment tax bills. You would have been assessed a 10 percent penalty, plus any applicable fees and charges, on the full amount of the tax installment.

This changed three years ago. The County now accepts partial payment and only the unpaid amount on the first and second installment bills will be treated as delinquent tax on December 10 and April 10 of each year. The County will add a 10 percent penalty and applicable costs only to the unpaid tax amounts on the delinquency dates.

But wait, this year there is even better news. Your friend is correct. On April 21, 2020, the County of Santa Clara Board of Supervisors voted to waive penalties and costs on the property tax bill that was due April 10, 2020. There are no penalties or fees if the property tax is paid no later than June 30.

You can pay your property tax in any number of payments and can pay online at taxpayment. sccdtac.org. The amount due for the first installment must be paid in full before the Department will apply any payments to the second installment. The entire amount for the county's fiscal year ending June 30 must be paid by June 30 or the ten percent penalty and additional fees will apply.

Note: The Senior Resource Services (SRS) office is currently closed for drop-in assistance. You may still leave messages at 408-239-5253 as we monitor phone messages every day and can still answer questions by phone. We can also e-mail handouts. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

Special charitable deduction in 2020

You may now take a new deduction for up to \$300 in charitable contributions if you don't itemize on your 2020 tax return. This means you can deduct the \$300 and also take the standard deduction of \$12,400 (single) or \$24,800 (married). This law could be used by you to benefit a food bank, your church, a university, or a Villages charity such as EVF or VMA.

The contribution must be in cash. Donations of clothing, household goods, etc. are not eligible for the new deduction.

If you itemize deductions, the amount to charity will be included in your itemized Schedule A as in prior years.

IRS Resolution Vote: For all three corporations, vote packages will include a ballot resolution, Excess Membership Income Over Membership Expenses Refunded to Members. An approval vote of these resolutions will enable the corporations to avoid income tax on operating surpluses by refunding these surpluses to the membership in the form of assessment reduction in accordance with IRS Revenue Ruling 70-604.


EVF FOCUS

from the same household or living unit. Members of separate households or living units are not allowed to dine at the same table.

- All tables must be separated to ensure that six-feet minimum social distance can easily be maintained between all members of separate households or living units at all times. For clarity, patrons who are members of the same household or living unit and seated together at a table do not need to be six feet apart. Alcohol may be sold to patrons in conjunction with a meal, but it may not be sold independently.
 - Bar areas must remain closed to customers.
 - Entertainment events are not allowed at this time.
- Outdoor dining, placement of outdoor seating arrangements, and food service must be in compliance with local laws, regulations, and permitting requirements.
- Facilities that open for outdoor dining must offer curbside pickup, takeaway, and/or delivery service alternatives.


Seating on the patio will be limited, with tables set at least six feet apart. Patrons will be able to sit two from the same household to a table, and will be issued single-use paper menus.

For your safety, Clubhouse staff will be working with gloves and face masks. We request that patrons, while not eating, please use their face masks as well.




Villages Technology Explorers: Meet Kiki the Robot Ice Cream Social cancelled

From the Villages Deer and Wildlife Club

Springtime in The Villages usually means lots of action for both residents and the wildlife that abide here. However, this year, as we all know, Covid19 has forced Villagers to change gears a lot....no golf or limited golf for a while and lots more walking, for instance.

Ordinarily the Deer and Wildlife Club conducts a Spring count of the deer in The Villages, but social distancing would have made this a difficult task, so we will not ask Villagers to help us count this year. However, thanks

to the wonderful efforts of Villagers who contact us to tell us about the deer (and other wildlife) that they see as well as the efforts of one Villager in particular who has been photographing and reporting the does by numbers as well as the bucks; we believe that we have a very accurate count. The total amount of deer seen in The Villages in April is 39 does and 11 bucks. There are two more does that have been seen during other months that were not seen in April and so they are not included in our total.

Sad to say, two bucks were killed during the period of end of April into beginning of May. Both of these animals appeared to have been killed by predators—either covotes or mountain lions.

During the spring months, bucks typically shed their old antlers and grow new ones, so there is usually a period when it might be difficult to recognize a buck without its antlers. There is one buck, however who doesn't seem to lose his antlers and whose antlers are particularly grotesque in appearance. The cause of this "condition" is not known for sure.

Spring is also the time when fawns may make an appearance. While the majority of the does are sterilized, we have had two known fawns born to them during the last four years or so. Unfortunately, both of these little deer did not make it, however there are two other fawns that were spotted last fall twins—who may still be alive and may have been assimilated into the herd.

You may wonder why we count the deer. This is done partly for our own interests and partly in the hope that some wildlife organization may at some point agree to introduce orphaned fawns into The Villages.

Villagers also can contact us if they have concerns about wildlife welfare or send us photos of animals here. We are happy to hear from Villagers anytime during the year.

From St. Francis of Assisi Parish: There has been significant media coverage about the reopening of churches, and SFOA wants to provide you with some clarity. Presently, the County of Santa Clara Public Health Department Order restricts the reopening of houses of worship. The County has not yet provided us with a date, a determination of the size of gatherings, or other guidance for public Masses. The Governor released state guidance on Monday, May 25; however, it will still be up to the County to determine how and when to implement them in this jurisdiction.

From the Diocese of San Jose: Parishes are now working to implement the many adaptations, train their liturgical ministers, and have the necessary equipment required in anticipation for when the County Health Department lifts the current restrictions. Until the public Masses take place again in our Diocese, our parishes will continue to livestream Masses and provide online ministry in response to the spiritual needs of their communities. Even after the public Masses resume, livestreaming and online ministry will continue for the high-risk parishioners, who will need to continue to stay home for their own safety.

'Sheltering in Summer'

Ugh. It's a hot one today and I just snapped at my husband for no good reason. I'll apologize and we'll be fine, but it's probably equally important for me to examine what I did and why. It's been a long season of marital togetherness (we both work mostly at home) and if I'm not careful, I'll unthinkingly project whatever discomfort I'm feeling (which may have to do with the virus, the weather or the state of the unwashed dishes...) onto the person closest to me.

Believe it or not, Christian community is formed out of everyday challenges just like this. That is, out of the inevitable tension of being close together, committed to one another's wellbeing and—for much of the history of the early church—contending with external stress and even threats. This was the context in which the Letter to the Colossians was written in the mid-first century, likely by Paul or one of his close associates when he was in jail. But even in captivity, the Apostle was imagining the new humanity we are made to be in Christ. In Colossians 3:12-15 he wrote:

"As God's chosen ones, holy and beloved, clothe yourselves with compassion, kindness, humility, meekness, and patience. Bear with one another and, if anyone has a complaint against another, forgive each other; just as the Lord has forgiven you, so you also must forgive. Above all, clothe yourselves with love, which binds everything together in perfect harmony. And let the peace of Christ rule in your hearts, to which indeed you were called in the one body. And be thankful."

And there we have it. Compassion, kindness, humility, meekness, patience, forgiveness and thankfulness. These simple rules of self-discipline have never been more important, and become more important as the days get warmer and sheltering gets longer. Followers of Jesus are sometimes called to heroism and extraordinary sacrifice, but more often we are called to bear with one another and actually do such holy acts as being kind and forgiving. I'd have lots more to say about this, but right now I have to humbly ask my husband's forgiveness. What holy act of Christian community are you called to today?

Message from the GCC (courtesy of Ron Burke): All our restrictive roping is now in place and despite the increase in cart traffic many of our sensitive turf areas are not showing signs of significant damage. This is good news. However, there are four specific areas that require some special care.

- 1. The mouth of the 14th fairway. This is one of the most damaged areas. Many of our members are ignoring the horizontal roping which is intended to direct cart traffic to the left and are entering the fairway right of the rope. This has created a defined cart path trail resulting in a hard pan area that continues to expand.
- 2. The #1 fairway. It is also beginning to show cart trail wear since many members are ignoring the directional roping and entering the fairway on the right-hand side. When we hit our drives to the right-hand side of these fairways our instinct is to follow our brain's instruction that the shortest distance between two points is a straight line. We need to override our brain's wiring and follow 90-degree rule by staying on the path until we are well beyond the #2 tees on these and other fairways.
- 3. The green complex on #3. This is also showing excessive cart wear. This green is surrounded by steep mounding and has special exemptions for Handicap carts. These designated carts can park on the left side of the green below the mound peak but must return to the cart path before proceeding to the next hole. Naturally, all able-bodied cart drivers are expected to remain on the cart path.
- 4. The green complex on #5. There is significant abuse on the left side all the way to the bocci ball courts. This area was almost healed after the pause in play but is now becoming a cart path trail. Handicap carts should follow the same procedure as on #3, and able-bodied cart drivers should remain on the cart path.

Let us all try to follow these golf cart etiquette guidelines to keep our course as beautiful as it can be.

PICKLEBALL

Pickleball turns 55 this year! There is no question (there never really was) that pickleball now fully qualifies to be here at The Villages! Pickleball was invented in 1965 and has been played enthusiastically here at The Villages since 2014.



Scott Steele's Tips from the Pro: What speed is the right speed?

Many golfers think the key on long putts is speed and shorter putts are more about line. Actually, speed is critical on all putts. The pace of the ball dictates the size of the hole. If you hit a putt firmly, the effective width of the cup might be two inches, but if the ball is rolling slowly, the cup might play twice as wide. You want your ball rolling slowly as it approaches the cup, this is called "hole speed".

To work on your hole speed, try this putting drill...

Set up an imaginary box on the putting green using four tees, three feet wide and about 18-inches deep. Drop three balls five feet from the center of the box, and try to roll all three into it the box. If a ball doesn't come to rest inside the boundaries, start over. Once you get all three, move back two feet, and do it again. Then go back another two feet, and so on, until you're about 15 feet out. Remember, a miss means vou have to start over from that distance. This isn't an easy drill, but when you get good at it, you'll have distance control and hole speed...and believe me, you'll make a lot more putts.

He switches to the King of Hearts, East takes the trick with the Ace, follows with a Diamond, and South uses his Ace. South then plays a Heart to the Queen on the board, leads the Ace of Clubs, follows with the Ace of Spades, and next leads a Spade. East takes the trick with the Queen, follows with the Jack of Spades, and West overtakes the trick with the King. West now plays the Queen of Clubs, then the King and uses his last card, the good Jack of Hearts. Great. The contract is made exactly. However, if South had decided to take a chance and hope the Queen of Diamonds is a singleton, then he could have led the Ace of Diamonds instead of the 10 and capture the Queen, and make an overtrick.

Household formation is a statistic that economists and others watch and report on. We hear that a significant number of people in their mid-to-late twenties these days are still living in their parents' homes. In our day, people were married in their early twenties, in many cases, and they were parents themselves by their mid-to-late twenties. And, of course, they were part of the household formation statistics.



If households were formed predominantly by married couples in our day, they are increasingly formed these days by groups of people or by unmarried couples. Most of these households will dissolve and reform over time. Households formed by married couples are much more likely to be permanent, although the couple will relocate a few times in their lives. The "life expectancy" of a household formed today is necessarily shorter than in days gone by.


