New Comcast contract has more for residents at lower cost

The Club Board has completed negotiations with Comcast and is finalizing contract terms. The new contract provides more services for Villagers at a lower cost.

The monthly bulk cable TV cost component of the Club assessment will go down almost \$6 and the new contract is for five years, until 2027. Being sensitive to the pressure of upcoming assessment increases, the Club Board decided not to add bulk internet at this time to give residents flexibility in their options, such as the newly advertised T-Mobile 5G Home Internet. This also allows future boards the flexibility to add internet services if new technologies become available or market conditions change. The new monthly charges will maintain The Villages' substantial discount from Comcast's Everyday Pricing offerings.

One additional positive change is that High Definition (HD), which currently costs residents \$10 a month, will be included for free in the new bulk agreement. The new contract also allows for three cable boxes per household, versus the current one cable box, a benefit for those with more than one television set in their home and are currently paying for the additional

Message from the Club Board

Tim Sutherland, our General Manager, informed the Club Board on Tuesday, March 29, that he was resigning, effective April 29, 2022. Until his final date, Tim will continue to perform his role as General Manager and will focus on documenting his roles and responsibilities, plus identifying whom from his current staff will temporarily take on additional responsibilities.

Tim plans to try out retirement for a while and then make decisions about where he'll next apply his seemingly unlimited energy. We can't imagine him being retired for long.

We are grateful to Tim Sutherland for his nearly five years as the General Manager for The Villages. Tim's invaluable knowledge and expertise in the HOA industry has had a dramatically positive impact on The Villages. The Villages is better for his efforts in providing expert guidance, instilling best practices and repeatable procedures, which have contributed to maintaining the value of our homes and beauty of the property.

A meeting of the Presidents and Vice Presidents of the three corporations was held on March 29, and all respective Board Directors were notified that same evening. The group of Presidents and Vice Presidents discussed the steps to be taken, including continuing vital operations and the process for replacing the General Manager.

The Villages process to replace the General Manager role is well documented and a team to activate and work that process is being formed now. The Villages went through this same process and transition nearly five years ago. During that former search process, The Villages continued to run smoothly due in large part to our dedicated and experienced staff. The Villages staff is some of the best in the business! The Club Board is confident of the same effective transition this time.

The Club Board will provide updates as our plans develop.

Operating Financial Commentary for the Month of February 2022

Club Operating Statement Review

For the month of February 2022

Total revenue was \$35,200 (3.3 percent) favorable to the budget of \$1,056,800. Another dry weather month produced favorable budget variances in every revenue category for the golf program (i.e. green fees, merchandise sales, driving range income, golf cart rentals and golf lessons). The combined positive budget variance in all golf revenue lines totaled \$29,800, 25.4 percent higher than the budget of \$117,400. Combined food and bar sales were favorable to the budget of \$157,600 by \$11,900 (7.6 percent). Notable unfavorable to budget revenues were resident activities (actual \$0 vs. budget of \$4,500) and guest room rentals (actual \$0 vs. budget of \$3,700). The budget assumed guest room rentals would have resumed operations by this time.

Total expenditures were \$42,500 favorable to budget, or 4.2 percent less than the budget of \$1,015,500. The most significant favorable to budget expense category was employee expense with a positive variance of \$76,400 or 11.1 percent (actual \$614,600 vs. budget of \$691,000) with continued employee vacancies in the Restaurant and Community Activities Department. The only other notable favorable to budget category for the month was tree trimming (\$4,400 spent on budget of \$10,200) due to timing of work on the golf course. Notable unfavorable to budget expense categories were the following: 1) water expense due to unseasonably dry weather, 2) electricity expense (mostly at Golf Course, Cribari Center and Clubhouse) 3) gas expense (community centers, pools and Clubhouse) and 4) pest control due to timing of geese control on the golf course.

The net positive operating budget variance for the month of February was \$77,700. See table below.

When BrightView did turf reduction at the entrance of Del Lago I wish they had used best/green practices. Sheet mulching (not to be confused with mulch) is the recommended method. This method lays down sheets of cardboard on top of the grass and covers this with dirt. This way no herbicides are needed to kill the existing grass and it keeps all the existing top soil with its active biology in place. In 2016 California passed Senate Bill 1383 to reduce the disposal of organic waste in landfills. If the turf is hauled away to a landfill this results in the release of methane gas, a terrible greenhouse gas. The turf can be recycled if the dirt is removed. I wonder if BrightView does that? In addition, when BrightView laid down bark mulch in this area to reduce evaporation, in my opinion they smothered the plants and laid it up to the base of trees. This makes it easier for fungal infections to kill the plants. Even the redwood trees across the street have mulch all the way up to their base. General practice is to leave mulch at least 4"-12" away from trees and less for shrubs.

THE ASSOCIATION BOARD

Association President's Report—March 29,2022

Welcome to the March 2022 Villages Association Board Regular Monthly Meeting.

We live in "interesting times!" The driest months in history and severe drought, world-wide virus pandemic, a war in Eastern Europe, and the highest inflation in a generation are just the headlines. As nice as our Villages community can be, we are not immune from the pressures of the outside world. Just one example—the minimum wage in San Jose has risen from \$8/hour in 2012, to \$16.20/hour in 2022—more than double in the last ten years. With so many of our expenses being dependent upon labor cost, you can easily imagine the impact on our budgets. For all the Villages' top three expenses—labor, water, and insurance—prices continue to increase at a breathtaking rate this year. Roof replacement costs alone have increased about 30 percent due to increased costs in material and labor. That's not good news for villages that have roof replacements needed in the next 10 to 20 years, with only a short time to increase saving for them.

What is the Association Board doing about these increased costs? We are looking hard at how we can lower usage of water and minimize discretionary expenses. We are making more investments in turf reduction and drip irrigation conversion, and few, if any, optional enhancements like additional electrical outlets for outdoor decorations. This year we will be focusing on the "Protect and Maintain" but mostly deferring the "Enhance" portion of the Association's mission. In addition, we have taken several hard looks at our thirty-year Reserves Planning process. We have updated the Association Reserves Policy and brought in two outside Reserves companies to develop independent Reserves Plans. We are focused on minimizing our long-term costs by saving for everything we need to repair or replace over time, but not saving more than we need. We are making sure that estimated replacement costs are up to date and based on actual project experiences, and we are continuing to invest in preventative maintenance to extend the lifetime of major components like roofs and paint. Having two outside views has been worth the cost to confirm and augment the work of our experienced staff.

The good news is that both outside Reserves companies have looked deeply at the Villages Association and have given us high marks! They observed that our plans are comprehensive, include all our assets, and use realistic cost and lifetime estimates. While we plan thoroughly, we also inspect to verify when roofing and paint are actually needed, and don't just blindly follow a schedule. Both have told us that we are in the top tier of all the best HOAs they have seen. As a business, the Association has gotten a lot smarter and more rigorous over the years as our processes are continually improved. The bad news is that costs have increased in areas that we can't control—meaning once again increased assessments to catch up. Every HOA in the country is facing the same challenges.

One frequent misconception about the Reserves Plan is that we are saving for expenses that are thirty years away, when many of us won't still be here. In fact, what we are paying for is the wear and tear of each year that we are putting on our homes while we are here. We set our assessments each year to pay the next year's share of those costs. We must all pay our fair share each year, and not defer costs onto the next generation of owners. Not only is deferring work not fair to future owners, but it is also counter-productive since everything costs more in the future.

You will all be hearing and seeing more about budgets and assessments over the next few weeks as the plans are finalized, and next years' budget is approved next month

This is the peak activity for our staff with multiple maintenance activities going on, budget development, and special projects like the Valle Vista Rosemary Replacement project, and drafting Association Bylaws and CC&R updates. Please give them our encouragement and try to minimize adding to their workload. I hope everyone understands how hard they work for us behind the scenes to keep things running smoothly.

'Ask the CBOD' Response - March 31, 2022

Lynn Peters, writes:

With so much TV entertainment provided today via streaming using high speed internet, why not negotiate for only Internet services (an ISP) rather than TV services? Then, those that wish to maintain Comcast TV can contract separately? It is just the reverse of today where TV services are provided from Comcast through our HOAs and we contract separately for Internet services. Time to join the 21st Century.

CBOD Response:

Thank you for your question concerning the decisions on the upcoming Comcast contract. Several individuals have raised this same question concerning moving to streaming for video content. "Cutting the cord" is a popular trend. Going the streaming route is for the more technology savvy amongst us. Overall, in the U.S., streaming is not broadly used to access video content.

As stewards of The Villages community, the Club Board must consider the total population when decisions are made that impact everyone. Last year, the Network Services Committee surveyed The Villages' residents concerning television and internet needs. It is known that we have older residents who do not have an email address and may not own a computer. Many comments were received asking we consider these individuals who can't or aren't able to keep up with increasing technology changes. For many of these Villagers, television is in an important part of their daily lives. They want to be able to turn on the television and simply watch their favorite programs. Requiring those individuals to navigate the world of streaming without constant technical support is not realistic. The Club Board must consider everyone in The Villages when we make these types of decisions.

Over the next five years, the Club Board will be evaluating the technology landscape to determine what direction to take for the future video and internet needs of The Villages. Over that time, streaming technologies may become easier to use and more widely accepted than they are today and could be a viable option for the entire Villages community. Currently there are many options to consider for accessing the internet via broadband, and Villagers may subscribe to these additional services—their choice. These include wireless providers, such as Verizon 5G or T-Mobile 5G, and wireline services, such as Comcast. In addition, there are other new wireless providers such as Astound and Sail that are promoting broadband solutions. No matter the brand name, speeds and costs will vary. With this ever-changing technology landscape, the Club Board elected to not contract for bulk internet services with Comcast currently to allow Villagers to explore these options. Another factor in the decision was the recent upgrade to the T-Mobile cell tower near the driving range which included adding 5G Wi-Fi capabilities. This new option may make moving to 5G home internet a reasonable option for individual Villagers soon.

CBOD President's Message—March 2022

Last Friday, I had the pleasure of golfing with Tim Flanagan, our Teaching Professional when he joined our threesome. It is always enjoyable to play with someone who can really play the game well and just watching Tim with his shot selection, his set-up, his swing tempo and his follow-through was a lesson all by itself. Thank you, Tim.

During the round, I learned that Tim has been here for 28 years. And, as he said, during that time, the course has changed. He has great respect for Robert Graves, our golf course designer as "each tree was strategically placed." This made the course more challenging for the longer hitters, and, as Tim said, "On some holes you needed to shape your drives," which means you had to curve the ball to the right or left to stay on the fairway.

Many of the trees have died mainly because of old age or because they couldn't tolerate the salt in the reclaimed water we use. Each year, trees are being removed and there are more to be removed this year. Some were the large redwoods.

Sadly, the trees are not being replaced. The course has become more barren. The brilliance of the Robert Graves design is gone.

The golf course is a vital element of The Villages and we need to take care of it. We can restore some of the original design and to do this we need to plant trees. Trees take a long, long time to mature and more trees will be removed during this time. We should not wait. Let's plant trees.



Notice of Proposed Changes to Association AC <u>Rule D-23 Garage Doors - Normal Replacement</u>

At the December 14, 2021, Association Board of Directors monthly meeting, proposed changes to The Villages Association Architectural Rule D-23 Garage Doors – Normal Replacement were approved for publication and member comments for the required notice and member comment period prior to formal approval consideration at the February 22, 2022, monthly board meeting. As a result, the proposed changes were published in the December 30, 2021 and January 6, 2022 editions of The Villager newspaper. At the February 22, 2022, monthly meeting, the Board approved for re-publication proposed changes to Rule D-23 as modified prior to formal approval consideration.

The purpose of the change is to update the rule with approved style and color that is in harmony with the village surrounding area and the venting that is required.

The Board will consider approval of the changes at the April 26, 2022, monthly meeting. Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the proposed changes at the Association Board of Directors April 26, 2022, monthly board meeting, or 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at mehernandez@the-villages.com.

Deletions are noted in strikethrough font; additions are underlined.

AC Rule D-23 Garage Doors - Normal Replacement

Replacement of garage doors may be permitted upon the applicant complying with the following conditions:

- a.) An OWNER ALTERATION REQUEST, signed by the Owner, including complete plans and specifications, must be submitted to the Committee for approval. The application shall include written comments by Owners of adjoining Villas (above, below, and on either side, as applicable, and as designated by the Committee). Comments from these adjoining Villa Owners will be given full and careful consideration by the Committee, but any unreasonable suggestion or objection may be disregarded.
- b.) The external physical appearance and color shall be in harmony (both the panel style and any glass) with the installed doors in the surrounding area. The color shall match the color of the existing Village painted doors in the surrounding area. (If your Village paint cycle is due to start within 6 months of the door installation, painting can be postponed with the approval of the AC.) The paint sheen shall match the doors in the surrounding area
- c.) The following options are not approvable by the AC. (1) Powder coated door panels. (2) Bevel, stained or similar glass options.
- d.) Garage door vents: (A) Existing garage doors with ventilation vents must be replaced with doors containing ventilation vents. (B) Existing garage doors without ventilation vents can be replaced with doors with or without ventilation vents at the owner's option.
- e.) <u>Ventilation vents, when required, shall consist of 2 metal louvered vents (6"x16" nominal)</u> <u>located on the outside portions of the lowest door panel.</u>
- f.) No alteration shall be undertaken until after the applicant has received final approval of the Committee. All work shall be done by an insured licensed contractor.
- g.) Periodic repainting of the alteration shall be done by the Association or its agent at the same time the building is repainted. If the alteration is an addition, or requires special maintenance, the repainting shall be done at the owner's expense.
- h.) By signing the OWNER ALTERATION REQUEST to which this rule is attached, the applicant agrees that if the building, including the alteration is damaged by fire or other casualty, and the Association rebuilds the damaged portions of the building, the rebuilding must be done in accordance with the provisions of the Governing Documents and Policies of the Board and insurance currently in place. Geese abatement program—article 3

In this article we will address expectations. Given the start-up of egg addling, The Villages now has a two-prong approach to maintain the geese population levels. (1) Hazing has the objective of chasing the geese somewhere else. (2) Addling has the objective of controlling growth of the population. The problem with hazing only is that Canada geese are often "philopatric." When sexually mature (four years old), they often return to nest where they were hatched. With a 20-year lifespan and four to eight eggs per pair there is no shortage of young returning to our attractive site.

The Villages strategy this past two years has been to haze aggressively just prior to nesting encouraging the geese to locate their nests elsewhere. In the long term then, they would return to that location. There are a couple of problems with that. For six months of the year Canada Geese do "pond hopping and foraging." Those youngsters may pond hop right back to The Villages, like it, and stay. Additionally, since we only haze off the golf course, "nesting elsewhere" for some of the geese means just moving into the residential areas. We would expect to continue the hazing during the fall/winter "pond-hopping" period (September – January). Normal would be two days/week with January aggressive at four days per week. February, which has also been at four times per week, should probably be dropped. The hazing activity is performed by a third-party contractor managed by the Director of Golf. The literature suggests that if an addling program is in place, it is best not to haze. It is better to allow them to nest where the eggs can be located.

Addling complements the hazing effort by focusing on managing the population growth. Although The Villages has addled eggs in the distant past, the current effort should be considered new to us. We will be learning and probably tweaking the program as we go. The new program is being performed by a third-party contractor managed by the Director of Facilities.

Nesting activity should be in process now—you can see many of them are paired up and they are in numerous locations throughout The Villages. Very soon now, if not already started, the hen will begin laying eggs. It takes a day to lay one egg. So a clutch of four to eight eggs will take four to eight days. When she is done, she will start sitting on the nest to incubate the eggs. She and the nest will probably be well hidden, but the gander assumes his sentinel job. He will not be near the nest to avoid calling attention to it, but a nest will be within 50 yards of him. There is a 24 to 27-day incubation period with the first 14 days the ideal addling period.

The above is provided to help you understand what you are seeing. DO NOT try to get close to the nest area itself even if it is in a very public access area. This is for your own safety. Please use The Villages work order system workorder@ the-villages.com or if you prefer, call Customer Service 408-223-4670. Let the professionals find the nest and deal with the geese, and please stay clear while they are doing their job.

This is our final article. The Geese Committee would like to thank the residents and maintenance people who are helping The Villages manage the population of Canada Geese within our community.

cable boxes. Many residents will receive free hardware upgrades to enable newer technologies, like HD. Channels 26 and 27 will still be available. As well, Comcast's dedicated services model will remain in place, including access to the bulk cable support desk and the Virtual Customer Events hosted by Ruhullah, our dedicated Comcast representative.

The process to reach this new contract was not without its pitfalls. Early on, the Club Board issued two separate RFPs for consultants to assist in the vendor identification and negotiation process, as was suggested by the Network Services Committee. Based on the responses to these RFPs, the consultant model was deemed inappropriate for The Villages based on pricing and timing perspectives and we elected to move on without a consulting firm.

Thus, Club Board member Judy Owen, backed by fellow Directors Leslie Lambert and Jerry Neece, joined General Manager Tim Sutherland as The Villages negotiating team. Fortunately, the Club Board was able to retain our previous consultant, Steve Blum, an individual very familiar with The Villages. Steve was involved in the initial negotiations 15 years ago and we still had already-paid-for consulting hours available with him. His current work with the Club Board proved invaluable as we kicked off the RFP and negotiating process. Steve has reviewed the currently proposed contract and has deemed it "a good deal" for Villagers.

The Club Board would like to extend our thanks to the Network Services Committee for their detailed evaluations of various technologies and their survey of other 55+ communities across the United States. The outcomes from their detailed Villages survey from March 2021 which received 751 responses, provided key guidance for Club Board decision-making on several items, including Villager's high level of satisfaction with Comcast. The recent FY22 Villages Satisfaction Survey also confirmed that most Villagers are satisfied with Comcast as a cable TV provider.

Year-to-date revenue is \$268,000 favorable to budget, 3 percent higher than the budget of \$8,873,000. Year- to-date expenditures are \$654,000 favorable to budget, 7.5 percent less than the budget of \$8,771,000. The year-to-date net positive operating budget variance is \$922,000. See table below for detail by department.

The bottom of the table below shows the financial impact of the monthly solar lease payments and contribution to the balloon payment fund (to be paid in 2023) captured on the Club's balance sheet. The year-to-date total for these two items is \$164,000.

EPC Sector Chiefs respond

EPC's Sector Chiefs are lynchpins in a well-organized, dedicated response organization. To highlight this important position and to recognize this group of volunteers, we reached out to Sector Chiefs for their perspectives. Meet Brodie (Bud) Burkett—Sector Chief for Olivas 1 North and Richard (Dean) Fisher—Sector Chief for Highland East. Burkett has been a Sector



Chief for 10 years, Fisher for a matter of months although he'd been an Area Rep for 10 years.

Why are you willing to take on the Sector Chief role?

Fisher: Because it is very likely that EPC will be the ONLY structured emergency response for Villages residents in the chaotic early hours and days of a true major emergency. Highland East with 12 Areas and 125 residences urgently needed a Sector Chief, so I stepped up.

Burkett: When I moved into The Villages, I was aware that this is "earthquake country!" I was contacted by the then Sector Chief Andrew O'Connor. He explained the need to have a sufficient number of volunteers ready for an emergency WHEN it occurs.

What is your biggest challenge as a Sector Chief?

Burkett: Recruitment of *new* volunteers for Area Reps and Sector Chiefs. I strongly believe that being fully staffed to easily and quickly cover our 39 condos is the most important, yet challenging, task that I have.

Fisher: Clearly recruiting new Area Reps. This is why I believe the publicity campaign needs to emphasize the "response" and "support" capabilities of the EPC and the very important role that the "EPC structure" provides in a major emergency through the Area Reps, Sector Chiefs and particularly, Support groups.

What is the one thing you want to say to the residents in your sector about the importance of EPC?

Fisher: The EPC and its volunteers have your back in the early hours and days of a major emergency. The EPC provides a structured and effective response – with volunteers checking on the status of neighbors, then working with the Sector Chiefs to get help from the appropriate Support Groups to provide temporary medical, (Continued on page 27)




She is a mother to three grown children, two of whom are artists themselves, and a grandmother of one, who she inspires and encourages her to express herself through creativity.

Facing the Mountain by Daniel James Brown: From the author of The Boys in the Boat comes a gripping World War II saga of patriotism and courage-the story of the special Japanese American army unit that overcame brutal odds in Europe while their families were incarcerated back home, and of a young man who refused to surrender his constitutional rights, even if it meant imprisonment. Some came from farms and small towns and big cities across the mainland of the United States, and others came from Hawaii. Their parents taught them to embrace both their Japanese heritage and the ways of their American homeland. They faced bigotry, but within days of the attack on Pearl Harbor many of these young men and their families would be living behind barbed wire in internment camps. Facing the Mountain is a chronicle of wartime America and the battlefields of Europe. The book portrays the journey of four Japanese American families and their second-generation young men-the Nisei- who volunteered for the 442 Regimental Combat Team and were deployed to France, Germany, and Italy. There they were asked to do the near impossible in often suicidal missions. Harlem Shuffles by Colson Whitehead: To his customers and neighbors on 125th Street, Ray Carney is an upstanding salesman of reasonably priced furniture, making a decent living for himself and his family. He and his wife Elizabeth are expecting their second child. Few people know he descends from a line of uptown hoods and crooks. His façade of normalcy has more than a few cracks in it. Cash is tight, so if his cousin Freddie occasionally drops off the odd ring or necklace, he doesn't ask where it comes from. He knows a discreet jeweler downtown who doesn't ask questions. When Freddie volunteers Ray's services to fence the take from a robbery of the Hotel Theresa, the Waldorf of Harlem, things don't go as planned. Now Ray has a clientele of local gangsters, shady cops, and other Harlem lowlifes. Thus begins the internal tussle between Ray the striver and Ray the crook. Can he avoid getting killed, save his cousin, and grab his share of the big score, all while maintaining his reputation. 'A New Kind of Freedom'

A mob enraged by religiosity, pursues Jesus to trap Him and to stone a defenseless woman, Julia Stankova, a modern-day, Bulgarian iconographer, captures the grim scene in "Woman Caught in Adultery." Nearly faceless, muscle-bound men clad in dull, prison-grey robes clutch rocks. The leader points an accusing finger at the cowering woman. Her hands and arms protect her head. No veil covers her face or hides her tortured eyes. To the left of this evil, bends Jesus, eyes closed, hand extended on the ground. Praying? Drawing? Writing? Gospel writer John omits that detail. (John 8:1-11). Observing Jesus' inner peace and deliberate gesture, did the murderous crowd recall Jesus recent warning: "If I drive out demons by Beelzebub, by whom do your followers drive them out? So then, they will be your judges. But if I drive our demons by the finger of God, then the Kingdom of God has come upon you." (Luke 11:19-20.) The Finger of God image harkens back to Exodus when the magicians in Pharaoh's court were defeated by the 'finger of God" (Ex. 8:19.) Shamed--the murderous mob dropped their rocks and slunk away. Commentator Edward P. Hahnenberg PhD, notes: "In pointing out injustice, ...Jesus didn't...round up all the guilty parties. He didn't demand the man be punished by equal force. That's our notion of justice. Instead, Jesus lets everyone go, and so offered a new kind of freedom. What Jesus said to the woman, Jesus says to us-faithful disciples, Pharisees, and scribes that we are— "Go...and sin no more."

Stations of the Cross, 14 images following Jesus' Passion and death, are found on the walls of every Catholic Church in the world. They constitute a virtual pilgrimage intended to substitute for the millennium-long Christian custom of physically walking the "Way of the Cross" in Jerusalem. Eleventh century invaders conquered the Holy Land, and cut off access to the pilgrimage sites. Catholics therefore replaced the pilgrimage with a virtual "Way of the Cross" walking from image to image, meditating on the stages of Jesus' passion, and reciting certain prayers. 'Death, Be Not Proud'

"Death, be not proud," wrote metaphysical poet John Donne in the 17th century, "though some have called thee. Mighty and dreadful, for thou art not so. For those whom thou think thou dost overthrow. Die not, poor Death, nor yet canst thou kill me." The Episcopal Church celebrated his day on our calendar of holy people this week, and I am grateful for a slight break from the commemorative parade of martyr saints whose days tend to populate our Lenten calendar. John Donne, an Anglican cleric, died of natural causes. But he lived his short life with an extraordinary consciousness of its finitude.

Death was always near to John Donne (except in his youth when he was thinking about wine and women), but his poetry and sermons reveal his deep faith in God's sovereignty over death. From the same sonnet quoted above, he wrote "One short sleep past, we wake eternally. And death shall be no more; Death, thou shalt die."

This is why Donne remains one of my favorite poets, especially (but not only) during Lent. His own rather dissolute younger life—which left him in poverty—taught him of God's relentless love even in the midst of his own failings. The sum of Lent's lessons can be found in Donne's writings: our human pride need not be diminished by death, because it is always hidden in the eternal life of God.


PICKLEBALL

Did you know that you should not make adjustments to your scores during Tuesday Sweeps tournaments? Rather, mark your gross score for each hole, yes, even those 11s and 12s. The Pro Shop will take care of any necessary adjustments when they post scores. You do, of course, make your own posting adjustments when you're not playing sweeps with the Swingers. For casual play, to calculate the adjusted maximum strokes to enter per hole, use the following formula: par of the hole + 2 strokes (double bogey) + any handicap strokes you are entitled to receive on that hole based on your Course Handicap. Handicap strokes are those "pops" you see during special tournament play. When you post your own score, you are benefitted by posting hole-by hole as the adjustments are made automatically, eliminating the need for you to calculate maximum strokes per hole.



Tips from the Pro-I've got rhythm...who can ask for anything more?

There's no such thing as the perfect tempo or rhythm. Ideally each of us should adopt a swing speed that is consistent with our overall temperament. Lanny Wadkins swings quickly, but Lanny does everything quickly. Ernie Els is a more deliberate person, and his swing is slow and smooth. So suit yourself - But whatever tempo you adopt, be sure that you keep it consistent throughout the round, meaning full swing, chipping and putting. And try not to speed up when the pressure is on. If you find yourself quickening, consciously slow things slow down your walk, your speech, your club selection. As for rhythm, there is an ideal, but it can't be described in print. It must be absorbed. The three keys to great rhythm are to swing your arms and body at the same pace and in synch; to maintain good balance; and to make a smooth transition from backswing to downswing. The best thing to do is to spend several minutes watching the swings of players with great rhythm, guys like Ernie Els, Freddie Couples, Jimmie Walker or Annika Sorenstam. Then walk - don't run - to the course and try to mimic them. A fabulous tempo and rhythm training aid is the **Orange Whip...swing** in sequence 20 swings back & forth without stopping, marry your arms and body and you will start to find your optimal tempo, rhythm and balance. 

Two ways to file for the school tax exemption

You will qualify to file for exemption from the annual \$125 Evergreen School District parcel tax on your principal residence if you will be age 65 by June 30, 2023 – the end of the next property tax fiscal year. If there are joint owners of your principal residence, only one owner needs to be age 65.

Your application must be in the School District office by Tuesday, May 31. This deadline is a State requirement. Sobbing on June 1 will not work.

Evergreen School District representatives will be at The Villages on **Thursday, April 14** in the Cribari Center Forum Room from **2:30 to 4 p.m.** to approve your parcel tax exemption request.

You must have documents to prove (1) your property ownership, (2) your residency, and (3) your age. Your 2021/2022 property tax statement will prove your ownership. Your driver's license or CA identification card will prove your residency and age. Your documents will be reviewed and immediately returned to you.

If you are new to The Villages and the address on your driver's license does not match your property tax statement, please also bring your PG&E bill or other bill to prove your residency. If you do not yet have a property tax statement, bring your escrow purchase statement and related papers.

Can't make the April 14 session? You may file online. Go to the School District's web site at eesd.org. Under the Community tab click on Senior Parcel Tax Exemption. Complete the application and scan the supporting documents. Email questions to Accounting@eesd.org

If you don't have a computer, stop by the Evergreen School District Business office with your support documents. The address is 3188 Quimby Road.

If you had the exemption from the parcel tax for 2021/2022, your exemption has been automatically renewed by the School District. There is nothing more you need to do. The above instructions are for new exemption requests.

Not sure whether you have the exemption? Go to your last property tax bill. Look under the section on page 2 labeled "Parcel Tax / Special Assessments." If a line item is "Evergreen Measure EE 2018" followed by "\$125", you are paying the tax. If you can't find this listing, i.e., if there is no \$125 charge, you are currently exempt from the tax. Relax!

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday, and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253 or e-mail SRS at villagessrs@ sbcglobal.net. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

SRS Reminder:

Answer question on page 1 of form 1040

As with your 2020 return, again there is a question at the top of Form 1040 and Form 1040-SR asking about virtual currency transactions. All taxpayers filing these forms must check the box indicating either "yes" or "no."

If you disposed of any virtual currency that was held as a capital asset through a sale, exchange, or transfer, you should check "Yes" and use Form 8949 to figure your capital gain or loss and report it on Schedule D (Form 1040).

If you received any virtual currency as compensation for services, you must report the income as you would report other income of the same type (for example, W-2 wages on Form 1040 or 1040-SR, line 1).

More information on virtual currency can be found in Instruction for Form 1040.
