Comcast Services Update

The new Comcast agreement will be effective May 1, 2022, and you can expect detailed communication over the next few weeks.

What is not changing with your services? No need to worry, your channel lineup is not changing, HBO is still part of the package; neither your internet services nor other individual upgrades are changing, and there is nothing you need to do right now to take advantage of the new savings! If you require upgraded equipment, communication will be sent to you directly toward the end of May with options.

What is changing? Villagers are now eligible to receive HD programming at no additional cost! Meaning, if you already have HD and are paying a fee, the fee will now go away. If you do not have HD and want it, arrangements will be made to get you updated equipment. If you have HD and are not paying for it on your bill nothing will change. Over the next two to three weeks Comcast will be making the necessary billing changes, holding onsite events to serve as a resource for residents and sending individual notifications of options and next steps. Villagers can expect to see any necessary billing adjustments on their June statement with rates retroactive to the May 1, 2022, contract effective date.

- Residents who need upgraded equipment will be notified individually toward the end of May about the next steps and available options to receive the new equipment

The geese were apparently reported to have been "aggressive."

I observed attempts by a few residents to scare them away in very aggressive ways out of their own fears and lack of understanding without any provocation from the geese. Most, some of whom had dogs, walked by or went around the geese carefully and respectfully without incident.

The geese were not aggressive. I saw the geese react once because it had been physically threatened by the same person twice within minutes! No one was hurt. The male geese was simply wanting to protect his family.

There is so much we can learn from these beautiful, elegant creatures—-courage, integrity, respect, love of family, grace...

2022 Annual Member Meetings and Elections

The three Villages Corporations (Club, Association and Homeowners' Corporation) are preparing for this year's elections and annual membership meetings (this year like last, via teleconference).

Elections will be conducted in May and June with election results announced at this year's annual membership meetings to be held on Thursday, June 9, 2022, with the Homeowners' Corporation to be at 3 p.m., the Association's at 4 p.m. and the Club's at 5 p.m.

Club: Elections will be held for two director positions (each for a term of three years) on The Villages Golf and Country Club (VGCC) Board of Directors. The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Director terms expiring are for Jerry Neece and Del Yamaki, and the directors who will continue to serve during the ensuing year are Bob Wilk, Leslie Lambert, Bob Krattli, Richard Zahner, and Judy Owen.

There are three candidates for which nominations have been qualified for the ballot, Garry Ashby, Liz Kung and Howie Blumstein. Pursuant to the bylaws the two candidates receiving the largest number of votes shall be elected to serve a term of three years.

Association: The Villages Association will hold a vote this May and June to vote on The Villages Association Resolution, Excess of Membership Income Over Membership Expenses Refunded to Members and Amendments to The Villages Association CC&Rs and Bylaws.

The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are David Cook, Diana Hallock, Richard Holmboe, Julie Wash, and George Paris. Director terms expiring are that of Garry Ashby and Noel Lanctot. Upon adjournment of the 2022 annual meeting, there will be two vacancies on the Association Board of Directors. As of the duly noticed Deadline of Nominations date of March 29, 2022, no qualified candidate nominations have been received by The Villages Association, so this year there will not be a director election for the Association.

Per Association Bylaws Section 5.8 Filling Vacancies, any vacancy occurring on the Board, except a vacancy created by the removal of a Director by a vote of the Members, may be filled by approval of the Board and Directors so chosen shall serve until the next general election.

Homeowners: The Villages Homeowners' Corporation will hold a vote to fill two director positions (each for a term of three years) and to vote on The Villages Homeowners' Corporation Resolution, Excess of Membership Income Over Membership Expenses Refunded to Members.

The bylaws of the Homeowners' Corporation provide that there will be five directors. Those who will continue to serve during the ensuing year are Rob Kirschbaum, Brooks Fuller and Jeannie Omel. As of the deadline of May 1, 2022, at 5:00 p.m. there have been two candidates nominated and qualified, Teddy Morse and Larry Versaw, and per Section 7.3 of the Second Amended and Restated Bylaws of the Villages Homeowners' Corporation they are declared elected by acclamation and will begin their terms as Directors on June 9, 2022, upon adjournment of the Annual Meeting of the Members.

Association/Homeowners documents available via e-mail

Per an amendment to California Civil Code, homeowner associations are permitted, with owner's written consent, to distribute annual disclosures, (like the pro forma budget summary) and other specified association documents to owners via electronic mail, facsimile, or other electronic means (such as posting on the association's website) instead of sending those documents out by regular mail or personal delivery. This has the potential to provide cost savings to The Villages. Delivery and postage costs for the Villages' annual distribution of the pro forma budget summary alone are close to \$1,000, not to mention the paper and printing costs.

In order to transmit association documents via e-mail or by posting on the homeowners association's website, 1) the homeowners association must first receive the owner's written consent, and 2) the homeowners association sends a separate notice to the owner that the documents have been posted and are available for viewing.

Consent forms for owners to request delivery of documents have been developed for both The Villages Association and Homeowners Corporations. These forms provide an owner's consent to electronic delivery of documents that are capable, under current laws, of being distributed electronically. Owners have the right to revoke this request and receive "hard copies" of the documents by sending a written revocation signed by the owner, to the applicable corporation.

Forms of owner's written consent are available in Business Administration Buildings A and B, and on The Villages web site, http://www.thevillagesgcc.com (Click on *Resident Info* and then Click on *Resource Files*.)



Coyote reminder and tips

Coyotes may try to escort walkers out of an area to protect their pups or food sources when encountered on a trail or street. Humans may perceive this behavior as stalking, which is usually not the case. They may also view your pet as prey. To allow coyotes to be wild while keeping yourself and pets safe, please follow these pointers:

- Never feed coyotes—it is illegal to feed coyotes in most places. Feeding endangers your family and neighbors because it lures coyotes into neighborhoods.
- Keep unattended cats and dogs indoors or in completely enclosed runs, especially at night, and do not assume that a fence will keep a coyote out of your backyard.
- · Accompany your leashed pet outside. Make sure you turn on lights if it is dark to check your backyard for unexpected wildlife.
- Keep dogs on short leashes while walking outside; the Division of Wildlife recommends a leash no longer than 6 feet.
- Keep noisemakers on hand to scare away coyotes that may enter your yard. Some examples of noise makers are whistles, horns or metal cans with small rocks or coins that rattle.
 - Never run away or turn your back on a coyote.
 - Do not allow a coyote to get between you and your pet or child—keep children close to you.
- Yell, clap hands, blow a whistle or rattle a can and try to make yourself look larger if you have a close encounter with a coyote.

· An empty soda can with pennies sealed with duct tape makes a very good noise maker when shaken. Reminder to all small pet owners: A recent rise in coyote aggression has been seen with small dogs, most unleashed. Please always leash your pets. Keep leases short. Coyotes will try to get between you and your pet if the leash is extended far enough. Coyotes are known to attack leashed dogs when the owner gets distracted. Please stay cautious and aware of your surroundings when cleaning up after your pet, talking to a neighbor, checking the mail, etc. Coyotes are opportunists and may make their attacks when you are not paying attention.

Carry a noise maker and always be alert. Use caution when walking past wooded areas, hiding spots between homes, and the golf course. They are widespread in The Villages and can truly be anywhere.

There is no way to completely eliminate coyotes from The Villages so always use caution when walking, especially with pets. Also, coyotes tend to be most active around sunrise and sunset. Pick different times for walks.

Don't feed the 'critters'

The Villages is known for its wide variety of wildlife. Many Villagers want to feed our four-legged or winged guests on a routine basis, which can be quite detrimental to our wild friends. Most wild animals naturally fear humans and keep their distance. When animals have access to food and garbage left out by residents they keep coming back for more. When this happens, they often lose their natural fear of humans and can become aggressive. To prevent that, residents should not leave out any food, including canned food, in a manner that may become accessible to our furry friends. Please comply with Villages Golf & County Club Rule 1.51.4, which states: "Feeding of waterfowl and other wild animals on a routine basis is prohibited for the protection of both residents and the animals."

Even social clubs may need to file with the IRS

It happened again. This past summer one of the golf groups received a letter from the IRS. Does your social club, activity club or special interest group have a bank account? If it does,

this means it has an Employer or Taxpayer Identification Number (EIN or TIN) from the IRS. Are you an officer or leader of the group? If you have answered yes to these questions, SRS has another question for you. Has your group identified a person responsible for filing the required annual report with the IRS?

Yes, even though it is just a social club, a tax return is required to be filed by May 15 of each year. Because of the weekend it is May 16 in 2022.

Most likely the gross receipts of the club are less than \$50,000. If so, your organization needs to file is Form 990-N also known as the e-Postcard. Form 990-N must be filed online at the IRS web site. It is easy. You do not have to be an accountant to do this form. It requires eight items of information:

- Employer/Taxpayer identification number
- Tax year (most likely calendar)
- Legal name and mailing address
- Any other names the organization uses
- Name and address of a principal officer
- · Website address if the organization has one
- Confirmation that the organization's annual gross receipts are \$50,000 or less
- · If applicable, a statement that the organization has terminated or is terminating (going out of existence)

An organization that fails to file the required e-Postcard for three consecutive tax years automatically loses its tax-exempt status.

An organization can have its tax-exempt status reinstated if it was revoked for failing to file. You will have to apply and, if required, pay the appropriate user fee.

The IRS web site is highly informative for non-profit organizations. It has access to the filing site for Form 990-N and also includes the Forms 990-EZ and 990. Go to www.irs.gov. In the top right corner is a drop-down menu labeled "Information for..." with a choice for "Charities and Non-profits".

Of course, the State of California would also like to hear from the non-profit. The State forms are similar to the IRS forms starting with the e-postcard form 199-N. Go to www.ftb.ca.gov. Enter "charities nonprofits" in the search box; then click on "Annual Filing Requirements" and you will see 199-N.

Proposed Bylaws Amendment for The Villages Association

The proposed First Amendment to Amended and Restated Bylaws of The Villages Association is necessary to conform outdated sections with changes in the law including laws affecting the way membership votes in association are to be conducted. Specifically legal counsel made changes to Sections 2.16, 2.20, 2.26, 3.3, 3.6, 4.3, 5.2, 5.3, 6.2, 6.3, 6.4, 6.5, 6.6, 7.2, 8.2, 8.6, 8.7, 8.8, 8.11, 13.2 and 13.4 and added new sections 3.7, 3.8, and 8.15.

The Bylaws Amendment can be adopted by Board vote only. Although not a legal requirement, legal counsel suggested the Board follow the same procedure as required to adopt new Association rules by publishing the proposed Bylaws Amendment for member review/comment period. Following this member review/comment period, because these changes are deemed non-discretionary to conform the Bylaws to changes required by law, the proposed Bylaws Amendment can then be adopted at an open Board meeting by two-thirds (2/3) majority vote of the Board pursuant to the applicable provisions of the Bylaws. The Board will consider formal approval of the Bylaws Amendment at the May 31, 2022, regular monthly meeting.

Following are the proposed changes. Deletions are noted in strikethrough font; additions are in **bold text**.

Response to the proposed amendment to rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the proposed changes at the Association Board of Directors May 31, 2022, board meeting, or 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at mehernandez@the-villages.com.

FIRST AMENDMENT TO AMENDED AND RESTATED BYLAWS OF THE VILLAGES ASSOCIATION

This First Amendment to the Amended and Restated Bylaws of The Villages Association (the "First Amendment") is made with respect to that certain AMENDED AND RESTATED BYLAWS OF THE VILLAGES ASSOCIATION executed on June 2, 2014, (the "Bylaws"), and is adopted on the date set forth at the end of this document by The Villages Association ("Association").

WHEREAS, recent statutory changes effective January 1, 2020, and January 1, 2022, have resulted in a lack of conformity between the applicable law and certain provisions of the Bylaws.

WHEREAS, Article 14, Section 14.2 ("Amendment by the Board of Directors") of the Bylaws provides that "The Board of Directors may, by a vote of a two-thirds (2/3) majority of all Directors, adopt amendments to these Bylaws when an amendment is needed to conform a particular provision or provisions of the Bylaws to changes in applicable California statutory law that are nondiscretionary in nature. Before entertaining a motion to approve any such amendment(s), the Board shall receive a written opinion from an attorney licensed to practice law in the state of California confirming that a change or changes in California statutory law necessitates a corresponding amendment to these Bylaws to make the affected provision(s) of these Bylaws conform to the statutory requirements, which the Association is bound by law to follow."

WHEREAS, the Board now desires to amend the nonconforming provisions of the Bylaws to be consistent with current statutory law pursuant to Article 14, Section 14.2, of the Bylaws.

NOW, THEREFORE, notwithstanding anything to the contrary in the Bylaws, the Bylaws are hereby amended as follows (words with a strike through are deleted and in **bold** are added):

- 1. Article 2, Section 2.16 ("General Delivery / General Notice"), is hereby amended to add a new subsection (v) as follows:
 - (v) If the Association maintains an internet website for the purpose of distributing information on Association business to the Members, by posting the notice on the Association's internet website in a prominent location that is accessible to all Members if designated as a location for posting general notices in the annual policy statement prepared pursuant to Civil Code section 5310.
- 2. Article 2, Section 2.20 ("Member in Good Standing"), is hereby amended to read as follows:
- 2.20 Member in Good Standing. "Member in Good Standing" shall mean a Member of the Association who is current in the payment of all **Annual** Assessments, Additional Charges, and other charges of any kind and Special **Assessments** imposed in accordance with the Governing Documents, and who is in compliance with all of the provisions of the Governing Documents. A Member shall be deemed to be in Good Standing unless, after notice and an opportunity for hearing, pursuant to <u>Article 11 of the Declaration</u> ("Enforcement; Notice; Hearings"), the Board has found the Member to be not in Good Standing and has so notified the Member in accordance with Civil Code section 5855.
 - 3. Article 2, Section 2.26 ("Total Voting Power"), is hereby amended to read

as follows:

- 2.26 <u>Total Voting Power</u>. "Total Voting Power" shall mean the total number of votes of all Members entitled to vote at a particular time, calculated on the basis of one vote for each Unit, excluding any Units as to which an Owner is not then a Member in Good Standing.
 - 4. Article 3, Section 3.3 ("Voting"), is hereby amended to read as follows:
- 3.3 <u>Voting</u>. Members in <u>Good Standing</u> shall be entitled to cast one (1) vote for each Unit owned provided, however, that as set forth in <u>Section 3.4</u> ("Multiple Owners") below, each Unit is entitled to only one (1) vote, <u>regardless of the number of Members in Good Standing for that Unit</u>. If a <u>Member owns multiple Units and is determined by the Board, in accordance with the Declaration, to not to be in "good standing" as to a particular <u>Unit</u>, that <u>Member shall be automatically deemed to be not in "good standing" as to all other Units owned by such Member. A <u>Member's "good standing" shall be determined as of the record date established in accordance with Section 3.6 ("Record Date for Voting") of these Bylaws.</u></u></u>
- 5 Article 3, Section 3.6 ("Record Date for Voting"), is hereby amended to read as follows:
- 3.6 Record Date for Voting. Consistent with Corporations Code section 7611(b),(c), the Board may fix a date not more than sixty (60) days before the date of any mailing or delivery of ballots as the record date for determining Members entitled to vote and only Members in Good Standing as shown in the records of the Association as of the record date for voting shall be entitled to vote in such vote or election. If no record date for voting is set by the Board, Members in Good Standing on the day of the mailing or delivery of ballots who are otherwise eligible to vote shall be entitled to vote in such vote or election.
- 6. Article 3, Section 3.7 ("Conservator, Guardian, Parent of Minor, Executor, Attorney-in-Fact"), is hereby added to read as follows:
- 3.7 Conservator, Guardian, Parent of Minor, Executor, Attorney-in- Fact. The power to cast a particular Member's vote may be exercised by (i) the Member's conservator, (ii) the guardian of the Member's estate, (iii) the parent(s) entitled to custody of a Member if the Member is a minor, (iv) the executor or administrator of a deceased Member's estate if the Member's interest in the Unit is subject to administration in his or her estate, or (v) a person with a general power of attorney for a Member.
- 7. Article 3, Section 3.8 ("Owner's Duty to Annually Provide Address, Other Information"), is hereby added to read as follows:
- 3.8 Owner's Duty to Annually Provide Address, Other Information. As required by Civil Code section 4041, each Member shall annually provide written notice to the Association of all of the following: (i) the Member's preferred delivery method for receiving notices from the Association, including either a mailing address, a valid email address, or both, (ii) an alternative or secondary delivery method, if any, to which notices from the Association are to be delivered, including either a mailing address, a valid email address, or both, (iii) the name, mailing address and valid email address (if available) of the Owner's legal representative, if any, including any person with power of attorney or other person who can be contacted in the event of the Member's extended absence from the Unit, and (iv) whether the Unit is Owner-occupied, is rented out, or if the Unit is vacant. If a Member fails to provide notice to the Association of the information set forth in (i), (ii), and (iii) above, the last mailing address provided in writing by the Member or, if none, the Unit property address, is deemed to be the address to which the Association shall deliver notices. For purposes of this Section 3.8, a "valid email address" is one that, after a notice is sent, does not result in a bounce back or other error notification indicating failure of the message to be delivered. If the Association delivers a notice to a Member's email address and finds that the email address provided is not valid, the Association shall resend the notice by Individual Delivery to a mailing or email address provided by the Members.
- 8. Article 4, Section 4.3 ("Voting and Election Rules"), is hereby amended to read as follows:
- 4.3 <u>Voting and Election Rules</u>. The Board shall adopt Rules governing membership voting and elections of Directors in conformity with Civil Code section 5101(a) 5105. Election Rules adopted pursuant to Civil Code section 5105 shall not be amended less than ninety (90) days prior to an election.
- 9. Article 5, Section 5.2 ("Qualification of Directors"), is hereby amended to read as follows:
- 5.2 <u>Qualifications of Directors</u>. Only persons who are both Members in Good Standing of the Association and Residents shall be eligible to be elected to or serve on the Board, provided that no one shall be entitled to serve on the Board who is concurrently serving on the board of directors of the Club. Only one Owner of a particular Unit **may be nominated for or** serve on the Board at any time.
- 10. Article 5, Section 5.3 ("Disqualification of Directors"), is hereby amended to read as follows:
- 5.3 <u>Disqualification of Directors</u>. A person shall be deemed disqualified from serving on the Board under the following circumstances: (i) the person is found

by a court of competent jurisdiction to be of unsound mind or is convicted of a felony; the person has a criminal conviction that would prevent the Association from purchasing the fidelity bond coverage required by Civil Code section 5806 or terminate the Association's existing insurance coverage required by Civil Code section 5806 as to that person; (ii) the person fails within sixty (60) days after receiving notice of election to accept such office, either in writing or by attending a meeting of the Board of Directors as a Director; (iii) the person is absent from three (3) consecutive regular monthly meetings of the Board or four (4) regular monthly meetings of the Board in a single fiscal year; or (iv) the person ceases to be an Owner or ceases to be a Member in Good Standing; or (v) the person ceases to be a Resident of the Condominium Development.

- 11. Article 6, Section 6.2 ("Deadline for Nominations"), is hereby amended to read as follows:
- 6.2 <u>Deadline for Nominations</u>. The deadline for nominations shall be set by the Board and shall be not less than thirty-five (35) and not more than forty-five (45) thirty (30) days prior to the date of the mailing or delivery of ballots for any annual election of Directors.
- 12. Article 6, Section 6.3 ("Publication of Deadline for Nominations"), is hereby amended to read as follows:
- 6.3 <u>Publication of Deadline for Nominations</u>. The date and time of the deadline for nominations and the procedure for submitting a nomination shall be published provided to the Members by General Delivery (and by Individual Delivery if so requested by a Member) at least thirty (30) days in advance of the nomination deadline in an Association newsletter, or if there is no such newsletter, notice shall be given in one or more of the following manners: (i) by posting a notice in one or more prominent places within the Condominium Development, (ii) by mailing or delivering a notice to each Unit, or (iii) by other means reasonably designed to provide actual notice to the Members.
- 13. Article 6, Section 6.4 ("Notice of Known Candidate Names"), is hereby amended to read as follows:
- 6.4 Notice-List of Known Candidate Names. The A list of the names of all persons known by the Board to be qualified candidates for election to the Board as of the published deadline for nominations shall be set forth in the notice of the election-prepared and distributed as set forth in Civil Code section 5115(b) and in the Rules described in Section 4.3 ("Voting and Election Rules").
- 14. Article 6, Section 6.5 ("Voting for Directors"), is hereby amended to read as follows:
- 6.5 <u>Voting for Directors</u>. Voting for Directors shall be conducted by "secret ballot" pursuant to Civil Code sections 5100. At each election of Directors, the Members in Good Standing-may cast in respect to each position on the Board to be filled, one vote for each Unit owned. The persons receiving the largest number of votes shall be elected and, of those elected, the one receiving the largest number of votes shall be elected to the longest position term and the one receiving the lowest number of votes shall be elected to the shortest position term. In the case of a tie for any position, a run-off election will be conducted by secret ballot pursuant to Civil Code section 5100 through 5145. Cumulative voting shall not be permitted.
- 15. Article 6, Section 6.6 ("Election by Acclamation"), is hereby deleted in its entirety and replaced with the following:
- 6.6 Election by Acclamation. Notwithstanding the secret balloting requirements of Section 4.1 ("Voting by Members; Member Request for Vote") or anything to the contrary in the Governing Documents, if, as of the published deadline for nominations, the number of qualified candidates nominated is not more than the number of Directors to be elected, as determined by the inspector of elections, then the persons nominated and qualified to be elected may be declared elected by acclamation if all of the following conditions have been met:
- 6.6.1 <u>Elections Held at Least Once Every Three Years</u>. The Association has held a regular election for Directors in the last three (3) years. The three-year time period shall be calculated from the date ballots were due in the last full election to the start of voting for the proposed election.
- 6.6.2 <u>Individual Notice of Nomination Procedure Provided</u>. The Association provided individual notice of the election and the procedure for nominating candidates at least ninety (90) days before the deadline for submitting nominations that includes all of the following:
 - (i) the number of Board positions to be filled at the election.
 - (ii) the deadline for submitting nominations.
 - (iii) the manner in which nominations can be submitted.
- (iv) a statement informing Members that if, at the close of the time period for nominations, there are the same number or fewer qualified candidates as there are Board positions to be filled, then the Board may, after voting to do so, seat the qualified candidates by acclamation without balloting.
- 6.6.3 Reminder Notice Provided. The Association provided a reminder notice between seven (7) and thirty (30) days before the deadline for submitting nominations that includes all of the following:
 - (i) the number of Board positions to be filled at the election.

- (ii) the deadline for submitting nominations.
- (iii) a list of the names of all of the qualified candidates to fill the Board positions as of the date of the reminder notice.
- (iv) a statement reminding Members that if, as of the deadline for nominations, there are the same number or fewer qualified candidates as there are Board positions to be filled, then the Board may, after voting to do so, seat the qualified candidates by acclamation without balloting. This statement is not required if, at the time the reminder notice will be delivered, the number of qualified candidates already exceeds the number of Board positions to be filled.
- 6.6.4 <u>Acknowledgment of Nomination Provided</u>. The Association provides, within seven (7) business days of receiving a nomination, a written or electronic communication acknowledging receipt of the nomination to the Member who submitted the nomination, and if the nominee and the Member who submitted the nomination are not the same person, then a written or electronic communication to the nominee within the same time period indicating the following:
 - (i) the nominee is a qualified candidate for the Board; or
- (ii) the nominee is not a qualified candidate for the Board, the basis for the disqualification, and the Association's internal dispute resolution procedure, which shall comply with Civil Code section 5900 et al., by which the nominee may appeal the disqualification.
- 6.6.5 <u>All Qualified Candidates Allowed</u>. The Association permits all candidates to run for election, except for any nominees disqualified from running as allowed or required pursuant to <u>Section 5.2</u> ("Qualification of Directors").
- 6.6.6 <u>Board Vote at Open Meeting</u>. The Board votes to consider the qualified candidates elected by acclamation at an open meeting for which the agenda item reflects the name of each qualified candidate that will be seated by acclamation if the item is approved.
- 16. Article 7, Section 7.2 ("Teleconference Meetings"), is hereby amended to read as follows:
- 7.2 Teleconference Meetings. A-As provided in Civil Code section 4090(b), a teleconference meeting shall be conducted in a manner that protects the rights of Members of the Association and otherwise complies with the requirements of the Davis-Stirling Common Interest Development Act (Civil Code section 4000 and following). Except for a meeting that will be held solely in executive session or conducted under Civil Code section 5450 when a local, state, or federal state of emergency has been declared, the notice of the teleconference meeting shall identify at least one physical location so that Members of the Association may attend, and at least one Director or a person designated by the Board shall be present at the location. Participation by Directors in a teleconference meeting constitutes presence at that meeting as long as all Directors participating are able to hear one another, as well as Members of the association speaking on matters before the Board.
- 17. Article 8, Section 8.2 ("Records and Minutes"), is hereby amended to read as follows:
- 8.2 Records and Minutes. The Board shall cause to be kept a complete record of all its acts and the corporate affairs, including an accurate and current record of the Members setting forth their names and addresses a membership list described in Civil Code section 5200(a)(9), adequate and correct books and records of account, and minutes of the proceedings of the Members, the Board, and committees of the Board.
- 18. Article 8, Section 8.6 ("Annual Budget Report"), is hereby deleted in its entirety and replaced with the following:
- 8.6 <u>Annual Budget Report</u>. In accordance with Civil Code section 5300(a), the Association shall distribute an annual budget report, not less than thirty (30) days and not more than ninety (90) days prior to the end of the Association's fiscal year. The annual budget report shall conform to the requirements of Civil Code section 5300(b) and (e) and section 5550 concerning the following and any other matters as may be required by law:
- 8.6.1 Pro Forma Operating Budget. A "pro forma operating budget" showing the estimated revenue and expenses on an accrual basis.
- 8.6.2 <u>Reserves Summary</u>. A summary of the Association's reserves, prepared in accordance with Civil Code section 5565.
- 8.6.3 <u>Reserves Funding Plan</u>. A summary of the reserve funding plan adopted by the Board in accordance with Civil Code section 5550(b)(5). The summary shall include notice to Members that the full reserve study is available on request, and the Association shall provide the full reserve funding plan to any Member upon request.
- 8.6.4 <u>Statement of Deferred Repairs</u>. A statement as to whether the Board has determined to defer repairs or replacement of any major component with a remaining life of thirty (30) years or less, including a justification for decision not to make repairs or replacement.
 - 8.6.5 <u>Statement of Anticipated Special Assessments</u>. A statement,

consistent with the reserves funding plan, as to whether the Board has determined that one (1) or more Special Assessments will be required to repair, replace or restore any major component or to provide for adequate reserves for such repair, replacement or restoration. The statement shall set out the estimated amount, commencement date and duration of the Assessment, if anticipated.

8.6.6 <u>Mechanisms for Funding Reserves</u>. A statement as to the mechanism or mechanisms by which the Board will fund reserves to repair or replace major components, including Assessments, borrowing, use of other assets, deferral of selected replacements or repairs, or alternative mechanisms.

8.6.7 Statement of Reserve Calculations. A general statement addressing the procedures used for the calculation and establishment of those reserves to defray the future repair, replacement, or additions to those major components that the Association is obligated to maintain. The statement shall include, but need not be limited to, reserve calculations made using the formula described in Civil Code section 5570(b)(4), and may not assume a rate of return on cash reserves in excess of two percent (2%) above the discount rate published by the Federal Reserve Bank of San Francisco at the time the calculation was made.

8.6.8 <u>Statement of Outstanding Loans</u>. A statement as to whether the Association has any outstanding loans with an original term of more than one (1) year, including the payee, interest rate, amount outstanding, annual payment, and when the loan is scheduled to be retired.

8.6.9 <u>Summary of Association's Insurance Policies</u>. A summary of the Association's property, general liability, earthquake, flood, and fidelity insurance policies; and for each policy, the summary shall include the name of the insurer, the type of insurance, the policy limit, and the amount of the deductible, if any. To the extent that any of the required information is specified in the insurance policy declaration page, the Association may meet its obligation to disclose that information by making copies of that page and distributing it with the annual budget report. The summary distributed pursuant to this paragraph shall contain, in at least 10- point boldface type, the following statement:

"This summary of the association's policies of insurance provides only certain information, as required by Section 5300 of the Civil Code, and should not be considered a substitute for the complete policy terms and conditions contained in the actual policies of insurance. Any association member may, upon request and provision of reasonable notice, review the association's insurance policies and, upon request and payment of reasonable duplication charges, obtain copies of those policies. Although the association maintains the policies of insurance specified in this summary, the association's policies of insurance may not cover your property, including personal property or real property improvements to or around your dwelling, or personal injuries or other losses that occur within or around your dwelling. Even if a loss is covered, you may nevertheless be responsible for paying all or a portion of any deductible that applies. Association members should consult with their individual insurance broker or agent for appropriate additional coverage."

8.6.10 Statement of Status As FHA Approved Condominium Project. A statement describing the status of the common interest development as a Federal Housing Administration (FHA) approved condominium project pursuant to FHA guidelines, including whether the common interest development is an FHA approved condominium project. The statement shall be in at least 10-point font on a separate piece of paper and in the following form:

"Certification by the Federal Housing Administration may provide benefits to members of any association, including an improvement in an owner's ability to refinance a mortgage or obtain secondary financing and an increase in the pool of potential buyers of the separate interest.

This common interest development [is/is not (circle one)] a condominium project. The association of this common interest development [is/is not (circle one)] certified by the Federal Housing Administration."

8.6.11 <u>Statement of VA Approved Condominium Project Status</u>. A statement describing the status of the common interest development as a federal Department of Veterans Affairs (VA) approved condominium project pursuant to VA guidelines, including whether the common interest development is a VA approved condominium project. The statement shall be in at least 10-point font on a separate piece of paper and in the following form:

"Certification by the federal Department of Veterans Affairs may provide benefits to members of an association, including an improvement in an owner's ability to refinance a mortgage or obtain secondary financing and an increase in the pool of potential buyers of the separate interest.

This common interest development [is/is not (circle one)] a condominium project. The association of this common interest development [is/is not (circle

one)] certified by the federal Department of Veterans Affairs."

8.6.12 <u>Charges for Documents Provided Disclosure</u>. The completed "Charges for Documents Provided" disclosure identified in Civil Code section 4528. For purposes of this <u>Section 7.5.10</u>, "completed" means that the "Fee for Document" section of the form individually identifies the costs associated with providing each document listed on the form.

19. Article 8, Section 8.7 ("Notice of Certain Changes in Insurance"), is hereby amended to read as follows:

8.7 Notice of Certain Changes in Insurance. In accordance with Civil Code section 5810, as soon as reasonably practicable, the Association shall provide Individual Notice, pursuant to Civil Code section 4040, to all Members if any of the policies described in Section 8.6.8 8.6.9 ("Summary of Association's Insurance Policies") have lapsed or been canceled, and are not immediately renewed, restored, or replaced, or if there is a significant change, such as a reduction in coverage or limits or an increase in the deductible for any of those policies. If the Association receives any notice of non- renewal of a policy described in Section 8.6.8 8.6.9 ("Summary of Association's Insurance Polices") and replacement coverage will not be in effect by the date the existing coverage will lapse, the Association shall immediately provide Individual Notice thereof to the Members.

20. Article 8, Section 8.8 ("Annual Policy Statement; Notifications to Members"), is hereby deleted in its entirety and replaced with the following:

8.8 <u>Annual Policy Statement; Notifications to Members</u>. In accordance with Civil Code section 5310(a)(1) through (12), not less than thirty (30) days and not more than ninety (90) days before the end of the fiscal year, the Board shall distribute to the Members an annual policy statement which shall include all of the following:

8.8.1 Official Communications to Association. A statement notifying the Members of the name and address of the person designated to receive official communications to the Association, in the manner prescribed by Civil Code section 4035;

8.8.2 <u>Secondary Address for Certain Notices</u>. A statement notifying the Members of an Owner's right to submit to the Association, in accordance with Civil Code section 5260(b), a request to have notices sent to up to two (2) different addresses pursuant to Civil Code section 4040(b) (concerning annual reports, enforcement of delinquent Assessments, sale by trustee);

8.8.3 <u>Location Designated for Posting General Notices</u>. A statement notifying the Members of the location, if any, designated for posting General Notice pursuant to Civil Code section 4045(a)(3);

8.8.4 Option to Receive General Notices by Individual Delivery. A statement notifying the Members of their option to receive General Notices by Individual Delivery in accordance with Civil Code section 4045(b);

8.8.5 <u>Notice of Members' Right to Receive Meeting Minutes</u>. A statement notifying the Members of their right to receive meeting minutes in accordance with Civil Code section 4950(b);

8.8.6 Notice of Assessment Collection Policy. A statement of Assessment collection policies as required by Civil Code section 5730(a) printed in at least 12-point type;

8.8.7 <u>Notice Regarding Liens and Foreclosure</u>. A statement describing the Association's policies and practices in enforcing lien rights or other legal remedies for default in the payment of Assessments;

8.8.8 <u>Notice of Discipline Policy</u>. A statement describing the Association's discipline policy, if any, including any schedule of penalties for violations of the Governing Documents pursuant to Civil Code section 5850;

8.8.9 Notice of Dispute Resolution Procedures. A summary of the statutory provisions relating to employing internal dispute resolution procedures and alternative dispute resolution procedures in certain matters related to enforcement of the Governing Documents which specifically references Civil Code sections 5920 and 5965. The summary of the Association's internal dispute resolution procedure may consist of a copy of Section 11.9 of the Declaration ("Investigation of Complaints") through Section 11.16 of the Declaration ("Internal Dispute Resolution"). The summary of the statutory provisions relating to employing alternative dispute resolution procedures in certain matters related to enforcement of the Governing Documents may consist of a copy of Section 11.17 of the Declaration ("Alternative Dispute Resolution Before Initiating Lawsuit") through Section 11.19 of the Declaration ("Costs and Attorneys' Fees");

8.8.10 Notice of Required Architectural Approval. A notice of the requirement for Association approval of physical changes to property, as required by Civil Code section 4765 describing the types of changes that require Association approval and including a copy of the procedure for review and approval or disapproval which may consist of a copy of Article 10 of the Declaration ("Architectural Committee") and a copy of the Architectural Rules, if any;

8.8.11 <u>Mailing Address for Overnight Payment of Assessments</u>. A statement notifying the Members of the mailing address for overnight payment of Assessments in accordance with Civil Code section 5655(c); and

8.8.12 Other Required Information. A statement notifying the Members of other information required by law, or by the Governing Documents, or that the Board determines in its sole judgment to be appropriate for inclusion in the annual policy statement.

- 21. Article 8, Section 8.11 ("Quarterly Review of Accounts"), is hereby deleted in its entirety and replaced with the following:
- 8.11 Monthly Review of Accounts. The Board shall review the Association's operating and reserve accounts at least monthly in accordance with the minimum requirements set forth in Civil Code section 5500, as follows:
- (a) Review a current reconciliation of the Association's operating accounts on a monthly basis;
- (b) Review a current reconciliation of the Association's reserve accounts on a monthly basis;
- (c) Review, on a monthly basis, the current year's actual operating revenues and expenses compared to the current year's budget;
- (d) Review, on a monthly basis, the latest account statements prepared by the financial institutions where the Association keeps its operating and reserve accounts;
- (e) Review, on a monthly basis, an income and expense statement for the Association's operating and reserve accounts; and
- (f) Review, on a monthly basis, the check register, monthly general ledger, and delinquent assessment receivable reports.

As used in this <u>Section 8.11</u>, the term "reserve accounts" shall have the meaning set forth in Civil Code section 4177. Pursuant to Civil Code section 5501, the review requirements of Civil Code section 5500 may be met when every member of the Board, or a subcommittee of the Board consisting of the Chief Financial Officer and at least one (1) other Board member, reviews the documents and statements described above outside of a Board meeting, so long as the review is ratified at the next Board meeting following the review and the ratification is reflected in the minutes of the Board meeting.

22. Article 8, Section 8.15 ("Association's Duty to Annually Solicit Owners' Notice of Address, Other Information"), is hereby added to read as follows:

8.15 Association's Duty to Annually Solicit Owners' Notice of Address, Other Information. As required by Civil Code section 4041, the Association shall annually solicit from each Owner the information as set forth in Section 3.8 ("Owner's Duty to Annually Provide Address, Other Information"). The Association shall include in its annual solicitation of Owners both of the following: (i) That Members do not have to provide an email address to the Association, and (ii) a simple method for Members to inform the Association in writing if a Member wishes to change their preferred delivery method for receiving notices from the Association. The information obtained from each Owner shall be entered into the books and records of the Association at least thirty (30) days prior to sending its annual budget report as set forth in Section 8.6 ("Annual Budget Report"). If a Member fails to provide the information to the Association as set forth in Section 3.8, the last mailing address provided in writing by the Member or, if none, the Unit property address, is deemed to be the address to which the Association shall deliver notices.

23. Article 13, Section 13.2 ("Member Access to Minutes, Books and Records"), is hereby amended to read as follows:

13.2 Member Access to Minutes, Books, and Records. To the extent required by Civil Code sections **5200**, 5205, and 5210, **5215**, **5220**, **5225**, and **5230**, and subject to a requesting Member's compliance with all applicable prerequisites and any applicable limitations (including but not limited to Corporations Code section 8332 concerning protection of constitutional rights of other Members, Corporations Code section 8338 concerning use of membership lists, and Civil Code section 5215 concerning withholding or redacting certain records), the Association shall make available for inspection and copying by any Member "Association records" and "enhanced Association records" (as defined in Civil Code section 5200) maintained by the Association. This provision does not require the Association to create or maintain any records not otherwise required by law to be maintained. The Board may adopt and publish reasonable rules and regulations establishing procedures relating to a Member's inspection and obtaining copies of Association records, consistent with the provisions of Civil Code section 5205.

24. Article 13, Section 13.4 ("Funds and Deposits"), is hereby amended to read as follows:

13.4 <u>Funds and Deposits</u>. Any funds of the Association shall be deposited to the credit of the Association in such banks or other depositories as the Board of Directors shall, from time to time, determine. **The managing agent of the Association, if any, shall manage the Association's funds in accordance with Civil Code section 5380.**

<u>Defined Terms</u>. Capitalized terms used in this First Amendment and not otherwise defined herein shall have the meanings given in Article 2 of the Bylaws.

This First Amendment shall be effective as of the date of signing of the attached Certificate of First Amendment to Amended and Restated Bylaws of The Villages Association, attached hereto. The Board shall have the right, but not the obligation, to restate the Bylaws in its entirety with the above-noted changes fully incorporated.

Proposed Changes to Club Rule 1.30 The Villager and The Pulse

At the April 26, 2022, Board meeting the Board approved for 30-day notice proposed changes to Rule 1.30 The Villager and The Pulse.

As Rules Committee Chair Frank Langben reports, the Rules Committee was asked to consider changes to Rule 1.30, and the Rules Committee and the Communications Advisory Committee have approved of the recommended changes. The purposes of the changes are:

• To restrict Pulse letters to one Pulse letter per calendar month, so that the Pulse feature doesn't turn into a "weekly column" by a few residents. This still allows residents up to twelve Pulse letters per year, in addition to everyone's ability to contact the Boards and Management at any time, and to speak at Board meetings.

• To flip sections 1 and 2, so that rules on the Pulse feature come before rules on The Villager's other content, such as articles submitted by clubs, and advertising; most people looking at guidelines want to see the Pulse guidelines, which should come first.

• Other relatively minor changes, to not allow websites or personal contact information in Pulse letters, not allowing political advertising or endorsements except as allowed by Club Policy, and other minor changes.

1.30 THE VILLAGER AND THE PULSE 1.30 THE PULSE AND THE VILLAGER

1. The Pulse [moved from section 2]

A Villages "Pulse" Letter serves as a vehicle for residents and non-resident owners to express opinions or to make suggestions or comments. [paragraph break inserted]

Pulse letters may be <u>submitted online via the Resident's Portal</u> or emailed to the editor of The Villager, deposited in The Communication Communications Advisory Committee mailbox in Building B or mailed to The Communication Communications Advisory Committee, 5000 Cribari Lane, San Jose, CA 95135. To submit letters, follow the guidelines in the Pulse column published weekly in The Villager.

The Communication Communications Advisory Committee (CAC) will review letters submitted for publication subject to the following:

A. Each letter must include the sender's name, address, phone number, date, and a word count of no more than 200 words. The word count should be furnished by the author in the letter.

B. Each letter will deal with only one specific topic related to life in The Villages.

C. Each letter will be reviewed for proper content. The committee will reject letters containing:

1) Statements that cannot be substantiated by the submitter of the letter if the veracity of the statements is questioned by the committee.

2) Language insulting to individuals or to groups. Insulting language can take several forms from profanity, to name calling, humiliation, disrespect, to even concealed contempt, to inadvertent indifference or disregard. Insulting language or phraseology is most likely to appear in letters where the writers are angry or complaining. Letters should stick to facts and opinions and avoid ad hominem or personal attacks.

3) Political opinions or endorsements pertaining to any candidate election in The Villages.

4) Partisan political opinions or endorsements pertaining to any election or ballot measure external to The Villages.

5) Recommend any product or service other than from clubs and organizations within The Villages.

6) Language that discriminates with regard to race, religion, ethnicity, gender, or sexual preference, that may be deemed offensive.

7) Any website link.

8) Any personal name or contact information included in the published letter, e.g. phone number, address, email.

D. Only one Pulse letter per week per person is allowed <u>per calendar month, per person, is allowed.</u> An author may not queue letters for publication in multiple weeks.

E. Pulse Letters are reviewed by the Communications Advisory Committee (CAC) and the Publisher using the following process:

1) Each pulse letter shall be reviewed by two members of the CAC, reviewing the letter together using the criteria stated above.

2) An author who is also a CAC member may not review their own letter. In which case, an alternate CAC reviewer will review the letter.

3) Pulse Letter reviewers who reject letters will inform the author of the reason(s) for rejection and work with the author to revise the letter.

4) Pulse Letter reviewers may recommend a Publisher's Comment for any unrejected letter.

5) If a Pulse letter is <u>unrejected accepted</u> by the CAC reviewers, but rejected by the Publisher, then the Publisher must inform the CAC Chair and the CBOD liaison of the decision and the reason(s) for rejection. The Publisher, CAC Chair, and the CBOD liaison will then work together to resolve the Publisher's reason(s) for rejection, involving the author and original CAC reviewers if necessary.

F. When a Publisher's Comment is added to a letter, the <u>The Publisher may add a Publisher's Comment to a letter, but such</u> Publisher's Comment must be reviewed and approved by the CAC CBOD Liaison.

2. The Villager [previously section 1]

The Villager is a newspaper published weekly by the Club Board for Villages residents. It has been designated by each Board as the authorized means of providing legal notice to residents and owners of record. The General Manager is the publisher Publisher. The Villager editors are authorized by the Board of Directors to exercise editorial judgment using the following guidelines:

A. No copy or advertisement will be accepted from any source that expresses partisan political opinions or endorsements pertaining to any election or ballot measure external to The Villages.

- B. No copy will be accepted that:
 - 1) Is tactless or of questionable taste
 - 2) May be injurious to personal reputations
 - 3) Contains the intent to ridicule or shame a person
 - 4) Expresses partisan political opinions or endorsements
 - 5) Promotes religious or ethnic bias
 - 6) Plagiarizes
- 7) Uses language that discriminates with regard to race, religion, ethnicity,

gender, or sexual preference that may be deemed offensive.

- C. Advertising of patent medicine, medical "cure-all" or any other medical articles, except from Board approved organizations, will not be permitted.
- D. Political advertising <u>and/or endorsements</u> will not be accepted. Candidates for Boards of Directors may advertise as permitted by <u>Policy CPo Club Policy</u> 112.
- E. Advertisements for the sale, lease, or rental of Villages property will be accepted.
- F. Advertisements for the sale, lease, or rental of real property outside The Villages will not be accepted from non-residents, except for retirement homes, life-care facilities, etc. However, a resident owner may advertise owned outside property.
- G. A resident's death may be published under the heading "In Memoriam." It will be limited to the resident's name, date of birth, and date of death. A memorial service held in The Villages, open to all residents, may announce the place, day, date, and time of service. Paid obituaries or death notices are allowed in the Villager. A family member, executor, or a designated resident may provide such information.
- H. Contributing writers providing editorial copy on behalf of their designated organizations, committee, or Board board are to include only information in reference to the organization's activities, membership, and events.
- I. Articles may not promote expenditure of Villages funds without stating such expenditures have not been approved by the relevant board if that is the case.

Preparing for power outages

Extended power outages may accompany wildfires, earthquakes or other emergencies and may impact the community as well as the economy. In the event of a power outage, you may reduce some of the impact by being prepared. Review the following tips:

Page 15 The Villager May 5, 2022

Prepare NOW before the power goes out.

- Take an inventory of items you need that run on electricity.
- Talk to your medical provider about a power outage plan for devices powered by electricity and refrigerated medicines. Find out how long medication can be stored at higher temperatures and get specific guidance for any critical medications.
 - · Have batteries to meet your needs when the power goes out.
 - · Sign up for local alerts and warning systems. Monitor weather reports.
 - Install carbon monoxide detectors with battery backup in your home.
 - Determine whether your home phone will work in an outage and how long battery backup will last.
- · Review available supplies in case of an outage. Have flashlights with extra batteries for every household member. Have enough nonperishable food and water.
- Put thermometers in the refrigerator and freezer so that you know the temperature when the power is restored. Throw out food if the temperature is 40 degrees or higher.
 - · Keep mobile phones and other electric devices charged and gas tanks full.

Survive DURING the outage.

- · Keep freezers and refrigerators closed. Refrigerators keep food cold for a few hours. A full freezer will keep the temperature for about 48 hours. Use ice chests if necessary. Monitor temperatures with a thermometer.
 - Maintain food supplies that do not require refrigeration.
- · Avoid carbon monoxide poisoning. Generators, camp stoves, or charcoal grills should always be used outdoors and at least 20 feet away from windows. Never use a gas stovetop or oven to heat your home.
- Check on your neighbors. Older adults and young children are especially vulnerable to extreme temperatures.
 - Go to a community location with power if heat or cold is extreme.
- Turn off or disconnect appliances, equipment, or electronics to avoid any "surges" or "spikes" when power is restored.

Be Safe AFTER the outage.

- Throw away any food that has been exposed to temperatures 40 degrees or higher for two
- · If the power is out for more than a day, discard any medication that should be refrigerated, unless the drug's label says otherwise. Information from: https://www.ready.gov/power-outages

Contacting PG&E during a power outage

You can report or get more information about power outages during a heat wave (and under regular conditions, too) through some of the following ways:

PG&E's 24-hour Customer Service number 1-800-743-5000.

To report or get more information about an outage call PG&E's 24-hour Outage Information Center at 1-800-743-5002.

You can report an outage, learn about future planned outages, get outage updates and take a look at the outage map for your locality on the PG&E website at: pge.com

For those who don't have computers, advanced phones or may be technologically challenged, PG&E customer service suggests calling the Customer Service number at 1-800-743-5000 to update your contact information so you can receive critical information when necessary. PG&E requests the following updates: Your primary home/landline number, your cell phone number, your email address and secondary contact information, such as friends or family members who can receive alerts in the event contact cannot be made.

If you experience a power outage, do not be hesitant to contact PG&E and report it or to get more information about outages in your vicinity.

Accessing Fitness Center using your Villages ID

The Fitness Center is accessible to residents who have attended the required Equipment Demonstration and thus have had their Villages ID Card activated to use as a key. When wanting access make sure to hold your ID up to the door sensor with your photo facing yourself. You may need to move the ID around a little so that the sensor can locate and read the microchip embedded in your card. Once the chip is read there should be a green light, some beeps, and you will have four seconds to open the door.

If the light does not turn green it could be because:

- a) You have not attended the required demo. You can register for one online by logging on to the Resident Portal and using the "Reservations" menu option, or register via phone by calling the Community Resource Center (CRC) at 408-754-1336.
- b) You have attended the required demo but not yet submitted the paperwork given to you after the session. If so please read and sign that paperwork and bring it to

Building B so we can process it. There should be two pages.

- c) You have attended the required demo but moved out of The Villages and have since moved back in. You will need to re-establish your facility access by taking the Equipment Demonstration again.
- d) The microchip in your card has been damaged in some way and your card must be replaced. Please contact the Public Safety Administration office at 408-239-5246, Option 2 for assistance.

Notice of Proposed Changes to Association Policy APr 202 District Advisory Committees

At the April 26, 2022, meeting, the Association Board provisionally approved proposed changes to The Villages Association Policy APr 202 District Advisory Committees and to publish proposed changes for the required member comment prior to formal approval consideration at the June 28, 2022, board meeting.

The purpose of the proposed changes to the procedure Apr 202 were made to address confusion DACs have experience over just what their purpose is and limitation on their authority. Additionally, a financial and budget process has been added to explain how DACs propose new projects/services, how the Board responds, how the Board feeds back information to the DACs, and finally, how the DACs provide comments back to the Board.

An open study session has been scheduled for Monday, May 16, 2022, at 9:30 a.m. via Zoom to review and discuss the proposed changes.

Response to the proposed policy changes may be made by one or more of the following methods: 1) Participation in the discussion of the proposed changes at the Association Board of Directors May 2022, study session or the May 31, and June 28, 2022 monthly meetings, 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at mehernandez@the-villages.com.

THE VILLAGES ASSOCIATION BOARD OF DIRECTORS DISTRICT ADVISORY COMMITTEE CHARTER

Committee: District Advisory Committee (DAC) **Reportsto:** AssociationBoardofDirectors(Board) **Purpose:**

Each DAC serves as the eyes, ears and voice of the Association within its District. It listens to the wishes of the District residents and reports those wishes to the Board. The DAC helps residents understand how the Villages Association operates, what the rules are and how to get assistance for routine activities. DAC members attend Association Board meetings and pass along the latest news. DACs are provided monthly financial reports, water usage and facilities plans, to help them understand and explain the budget and actions of the Board. DACs make important recommendations on residence paint colors, landscape plant choices, service changes and project proposals.

The most important purpose of the DAC is to facilitate communication between residents and the Board. The DAC shall:

- Advise owners and residents of recent Board announcements, plans, and decisions that may affect them. The Board liaison will assist in providing this information.
- Advise the Board through meeting minutes, correspondence, and oral communication at Board meetings regarding matters of concern to the DAC and/or District owners and residents.
- Advise and assist owners and residents on understanding the requirements of Association Rules and Policies and villa safety best practices.
- Survey district for owner and resident opinions regarding Association matters when requested by the Board.
- Provide a forum to hear owner and resident comments about relevant Association issues.
- Serve as role models in following Association Governing Documents, including the Bylaws, CC&Rs, Policies, and Rules and explaining them to owners and residents. See the DAC Handbook for information on the governing documents and where to find them.

<u>Limitation of DAC Authority:</u>

The Association Board is solely responsible for all Association matters. The DAC has only the authority to recommend actions to the Board and those items delegated by the Board to the DAC (specifically in working with Staff on Landscaping and Facilities as listed below under DAC Responsibilities and Practices). Some of examples of what DACs may not do:

- The DAC has no authority to evaluate, direct, or supervise staff or contractors in their activities.
- The DAC has no authority to commit or to withhold Association funds of any kind.
- Neither the DAC nor DAC Members may represent themselves to outside organizations as agents of the Association, nor use the term DAC/District Advisory Committee, unless authorized by the Board in writing.
- The DAC has no authority to make or approve alterations to Association Common Areas other than temporary, incidental, holiday decorations.
- DACs may not request bids from any vendors. This is a function of the Staff. Staff will make necessary inquiries based on information provided by the DAC in the Project Requirements Form.

Committee Composition:

Committee members <u>must be residents and</u> are appointed by the Board.;

The DAC may encourage and will-recommend candidates for appointment. All Ppersons requesting desiring to serve on a DAC must fill out a DAC Application form and have it signed (or endorsed by email) by their DAC chairperson or by the Board. The preferred method to fill out the form is using the online version available on The Villages Resident Portal.

- Each DAC will consist of three to seven voting members, the majority to be resident owners.
- <u>Chairperson: The DAC Chairperson is nominated by the DAC and must be approved by the Board.</u>
- Up to five associate members may be appointed by the DAC. Associate members are in- training, non-voting members of the committee. Although not a prerequisite, the Board intends that associate members will be candidates for future committee appointments.
- The DAC shall appoint a Landscape Committee and may appoint <u>Painting</u>. <u>Decorating</u>, <u>Water Conservation</u>, <u>Social and such other</u> subcommittees <u>and study</u> <u>groups</u> as necessary to accomplish its <u>P</u>purpose <u>(defined below)</u>.
- Staff support: Staff personnel are assigned a non-voting support role. The Association Operations Manager shall be the primary DAC contact for information and/or staff support requests. Requests for information will be accepted only from the DAC chairperson or his/her designee.
- Board liaison: One Board member will be assigned as a liaison to each DAC as defined in APo 112.
- Contact with staff members should be only initiated by the DAC chairperson or their designee.

Member Terms:

- Members are appointed for <u>staggered</u> two-year terms. Each additional term request shall be submitted to the Board for consideration and approval.
- Member terms will be staggered, with terms beginning July 1 and ending June 30.
- It is highly recommended that DAC chairs only serve in that role no more than three consecutive years. A replacement appointment will complete the unexpired term of the member being replaced.
- Vacancies will be filled by DAC recommendation and Board approval to complete the unexpired term of the member being replaced.
- DAC members may not also be Club or Association Board members. If elected to a Board, then the DAC membership is ended when starting the Board membership.
- Only one person per residence may serve as a DAC member, but other residence members may serve on DAC subcommittees.

Chairperson: Chairperson selected by the DAC for Board approval. Meetings:

- _The DAC will meet at least quarterly. With the exception of work/study meetings, DAC meetings will be open to all district residents, publicized in advance, and will include scheduled time for resident comment. Following adjournment of the Association business portion of the meeting, any other matters of interest to the residents may be discussed.
- At least twice each year, conduct meetings in the evening to allow residents to attend who cannot attend during normal work hours. One of those meetings should be a presentation of the new fiscal year's approved budget.
- All DAC meetings, except agenda setting meetings, will be open to all District residents.
- DACs will publicize their meetings in advance in The Villager, Fast Lane, and The Villages Resident Portal.
- The DAC chair will prepare a meeting agenda and make it available to DAC members and residents at least 72 hours before the meeting.
- The DAC shall conduct its business in an open and organized manner, according to the published agenda.
 - DAC meetings will include scheduled time for resident comment.
 When using Club facilities DACs must follow all associated Club rules.
- DAC meetings will respect the privacy of residents. Meetings may not be recorded unless explicitly allowed in writing by the Association Board of Directors.

 Purpose: The general purpose of the DAC is to assist the Board by facilitating communication to and from district residents regarding Association business
- matters. The DAC shall:

 1. Advise the Board through meeting minutes, correspondence and oral communication at Board meetings regarding matters of concern to the DAC and/or district owners and residents.
- 2. Disseminate information to district owners and residents regarding DAC activities and Association matters pertinent to residents' interest.
- 3. Survey district for owner and resident opinions regarding Association matters.
- 4. Review year-to-date and other periodic maintenance and financial reports for the district.
- 5. Developannualoperatingandreplacementreservebudgetrecommendations.6. Provide a forum to hear owner and resident comments about relevant
- Association issues.
 7. Promote participation by District residents to attend and to serve on the DAC.

Limitation of Authority: The DAC has no authority to direct or supervise staff or staff activities, nor is the DAC authorized to commit expenditures of any kind, but can recommend actions to staff.

The general purpose of District Advisory Committees is to facilitate communications. 1. Conduct and Attend Meetings

- Conduct DAC meetings as defined under Meetings (above) and prepare minutes of the DAC meeting and forward them to the Board (via the Association Operations Manager), and District residents.
 - Monthly, attend Board meetings (by at least one DAC member).
- · When requested by Management, attend meeting with Facilities and Landscaping supervisors.
- The DAC chairperson or designee should attend the "All-DAC" or Budget meetings with management and the Board members.
 - As requested by Architectural Committee (AC):
 - o Provide recommendations regarding villa and landscaping alterations, and
 - o Review/recommend changes to AC Rules
 - At least quarterly, conduct a DAC meeting.
- Use The Villager, Fast Lane, The Villages Resident Portal, and Channel 26 to notify residents.
- Prepare a meeting agenda and make it available to DAC members 72 hours before the meeting.
- Prepare minutes of the Association business portion of the meeting; forward to the Board, Management and all DACs.
- At least twice each year, conduct a "Town Meeting" with resident and nonresident owners. One meeting shall be the annual budget meeting with management around May 1.
 - Monthly, attend Board meeting (at least one member).
 - · When requested, attend AC meeting (at least one member).
 - · When applicable, attend meeting with Facilities and Landscaping supervisors. The DAC chairperson or designee should attend the "all DAC" meeting with
- management and the Board members. Support Emergency Preparedness Committee (EPC) activities by being familiar with the EPC organization and procedures.

2. Financial Analyze/Recommend:

- Review District financial information to help residents understand the reports and the relationship to their HOA fees. If needed, request clarification from the Association Operations Manager (who can get additional information from The Villages Controller or Accounting departments).
- Financial and budget information Q&A are published on the in-house Resident Portal for each Village. The DAC should review prior year's Q&A's when preparing new budget requests or before sending in new questions to staff.
- · During the Budget Development process, the DAC will have a once-per-year opportunity to request additional services, adjusted service levels, and new maintenance and landscape projects. The process will flow as follows:
- o The DAC will utilize the Association Project Requirements Form to make its requests. (Search the in-house Resident Portal for "Association Project Requirements Form".)
- o If the DAC makes more than one request, the requests must be prioritized in a memo to the Board president at the time the Association Project Requirements Forms are submitted.
- o It is not necessary for the DAC to fully understand the costs involved in either the services or projects at the time they submit the request.
- o Once submitted, the Board will conduct a first evaluation of the requests before sending approved items on to Staff.
 - o Staff will determine the costs of each service and project.
 - o The Board will evaluate the proposals again after receiving cost estimates from
 - o Approved items will be included by Staff in the draft budgets.
- o The Board will evaluate the requested items again after the first draft of the operating and reserve budgets are received. o The DAC will receive feedback from the Board after each of its evaluations.
- •o The DAC will have opportunity to respond to each Board project evaluation and to ask questions about the draft budget presentation up to two weeks after the
- feedback or presentation. Q&A will be published on the in-house Resident Portal. Request clarification as required from the Association Operations Manager.
- · Make recommendations to, and respond to requests from, Facilities and Landscaping.
- Document special project requests using the Project Requirements Form (available on The Villages Resident Portal).
- Provide spending recommendations to aid the Board in developing the next fiscal year's Operating Budget and Reserve Fund.
- As requested by Architectural Committee (AC):
 - Provide recommendations regarding villa and landscaping alterations, and
- Review / recommend changes to AC policies.

3. Facilities

- Painting For each paint cycle recommend to Facilities what paint colors
- Educate residents on Rules to avoid causing unnecessary building repair expenses (e.g. no pots on railings, no nails or items mounted on outside walls without AC approval, etc.) Make requests to Facilities through the Association Operations Manager.
- 4. Landscaping • For each landscaping project scheduled, choose the plants from the plant selections presented by Staff.

- During the budget development cycle each year the DAC may recommend special landscaping projects for consideration by the staff and the Board.
- Requests to Landscaping staff shall be made through the Association Operations Manager.

5. WaterConservation

• Help residents understand what actions they can personally take to save water and what current Association rules are in effect on water usage. 6. Safety

• Help residents understand their vital role in protecting themselves and their

neighbors as well as minimizing HOA insurance charges. Some areas that can

- have a significant impact on our insurance premiums are the following: o Maintain fire/smoke/carbon monoxide detectors. o Keep dryer vents, and bathroom and kitchen exhaust systems cleaned.
- o Follow Association Rules regarding barbecues, emergency power systems, and hazardous materials storage.
 - o Use licensed contractors and follow building codes.
 - o Correct water leaks immediately.
- · Support Emergency Preparedness Committee (EPC) activities by being familiar with the EPC organization and procedures.
- Ensure that temporary holiday and other decorations installed by DAC volunteers are safe and follow the guidance of staff as to whether they need to be modified for safety.

7. Communications:

- It is recommended that the DAC, Aat least semi-annually, prepare a newsletter and distribute it to residents, non-resident owners, the Board, and Management, and all other DACs. It is recommended that Nnewsletters also must be submitted in electronic format to Staff for availability on The Villages Resident Portalreview by Management and the Board.
- Any media created by the DAC (newsletters, minutes, websites, etc.) must be submitted to the Association Operations Manager for ABOD review and distribution to other DACs.
- Provide the Board, the General Manager's office and applicable Board committees with issues / concerns /or recommendations. Contact the Association Operations Manager to have an item placed on the agenda forrequest a topic to be addressed at a Board meeting.
- The DAC must follow Board guidelines regarding use of "social media" and websites.

8. Education:

- · In June, Aat least one DAC member from each district should attend the yearly Educational Community for Homeowners (ECHO) seminar.
- Attend DAC educational sessions sponsored by the Board or the General Manager.
- Periodically educate residents on the AC Rules and Association Rules that they must follow. Help residents understand their responsibilities that must be performed before, during, and after undertaking any changes to their homes.
- Promote participation by District residents to attend and to serve on the DAC.
- Prepare DAC members and residents for potential service on the Association Board of Directors.

9. Elections

• A DAC may not endorse candidates for any Villages governance or club election.

10. DAC Leadership Continuity:

• It is highly recommended that each DAC chairperson maintain an up-to-date binder of key DAC documents for handoff to the next DAC chairperson to provide continuity of operations when changing chairpersons. The binder should contain such items as District budgets, District projects, Landscaping information, DAC membership and contact information, information regarding EPC and Safety, support for the District, and Socialand DAC Committee information.





Help Us Keep Your Vote a Secret

Do you wonder if your vote is really a secret? If so, you're not alone. Some Villagers do not fully understand our two-envelope secret ballot system, so here are some answers.

Three Election Inspectors, Judy Bushey, Jeanne Filice and Kathy Weatherford, have been appointed by The Villages Association, Homeowners and Club Boards of Directors.

Once your ballot is placed in a locked ballot box, it is kept under lock-and-key at all times.

The Inspectors remove and sort the ballot envelopes according to color (blue for Association, green for Homeowners, and tan for Club).

The bar codes are scanned, which registers and validates that the envelope was received from a member who

is eligible to vote. The bar code must remain intact for the ballot to be valid.

Following registration, the barcoded envelope is opened and the secret envelope is removed. Barcoded

envelopes are sent to storage while secret envelopes are bundled for counting.

On counting day, only the secret envelopes are given to the Tellers for counting. These envelopes contain

On counting day, only the secret envelopes are given to the Tellers for counting. These envelopes contain no names, bar codes or other identifying marks. They remain sealed and under lock-and-key until the Inspectors and Tellers meet at an open Board of Directors meeting to begin the counting process.

This entire process is in accordance with California Civil Code.

The counting process is closely directed and monitored by the Election Inspectors. All ballots are counted by two different Teller teams to ensure accuracy.

The Inspectors present the election results to the Boards of Directors at the annual membership meeting on June 9. Mark you calendar now and plan to attend!

Villagers can rest assured that the Election Inspectors follow Civil Code and the election rules for every election so your vote remains a secret. You can help us keep your vote valid and a secret by carefully following the instructions included with your ballot package.

If you have further questions or if you'd like to witness the entire process, please contact one of the Election Inspectors. And please cast your vote before the deadline!







"Beautiful World, Where Are You?" by Sally Rooney: Alice, a novelist, meets Felix, who works in a warehouse, and asks him if he'd like to travel to Rome with her. In Dublin, her best friend, Eileen, is getting over a breakup and slips back into flirting with Simon, a man she has known since childhood. Alice, Felix, Eileen and Simon are still young-but life is catching up with them. They desire each other, they delude each other, they get together, they break apart. They have sex, they worry about sex, they worry about their friendships and the world they live in. Are they standing in the last lighted room before the darkness, bearing witness to something? Will they find a way to believe in a beautiful world? Fiction 2021

"Not Dark Yet" by Peter Robinson: One of the greatest suspense writers returns with his 27th novel featuring the legendary detective, Alan Banks. When property developer Conner Clive Blaydon is found dead, Detective Chief Inspector Alan Banks and his Yorkshire team dive into the investigation. As luck would have it, someone had installed a cache of spy-cams all around Connor's luxurious home. The team hopes that they'll find answers-and the culprit-among the video recordings. Instead of discovering Connor's murderer, however, the grainy and blurry footage reveals another crime: a brutal rape. If they can discover the woman's identity, it could lead to more than justice for the victim; it could change everything the police think they know about Connor and why anyone would want him dead. Meanwhile tensions are rising between Banks and his friend Zelda. A superrecognizer able to recognize faces significantly better than most, Zelda is determined to bring the men who abused her to justice. 

Accessing Table Tennis using your Villages ID

The Montgomery Multi-Purpose room is accessible during table tennis/ping pong play hours by residents who have met the following requirements: 1) attended a Table Tennis Group membership orientation, and 2) read and signed the release waiver to use this space. Once both requirements are met the Table Tennis Group will provide Community Activities with the waiver and we will activate your Villages ID Card to use as a key to the facility.

When wanting access make sure to hold your ID up to the door sensor with your photo facing yourself. You may need to move the ID around a little so that the sensor can locate and read the microchip embedded in your card. Once the chip is read there should be a green light, some beeps, and you will have four seconds to open the door.

If the light does not turn green it could be because:

a) You have not completed both requirements listed above. Please contact the Table Tennis Group to set up a membership orientation; their contact information is available when logged onto the Resident Portal or by calling the Community Resource Center (CRC) in Building B at 408-754-1336. The club will provide a copy of the waiver to you.

b) You have met the requirements previously but moved out of The Villages and have since moved back in. You will need to re-establish your membership in the Table Tennis Group and sign a new release waiver.

c) The microchip in your card has been damaged in some way and your card must be replaced. Please contact the Public Safety Administration office at 408-239-5246, Option 2 for assistance.

The most important thing to have during an emergency is current information. That's why signing up with the county alert system is a "must-do" for Villagers. As the county says, having the right information at the right time will help you make the right decisions in a

Fortunately, the county of Santa Clara has a system to help you face an emergency armed with warnings and information, and it is easily accessible. It's also free!

Called AlertSCC, it is the county's official emergency warning system. Used in conjunction with our local, state and federal alert systems, emergencies in our



area can be tracked. Alerts can be sent directly on your mobile device, landline, and or email, depending upon how you prefer to receive them. You can even designate all three in priority order. It will alert you to fire, earthquake, severe weather, and crime events and provide instructions during a disaster.

Call 911 for medical emergencies

Public Safety Reminder: In case of a medical emergency, please remember to dial 911 first. Public Safety monitors all emergency calls through San Jose Fire Dispatch. We will respond at the exact same time as the Fire Department and Paramedics. Calling the front gate can only delay response time by emergency personnel. It is always quicker to call 911. It is the only phone call you will need to make.

Residents are reminded, as per Club Rule 1.51, that pets must be kept on a leash, under control, and attended to at all times. This also applies to the Hill Lands.

An increase in coyote aggression has created problems with small dogs, especially those that are unleashed. Please always leash your pets. And keep leases short, the Division of Wildlife recommends a leash no longer than 6 feet.

Furthermore, accompany your leashed pet at all times while outside. Do not let go of the leash or tie your animal to trees or other objects. An unattended leash not only attracts the attention of coyotes, but is also a tripping hazard to other walkers.



Owners responsible for cleaning up after pets

The Villages Rules and CC&Rs state that it is the owner's/handler's responsibility for immediately cleaning and disposing of pet excrements in a sealed container. We are finding and hearing that some owners are not immediately cleaning up after their pets and assume that it is the responsibility of the landscaping crew, which it is not.

The pet poop should be picked up immediately and placed into the dumpsters in the trash enclosure near your home or in the designated pet poop stations in the center parking lots. Please do not place any pet poop in any restrooms or other containers at any of the various centers.

Pedestrian Safety Reminder:

Rain or shine pedestrians in The Villages should be aware of the traffic in their surroundings. Please walk on the correct side of the road when getting some fresh air, and walk toward oncoming traffic. The arrows are painted on the main roads. You should also remain in single file when in groups to keep within the white lines as well as social distancing. When walking pets, be sure they, too, remain within the white lines; on a short leash out of traffic.

Catholic Meditation: The most popular form of Catholic meditation is the rosary, a prayerful reflection on Jesus' life and teaching that follows an outline of twenty important events in Christ's life described in the New Testament. This meditation is done using a string of beads consisting mostly of five decades (sets) of ten small and one larger bead. The twenty historical events are divided into four sets according to themes called the "Glorious", "Sorrowful", "Joyous", and "Luminous" mysteries that are assigned to various days of the week. While reflecting on the mysteries, one prays to Mary the "Hail Mary" prayer on the small beads, asking for her help to know and love her Son more deeply, and request her assistance with other matters of concern. On the large beads, one prays the "Our Father." Saying the rosary is not a mindless rattling off of words, but a meditation that requires the collaboration of reason, memory, and imagination. May, the month dedicated to Mary, is ideal for daily recitation of the rosary to ask her help in our troubled times.

'All Shall Be Well'

Easter continues its fifty-day celebration, per the calendar of liturgical churches like mine. And don't we need at least that much time to explore the meaning of so wonderful (and strange) a gift as the Resurrection of Jesus Christ? This month I'm paying special attention to some of the lives of female saints. In honor, perhaps, of those brave women who were the first to visit the tomb, and find it empty of death and full of possibility. We might think of Julian of Norwich (1343-1416) as their successor in faithful witness.

Like Catherine of Siena, Julian was a mystic who saw visions of God during her life as an

anchoress (a woman vowed to solitary religious life). But the power of her visions and the strength of her commitment never really left her alone; people came from all over England to seek her spiritual counsel. Little is known of her early history, but she was educated enough to write well in English, and so was able to communicate her exquisite joy in Christ in a popular tongue. She is especially known for using maternal imagery for God, and for her conviction of God's intimate love and grace. She wrote that "God is nearer to us than our own soul," and for the famous words that she heard Jesus say: "All shall be well, and all shall be well, and all manner of thing shall be well," which were amplified by 20th century poets T.S. Eliot and W.H. Auden.



More Tips to Improve Your Game

"I really want to improve my game!! More tips, please!" Well, OK, then... here you are.

- **1. Serve deep.** This does two things: 1.) It keeps your opponent away from the kitchen line 2.) It makes their return serve shot harder because it's further
- 2. Return serves as deep as possible.
- 3. Don't be a victim of the pick-



- 4. Always be ready. What do infield baseball players look like when the pitch is being thrown? They're not standing up straight with their hands at their sides! They're crouching slightly with their glove and hands ready. Do the same in Pickleball. It doesn't really matter how you do it, but just getting in your stance is important.
- 5. Make sure you stretch. It will help you prevent injury and help you on the court.
- **6. Block power shots the right way.** If your opponent sends the ball screaming over the net, stop the power shot by not swinging at it. Instead, stick your paddle out and just let it collide. It
- 7. Know the rules, at least the non-obvious ones. For example, did you know that touching the net is a fault? Or that it's also a fault if you and your partner disagree on a line call on your side of the court?
- 8. If the ball goes out, say it quickly! It's not just common courtesy, but it's a rule as well. When you're judging whether a ball is in or out, you have to make your judgement nearly instantly. (Oops, yours truly is guilty of not doing this) Make sure you say it loudly so all can hear you. "Out!"

Very simply, Golf Rule 1.14 is a document containing the rules of conduct for all golf play at The Villages. There are various means through which each resident golfer will be able to receive a hard copy of Golf Rule 1.14. Rule 1.14 is provided through the website resident portal, through a link in the Golf Fast Lane every Tuesday, through the 6-Clubs Captains, and through copies available at The Pro Shop.

Wednesdays—One update included in Rule 1.14 is the return of Wednesday golf parameters to pre-COVID protocols. Wednesdays will now be reserved for the Men's Club only from 7 to 11:30 a.m. Each Thursday morning the remaining open Wednesday tee-times two weeks ahead will be opened up for all golfers to book. Please plan accordingly.

Tips from the Pro-Balance the Scales

One of the biggest flaws I see when working with a student on the short game is that the backswing does not match the shot they are hitting. What do I mean by that? When chipping or pitching, the delivery of the club to the ball and the resultant trajectory and spin are all direct results of the backswing. When green-side chipping (aka chip and run), we use a one lever backswing, meaning no wrist hinge...so the backswing is wrist free with minimal vertical lift of the club (like a putting stroke). This allows the ball to come off low with less backspin and more forward roll. When pitching a mid-length shot, the backswing is necessarily longer, incorporating a slight break of the wrist with more vertical lift of the club (waist high). The club must swing back longer with the wrist hinge lever added so that there is more speed created to get the ball airborne with a higher trajectory and more spin. The biggest mistake I see is the use of a one lever chip motion to pitch...it simply does not work because one lever does not create enough speed to get the ball spinning and into the air. So the result is a flip to gain speed on the downswing, and contact becomes thin and scathing instead of covering and compressing. Finally when hitting a longer pitch or a pitch over a bunker or stream, the backswing needs to be even longer with even more wrist hinge and vertical lift of the club (shoulder high). So when trying to hit a long pitch, do not inhibit the backswing, let it go. It is not full swing length, but very close. Stay still on the backswing and swing the club back nice and long, be sure to hit down on the ball and rotate your body and shoulders on the through swing to expose your body to the target. Finish on you left side with your body facing the target. Let me know how these tips work. To sign up for a lesson, email ssteele@the-villages.com

Golf Cart Enter and Exit Poles

The Villages Golf Committee, PGA Director of Golf Scott Steele, and GMS Golf Course Maintenance are happy to introduce you to a new initiative regarding cart traffic control at The Villages. We will be installing on every hole of the 18-hole course two poles at the start of each hole and two poles and the end of each hole to define where all golf carts will be permitted to enter the fairway and exit the fairway of each hole. The poles will be white with a blue cap and will be very visible at 48 inches in height. The two

poles will form a "gate" through which each cart will pass to enter and exit each hole at a defined location. See picture above. Very simply, cart drivers will drive away from each tee box and then enter the fairway through the "enter"



gate" and then proceed to play the hole keeping the cart on the fairway as much as possible during tee to green play, and then will exit the fairway through the "exit gate" and proceed on the cart path to the next hole. Carts will still be permitted no closer than 30 feet from the front of the green surface, but when exiting the hole will be required to pass through the exit gate. To lessen wear and tear at any enter and exit area, the poles will be moved periodically to a slightly different location on each hole.

The goals of this initiative are as follows:

- 1. To create a constant and consistent flow of cart traffic onto and away from each hole
- 2. To mitigate cart traffic and resultant turf damage around the tees and green complexes
- 3. To eliminate the current need for excessive greenside stakes and roping to control cart traffic

This initiative will be a rule of cart usage and will be included in golf Rule 1.14. Therefore compliance will be mandatory for all cart users on the 18-hole golf course. We ask for your immediate assistance with this new cart usage rule and although we understand that this initiative is new and different, we expect everyone to cooperate and to help to enhance our golf course culture of care for the betterment of our golf course conditions and enjoyment of all golfers. Please let the Pro Shop Staff know if you have any questions. Thank you.

Parking facilities and street frontage may be in use on a temporary basis for vehicle, material and equipment staging. Debris, dust, noise, odor and visual inconveniences may result from a project. 




FROM THE HOMEOWNERS' BOARD

Selecting a licensed contractor is important

Regardless of the size and nature of your remodel project, it's always wise to obtain at least two estimates before you choose a contractor.

When considering a contractor, it's important to know that the Architectural Control Committee (ACC) Rules require that your contractor be licensed by the state of California. This requirement is essential to enable approval of your application by the committee.





"When contractors are used, they must be licensed, bonded and carry workman's compensation insurance." This rule is in compliance with state guidelines, which require all individuals who construct or alter any building to be licensed by the California Contractors State License Board (CSLB) if the total cost (labor and materials) of the project is \$500 or more.

It's important to do your homework and find the licensed contractor that best fits your needs. To help homeowners complete the application process as quickly as possible, the ACC will review and take action on all Alteration Requests within 15 days.
