General Manager Search Update

At its May 31, 2022 Board meeting, the CBOD approved the charter for the ad-hoc GM Search Committee and the committee's recommendation that the CBOD hire a professional recruiting firm. Three firms specializing in HOA and country club management presented proposals to the Search Committee and the CBOD. The CBOD chose Kopplin Kuebler & Wallace, an executive search and consulting firm specializing in all aspects of private country club and senior community management.

While the decision to hire a professional firm was being discussed and firms vetted, the GM Search Committee finalized the job description and posted it on several websites. The position was posted on professional HOA/country club sites California Association of Community Managers, Community Associations Institute and Adamen, Inc., as well as The Villages website, Craigslist, Indeed, ZipRecruiter, Santa Clara University Business School and LinkedIn. In addition, the committee developed an initial resume assessment form and began screening applications.

The next steps are up to Kopplin Kuebler & Wallace. The firm's broad professional outreach will enable it to reach out to candidates beyond advertising the job; and directly contact qualified candidates who are not currently looking for a new position.

Through articles in *The Villager*, we will keep the community posted on the steps taken over the next few months to find the right person to lead our community.

Operating Financial Commentary for the Month of April 2022

Club Operating Statement Review

For the month of April 2022

Total revenue was \$2,300 (0.2 percent) unfavorable to the budget of \$1,217,500. Notable unfavorable to budget revenues were food and bar sales, short of budget by \$45,000 (16.2 percent). With the guest rooms not yet open, rentals were \$4,200 less than planned (actual \$0 vs. budget of \$4,200). The budget assumed guest room rentals would have resumed operations by this time. Additionally, advertising income was \$4,200 (21 percent) unfavorable to the budget of \$20,000. On the bright side, the combined positive budget variance in all golf revenue lines totaled \$32,200, 21.6 percent higher than the budget of \$148,800.

Total expenditures were \$68,400 favorable to budget, or 6 percent less than the budget of \$1,138,000. The most significant favorable to budget expense category was employee expense with a positive variance of \$77,000 or 10.6 percent (actual \$648,400 vs. budget of \$725,400) with open positions in the Restaurant and Community Activities Department. Other notable favorable to budget categories for the month were the following: 1) tree trimming (\$5,200 spent on budget of \$8,200) due to timing of work on the golf course, 2) planting expense (actual \$600 vs. budget of \$7,700) due to current drought conditions and associated water restrictions and 3) irrigation supplies (actual \$2,500 vs. budget of \$7,300). Highlights of unfavorable to budget expense categories were the following: 1) water expense (actual \$77,400 vs. budget of \$57,600) due to lack of rain in the March/April billing period, 2) electricity expense (actual \$15,800 vs. budget of \$9,900) mostly at Golf Course, Cribari Center, Fitness Center and Clubhouse, and 3) gas expense (actual \$17,400 vs. budget of \$13,300) mostly at the pools and Clubhouse.

The net positive operating budget variance for the month of April was \$66,100. See table below.

I read a fellow Villager's Pulse Letter on May 19 and I could not believe her timing. I had just reported to my DAC chair that Friday morning that The Villages watered the Sonata lawns three days that week (Sunday, Tuesday and Thursday). This is not the first time I have found The Villages watering more days than San Jose Muni Water Company allows. Last December I reported this same situation and the staff thought our irrigation system was turned off! I checked Thursday evening and the sprinklers started just after 7 p.m. I called San Jose Muni Water Company and they verified the valid watering time will still be between 8 p.m. and 10 a.m. despite what you may have heard or read. So, yes, I encourage others to check to see if this is happening in your village, and please let the staff know if it violates the rules. I understand they may start fining water violators, so let's be good citizens to keep The Villages in good standing.

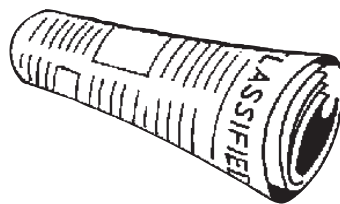

Association President's Report—May 31, 2022

Welcome to the May 2022 Villages Association Board Regular Monthly Meeting.

The key topics for this month are Property Insurance, drought, and fire safety. Unfortunately, the impact of inflation continues to shock and to stress our budgets. Property insurance is costing the Association a little over \$2M this year, and we had budgeted for about a 50-percent increase to roughly \$3 million for FY23. The quote we received late last week for FY23 was almost \$4.1 million! No single carrier is willing to be our sole provider, and our insurance brokers find it increasingly hard to find insurers that want to participate in the many layers of insurance needed to build our coverage. Two main factors contributed to the large increase in premiums – 1). Increasing our insured value to reflect current replacement costs; and 2) ever increasing costs from the carriers due to their payouts and losses due to recent wildfire and other natural disasters. Just as increases in labor rates and inflation have caused dramatic increases in our operating costs, they have also dramatically increased the costs to rebuild The Villages after a disaster. This meant we needed more insurance coverage, which resulted in increased premiums.

Some hard choices had to be made to keep our insurance costs even close to budget. The only real cost saving option available was to drop Earth Movement and Flood insurance, quoted at over \$500K. While we only had \$2.5M of quake and flood coverage with many deductibles and limits on payout, it is disconcerting to discontinue this coverage. We will be addressing the implications and provide additional information on how owners can increase their own earthquake coverage if they so choose.

The current historic drought and ongoing climate stress has caused more, and increasingly severe, wildfires across the State of California. Insurance companies are becoming more selective about who and how much coverage they will offer, and the fact that the Villages has a wildfire urban interface (WUI) around its higher elevations is a significant consideration. How insurers perceive the risk impacts their willingness to offer insurance and the premiums they require. Villagers have done an outstanding job on managing the risks we can control in our homes—no claims for almost three years—thank you very much! Please keep up the vigilance! With ABOD encouragement, the management staff have put a great deal of focus and effort in working with BrightView to improve our defensible space around the perimeter of The Villages within Association property. Now it is time to move inward from the outer edges into the backyard of those units closest to high fire dangers, what is known as zone 1 defensible space. The first of these areas is in Valle Vista. You will be hearing more about defensible spaces and fire breaks over the coming months from the ABOD for Association property and the CBOD for Club property. By uniting our efforts across The Villages and with our neighbors, there may be opportunities to improve our local regional fire safety as the state and county increase their attention and funding for larger scale projects.

Since this is the ABOD's last regular monthly meeting with this set of members and officers, I wanted to thank my fellow directors for their hard work and diligence on behalf of our members. We've had many unique challenges with drought, inflation, updating governing documents, and even coyotes, but you have worked hard to find good solutions and continue to make The Villages the best community in the Bay Area. Thank you!

Year-to-date revenue is \$273,000 favorable to budget, 2.4 percent higher than the budget of \$11,261,000. Year-to-date expenditures are \$822,000 favorable to budget, 7.4 percent less than the budget of \$11,061,000. **The year-to-date net positive operating budget variance is \$1,095,000.** See table below for detail by department.

The bottom of the table below shows the financial impact of the monthly solar lease payments and contribution to the balloon payment fund (to be paid in 2023) captured on the Club's balance sheet. The year-to-date total for these two items is \$206,000.

Golf Course/Pro Shop has posted a \$423,000 net positive variance due to favorable green fee revenue, driving range income, golf cart rentals, golf lessons and Pro Shop merchandise sales, as well as favorable employee expense, tree trimming expense and water expense. Clubhouse/Restaurant shows a \$223,000 net positive variance due to favorable employee expense. All Other shows a net positive variance of \$158,000 due to favorable water expense, Comcast and planting expenses. Public Safety has a \$142,000 net positive variance mostly from

less than planned employee expense. G&A has posted a \$76,000 net positive variance due to more than planned income from resale administration fees, other income and interest income/late fees, as well as less than planned legal fees and data processing fees. Community Activities shows a \$64,000 net positive variance from favorable employee expense, advertising/directory income and resident activities income. Community Centers show a \$13,000 net positive variance from less than planned repair and maintenance, water, professional fees and operating supplies expense, offset by more than planned electricity and gas expenses. Pools have an \$11,000 net negative variance due to higher than planned natural gas expense, offset by favorable water expense.

Association Operating Statement Review

For the month of April 2022

Revenue was \$500 (0.06 percent) favorable to the budget of \$859,000 due to higher than planned third party assessments.

Expenditures for the month were \$900 (0.1 percent) favorable to the budget of \$844,400.

Notable **unfavorable** to budget expense categories for the month were the following:

- BrightView Landscape Contract including tree maintenance, 18.8 percent more than budget (actual \$270,200 vs. budget of \$227,400) -Contract price increase due to rising labor, fuel and materials costs effective January 1, 2022

- Pest Control Expense, 30.7 percent more than budget (actual \$11,600 vs. budget of \$8,900) due to goose egg addling project

Significant **favorable** to budget expense categories for the month were the following:

- Planting Expense, 77.4 percent less than budget (actual \$5,100 vs. budget of \$22,600) due to current drought conditions and associated water restrictions
- Irrigation Maintenance, 45.5 percent less than budget (actual \$17,400 vs. budget of \$31,900)

The net positive operating budget variance for the month of April was \$1,400.

Year-to-date (ten months of operations), total revenue is \$8,599,400 or 0.05 percent (\$3,900) more than the budget of \$8,595,500. Year-to-date, operating expenditures are \$8,409,400 or 3.3 percent (\$286,100) less than the budget of \$8,695,500. The positive budget variance is mostly attributed to savings in water expense, insurance expense and planting expense, offset by an increase in the BrightView landscape contract beginning January 1, 2022. **The year-to-date net positive operating budget variance is \$290,000.**



Ice Machine access update

Many residents wonder why access to the ice machine has changed since the pandemic. Originally, the ice machine was bought to take the burden from the Clubhouse to supply ice to events not being held at the Clubhouse. Over time the ice machine became available 24/7 to anyone on Villages property. In addition to resident groups or individual residents, it was common to see vendors, contractors, resident family members, friends and delivery people helping themselves to ice.

When facilities were shut down in March of 2020, the ice machine was cleaned and turned off. In the cleaning process a number of unsanitary items were found at the bottom of the machine. We had been always concerned about cross contamination and hoped the ice was used for cooling purposes only. Moving forward to the spring of 2021 and signs that facilities might be opening, we plugged in the ice machine and found the condenser had gone bad. Being an old machine, it was time to replace it. It was decided to look at machines with chutes to minimize hand contact with the ice. A chute model was installed.

The holding capacity of the chute model ice machine is about half of the bin type. To continue the practice of supporting Board Recognized Organizations, Board Appointed Committees and DAC social groups with ice for events, a reservation system was set up to access the ice machine. Any forementioned group is asked to contact the Community Activities office to reserve the ice machine for an event. Often an event will require all the ice and the machine might not be available. A key is needed to access the machine. One business day's notice is needed for a reservation.

We are looking for an ice machine that dispenses bagged ice for the community at large. With a large footprint, the space needed for this type of machine does not match what might be available. We continue to look at options. Meanwhile there is a small ice machine found in the courtyard of the Clubhouse near the Pro Shop available for resident use.

Changes to Woodshop access

Woodshop access will begin transitioning to resident ID card access later this month. Please watch The Villager and Fastlane for information on the process and timeline.

For those currently qualified to use the shop, the transitions will include reviewing safety videos, taking a short test, signing new documents, and showing ownership proof of personal protective equipment (safety glasses, ear protection and face mask).

For new users, there will be scheduled in-person safety orientations by appointment through Community Activities. New users will also sign documents and show ownership proof of personal protective equipment (safety glasses, ear protection and face mask).

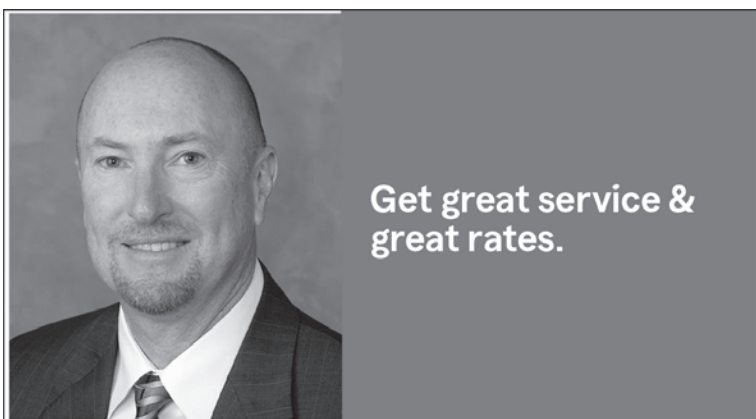
Facility Use Reminders

Covid related public health orders eliminated indoor Club facility usage for 18 months in 2020/2021. The Villages was able to re-open indoor use of facilities beginning last July. Since then, many organizations, committees and private events have had difficulty remembering all the details pertaining to facility usage. This is the first of a series of reminders to assist in holding a successful meeting or event.

Alcohol in Club Facilities - The Villages liquor license covers all Club Facilities, indoors and out of doors. If alcohol (wine, beer, spirits) will be part of the event/meeting such as BYOB, provided as part of the event or sold, a request to lift the liquor is required to be submitted to the Community Activities office no less than ten business days in advance. If the date of the meeting/event is changed, the location changes and or the time changes, a new request must be submitted ten business days in advance. The lifting of the liquor license is date, location, and time specific per the Alcoholic Beverage Control Board.

If there is no reservation for use and consequentially no request to lift the liquor license, then alcohol may not be consumed in or on the premises. There is not an option to just go to Gazebo Park, Tennis Review Stand, Bocce Courts, hill lands or the picnic tables by the Pickleball Courts and have alcoholic beverages with friends.

Villages Dog Club welcomes everyone

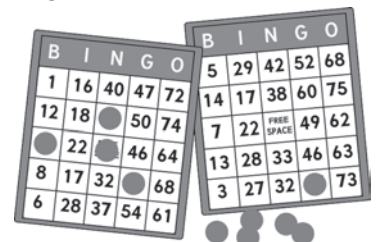

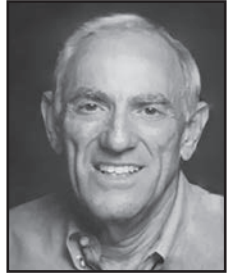

2022 Annual Member Meetings and Elections

The three Villages Corporations (Club, Association and Homeowners' Corporation) are preparing for this year's elections and annual membership meetings (this year like last, via teleconference).

Elections will be conducted in May and June with election results announced at this year's annual membership meetings to be held on Thursday, June 9, 2022, with the Homeowners' Corporation to be at 3 p.m., the Association's at 4 p.m. and the Club's at 5 p.m.

Club: Elections will be held for two director positions (each for a term of three years) on The Villages Golf and Country Club (VGCC) Board of Directors. The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Director terms expiring are for Jerry Neece and Del Yamaki, and the directors who will continue to serve during the ensuing year are Bob Wilk, Leslie Lambert, Bob Krattli, Richard Zahner, and Judy Owen.

There are three candidates for which nominations have been qualified for the ballot, Garry Ashby, Liz Kung and Howie Blumstein. Pursuant to the bylaws the two candidates receiving the largest number of votes shall be elected to serve a term of three years.

Association: The Villages Association will hold a vote this May and June to vote on The Villages Association Resolution, Excess of Membership Income Over Membership Expenses Refunded to Members and Amendments to The Villages Association CC&Rs and Bylaws.

The Amended and Restated Bylaws of the Corporation provide that there shall be seven directors. Those who will continue to serve during the ensuing year are David Cook, Diana Hallock, Richard Holmboe, Julie Wash, and George Paris. Director terms expiring are those of Garry Ashby and Noel Lanctot. Upon adjournment of the 2022 annual meeting, there will be two vacancies on the Association Board of Directors. As of the duly noticed Deadline of Nominations date of March 29, 2022, no qualified candidate nominations have been received by The Villages Association, so this year there will not be a director election for the Association.

Per Association Bylaws Section 5.8 Filling Vacancies, any vacancy occurring on the Board, except a vacancy created by the removal of a Director by a vote of the Members, may be filled by approval of the Board and Directors so chosen shall serve until the next general election.

Homeowners: The Villages Homeowners' Corporation will hold a vote to fill two director positions (each for a term of three years) and to vote on The Villages Homeowners' Corporation Resolution, Excess of Membership Income Over Membership Expenses Refunded to Members.

The bylaws of the Homeowners' Corporation provide that there will be five directors. Those who will continue to serve during the ensuing year are Rob Kirschbaum, Brooks Fuller and Jeannie Omel. As of the deadline of May 1, 2022, at 5:00 p.m. there have been two candidates nominated and qualified, Teddy Morse and Larry Versaw, and per Section 7.3 of the Second Amended and Restated Bylaws of the Villages Homeowners' Corporation they are declared elected by acclamation and will begin their terms as Directors on June 9, 2022, upon adjournment of the Annual Meeting of the Members.

Help Us Keep Your Vote a Secret

Do you wonder if your vote is really a secret? If so, you're not alone. Some Villagers do not fully understand our two-envelope secret ballot system, so here are some answers.

Three Election Inspectors, Judy Bushey, Jeanne Filice and Kathy Weatherford, have been appointed by The Villages Association, Homeowners and Club Boards of Directors.

Once your ballot is placed in a locked ballot box, it is kept under lock-and-key at all times.

The Inspectors remove and sort the ballot envelopes according to color (blue for Association, green for Homeowners, and tan for Club).

The bar codes are scanned, which registers and validates that the envelope was received from a member who is eligible to vote. The bar code must remain intact for the ballot to be valid.

Following registration, the barcoded envelope is opened and the secret envelope is removed. Barcoded envelopes are sent to storage while secret envelopes are bundled for counting.

On counting day, only the secret envelopes are given to the Tellers for counting. These envelopes contain no names, bar codes or other identifying marks. They remain sealed and under lock-and-key until the Inspectors and Tellers meet at an open Board of Directors meeting to begin the counting process.

This entire process is in accordance with California Civil Code.

The counting process is closely directed and monitored by the Election Inspectors. All ballots are counted by two different Teller teams to ensure accuracy.

The Inspectors present the election results to the Boards of Directors at the annual membership meeting on June 9. Mark your calendar now and plan to attend!

Villagers can rest assured that the Election Inspectors follow Civil Code and the election rules for every election so your vote remains a secret. You can help us keep your vote valid and a secret by carefully following the instructions included with your ballot package.

If you have further questions or if you'd like to witness the entire process, please contact one of the Election Inspectors. And please...cast your vote before the deadline!

Nearly 70 Villagers packed Foothill Center Tuesday evening to meet and hear from Congressman Jimmy Panetta, who, if he wins his seat on June 7, would represent a newly formed district that includes The Villages. The event was sponsored by the Villages Democratic Club.

Upon arrival, Panetta made the rounds, introducing himself to each attendee, before taking the mic and addressing a large menu of national and local issues and his position on them.

Panetta, if elected, would replace Congresswoman Zoe Lofgren as our representative. First elected in 2016, he is serving in his third term in Congress. He serves on several important committees, including Ways & Means, Agriculture, Armed Services and Democratic Steering and Policy. He is also a member of more than 30 caucuses and co-chairs four of them.



Sharing the family name of a well-known and respected father, Leon Panetta, he said, is a blessing and a curse. While he has immediate name recognition, expectations are set extremely high. Panetta answered questions, stressed the need for hope, despite myriad national challenges, and emphasized the need for citizen involvement. Panetta currently serves on several bipartisan working groups that are attempting to find common ground. He is enthusiastic about the non-partisan makeup of many of these groups as an example of cooperation across the aisle. This was an opportunity for Villagers to get up close and comfortable with the candidate who may represent them in Congress.

‘Miracle of Tongue and Ear’

What’s the deal with the Feast of Pentecost, celebrated this weekend? In the Episcopal tradition, it’s an occasion to dress up in red and sometimes swing around kites shaped like doves in church. But what we’re really doing is remembering some frightened disciples, suddenly surrounded by wind and fire, and empowered to preach God’s deeds of power in the languages of “Parthians, Medes, Elamites, and residents of Mesopotamia, Judea and Cappadocia, Pontus and Asia, Phrygia and Pamphylia, Egypt and the parts of Libya belonging to Cyrene, and visitors from Rome, both Jews and proselytes, Cretans and Arabs—in [their] own languages.” (Acts 2:9-11)

This “gift of tongues” has a diverse history in Christian tradition and practice. However it is received—then and now—it’s clear that its purpose was and is to grow and build the body of believers. But I am especially convinced by New Testament scholar Walter Wink’s interpretation of this historic event: he describes it as a “miracle of the ear” (as much as a miracle of tongues). The scripture text actually speaks of the astonishment of the hearers, not of the skill or gifts of the speakers. Which reminds me that all of us can participate in this miracle, whether we come from a charismatic tradition or not. We can all—and always—listen more deeply for the word of God spoken to us by an unexpected voice.

Confirmation: Are you a baptized Catholic who hasn’t been confirmed? If so, St. Francis of Assisi’s friendly director of faith formation, Lisa Nakamura, (408-223-1759 x316) is there to help.

Confirmation confers on today’s baptized the same graces received by Mary and the Apostles on Pentecost. For Catholics, Baptism and Confirmation are two separate but connected sacraments, with Confirmation being the completion of Baptism. Baptism plants the seed of divine life, Confirmation enables it to grow to maturity amidst struggles against the world, the flesh, and the devil. “Laying on of hands” is the New Testament term for Confirmation. The identification of two separate sacraments dates back to the “Acts of the Apostles” where Philip baptized, but sent to Jerusalem for the apostles to “lay on hands” (confirm) (Acts 8:12-17). This corresponds to the Catholic practice of priests (generally) baptizing and bishops (successors of the apostles) confirming.

Golf Cart Enter & Exit Poles in Place Now—We have installed on every hole of the 18-hole course two poles at the start of each hole and two poles at the end of each hole to define where all golf carts will be permitted to enter the fairway and exit the fairway of each hole. The

poles will be white with a blue cap and will be very visible at 48 inches in height. The two poles will form a "gate" through which each cart will pass to enter and exit each hole at a defined location. (See picture.) Very simply, cart drivers will drive away from each tee box and then enter the fairway through the "enter gate" and then proceed to play the hole keeping the cart on the fairway as much as possible during tee to green play, and then will exit the fairway through the "exit gate" and proceed on the cart path to the next hole. Carts will still be permitted no closer



than 30 feet from the front of the green surface, but when exiting the hole will be required to pass through the exit gate. To lessen wear and tear at any enter and exit area, the poles will be moved periodically to a slightly different location on each hole.

The goals of this initiative are as follows:

1. To create a constant and consistent flow of cart traffic onto and away from each hole
2. To mitigate cart traffic and resultant turf damage around the tees and green complexes
3. To eliminate the current need for excessive greenside stakes and roping to control cart traffic

Golf Course Trees—We are trimming a number of trees on the golf courses and removing over 20 dead trees from the golf course. With well over 925 trees on our golf courses, the upkeep and maintenance of trees is essential to the overall health and aesthetic appeal of the golf course. Please be aware of any tree crews trimming or removing trees and stay safe. If your golf ball enters any of these areas, be safe and play from a safe area adjacent to the tree crew without penalty.

Tips from the Pro—Keep your eyes on the Prize

How important are your eyes in the game of golf? The answer is that they are imperative!

The ability of our eyes to gauge distance, see obstacles and recognize changes in the terrain makes them one of the most important tools in our game. But as we know, at address, our eyes are on the ball...so the timing of when to use our eyes to your advantage is the key!

Here's what I mean:

1. On the tee use your eyes to see the hole in its entirety. Stand on the tee box and look at any trees, hazards, and where fairway and rough merge
2. Use your eyes to choose a specific and small target to aim at from tee to green; such as a rooftop, a mountain or a tree in the distance
3. Use your eyes when chipping and pitching to determine the proper trajectory for the shot and more importantly the landing spot for the shot. Focus on the landing spot during your rehearsal swings.

4. Use your eyes when putting during your pre-shot routine. Look at the hole during your practice strokes and your eyes will tell your arms how hard or soft to swing the putter. Use your eyes to see the top line of the break of the putt and be sure to putt toward that spot.

In all cases your eyes are best employed from **behind** the ball, using your eyes as a set of two, in line, using your binocular vision...it is **not** best to wait until you have addressed the ball to finally tilt your head and use your one-eyed peripheral vision. Road map for turning age 65

It all starts on or about your 64th birthday. Suddenly you find your mailbox overflowing with literature about supplemental Medicare plans. What's this all about?

Later, when your 65th birthday appears on the horizon, you become justifiably concerned about your ability to navigate through the morass of multiple decisions facing you as part of your welcome to Medicare. Well, fear not. As you may have guessed, your Senior Resource Services (SRS) is here to help.

We suggest you start by getting a basic overview of Medicare. You can do this by going to medicare.gov and clicking on the tab "Get Started" and then the tab "Learn about Medicare." Or an even better idea, is to attend a one-hour online class on the basics of Medicare. Go to mysourcewise.com – Sourcewise is the name for the County's Office on Aging. Click on "events" and scroll until you find the class titled "Introduction to Medicare."

Next call or stop by the SRS office and ask to be emailed a PDF copy of the "2022 HICAP Medicare Consumer Guide." The first few pages discuss Original Medicare and Medicare Advantage Plans. And then you hit gold! The booklet shows you the plans available in Santa Clara County, the basic provisions, and the premiums. It covers Medigap plans and Part D plans for Original Medicare people. Then it details Medicare Advantage plans available in our county. You don't have to paw through all those advertising mailers you have received to dig out the information.

Because of the number of pages and the odd size of some of the pages, SRS cannot print the booklet for you. If you have a HICAP appointment, you will receive a printed copy from HICAP.

Many people will still have questions or concerns. At this point we suggest you request an appointment for free Medicare counseling provided by HICAP (Health Insurance Counseling & Advocacy Program) through Sourcewise. SRS volunteers have not received the hours of medical insurance training to qualify as insurance volunteers.

You do this by calling HICAP at 408-383-6668. Tell them you are a Villager and would like to arrange a counseling session with HICAP counselor Douglas Campbell who is assigned to The Villages. Doug is currently connecting with Villagers via a telephone appointment or via Microsoft Teams Video conferencing. HICAP staff will provide instructions on either appointment process.

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday, and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253 or e-mail SRS at villagessrs@sbcglobal.net. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional adviser about your individual situation.

SRS Notice: Get your Notice of Assessed Value by email

You may elect to receive your annual property tax assessment notice from the County by email. The notice will be arriving in late June. Go to sccassessor.org/optin to create your account. You will need last year's assessment notice which shows the parcel number and your PIN in the upper left corner.

Non-Estates revenue tracked budget at \$3,599 for the month. April expenditures were \$114 favorable to budget, 3.1 percent less than the budget of \$3,691, due to less than planned legal fees (\$84) and insurance expense (\$30). **The net positive operating budget variance for the month of April was \$113.**

Year-to-date (ten months of operations), total revenue is short of budget by \$6 (rounding) at \$35,994. Year-to-date, operating expenditures are \$34,506 or 5.3 percent (\$1,948) less than the budget of \$36,454. The positive budget variance

is attributed to savings in insurance expense and legal fees. **The year-to-date net positive operating budget variance is \$1,942.**

Estates revenue for the month tracked budget at \$13,616. April expenditures were \$212 unfavorable to budget, 1.7 percent more than the budget of \$12,746, due to the increase in the BrightView landscape contract. **The net negative operating budget variance for the month of April was \$212.**

Year-to-date (ten months of operations), total revenue is short of budget by \$5 (rounding) at 136,155. Year-to-date, operating expenditures are \$126,455 or 7.7 percent (\$10,526) less than the budget of \$136,981. The positive budget variance is mostly attributed to savings in planting and water expenses. **The year-to-date net positive operating budget variance is \$10,521.**

Don't feed the 'critters'

The Villages is known for its wide variety of wildlife. Many Villagers want to feed our four-legged or winged guests on a routine basis, which can be quite detrimental to our wild friends. Most wild animals naturally fear humans and keep their distance. When animals have access to food and garbage left out by residents they keep coming back for more. When this happens, they often lose their natural fear of humans and can become aggressive. To prevent that, residents should not leave out any food, including canned food, in a manner that may become accessible to our furry friends. Please comply with Villages Golf & County Club Rule 1.51.4, which states: "Feeding of waterfowl and other wild animals on a routine basis is prohibited for the protection of both residents and the animals."

Leash rule for pets

Residents are reminded, as per Club Rule 1.51, that pets must be kept on a leash, under control, and attended to at all times. This also applies to the Hill Lands.

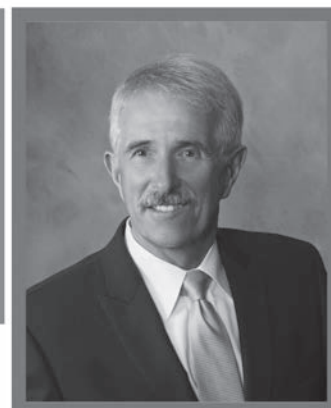
An increase in coyote aggression has created problems with small dogs, especially those that are unleashed. **Please always leash your pets. And keep leashes short, the Division of Wildlife recommends a leash no longer than 6 feet.**

Furthermore, accompany your leashed pet at all times while outside. Do not let go of the leash or tie your animal to trees or other objects. An unattended leash not only attracts the attention of coyotes, but is also a tripping hazard to other walkers.

Tips for preparing for power outages

Extended power outages may be the result of wildfires, earthquakes or other emergencies and may impact the whole community as well as the economy. In the event of such a power outage, you may be able to reduce some of the impact by being prepared. Review the following tips for ways you can ease potential difficulties.

Prepare NOW before the power goes out.

Take an inventory of items you need that run on electricity.

Talk to your medical provider about a power outage plan for medical devices powered by electricity and refrigerated medicines. Find out how long medication can be stored at higher temperatures and get specific guidance for any critical medications.

Have batteries and other alternatives to meet your needs when the power goes out.

Sign up for local alerts and warning systems. Monitor weather reports.

Install carbon monoxide detectors with battery backup in central locations on every level of your home.

Determine whether your home phone will work in a power outage and how long battery backup will last.

Review the supplies that are available in case of a power outage. Have flashlights with extra batteries for every household member. Have enough nonperishable food and water.

Put thermometers in the refrigerator and freezer so that you can know the temperature when the power is restored. Throw out food if the temperature is 40 degrees or higher.

Keep mobile phones and other electric equipment charged and gas tanks full.

Survive DURING the outage.

Keep freezers and refrigerators closed. The refrigerator will keep food cold for a few hours. A full freezer will keep the temperature for about 48 hours. Use coolers with ice if necessary. Monitor temperatures with a thermometer.

Maintain food supplies that do not require refrigeration.

Avoid carbon monoxide poisoning. Generators, camp stoves, or charcoal grills should always be used outdoors and at least 20 feet away from windows. Never use a gas stovetop or oven to heat your home.

Check on your neighbors.

Get Ready!

Prepare your family

- Create a Family Disaster Plan that includes meeting locations and communication plans and rehearse it regularly. Include in your plan the evacuation of large animals such as horses.
- Have fire extinguishers on hand and train your family how to use them.
- Ensure that your family knows where your gas shut-off is and how to use it.
- Plan several different evacuation routes.
- Designate an emergency meeting location outside the fire hazard area.
- Assemble an emergency supply kit as recommended by the American Red Cross.
- Appoint an out-of-area friend or relative as a point of contact so you can communicate with family members who have relocated.
- Maintain a list of emergency contact numbers posted near your phone and in your emergency supply kit.
- Keep an extra emergency supply kit in your car in case you can't get to your home because of fire.
- Have a portable radio or scanner so you can stay updated on the fire.

Get Set!

As Fire Approaches

- Evacuate as soon as you are set!
- Alert family and neighbors.
- Dress in long sleeves and pants. Have goggles and a dry bandana/particle mask handy.
- Ensure that you have your emergency supply kit on hand.

Inside Checklist

- Close windows, unlock doors.
- Remove flammable window coverings.
- Move flammable furniture to center of room.
- Plan several different evacuation routes.
- Shut off gas and pilot lights.
- Shut off air conditioner.
- Leave your house lights on!

Outside Checklist

- Bring all flammables inside the house.
- Turn off propane tanks.
- Shut off sprinklers. Don't leave on!
- Back car into driveway, shut doors/windows.
- Have an outside ladder ready.
- Extinguish small outside fires until you leave.
- Seal off attic and ground vents, if able.

Tips—If You Are Trapped

- Stay away from outside walls.
- Bring garden hose inside house.
- Patrol inside home for spot fires—extinguish.
- Wear long sleeved, cotton clothing.
- Stay hydrated—keep drinking water.
- Ensure that it is safe to exit home if it catches fire.
- Fill sinks and tubs for emergency water.
- Place wet towels under doors.
- After the fire has passed, check roof for fire.
- Check inside attic space for embers.
- Patrol your property for fire.
- Call 911 if you cannot put out fires with small amount of water.

GO! EARLY!

When to Leave

Do not wait to be told by authorities to evacuate. Leave early enough to avoid being caught in the fire, smoke or road congestion. If and when you are advised to leave—don't hesitate!

Where to Go

Leave to a predetermined location (it should be a low-risk area, such as a well-prepared neighbor's or relative's house, a Red Cross shelter or evacuation center, motel, etc.)

How to Get There

Have several travel routes in case one route is blocked by the fire or emergency vehicles and equipment. Choose an escape route away from the fire.

Emergency Supplies

- One gallon of water per person per day.
- Non-perishable food.
- First Aid kit, emergency blanket, multi-purpose tool.
- Flashlight, radio, extra batteries.
- Keys, cash, credit cards, travelers checks, cell phones and chargers.
- Map with evacuation routes.
- Family/emergency contact information.
- Sanitation supplies/personal hygiene items.
- Prescriptions and medications.
- Important numbers and documents.
- Photos/easily carried valuables.
- Hard drive information.

Older adults and young children are especially vulnerable to extreme temperatures.

Go to a community location with power if heat or cold is extreme. (Be aware that community shelters may not be available during the coronavirus emergency.)

Turn off or disconnect appliances, equipment, or electronics. Power may return with momentary "surges" or "spikes" that can cause damage.

Be Safe AFTER the outage.

When in doubt, throw it out! Throw away any food that has been exposed to temperatures 40 degrees or higher for two hours or more, or that has an unusual odor, color, or texture.

If the power is out for more than a day, discard any medication that should be refrigerated, unless the drug's label says otherwise. If a life depends on the refrigerated drugs, consult a doctor or pharmacist and use medicine only until a new supply is available.

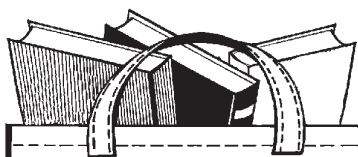

OBITUARY

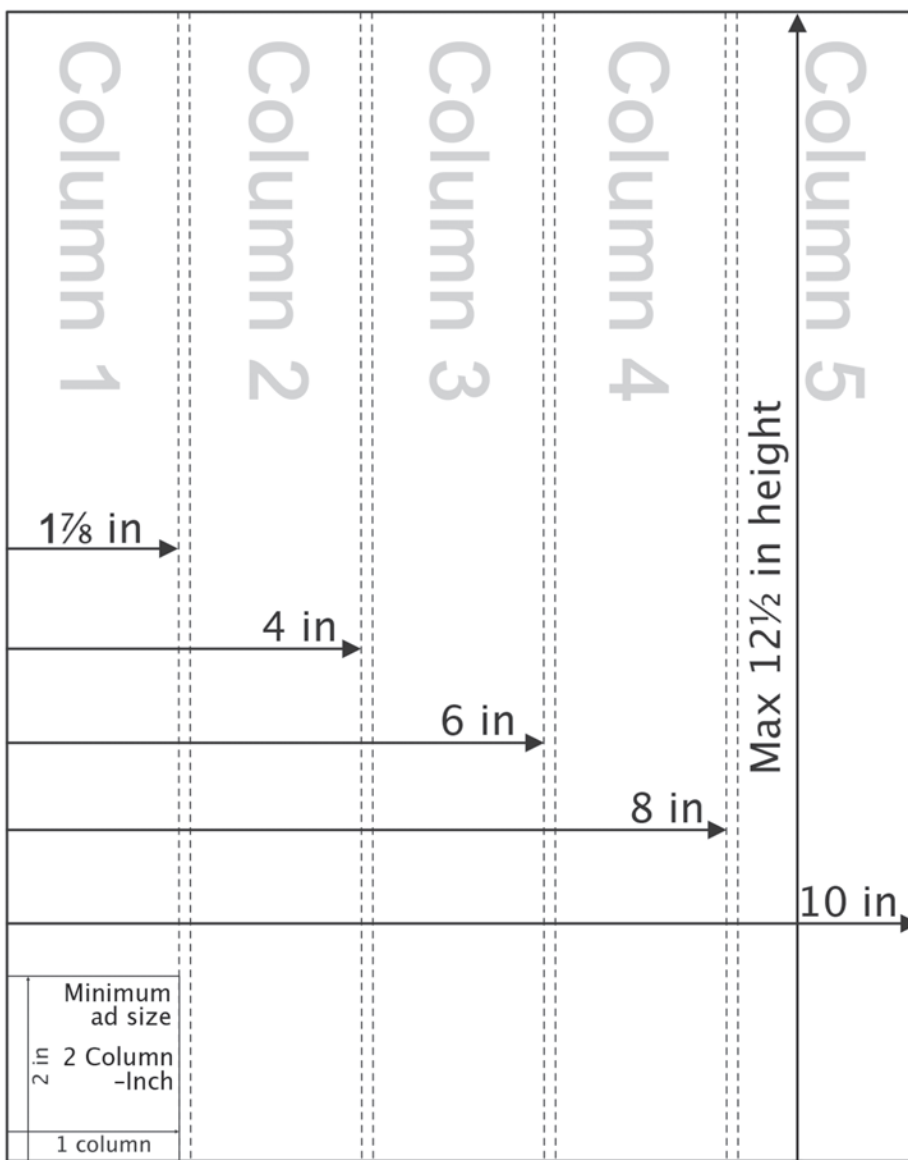
