Judging by their comments, Villagers tend to think of our local community emergency resources as their first line of defense when a disaster hits. After all, that's their job and Station 11 is right outside our gates. And yes, the fire and police departments will respond, and longer term, the Red Cross, medical personnel, and our very own Emergency Preparedness Committee (EPC) volunteers will respond and do all they can to assist.

But the first 72 hours after an emergency are on us as individual residents, so being prepared is our REAL first line of defense. Fortunately, preparing yourself for an emergency is basically a one-time effort. Once you have yourself covered, minor tweaks annually are all that are needed.

To help you get where you need to go in this regard, EPC is bringing those all-important community resources to you to inform you about emergency response and to help you prepare.

Help Your Neighbors! Help Yourself! Vote!

Beginning Friday, July 29, ballots were distributed for approving the revised and updated Association CC&Rs, formally known as the “Declaration of Covenants, Conditions, and Restrictions and Power of Attorney of the Villages Association.” Please follow the instructions on how to vote and return your ballot.

Why Vote?

The Declaration (CC&Rs) is one of the fundamental governance documents for the Villages Association and it defines the roles of the Association and Owners for use, restrictions, and maintenance of our Common Interest Development. The CC&Rs are tied to the land and apply to all current and future owners. Every owner is affected by the CC&Rs and changing them requires a majority of the Total Voting Power of the Association to vote in favor. What is being changed and why should I care?

The CC&Rs are being updated to:

- conform with current state laws that have changed over the last eight years
- improve and clean up the wording
- better define the responsibilities for our condo maintenance
- make it less burdensome for getting common area changes approved
- align earthquake recovery procedures with current repair costs

While there are no fundamental changes proposed, it is important to keep governance documents current and relevant to state law and inflation.

The Association Board unanimously approved these changes and recommends your YES vote.

Every vote counts!

Association/Homeowners documents available via e-mail

Per an amendment to California Civil Code, homeowner associations are permitted, with owner’s written consent, to distribute annual disclosures, (like the pro forma budget summary) and other specified association documents to owners via electronic mail, facsimile, or other electronic means (such as posting on the association’s website) instead of sending those documents out by regular mail or personal delivery. This has the potential to provide cost savings to The Villages. Delivery and postage costs for the Villages’ annual distribution of the pro forma budget summary alone are close to \$1,000, not to mention the paper and printing costs.

In order to transmit association documents via e-mail or by posting on the homeowners association’s website, 1) the homeowners association must first receive the owner’s written consent, and 2) the homeowners association sends a separate notice to the owner that the documents have been posted and are available for viewing.

Consent forms for owners to request delivery of documents have been developed for both The Villages Association and Homeowners Corporations. These forms provide an owner’s consent to electronic delivery of documents that are capable, under current laws, of being distributed electronically. Owners have the right to revoke this request and receive “hard copies” of the documents by sending a written revocation signed by the owner, to the applicable corporation.

The VGCC Board of Directors is responsible for the management of Club business and governance. The Club provides management agent services by agreement to The Villages Association and The Villages Homeowners’ Corporation. All Association members and Homeowners are members of the Club. The Club is subject to the California Corporations Code.

All members of The Villages Association own condo-units. The Association Board of Directors is responsible for management of the Association’s business and the maintenance of common area property within the Villages Association. Management services are provided by the Club under terms of a Management Agreement. The Association is a Common Interest Development subject to the Davis-Stirling Act and the California Corporations Code *(Continued on page 7)*

2023 Telephone Directory Updates

Call 911 for medical emergencies

The Public Safety Department would like to remind you, in the event of a medical emergency, please remember to dial 911 first.

Public Safety monitors all emergency calls through San Jose Fire Dispatch. They will respond at the exact same time as the Fire Department and Paramedics.

Calling the front gate can only delay response time by emergency personnel. It is always quicker to call 911. It is the only phone call you will need to make.

Leash rule for pets

Residents are reminded, as per Club Rule 1.51, that pets must be kept on a leash, under control, and attended to at all times. This also applies to the Hill Lands.

An increase in coyote aggression has created problems with small dogs, especially those that are unleashed. **Please always leash your pets. And keep leashes short; the Division of Wildlife recommends a leash no longer than 6 feet.**

Furthermore, accompany your leashed pet at all times while outside. Do not let go of the leash or tie your animal to trees or other objects. An unattended leash not only attracts the attention of coyotes, but is also a tripping hazard to other walkers.

Coyote reminder and tips

Coyotes may try to escort walkers out of an area to protect their pups or food sources when encountered on a trail or street. Humans may perceive this behavior as stalking, which is usually not the case. They may also view your pet as prey. To allow coyotes to be wild while keeping yourself and pets safe, please follow these pointers:

- Never feed coyotes—it is illegal to feed coyotes in most places. Feeding endangers your family and neighbors because it lures coyotes into neighborhoods.
- Keep unattended cats and dogs indoors or in completely enclosed runs, especially at night, and do not assume that a fence will keep a coyote out of your backyard.
- Accompany your leashed pet outside. Make sure you turn on lights if it is dark to check your backyard for unexpected wildlife.
- **Keep dogs on short leashes while walking outside; the Division of Wildlife recommends a leash no longer than 6 feet.**
- Keep noisemakers on hand to scare away coyotes that may enter your yard. Some examples of noise makers are whistles, horns or metal cans with small rocks or coins that rattle.
- Never run away or turn your back on a coyote.
- Do not allow a coyote to get between you and your pet or child—keep children close to you.
- Yell, clap hands, blow a whistle or rattle a can and try to make yourself look larger if you have a close encounter with a coyote.
- An empty soda can with pennies sealed with duct tape makes a very good noise maker when shaken.

Reminder to all small pet owners: A recent rise in coyote aggression has been seen with small dogs, most unleashed. **Please always leash your pets. Keep leashes short.** Coyotes will try to get between you and your pet if the leash is extended far enough. Coyotes are known to attack leashed dogs when the owner gets distracted. Please stay cautious and aware of your surroundings when cleaning up after your pet, talking to a neighbor, checking the mail, etc. Coyotes are opportunists and may make their attacks when you are not paying attention.

Carry a noise maker and always be alert. Use caution when walking past wooded areas, hiding spots between homes, and the golf course. They are widespread in The Villages and can truly be anywhere.

There is no way to completely eliminate coyotes from The Villages, so always use caution when walking, especially with pets. Also, coyotes tend to be most active around sunrise and sunset. Pick different times for walks.

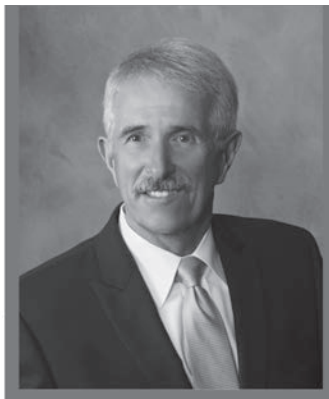

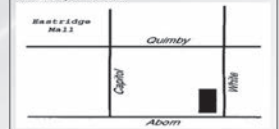

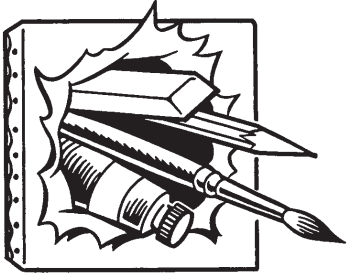

GENERAL MANAGER POSITION OVERVIEW

Federal Deposit Insurance

The United States government protects depositors if an FDIC (Federal Deposit Insurance Corporation) insured bank or savings association fails. Credit union deposits are insured under the same terms by the National Credit Union Share Insurance Fund. The basic insured amount is up to \$250,000 per depositor per insured bank.

Does that mean I have to keep my money in different banks if I have more than \$250,000 at the bank? Not necessarily. One of the easiest ways to increase the dollar amount of insured deposits is to open accounts under different ownership categories. Those categories include individual, joint, or trust accounts. Because of this, if you have assets above \$250,000, you can have additional coverage.

There are also provisions for trust accounts, retirement accounts and beneficiaries. Details are beyond the scope of this article. For further information, contact your bank, or the Federal Deposit Insurance Corporation at fdic.gov.

The FDIC website has a great Estimator that can help you plan.

John and Mary Villager have accounts at the bank outside the gate. They aren't sure if they need to move money to another bank. John has an account with \$300,000 and Mary has one for \$250,000. They have a joint account with \$400,000.

By running the Estimator we see that John's single account is over the insurance limit by \$50,000. He should move that amount to another FDIC insured bank (not a different branch of the bank outside the gate!)

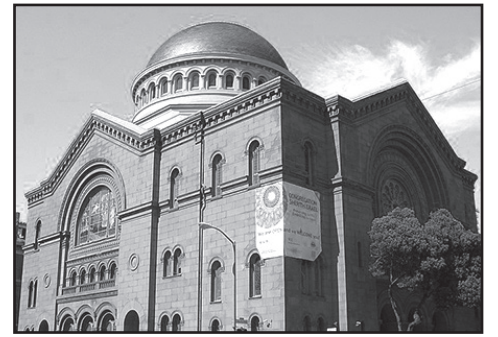

Know that your safety remains our #1 priority and to that end, masks are highly encouraged.



To Register for your Flu Shot:

Registration will be held on **Monday, August 22**, and **Thursday, August 25** at Vineyard Center from 9 a.m. to 4 p.m. on both days. You must register for your flu shot prior to the Flu Shot Clinic.

Bring your Medicare card to register. If you are under 65, bring your insurance card with your ID number

The following vaccines will be available: influenza, standard; influenza, high dose (65+); Prevnar 20; and TDAP (tetanus-diphtheria-pertussis)

Prevnar 20—The newest pneumonia vaccine available will be available at the Villages Flu Clinic on September 15 and 23. The CDC, Centers for Disease Control and Prevention, recommends the following for:

- Adults 19 through 64 years old with certain medical conditions or other risk factors who have not already received a pneumococcal conjugate vaccine should receive either a single dose of Prevnar 15 followed by a dose of Pneumovax 23 or a **single dose** of PREVNAR 20.

- Adults 65 years or older who have not already received a pneumococcal conjugate vaccine should receive either a single dose of Prevnar 15 followed by a dose of Pneumovax 23 or a **single dose** of PREVNAR 20.

The CDC also recommends you talk to your health care provider who can give you more information.

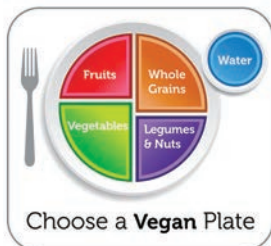

“Sea of Tranquility” by Emily St. John Mandel: Edwin St. Andrew is eighteen years old when he crosses the Atlantic by steamship, exiled from polite English society following an ill conceived diatribe at a dinner party. He enters the forest, spell-bound by the beauty of the Canadian wilderness, and suddenly hears notes of a violin echoing in an airship terminal—an experience that shocks him to his core. Two centuries later a famous writer name Olive Llewellyn is on a book tour. She’s travelling all over Earth, but her home is the second moon colony, a place of white stone, spired towers and artificial beauty. Within the text of Olive’s best-selling pandemic novel lies a strange passage: a man plays his violin for spare change in the echoing corridor of an airship terminal as the trees of the forest rise above him. When Gaspary Roberts, a hotel detective in the black-skied Night City, is hired to investigate an anomaly in the North American Wilderness, he uncovers a series of lives upended: the exiled son of an earl driven to madness, a writer trapped far from home as a pandemic ravages Earth, and a childhood friend from the Night City, who, like Gaspary himself, has glimpsed the chance to do something extraordinary that will disrupt the time line of the universe. A virtuoso performance that is as human and tender as it is intellectually playful, *Sea of Tranquility* is a novel of time travel and metaphysics that precisely captures the reality of our current moment. The Hard Truth about Recycling Part 2 —A Bleak Picture

This is the second of a series by the Sustainable Villages Club’s Sustainability Practices Group.

Last week, it was mentioned that 80 percent of recycling ends up in landfill. Items marked 1 and 2 within the “chasing arrows” logo get recycled. The others usually don’t. We have a huge plastic waste problem.

Why is recycling so hard? Every town is different and in some places, recycling is not done at all due to difficulties in finding buyers for plastic waste. It is just cheaper to make new plastic rather than using recycled contents.

Since 1960, plastics production has surged almost 100-fold. And, more than half of plastic products are designed to be used only once, according to the United Nations: such as hotel shampoo min-bottles, tooth-flossing picks, at-home Covid tests!

In 2015, plastics created 4.5 percent of global greenhouse gas emissions. A recent study estimated that plastic creates more pollutants than all the world’s airplanes combined!!

The plastic waste that we couldn’t handle was being exported to countries like China. However, in 2017, China said it would no longer accept the world’s plastic trash. Plastic is simply being landfilled or burned.

The God who would call me by name is calling you, and everyone else, by name too. And just waiting for each of us to listen to and know the particularity and depth of God's love.

‘Feast of the Transfiguration’

Tomorrow, August 6, is the feast of the Transfiguration. Shortly before his death, Jesus led Peter, James and John to the summit of Mt. Tabor to pray. There, a remarkable series of events unfolded that we call "The Transfiguration." (Lk 9:28-36, Matt 17: 1-8 and Mk 9:2-10)

In composite summary: 1) Jesus' face became brighter than the sun and his clothes as bright as lightning (or white as snow). 2) Moses and Elijah, long departed, appeared and spoke to Jesus about his impending death. 3) Overcome with astonishment, the apostles fell asleep (or into ecstasy). 4) On awakening, they witnessed Jesus enveloped in the dazzling radiance of divine glory. 5) Moses and Elijah vanished. 6) Peter unsuccessfully begged the Lord to let them erect three tents and remain. 7) A cloud appeared, overshadowed, then enveloped Jesus and his terrified apostles. 8) From the cloud a voice from Heaven spoke, "This is my chosen Son. Listen to him." 9) At once, everything returned to normal, and the apostles saw only Jesus as he had been before. As Jesus instructed, the men kept this baffling experience secret until after He ascended into heaven.

At Sunday Mass, we proclaim in the Nicene Creed that Jesus is, "God from God, Light from Light, true God from true God...and became made man." We Catholics believe the luminous historical event on Mt. Tabor, witnessed by the apostles, confirms these words; that the Transfiguration is literally true, not mythology or metaphor. Jesus' transformation in the light of divinity bears witness to our belief that our Lord is simultaneously God and man.

Additionally, Jesus' transfigured body, dazzling with divine light, offers a preview of our own glorified bodies after the Last Judgement when we believe the just will "shine like stars for eternity." St. Irenaeus described our post-Baptismal transfiguration thus: "It will be a glory that will grow ever brighter until we take on the likeness of the one who died for us."

On Tabor, the apostles entered a place where the divine merged with the human, the past with the present, the temporal with the eternal. St. John's frequent references to Christ as light reflect his eye-witness experience of the Transfiguration. This was an unforgettable encounter outside the precincts of our tidy understandings of space and time. Albert Einstein's words come to mind, "The distinction between past, present and future are an illusion, however persistent." The Transfiguration is a great mystery that opens a treasure chest of truths inaccessible to reason alone. This feast is a good time to lift the lid.

Watching Wimbledon was so engaging! Here is some trivia about the tournament.

All white: Wimbledon rules state that all players must be dressed almost entirely in white. This dates back to Victorian times when sweating was considered improper and white clothing did not show the perspiration as much. Andre Agassi refused to play in the tournament in 1988-1990 as a boycott against the dress code. He relented in 1992 when he won the tournament. Roger Federer got into trouble for having orange soles on his shoes! Umpires can ask a player to change if they don't meet the dress code. In the last tournament a female player came to the courts wearing a black bra which showed through her white top. Yep, she had to change. How did Kurios get away with a red hat at the ceremonies?

Surface: Wimbledon is the only Grand Slam that is played on grass courts and during the event, the grass is cut to a height of exactly 8 mm. Wimbledon has its own hawk named Rufus whose job it is to scare away pigeons each morning from the tennis courts.

Balls: 54,250 tennis balls are used during the tournament. The balls are replaced after every seven to nine games to make sure they're in perfect shape throughout the match. Those not in use are stored in a refrigerated container to keep them in tip-top condition.

Lucky Loser: Some questioned why Fritz could not come under the "lucky loser" ruling when Nadal pulled out of the tournament due to injury. This only applies to a player who loses in a qualifying round. If Nadal knew he couldn't play the semi-final match, he could have withdrawn handing the victory to Fritz, but he was hopeful to see another day.

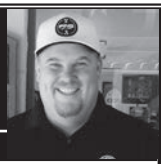
The trophy: The winner does not get to keep the trophy. It remains on display at the All England Club's museum, but the winner receives a small replica. The French Open and Australian Open also give a replica of the trophy to the winner. The US Open is the only tournament where the trophy goes home with the winner and may be kept for a year.

This project will return this essential water feature to its full and functional state.

Golf Course Turf Reduction Beta Site—In early September we will commence with installation of a Turf Reduction beta site around the tee complexes on Hole #8. This will give the golfing residents a chance to see what a Turf Reduction initiative will look like. The long-term goal of the Turf Reduction Program is to replace non-essential irrigated turf grass with viable and aesthetically pleasing drought resistant landscaping that will require much less irrigation and ultimately save us money on golf course water use. More details and information will follow as we get closer to the initial stages of the project.

Golf Cart Enter & Exit Gates—For those golfers that enter the fairway early just after the tee box, we stress that you should please use the Cart Enter Gates located at the start of each fairway. Then proceed down the fairway from shot to shot avoiding driving in the rough as much as possible. If you exit the hole late, please use the Exit Gates located at the end of each hole and stay on the cart path until you reach the next tee box.

For those who do not enter the fairway early, remember that it is always Ok to use the cart paths and enter and exit the fairway using the 90-degree rule staying on the cart path for the majority of the hole being played. Again, please avoid driving in the rough from shot to shot as much as possible. Using the cart paths and the 90-degree rule is always a good option! Let us know if you have any questions. Thank you for your cooperation!

Tips from the Pro—The Short Way to Success...
With over 60 percent of your strokes coming from inside of 100 yards, it is essential that you spend a proportionate amount of time on your short game as you practice. You should devote most of your short game practice to putting and pitching. These two shots make up the majority of your short game strokes. And lucky enough, it just so happens that here at The Villages we have ample areas to practice your short game. So as I have said before, spend 10 minutes per day putting...use 1 ball and simulate real golf. Then go spend another 20 minutes chipping and pitching at one of our fine practice greens. When putting, practice 25-35 foot putts, which is the proximity of the average approach shot...try to 2-putt using 1 ball from multiple spots. When pitching, practice shots from 10 yards to 40 yards and everything in between. Focus on the feel of a shortened swing and try to always land the ball just past the edge of the green. And finally, for the best short game "practice" of all, put both pitching and putting together and go play our wonderful Par-3 Course which is probably the best way to practice your 100 yards & in game... it has nine holes ranging from 60-134 yards, with greens that perfectly simulate our long course greens; and once you are out there, you can play as many holes as you like. The Ironmen are in morning play, gathering every Thursday morning at 10 a.m. with a shotgun start, sweeps, birdie pool, and closest to the pin. 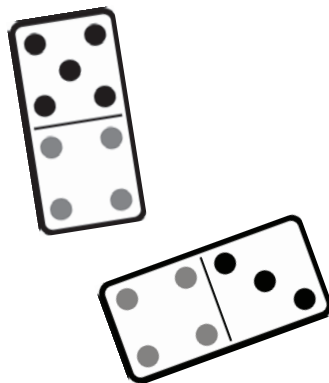

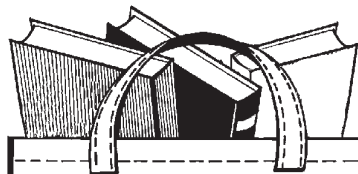

Fitness Center Advisory

Committee seeking members

The advisory committee for the Fitness Center is looking for new members. Several existing members will term-out at the end of this year.

The committee is required to meet its responsibilities, but shall meet at least quarterly. The current and previous committee met once a month for one hour. The committee reports to the Club Board of Directors.

The responsibilities of the committee are to make recommendations and to advise the Board of Directors on: 1. Fitness Center rules; 2. Use of the Fitness Center; 3. Improvements and care of the Fitness Center equipment; 4. Coordinate security issues with Public Safety.

Volunteering for one hour a month is not a large commitment in which to be engaged, making decisions that directly affect one of the most popular amenities in The Villages.

Applications may be obtained in Building B.

Accessing Fitness Center using your Villages ID

The Fitness Center is accessible to residents who have attended the required Equipment Demonstration and thus have had their Villages ID Card activated to use as a key. When wanting access make sure to hold your ID up to the door sensor with your photo facing yourself. You may need to move the ID around a little so that the sensor can locate and read the microchip embedded in your card. Once the chip is read there should be a green light, some beeps, and you will have four seconds to open the door.

If the light does not turn green it could be because:

a) You have not attended the required demo. You can register for one online by logging on to the Resident Portal and using the "Reservations" menu option, or register via phone by calling the Community Resource Center (CRC) at 408-754-1336.

b) You have attended the required demo but not yet submitted the paperwork given to you after the session. If so please read and sign that paperwork and bring it to

Building B so we can process it. There should be two pages.

c) You have attended the required demo but moved out of The Villages and have since moved back in. You will need to re-establish your facility access by taking the Equipment Demonstration again.

d) The microchip in your card has been damaged in some way and your card must be replaced. Please contact the Public Safety Administration office at 408-239-5246, Option 2 for assistance.

For more information on accessing the Fitness Center or to register for a demo please call the CRC at 408-754-1336.

Owners responsible for cleaning up after pets

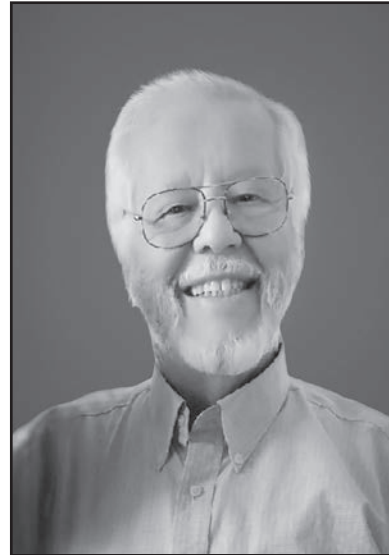

Planning an estate, moving or garage sale in The Villages?

Residents, or those working on the behalf of residents, are advised to call the Public Safety Administration office at 239-5246 before planning or opening a sale at the Villages. All sales on Villages property are subject to Association Rule 2.02 Residence Use and Occupancy Restrictions.

Homeowner Rule 3.2.10, Estate and Garage Sales states:

3.2.10 Estate and garage sales are permitted subject to the following:

A. A permit for the sale shall be obtained from the Public Safety Office prior to holding the sale and placement of advertising.

Also, effective July 1, 2012, all estate and garage sales in the Association will require a permit. The owner of the property must request the permit from Public Safety Administration in Building C.

The Villages Association Rule 2.02. 5., Residence Use and Occupancy Restrictions applies:

5. Estate and garage sales are permitted subject to the following:

A. Public Safety will not allow entry to anyone who is not authorized by name in advance (Club Rule 1.01, Access to the Villages).

B. All sales activity and sale items must be contained within the residence or garage.

C. Sales may be held only between 9 a.m. and 4 p.m.

D. Sales period may not exceed two days.

E. Only one sale per resident household per year will be permitted. In the event of the death of a resident of the unit, a subsequent estate sale will be permitted. A permit is required and can be obtained from Public Safety.

F. Residents may not use public media to invite members of the general public to attend estate or garage sales at The Villages.

In this context, "public media" includes the internet, social media such as Facebook and Twitter which will be seen by non-residents, and publications which circulate outside The Villages such as the Evergreen Times and Spotlight. Residents may post activities and notices on Next Door but must use the "Choose Neighbors: The Villages [only]" option.

Note: When placing classified ads for estate or garage sales in The Villager, you will need to attach proof of the permit to your Classified Advertising form.

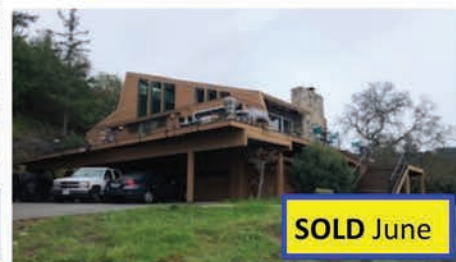
