## Operating Financial Commentary for the Month of January 2023

#### **Club Operating Statement Review**

For the month of January 2023

Total revenue was \$4,500 (0.4 percent) unfavorable to the budget of \$1,055,700. The most significant favorable to budget revenue category was food sales with a positive budget variance of \$53,500, or 51 percent higher than budget (actual \$158,500 vs. budget of \$105,000). Compared to January 2022, food sales were up 39 percent. Also notable as favorable to budget was advertising income with a positive variance of \$3,500 (actual \$17,100 vs. budget of \$13,700). With 17 days of rainy weather during the month, green fee revenue suffered, producing a negative budget variance of \$45,900 for the month (down 42 percent from the budget of \$109,600). All other golf related revenue categories were below budget as well. Additionally, resale administration fees were down \$5,100 (68 percent) compared to the budget of \$7,500.

Total expenses were \$13,600 favorable to budget, or 1.2 percent less than the budget of \$1,092,000. The most significant favorable to budget expense category was employee expenses, with a positive variance of \$18,900, or 2.5 percent (actual \$744,200 vs. budget of \$763,100). Many vacant job positions that were open for extended periods of time have been filled. Other notable favorable to budget expense categories for the month were as follows: 1) chemical supplies (actual \$1,900 vs. budget of \$12,300) due to timing on the golf course, 2) Comcast expense (actual \$84,000 vs. budget of \$92,400) due to new contract less than budget, and 3) postage & delivery expenses (actual \$4,000 vs. budget of \$8,600) due to timing of the telephone directory delivery. Highlights of unfavorable to budget expense categories were the following: 1) food cost of sales (actual \$54,800 vs. budget of \$32,000) due to higher sales volume and increasing food costs, 2) planting and miscellaneous landscape expenses (actual \$11,900 vs. budget of \$3,700) due to dead tree removals behind Corporation Yard, and 3) advertising/promotion (actual \$4,400 vs. budget of \$600) for BOGO promotion in the Bistro, offset by higher food sales, and 4) electricity expenses (actual \$27,500 vs. budget of \$22,900).

The net positive operating budget variance for the month of January was \$9,100. See table below.

I also observed them spraying and again there were no yellow flags posted. I am particularly upset because last year about this time after spraying, my dog got sick and the vet was concerned that she may have been poisoned. I have no way of knowing if it was caused by the poison they sprayed but please do a better job of posting the areas to be sprayed. In addition, I do not leave my village every day so please post signs several days in advance when the spraying will occur including the date when spraying will start.

What does this mean to you? Basically, two things: 1) Get your personal emergency plan in place, including actions you can take to reduce the risk of damage; 2) Enroll in the Villages free Emergency Alert system, NIXLE, to receive landline calls and/or texts in the event of an emergency. The best avenue for doing both is through the EPC's website at the village sepc.com. There you will find help to develop an effective personal emergency plan and a link to enroll in NIXLE.

It really, truly can happen here. As the Mercury News said: "A severe earthquake along the

Hayward Fault is coming." Be prepared. Act now.

In the continuing series of storms, we've lost additional trees, many more fallen tree limbs, and even a light pole on Fairway Drive. Our partners from GMS and BrightView have been quick on the case to perform cleanup duties, and PG&E responded rapidly to replace the toppling light pole. Plus, more storms are on the way. I'm thankful for the rain and snow, knowing that our state's reservoirs are on their own road to recovery from the devastating drought. ## Association President's Report—February 28, 2023

Welcome to the February 2023 Villages Association Board Regular Monthly Meeting.

Back in last July, the Association Board created its goals and objectives for this year. Now that we've completed two thirds of the FY22-23 term, it's a good time to review our progress.

Our three top goals for the year are Fire Safety, Fiscal Management, and Water Conservation. For Fire Safety our objectives are to obtain a professional opinion about fire safety for Valle Vista and implement the recommendations, identify and prioritize other Villages with similar fire safety issues, and partner with the Club and the Homeowners' boards to protect all Villages property. I believe the ABOD has done an excellent job in this area with the hiring of Carol Rice and her recommendations for Valle Vista were prioritized by the Fire Safety Committee and implementation has begun.

Ms. Rice has also already begun surveys of all the other Villages and will be including adjacent Homeowners' and Club property. These surveys will be completed before the end of the fiscal year. The resulting reports will be shared with the Club and Homeowners. The recommendations for each Village will be prioritized by the Fire Safety Committee, and the ABOD will look to use our bulk purchasing power where landscaping and building retrofits can be applied across many villages at the same time.

Our fire safety landscaping projects will have synergy with our water conservation goals, so that all projects can focus on reducing water usage and improving fire resistance at the same time. The process of locating and contracting with a landscape architect/designer to build landscaping plans for each village is underway and we will have the evaluation work in progress before the end of the year.

Implementing these projects will be a multi-year effort both in terms of the scope of the work to be done and in terms of incrementally funding them each year. The better the job we do now in the analysis and planning stage will result in the best outcomes and lowest costs over many years.

Next month I'll look at our progress toward our Financial and Water Conservation goals.

There is still about a month for condo owners to put their hats in the ring to be an Association Board Director. Talk to your friends, talk to the current directors, think about learning more about how The Villages operates and how you can contribute to the Association mission—To Protect, Maintain, and Enhance the common property of its members.

Year-to-date (seven months), revenue is \$23,000 favorable to budget, 0.3 percent higher than the budget of \$8,016,000. Year-to-date, expenses are \$384,000 favorable to budget, 5 percent less than the budget of \$8,152,000. **The year-to-date net positive operating budget variance is \$407,000.** See table below for results by department. The monthly solar lease payments and contribution to the balloon payment fund (to be paid in September 2023) are being funded from a portion of the FY22 Operating surplus. The year-to-date total for these two items is \$148,000.

All Other shows a \$145,000 net positive variance due to favorable water and Comcast expense. Clubhouse/Restaurant shows an \$89,000 net positive variance due to favorable food sales and employee expense, offset by higher food costs and promotion expenses. Community Activities shows an \$81,000 net positive variance mostly from favorable employee expenses and advertising income. G&A has posted a \$46,000 net positive variance due to reduced employee expenses with the vacancy in the General Manager position for most of the first four months of the fiscal year, offset by higher professional fees (HR consultant). Golf Course/Pro Shop shows a \$44,000 net positive variance from savings in employee expenses, water expense and tree trimming (timing), offset by less than planned green fee revenue. Public Safety has posted a \$29,000 net positive variance due to less than planned employee expenses. Pools have a \$17,000 net negative variance from higher than planned repair and maintenance, gas, and electricity expenses.

Community centers show a \$14,000 net negative variance from higher than planned electricity and insurance expenses, offset by more than planned rental income.

#### **Association Operating Statement Review**

For the month of January 2023

Revenue was \$100 (0.01 percent) unfavorable to the budget of \$1,014,200 due to less than planned laundry concession fees, offset by more than planned third party assessments and golf cart electricity fees.

Expenses for the month were \$46,700 (5 percent) unfavorable to the budget of \$914,000.

Notable **favorable** to budget expense category for the month was the following:

Planting Expense, \$12,100 (65 percent) less than budget (actual \$6,500 vs. budget of \$18,600)

Significant **unfavorable** to budget expense categories for the month were the following:

- Insurance Expense, \$37,800 (15 percent) more than budget (actual \$290,300 vs. budget of \$252,500) due to impact of 2022 property insurance renewal effective May 30, 2022
- Irrigation Maintenance, \$3,900 (87 percent) more than budget (actual \$8,400 vs. budget of \$4,500)
- Repair and Maintenance, \$5,500 (25 percent) more than budget (actual \$27,400 vs. budget of \$21,900)

The net negative operating budget variance for the month of January was \$46,800. See table below.

Year-to-date (seven months of operations), total revenue is \$7,100,000, or .01 percent (\$600) more than the budget of \$7,099,400. Year-to-date, operating expenses are \$7,003,000, or 3 percent (\$236,900) less than the budget of \$7,239,900. The positive budget variance is attributed to savings in water expense, repair and maintenance and planting expense, offset by more than planned insurance expense, operating supplies, and electricity expense. **The year-to-date net positive operating budget variance is \$237,500.**

## Notice of The Villages Association Proposed Second Amendment to CC&Rs for Legal Updates and to Correct Typographical Errors

9.3

At the February 28, 2023, monthly meeting the Board provisionally approved the revised nondiscretionary changes to the Second Amendment to Amended and Restated Declaration of Covenants, Condition and Restrictions and Power of Attorney of The Villages Association (CC&Rs) and to publish in *The Villager* newspaper for member comment period prior to the Board's adoption consideration at an open Board meeting (March 28, 2023, monthly meeting) by a vote of two-thirds (2/3) of the Board pursuant to the applicable provisions of the CC&Rs.

The purpose of the proposed CC&Rs Amendments are deemed non- discretionary, but necessary to conform certain outdated sections with recent changes in the law and to correct typographical errors. Specifically legal counsel has made changes to Sections 2.5, 3.2(c), 6.13, 7.1(d), 9.3, 10.12 and 11.5.

The Board will consider approval of the changes at the March 28, 2023, monthly meeting. Response to the proposed changes may be made by one or more of the following methods: 1) Participation in the discussion of the proposed changes at the Association Board of Directors March 28, 2023, monthly board meeting, or 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at: mehernandez@the-villages.com.

Deletions are noted in strikethrough font; additions are in **bold italics font**.

NOW, THEREFORE, the Association hereby declares that notwithstanding anything to the contrary in the Declaration, the Declaration is hereby amended as follows (words with a strike through are deleted and in **bold italics** are added).

- 1. Article 2, Section 2.5 ("Association Rules"), is hereby amended to read as follows:
  - 2.5 <u>Association Rules</u>. Subject to applicable law (including Civil Code sections 4340 *through 4370* regarding notice and procedures), the Board of Directors shall have the power and the authority to establish, promulgate, amend, repeal, and enforce such Association Rules as the Board deems necessary for the management and operation of the Condominium Development and the conduct of business and affairs of the Association.
- 2. Article 3, Section 3.2(c) ("Owners' Non-Exclusive Easements of Enjoyment"), is hereby amended to read as follows:
  - (c) The right of the Board, as more particularly addressed in the Bylaws, to suspend an Owner's rights and privileges as a Member, including voting rights and the right to use Association recreational facilities, if any, for any period during which any Assessment against such Owner's Condominium remains unpaid and/or for infraction of the Governing Documents of the Association;
- 3. Article 6, Section 6.13 ("Delinquent Assessments"), is hereby amended to read as follows:
  - 6.13 <u>Delinquent Assessments</u>. Any installment or other portion of an Assessment not received within fifteen (15) days after its due date shall be delinquent and, to the fullest extent permitted by law, including Civil Code section 5650(d)(b), shall be subject to interest and late charges not to exceed the maximum rate permitted by law, as well as all other Additional Charges.
- 4. Article 7, Section 7.1(d) ("Types of Coverage"), is hereby deleted in its entirety and replaced with the following:
  - In accordance with Civil Code section 5806, unless the Governing Documents require greater coverage amounts, the Association shall maintain crime insurance, employee dishonesty coverage, fidelity bond coverage, or their equivalent, for its directors, officers, and employees (if any) in an amount that is equal to or more than the combined amount of the Association's reserves and total Assessments for three (3) months. The coverage maintained by the Association shall also include protection in an equal amount against computer fraud and funds transferred fraud. If the Association uses a managing agent or management company, the Association's crime insurance, employee dishonesty coverage, fidelity bond coverage, or their equivalent, shall additionally include coverage for, or otherwise be endorsed to provide coverage for, dishonest acts by that person or entity and its employees. Self-insurance does not meet the requirements of this subsection (d).

- 5. Article 9, Section 9.3 ("Association Liability"), is hereby amended to read as follows:
  - Association Liability. Except as expressly provided in this Article 9, the Association shall not be responsible or liable for any Maintenance, Repair, or Replacement of a Unit or Exclusive Use Common Area or any part thereof, except to the extent that the need for such Maintenance, Repair, or Replacement results from the negligence or fault of the Association, its employees, contractors, or agents. Without limiting the generality of the foregoing, the occurrence of damage to any wall-, floor-, wall, floor, or ceiling covering or treatment, or fixture attached to a wall, floor, or ceiling in a Unit resulting from the unavoidable removal or perforation of the same required to perform any Maintenance, Repair, or Replacement for which the Association is responsible or to obtain access for that purpose shall not be deemed to constitute negligence or fault of the Association, its employees; agents, or contractors.
- 6. Article 10, Section 10.12 ("Further Appeal by Internal Dispute Resolution"), is hereby amended to read as follows:
  - 10.12 Further Appeal by Internal Dispute Resolution. If the Architectural Committee shall fail to act on a request for approval within the time specified in Section 10.8 ("Meetings") or Section 10.15.3 ("Notice of Compliance"), or if the Board shall fail to reconsider the Owner's request in a timely fashion pursuant to Section 10.11 ("Reconsideration by Board"), or if a request for approval is rejected by the Board, the Owner shall be entitled to invoke internal dispute resolution pursuant to Civil Code section 5910, discussed in Section 11.16 ("Internal Dispute Resolution"); except that, in the case of an application for installation or use of a solar energy system subject to Civil Code section 714, any application that is not denied by the Architectural Committee or Board within forty-five (45) days from receipt of a complete application shall be deemed approved.
- 7. Article 11, Section 11.5 ("Enforcement Rights Are Cumulative"), is hereby amended to read as follows:
  - 11.5 Enforcement Rights Are Cumulative. To the fullest extent permitted by law, including Civil Code section 5975, the Association, its Ddirectors, Oofficers, or agents, and any Owner shall have the right to enforce any and all provisions of the Governing Documents by any proceeding at law or in equity, or, with respect to action by the Association, through the use of such other remedies (including self-help remedies that do not breach the peace or otherwise violate applicable law or this Declaration) as are available and deemed appropriate by the Board. Each remedy provided is cumulative and not exclusive.

<u>Defined Terms</u>. Capitalized terms used in this Second Amendment and not otherwise defined herein shall have the meanings given in the Declaration.

ARTICLE 3: Candidates for the Board and Nomination Procedures

#### 3.1 Qualification of Candidates.

Candidates for the Board must be Members at the time of their nomination and (i) must meet any other qualifications or restrictions set forth in these Election Rules and (ii) must meet any other qualifications or restrictions set forth in the Bylaws so long as they do not conflict with these Election Rules. In the case of a Member that is not a natural person (such as a corporation or other entity), the entity Member shall have the power to appoint a natural person as the "Member" for purposes of director elections. The Association shall disqualify a nominee for the Board for any of the following reasons:

- 3.1.1 The nominee is not a Member.
- 3.1.2 The nominee does not reside within The Villages condominium project.
- 3.1.3 If the nominee, if elected, would be serving on the Board at the same time as serving on the Board of The Villages Golf and Country Club.
- 3.1.4 If the nominee, if elected, would be serving on the Board at the same time as another owner of the same separate interest and the other person is either properly nominated for the current election or is an incumbent director.
- 3.1.5 If the nominee, at the time of nomination, is delinquent in the payment of regular and/or special assessments. A nominee shall not be considered "delinquent" if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the nominee: (a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) the nominee has requested and has not been provide an opportunity to engage in internal dispute resolution.
  - 3.1.6 If the nominee has been a member of the Association for less than one year.
- 3.1.7 If the nominee discloses, or if the Association is aware or becomes aware of, a past criminal conviction that would, if the Member was elected, either prevent the Association from purchasing the fidelity bond coverage required by Civil Code section 5806 or terminate the Association's existing fidelity bond coverage.

## Proposed Changes to Club Rule 1.14 Golf Facilities

At the January 31, 2023, monthly board meeting, the Board approved for 30-day member notice proposed changes to <u>Rule 1.14 Golf Facilities</u> prior to formal approval consideration at the March 28, 2023, board meeting.

Special note: Prior publications of these proposed changes indicated changes to 9.A, which should have been changes to 8.A. – the language and context of the changes were correct, the error was in the numbering. In addition, publication of the newly added Paragraph 14 to the rule was inadvertently omitted. Both of these errors have been corrected and are hereby published and meet the requirements of the rules changes process and comply with the Board's formal approval consideration date of March 28, 2023.

As earlier published, Rules Committee Chair Frank Langben reports, the purpose of changes to 6.I and 8.A of <u>Rule 1.14 Golf Facilities</u> is to require that two riders be in each golf cart which follows the recommendation of the Villages Golf Committee, the Club Board, and will reduce wear on the golf course and save on maintenance costs.

The second inserted sentence to 8.A gives the Director of Golf the authority to make exceptions, such as a group of three golfers playing in two carts. The third inserted sentence to 8.A allows the Director of Golf to mandate single riders in each cart, if necessary, in the future without changing the rule again.

The purpose of adding Paragraph 14 is at the request of the Club Board Ad Hoc Policy Committee to take the identical language on golf tournament green fees from VGCC Board Policy CPo 312 and add it, instead, to Rule 1.14.

Deleted text is shown with strike-through text.

<u>Inserted text</u> is shown with underlined text.

The proposed changes are as follows:

#### 6. Golf Course Rules and Etiquette

I. The Pace of Play guideline at The Villages is 4-hours for 18-Holes and 2-hours for 9-Holes. Golfers are asked to play Ready Golf at all times. Golfers are asked to use individual carts to assist in maintaining pace.

#### 8. Golf Carts

A. It is recommended, to maximize pace of play, and to maximize the enjoyment of all golfers, that residents play with one rider per cart whenever possible. Residents are permitted to ride together in one cart if they so choose, but must maintain the daily pace of play.

A. Residents must play with two riders in each cart. The Director of Golf may grant exceptions. The Director of Golf may require one rider per cart for pandemic or health concerns. Residents must maintain the daily pace of play.

#### 14. Selected Tournament Fees

Resident green fees in effect on the date of the event shall be the authorized green fees charged for resident and guest participants in the following tournaments held in that calendar year.

- Men's Club, Women's 18-Hole Association, Swingers Invitational Tournaments
  - Men's Club Home & Home Tournaments
- Team Play Men's Club NCGA, Women's Valley League, Women's Mid Pen, Women's Silicon Valley League
  - Swingers Exchange Day
  - WGANC & WNHGA Open Days

Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the changes at the February 28, and March 28, 2023, board meetings, 2) via e-mail (jmeadows@the-villages.com) with comments sent to the General Manager's office at least seven days prior to the board meetings, or 3) via written comments to the General Manager's office (Business Administration Building A) delivered at least seven days prior to the aforementioned board meetings. Comments already submitted do not have to be resubmitted.



## Survey results are in: Resident Trip Interests

In the recent Community Activities Survey we asked participants the following: "What kind of trip type are you interested in? Please choose your top three interests."

Fourteen possible interests were provided, and participants also had the opportunity to write in additional responses or clarify their answer. Respondents who chose more than three answers and gave us permission to contact them regarding the survey were provided with the opportunity to update their answer by this past Friday. Respondents who chose more than three answers and did not give us permission to contact them or who did not meet the above deadline had

their answers for this question excluded; their other survey responses were not affected.

**Total Respondents:** 133 (119 online surveys and 14 paper surveys) **Respondents Who Skipped this Question:** 2 **Respondents Who Were Excluded:** 37

**Usable Responses for this Question:** 96 **Theater/Performance Art** = 76

History = 31

**Music** = 25

Art = 24

Agritourism = 22

Animal/Nature Viewing, Learning About Different Cultures, and Sports/Games

(3-way tie!) = 20 **Science/Tech** = 10

Architecture and Shopping (2-way tie!) = 8

Industry = 5

**Dance and Transportation** (2-way tie!) = 2

Theater/Performance Art received the most responses, a whopping 75 percent of respondents chose it from amongst the provided options. Regardless of how your particular interest faired, it will most likely be included in our programming at some point because many trips cross over multiple categories. Thank you to all who participated in the survey.

#### When will we go to the theater again?

Community Activities has put a hold on trips to any indoor venue where there is assigned seating (theaters, concert halls, some arenas, etc.) because of concern over contracting illness. Even now our department receives cancellations and hears resident concerns regarding illness for events happening inside our gates, let alone beyond them in the greater population. Our preference for the health of residents and staff is to patronize outdoor venues or indoor venues where Villagers can choose to distance themselves from anyone whom they feel might be ill.

However, even before the results of the survey were in, we were committed to reevaluate our stance once flu season is over, so stay tuned for a possible change in programming. In the meantime, outdoor theater venues have begun posting their schedules and we will be attending at least one performance later this year.

#### What are Some of the Biggest Takeaways from Write-in Responses?

- 1) Should we decide to do another survey like this, we should make Gambling an interest category.
  - 2) Museums, museums. Luckily, we have so many to choose from in the Bay Area.
- 3) Sports events other than Giants games. In all transparency, sports interest can vary greatly depending on a particular game and our department had to cancel many trips due to lack of interest last year so we will tread cautiously here.
  - 4) Food and alcohol tours. Were you hungry or thirsty when taking the survey?
  - 5) Villagers are animal lovers!

Employees, residents and their guests represent the Villages Golf and Country Club off site. It is expected that all participants will conduct themselves in a dignified, cooperative and congenial manner.



On Tuesday, March 7, coach Jerry Smith of the Santa Clara women's soccer program will be the speaker at the Villages Men's Fun Social Club.

In his 37th year of Santa Clara soccer, Jerry is one of three coaches in NCAA Division 1 history with more than 500 career wins. He has led the program to 32 NCAA Tournaments, 12 College Cups, and 13 West Coast Conference titles. He led Santa Clara to the 2001 and 2020 NCAA National Championships.

Jerry has compiled a record of 534-174-70, coaching 47 players who earned All-America nods, and 16 competing on the U.S. National Team. He saw seven of his former student-athletes (Brandi Chastain '91, Aly Wagner '02, Leslie Osborne '05, Marian Dalmy '07, Chioma Igwe '08, Brittany Klein '08, Meagan McCray '09) named to rosters in the 2008 inaugural season of Women's Professional Soccer League.

The 2001 National Championship team led the nation in scoring offense and won the Championship by defeating perennial power North Carolina 1-0. The team included four-time All American Danielle Slaton and Honda Player of the year Aly Wagner. Both Danielle and Aly are from San Jose, and they started their outstanding soccer careers for the Presentation High School women's soccer team.

Smith began his coaching career at his alma mater, Homestead High School in Sunnyvale. He resides in San Jose with his wife (and former U.S. National Team member Brandi Chastain) and two sons.





Projects such as the shredding event generate funds that go to EVF's General Fund to enhance Village amenities for the benefit and comfort of resi-





## 'Transfiguration' (Mt. 17:1-9)—Second Sunday of Lent

Shortly before His death, Jesus led Peter, James and John to the summit of Mt. Tabor where the light of divine glory radiated from His body and clothes. "His face shone like the sun and His clothes became as white as light (lightning)." We call this luminous transformation of Jesus' body the "Transfiguration". The apostles revealed its startling details only after Jesus rose from the dead. You can read what they had to say in: Mt. 17:1-9, Mk 9:2-8, Lk 9:28-36, and 2 Pt 1:16-18.

Catholics interpret the Transfiguration as a visible revelation not only of Jesus' divinity, but also of His intention to transform our resurrected bodies into dazzling copies of His own. St Paul explains:

"Our homeland is in heaven, and from heaven comes the savior we are waiting for, the Lord Jesus Christ, and he will transfigure these wretched bodies of ours into copies of his glorious body. He will do that by the same power with which He can subdue the whole universe." (Phil 3:20-21)

The Transfiguration harks back to Adam and Eve. Made in the "image and likeness of God," they were said to have been clothed in light just like God, who "wraps Himself in light as in a garment" (Ps 104:2). Scattered through early Christian writings like St. Ephrem's, St. Gregory of Nyssa's, and Eastern liturgies are references to Adam and Eve clothed in the light of glory. It was only when the pair disobeyed God that they lost their dazzling robes and found themselves "naked and ashamed".

Catholics see the Transfiguration as a sign that the souls and bodies of those who die in the state of grace will eventually be restored to the same radiant perfection Adam and Eve once enjoyed in Paradise. We interpret Moses' luminous face (Ex 34:29-35) and Scriptural references to the saints as "lamps," "sparks," "stars" in that sense. It also explains why we paint saints with halos.

Paul's term: "wretched bodies": The time comes for us all, however well exercised, properly fed, or right-minded when the poet's words "Things fall apart, the center does not hold" become lived reality. Positive thinking no longer suffices to deny our visible decline. Instinctively, we know our "wretched" bodies are becoming what they were never meant to be, that something has fundamentally gone wrong. With that recognition come temptations...to rage, despair, stoic suppression or denial of what we see happening. By contrast, Christian hope promises that one day Jesus will literally "transfigure our wretched bodies into copies of his glorious body." With that hope, we await the time when the whole universe will once more become radiant with the brilliance of eternal light - our own bodies included.

## 'Wesleys Who Led the Way'

For an Episcopal priest, I'm an awfully grateful student of Methodism. Or at least of the life and witness of John Wesley—founder of Methodism—whom our church remembers this week. He was actually an Anglican priest, the son of a priest and he also had a devout mother who schooled her nineteen children in Biblical languages, Holy Scripture and prayer. Let us never doubt the influence of faithful mothers and grandparents!

John Wesley was born in 1703 and educated at Oxford, where he distinguished himself by his commitment to holy habits. His rigor in prayer and study and asceticism gave rise to the description "methodist," which was adopted by the small community of devout Christians who gathered around John Wesley and his brother Charles. Initially considered to be rather fanatical by the standards of the Church of England, Wesley's methods and eventual popular movement captured the hearts of thousands of primarily working-class English people. Although neither John nor Charles desired to leave the Anglican Church, their extraordinary skills in organizing communities of worship and service outside of the traditional ecclesial system threatened the church leadership.

But also, it bears mentioning, changed it. Our own Episcopal Church's respect for diverse leadership—male and female, lay and ordained—owes much to the example of the Methodist movement. At a time when Anglican practices of personal spirituality were not well developed, the Wesleys taught our church to pray and to serve. And indeed, to sing their praises to God, in hymns we still sing every Sunday.

Please join us on Sundays at 9 a.m. at Montgomery Center to sing praises and worship the Lord. All are welcome at God's table.

#### Tips from the Pro — Why Newer is Better

If you play golf multiple times a week, you should change out your driver every four years minimum...why?

Newer drivers have larger sweet spots than older drivers. Newer drivers help improve ball speed and have thinner faces which produce longer drives. Newer drivers have repositioned the weight to maximize ball speeds while decreasing spin, creating the perfect balance between carry trajectory and maximized roll. Large golf companies such as Taylor Made, Callaway, Ping and Cobra use artificial intelligence and thousands of golfers of all levels to test their new equipment designs before they are launched. Al helps produce better performing drivers, year after year.

Variable face thickness is an improvement being added to drivers with newer technology. More variable face thickness leads to a better smash factor and a large bounce off the face which helps with distance. It also helps maximize distance on mishits off the heel, toe or high on the club-face.

## Golf Cart Yellow Lines Initiative

As part of the Villages continuing Culture of Care initiative for our 18-Hole golf course, in January of 2023 we will begin the installation of yellow ground paint lines in front of the green com-

plexes to clearly define the 30-foot golf cart restriction area at each green as prescribed in Golf Rule 1.14 Section 8-J:

8-J. Carts are to be kept on the cart path around all green complexes and teeing grounds. Carts must be kept a minimum of 30-feet from the green apron and are not permitted within the perimeter of greenside bunkers.



The golf course yellow lines

The yellow lines will take the place of stakes and ropes and serve as a visual reference point defining where golf carts cannot advance any closer to the green apron according to the 30-foot perimeter mandate in Rule 1.14, Section 8-J.

The former use of stakes and ropes for this purpose proved to be a challenge due to the following factors: Visually and aesthetically unappealing - Unsightly

Physical hindrance to golf shots – Formed an obstruction for advancing golf balls

Labor intensive – stakes and ropes were constantly moved, removed, and knocked down

Expense – the cost of attaining enough stakes and rope for each hole is very high

The yellow ground lines will serve as a better option than stakes and roping for the following reasons: Less Obtrusive yellow ground lines will not create an above ground obstruction to golf shots approaching the green

Aesthetically Subtle – yellow ground lines will be more visually appealing than above ground stakes and roping

Permanence - yellow ground lines cannot be moved, knocked over or completely removed

It is important for the condition of the green complexes and associated turf to keep cart traffic a minimum of 30feet from each green apron and outside the perimeter of the greenside bunkers. Cart traffic allowed too close to the greens damages turf, creates unsightly tire ruts and results in unfavorable playing conditions as the turf becomes thin, compacted, compressed and, in some cases, permanently damaged.

New technology in drivers can include improved head speeds due to the use of carbon in the club-head; so you can swing the club faster, and with an increased moment of inertia so the club won't twist at impact. The Taylor Made Stealth 2 Drivers boast the most carbon of any club in the market.

Jailbreak Technology by Callaway and Power-Bridge Technology by Cobra are examples of new technology. They connect the crown of the head with the sole in the back of the face with internal rods so during contact with the ball, the sole and crown make the energy move directly behind the face resulting in a springing and popping effect that leads to longer and straighter drives.

New drivers have become adjustable. Many allow you to adjust the hosel so you can adjust the loft, lie and face angle of the club. 

## Pickleball Serving Suggestions

We all know we can't score points if we mess up our serves and return of serves. Did you know there are strategies to help you improve your serve and return of serves and to therefore improve your game? Yes, there sure are!

#### **Serving Tips**

- 1. Before you serve:
- a. Check your feet and your partner's feet. They have to be behind the service line, not touching it.
  - b. Draw a mental line to where you intend to serve the ball
  - c. Focus on the ball before, during and through the swing.
- 2. Having a pre-serve routine is critically important, especially for players struggling with their serves. Come up

with a simple routine.

- 3. Hit to your opponent's weak side (backhand)
- 4. Against strong backhand returner, hit to their forehand.

#### **Return of Serve**

- 1. Get set and hit a solid return before moving forward.
- 2. Move quickly to the kitchen.
- 3. Return serve deep: Keep your opponents back to give you and your partner time to get up to the NYZ line.
- 4. Down the middle: returning the serve down the middle of the court is an underused strategy. Whenever possible, hit down the middle.

#### When your partner is returning the serve

- 1. Take one step back. Move back one step from NVZ; you can move back into position after they hit the return.
- 2. Turn your body slightly towards partner and watch the ball during flight. Be ready to call the ball out for your partner so he/she can concentrate on the return.
  - 3. Cover the middle while your partner is moving up.






