Notice of Proposed Changes to Association Policy APr 103 Board and Member Meetings

At the October 31, 2023, board meeting, the Association Board approved proposed changes to Association Policy Apr 103 Board and Member Meetings and to publish proposed changes for the required member comment prior to formal approval consideration at the January 30, 2024, board meeting.

The purpose of the proposed changes to procedure Apr 103-1 are to simplify the formatting of the agenda. The first change is to include to ratify the monthly review of accounts with the Treasurer's report. Second, is to add Action Items—these are agenda items to be considered for action at the board meeting. Third is to add Discussion Items—these art items that are listed for the Board to discuss, receive information, or plan possible action at a future Board meeting.

Response to the proposed new rule may be made by one or more of the following methods: 1) Participation in the discussion of the proposed new rule at the Association Board of Directors December 12, 2023, and January 30, 2024, board meetings, 2) via written comments delivered to the Board through Maria Hernandez in the General Manager's office at mehernandez@the-villages.com.

BOARD MEETING PROCEDURE

Board Meetings

All villa owners (resident or non-resident), individuals renting villas, invited guests and management personnel may attend meetings of the Board of Directors of the Corporation, except when the Board adjourns to Executive Session.

The following are not considered Board meetings:

• Individual contacts or conversations by a Board member with any other person.

• Attendance of a majority of the Board at a purely social or ceremonial event provided the majority of the Board does not discuss among themselves specific business within the Board's jurisdiction of business.

• Attendance of a majority of the Board members at an open and noticed meeting of a "standing committee" of that body provided that the Board members who are not members of the standing committee attend only as observers.

Attendance at Board meetings is subject to acceptable conduct. Anyone who intentionally interferes with or otherwise disrupts the Board's conduct of the meeting will be requested to vacate the meeting room. Refusal to vacate when requested may result in disciplinary action, as defined in the Association's Rules. When deemed necessary to maintain order, the Board may request intervention by Public Safety.

Meeting Notice

Except in the case of an emergency meeting or Executive Session meeting, notice of the time and place of a Board meeting including agenda items shall be posted at Cribari Center and via FastLane at least four (4) days in advance of the meeting and may also be posted on community television, and published in *The Villager*.

Regular monthly Board meetings are held on the last Tuesday of the month. Exceptions to the meeting schedule are sometimes approved by the Board to avoid conflicts with holidays and scheduled events.

Combining the November and December monthly meetings to a single meeting in December is one exception.

Special Board meetings may be called by or at the request of the President or any two (2) Directors. Notice of special meetings shall be given to the Directors at least four (4) days prior to the meeting date, unless the notice requirement is waived by the Directors, which would constitute an emergency situation. Notice of the time and place of a Board meeting including agenda items shall be posted at Cribari Center and via Fast Lane at least four (4) days in advance of the meeting and may also be posted on community television, and published in The Villager.

An emergency meeting of the Board may be called by the President, or by any two members of the Board other than the President, if there are circumstances that could not have been reasonably foreseen which require immediate attention and possible action by the Board, and which of necessity make it impracticable to provide advance notice to the members.

The Villages Association Board's ballot deadline for the Third Amendment to the Covenants, Conditions & Restrictions (CC&Rs) is **Monday, December 11, 2023 at 8 a.m**. Please vote on this important amendment.

Bocce Court update from General Manager's office

A *New Bocce Court News* message was recently sent to Bocce Club members. While there's excitement that surrounds this project—within the club and the entire Community—we pause to make clear project timelines, budgets and included amenity items to properly set expectations.

During the CBOD November 14 Working Session, AGM Public Works, Ryan Bell, presented the Bocce Court comprehensive plan phase details:

Phase 1: anticipated to be completed - March 2024 (weather permitting)

Phase 1 is the current phase approved to proceed by the Club Board as appropriated (Reserve & Capital fund expenses) for a total of \$292,050. This phase includes:

- Additional third court
- Concrete walkways
- Reconstruction of the existing two courts

Phase 2: This phase is currently being developed and will be presented to CBOD at the February 2024 regular Board meeting.

A ROM (rough order of magnitude) of \$100-\$125K allowance has been projected to add the Bocce ancillary amenities which include:

- Trellis
- Seating
- Storage shed(s)
- Scoreboard
- Etc.

Phase 3 is budgeted for FY25's Capital Budget. This final phase will be presented to CBOD at their regularly scheduled meeting in May 2024. The recommendations continue the comprehensive improvement projects for Gazebo Park, which includes:

- Cart parking
- Sitting area tables
- Seating
- Pavilion
- Improved walking paths

The GM office is working closely with our vendors, contractors, Club Board, and our own Public Works team. We trust this message further clarifies The Villages Bocce Court and Gazebo Park 2024/25 additions. We're excited!

Keeping your home out of probate What happens upon your death if you own your Villages home in your name alone? Let's say

you have a simple will, leaving your home to your two children. Upon your death, your condo will require court probate to transfer the ownership. Current probate fees begin at 4 percent for the first \$100,000 of value, 3 percent for the next \$100,000 and 2 percent for the next \$800,000, and then become 1 percent after \$1million. And this fee is usually charged twice—by the court and by the estate attorney.

Probate fees can be avoided by setting up a Living Trust and titling the condo in the name of the trust or alternately by adding one or more joint tenants to the condo deed.

Some Villagers believe their estate is not large enough to merit the legal cost of establishing a Living Trust. Joint tenancy with your children avoids probate, but it can cause problems of its own. Your joint tenants would legally own part of your condo. You would need their permission to sell or refinance. The creditors of your kids could place a lien on the condo. You will likely lose some of your Prop 13 tax base so your property taxes will increase.

And wait, there is more: Upon creation of the joint tenancy, you would need to file a gift tax return. Also, upon your death, your heirs will be stuck with part of your original condo cost in calculating the gain on sale and will likely owe income tax. And most importantly, you can't change your mind and take the others off the deed. A legal gift was made; it is permanent.

California law has another alternative to avoid probate: The Revocable Transfer on Death deed frequently called a TOD deed. This deed names the beneficiaries who will receive the property without the need for probate when the property owner dies.

Your heirs do not own any of the property during your life, avoiding the above joint tenancy problems. But when you die, the real estate is transferred to the designated beneficiaries just like your Payable on Death bank accounts.

You can revoke your TOD deed at any time by notarizing and recording a Revocation of Revocable Transfer on Death Deed.

SRS suggests you talk with an attorney before making this change. Your decision for a TOD deed may be confirmed or you may be persuaded that another solution such as a Living Trust is better for you.

Next week we will discuss more details about the form you need to file.

Be safe, be seen—VMA Safety Vests

Now that it's getting dark even earlier, it's extremely important that you wear bright, reflective clothing to ensure oncoming drivers can clearly see you.

The Villages Medical Auxiliary (VMA) has yellow/green reflective vests available, which are

SRS Reminder: Property tax due December 11

Monday, December 11 is the last date for paying your first installment of your Santa Clara County real estate tax for the fiscal year ending June 30, 2024.

You may pay online at https://payments.sccgov.org/propertytax/Secured. There is no fee for paying electronically. Just have your checkbook handy so you can enter the bank routing number and your account number.

If you pay with a credit or debit card, there is a 2.25 percent fee.

If you pay with a paper check, your payment envelope needs to be postmarked by December 11. Paying online eliminates the worry as to whether or not the post office processes your mail by the due date, or the county loses your envelope.

The Villages Amateur Theatre is excited to announce that the Spring musical will be "Man of La Mancha."







Yet Elinor's private and seemingly tranquil existence conceals a past trauma that comes to the fore when she is drawn into the predicament of a local man entangled with one of the most dangerous crime families in London. A treacherous path lies ahead, but it may be one that ultimately leads Elinor to a future unshackled from her own painful history. Mystery, 2023.

"Near Miss" (Stone Barrington #64) by Stuart Woods and Brett Battles. Following a string of adventures, Stone Barrington is enjoying some downtime in New York City when a chance encounter introduces him to a charming new companion. Too bad she also comes with the baggage of a persistent ex-boyfriend intent on retribution. As Stone skillfully dodges each disturbance, it soon becomes clear that there is potentially an even more treacherous game being played behind the scenes. And when long-standing grudges resurface, Stone is brought back into the orbit of some familiar enemies. He must use all of his tricks-as well as those of a few old friends-to evade trouble before it's too late. But this time, danger just might catch him. Large Print, Mystery, 2023.

"Beware the Woman" by Megan Abbott. "Honey, I just want you to have everything you ever wanted." That's what Jacy's mom always told her. Finally, she did. More facts about food waste



As a follow-up to last week's article on food waste from the Sustainable Villages Club, it is vital that one realizes food waste accounts for 18 percent to the country's methane pollution, a greenhouse gas that's 87 times more potent than carbon dioxide over a 20-year period.



If food waste were a country, it would be the third top emitter of greenhouse gas emissions after China and the United States, accounting for 3 billion tons of carbon emissions. In the United States, uneaten food

is the single largest source of trash in landfills. And the problem keeps growing. Over the past 50 years, greenhouse gas

emissions from food waste have increased more than 300 percent, and are projected to increase another 400 percent by mid-century if current dietary and waste trends continue.

With that said, be very mindful when going to the grocery store to buy only food that you can use. If you have leftovers, think of freezing it if pos-



Tips from the Pro-Get a Grip!

The one fundamental of golf that is the most important is the grip. Your hands are your only connection to the golf club, so the grip therefore is paramount to performance. Although the grip is often overlooked by the golfer, we that teach the game never give a lesson without checking the golfer's grip first. The key is to be comfortable but also position sound. Not every grip has to be perfect, but we do not want aggressive misconceptions of how the hands are placed.

Make sure the right thumb rests to the left of the handle. The left thumb should not be visible as it tucks into the right palm.

When you fan your right hand out, your palm should face the target, not the sky.


Make sure neither hand is aggressively rotated right or left but rather in a neutral position with your palms opposing. Grip pressure should be secure but not tight as that will inhibit hand and wrist action.

Two More Tips...

If your grip is biased to the right (right hand under, left hand on top)...that is called a "strong" grip and will promote the ball going left.



it is important enough that the Board have full knowledge and understanding prior to formal discussion.

The agenda functions as a tool to move along discussion of the issues and actions. The meeting agenda will contain the following:

Time and Place

Time, date and location of the meeting.

Call to Order

The President or other presiding officer (Chair) will call the meeting to order. Once called to order, the meeting will be conducted in accordance with accepted parliamentary procedure. Robert's Rules of Order will be used as a parliamentary guide.

Roll Call

Director's names are called to verify attendance and the presence of a quorum as defined in The Villages Association Amended Bylaws, Article 7.11.

President's Report

The President may provide a summary report of Board activities, including any special, Executive Session, or emergency meetings held since the last regular monthly meeting. The President may also use the report as an opportunity to inform the Directors and audience about matters of special interest to the community.

Treasurer's Report

The Treasurer will provide a summary report of the Corporation's general financial performance and status for the period since the last report and year-to-date. The report may be supplemented by management reports of specific financial and business activities. The Board may discuss the report and then will vote on accepting the report. The Board will also review the Treasurer's recommendation to ratify the monthly review of accounts and vote on ratification.

Accept Treasurer's Report

Ratify Monthly Review of Accounts

General Manager's Report

The General Manager will provide a summary report of management activities during the period since the last report and other matters of interest to the Board and membership.

Committee Reports

Committee Chairmen or their designees will provide summary reports of their activities as requested by the Chair.

Open Communication

An opportunity will be provided for audience members to address the Board on any Association-related matter. The time allotted to each speaker will be determined by the Chair. The Chair has sole discretion to permit response to questions and opinions. **Consent Agenda**

Items such as prior meeting minutes and committee reports will be submitted for Board consent approval; for example, "Consent to approve minutes and committee reports as submitted." A consent agenda alleviates the need for a verbal report on routine administrative items. The Board may remove an item from the consent agenda for purposes of separate discussion or action. However, the Chair will not normally invite audience comment on the item.

Unfinished Business

Unfinished Business is the consideration of those items purposely deferred by the Board from one meeting to another. Reports to the Board will include prior agenda submittals and any pertinent information received since the Board's last consideration. At the Chair's discretion, time will be allotted for comment from the audience on each agenda item considered by the Board. The Chair has sole discretion to permit Director response to questions or opinions presented by the audience. However, the Chair will not normally invite audience comment on the item.

The names of makers of motions and seconders shall be recorded in the Minutes of the meeting. The motion shall be read immediately prior to the Board vote. **New Business**

New Business is the consideration of those items presented for the first time. Each listed item will include a description to clarify the action or motion sought. The names of makers of motions and seconders shall be recorded in the Minutes

of the meeting. The motion shall be read immediately prior to the Board vote.

Executive Session

If needed.

Study Sessions

Study sessions will be called as needed.

A study session may be called by the President of the Association Board (Board) to discuss items of interest to the Board, Management or Members. In addition, two Board Members or the General Manager may request that the President call a study session. Upon that request, the President must call a study session within 14 days.

Except in the case of an emergency meeting or Executive Session meeting, notice of the time and place of a Board meeting including agenda items shall be posted at Cribari Center and via Fast Lane at least four (4) days in advance of the meeting and may also be posted on community television, and published in *The Villager*.

The purpose of the study session is to allow a topic to be studied by the Board in open session, prior to a formal decision being made at the monthly board meeting. Formal Board decisions will not normally be made at the study session, unless timing is such that a decision must be made. Rather, agenda items the Board deems appropriate will be brought back to the formal board meeting for consideration.

The President of the Board at his/her discretion shall conduct the meeting, dispensing with the normal formalities of the board meeting following the order of the agenda, which was published four days in advance of the study session. The President at his/her discretion may limit resident participation during the discussion of agenda items.

An opportunity will be provided for audience members to address the Board on any Association-related matter. The time allotted to each speaker will be determined by the Chair. The Chair has sole discretion to permit response to questions and opinions.

Executive Sessions

The Board may only hold an Executive Session only to consider the following:

- Litigation
- Contracts Formation
- Member discipline (in which case the subject member may attend)
- Personnel Matters
- To meet with a member, at the member's request to discuss delinquent assessments
- To decide whether to foreclose an assessment lien

Except in the case of an emergency, an Executive Session meeting notice including agenda items shall be posted at Cribari Center, and via Fast Lane at least four (4) days in advance of the meeting and may also be posted on community television, and published in *The Villager*.






